Congress to Kansas Tour
Larry Tawney & Sylva Nichols

This is the first time that any candidate has stopped in Manhattan and held a conversation with their constituents. At least, the first in my recollection.

The meeting was held at the Manhattan Train Depot on an August, Thursday morning. A small group of about 30 people gathered allowing those in attendance complete access to Representative Jenkins.

Representative Jenkins outlined the Listening Tour as our elected officials coming out to their districts to get input on what the People want done in Government. The location for more input on this is: www.americaspeakingout.com.

I thought the questions ask on immigration, repelling new health care bill, Social Security, Medicare (the not fixed Donut Hole), National Debt were good questions and were answered honestly and straightforward. There was no dodging questions, changing the subject, or just not answering. Every question/issue brought up was addressed.

Rep. Jenkins says Government Debt “Must Stop!” Stop funding in the red – 1.3 Trillion if not more is more than enough.

Rep. Jenkins feels strongly that illegal immigration needs to be stopped; our borders need to be secure – period. Those living in the US illegally are an issue to be taken care of.

Repelling the Health Care Bill passed last spring is more like a dream than a reality. Chances of being able to repeal it and it not being vetoed are slim to none. **IF** a voting majority in the House repels it, undoubtedly, the President would veto it. The chances of Congress being able to have the votes to override a Veto are very slim. Once the taxes to pay for it are in force they will not be refunded even if the bill was repelled. However, it may be possible to rewrite some parts of it and gain something.

When ask about Congress giving up their private health care and retirement she agreed that she would be in favor of Congress living by the same rules/laws as the rest of the population for health care, retirement, and all laws they pass. Congress now must serve 5 terms before they can receive retirement. (The retirement program Congress is now under is: a) must serve a minimum of 25 years of service or after they reach the age of 62. b) they are not eligible for a pension until they reach the age of 50, but only **if** they’ve completed 20 years of service or are eligible at any age after completing 25 yrs. of service or are 62 years old.) Rep. Jenkins would be willing to give up the retirement Congress now has and go on Social Security as their only federally funded retire, like the rest of us. As for term control, Rep. Jenkins feels that the people can control that. If the people feel a congressperson isn’t doing their job; then the people can vote them out.

The “Lame Duck” session to be held after the general election is when the Progressive Democrats and the RINO Republicans will push for Immigration Reform, VAT tax – “Value added Tax”, Cap & Trade – Giving last minute spending a blank check. In an effort to prevent legislators who had been fired by their constituency (voted out of office) from “wreaking havoc” on the voting public Rep. Jenkins has introduced a bill that would eliminate the Lame Duck session. Rep. Jenkins promises Conservative Republicans will do what they can to prevent as much damage as possible.

Those who missed this time with our Congresswoman Jenkins denied themselves of a very unique experience. In no way did she “duck” any questions or refuse to discuss any topic. If she felt we wouldn’t like the answers she still gave it to us “the way it is”. We want to thank her for being Honest with us on all issues.

What I came away with is some insight on what the Republican Party will do to curb Government. Presidential control: Czars will not have ability to cause run around. Legislative changes will be made. To have more transparency, change governing rules so things are not

done behind the people's backs; to not have rules thrown out the window. Martial Law type of a government is now being practiced by the Progressive Democrats. No debate; no adding amendments. No reading bills until **after** they've passed. The Republican Party will have no Eye for Eye policy to run Congress.

So folks, I came away understanding there will be no easy answers. It also may take a generation before our goal of limiting government is a reality. Rep. Jenkins made comments indicating Federal government has successfully restricted individual State rights. I think issues of State Sovereignty, forced Health Care, limiting personal freedom – is not trump by Federal government laws & mandates.

Minutes of August 28 Flint Hills TEA Party Team Meeting

We need a Secretary. Volunteers were ask for and Vicki Catlin, being the good member she is, volunteered. Matthew Chadwick volunteered to be her backup when she is absent.

Treasury Report by Paul Barkey

Sales Tax will need to be reported by January 15, 2011 for the FHTP. Chris Tawney indicated that she is keeping a spreadsheet for all sales and it could be used to calculate the sales tax.

Paul reported the current balance is \$546.08, but \$450.00 is dedicated to the Constitution Scholarship. A separate bank account will be set up for the scholarship monies as soon as it can be arranged. We have a bill at GTM for T-shirts in the amount of \$364.00. Chris gave him \$150.00 from sale of T-shirts to apply to the GTM Bill. She also reported the current cost of the T-shirts as \$15.20 each for size 3X, \$7.50 for size 2X, and \$6.50 for all others. It was discussed and decided there needs to be 2 people as treasurer. It is a huge responsibility for one person and one person cannot be available all the time. Paul indicated that it would be a huge relief to him to have someone else as Treasurer and he could be the second person or perhaps find 2

people and he would step down. Holly F. suggested Gail Lortscher. Sylva made a motion for two people to share the responsibility, but a primary person being the treasurer. Motion was 2nd and passed.

John Ford indicated it is time we started thinking of ideas for fundraisers. Discussion continued as to what items could be sold. Several items were mentioned: Constitution, T-shirts, Credit Card (were sold at the Riley County Fair), and a new FHTP decal Chris had. Different prices of different items were discussed.

Media Team Report by Larry and Chris Tawney

Larry stated that we are looking for sites to place “You have a Voice – Vote!!” signs. It was announced that we can place any signs we chose (FHTP, Candidate, Other) any time and any place as long as it is on private property and have owners permission.

The first newsletter is out, and the second in the works to be out between the 16th and 18th of September, if not sooner.

We discussed opening the weekly Wednesday meeting at McAlister’s for member venting and open discussion. Having a different meeting day and place for these meetings was also discussed. Paul was concerned if McAlister’s was a proper place for an open discussion meeting; being concerned that the conversation could become distracting to other customers. Larry explained he had talked with the management at McAlister’s and that they are good patriots, and that with Larry providing some measure of control there is no problem.

Larry reported postage for sending the newsletter to our “snail mail” list is time consuming and expensive. It was discussed whether we should ask for a small donation or fee for those who requested a mailed copy of the newsletter. Sylva suggested that maybe an alternative of requesting cash that these patriots could contribute a roll of stamps. John suggested that there might be people who couldn’t make it to the meetings regularly, might be able to help with the mailing or cost of postage and do it at home.

Scholarship Fund

John Matta informed us that we need to get the money for the Scholarship fund “put to bed”. It was stated that if each person (household) on our “interested list”, that we send the newsletter to, gave \$25 now and, hopefully, each year we would have enough to award the scholarships each year and also to pay the required “administrative” fees. Discussion ensued about making it a statewide contest, which would help with fund raising, as there would be more people and businesses interested in donating.

John M. informed us a board/steering committee to “govern” the scholarship is required and needs to be formed. After discussing all the “administrative” steps that need to be completed and in place to keep us legal and “in order” it was decided that we would not be able to accomplish all that and be ready to award the scholarships this year. The awarding will have to be delayed for one year. The Constituting board must be formed and by-laws in place. We do have a lawyer helping us to be sure we stay within legal boundaries. This will be addressed at Wednesdays meeting. The board is required to meet a minimum of once a year and report to the Secretary of State. The scholarship amounts that will be available are: \$500, \$750, and \$1,000.

Endorsing Candidates

Brief discussion was held about endorsing candidates. If the group wants to endorse, we can endorse anyone, however, if the group is putting funds into their campaign, the Federal Government wants to know about it.

A Brief discussion about whether group wanted a more formal leadership and/or membership. This was brought up in conjunction with the “endorsing candidates” discussion as to how we would decide to endorse. If we took a vote, would we vote off of a “membership” list? Would we vote, using those who were present at the meeting? Also, what vetting would we use to decide on whom the group was going to endorse. John Ford volunteered to be leadership of a research committee to research candidates for possible endorsement. Holly suggested we should establish criteria that a candidate has to have to be considered for endorsement.

Forum

In a past meeting it had been discussed to have a candidate forum that we co-sponsor with the American Legion. Lee said that he knows the owner of the Wareham and said he would talk to him about using it for a candidate forum. Holly suggested Pottorf Hall. John Matta said it might be stronger if we could co-sponsor with the American Legion. He also stated we need to set a date. It was decided that Chuck would book the Library for a forum on October 13th. Ernie brought up that “Our Manhattan” thinks that they are working on forums for local candidates (county & city), and FHTP is working on state and national candidates. Questions need to be formulated for presentation to the candidates, and then questions could be taken from the audience. Paul is going to follow up with the American Legion. John is going to contact Carolyn (Our Manhattan) about merging with their forum. Rob & Holly volunteered to help with the forum on October 13th. There was also discussion about checking with the Black Jack Legion.

Constitution & 5,000-Year Leap Classes

Holly announced that she & Rob were going to start another class at the Grace Baptist Church, on Tuesday, September 14th. Fellowship time will be from 6:45 to 7:00, followed by the class, which will end at 8:30pm. A sign up sheet for the class was passed around.

Apple Days

Holly announced that there is an event, Apple Days, at Fort Riley on September 18th. Holly and Rob will have a booth there, and invited anyone from the FHTP to stop by, wearing their FHTP T-shirts.

Constitution Day

A celebration ceremony was discussed. Holly, Matthew and Chris are will work on it.

Sylda announced that Lynn Jenkins joined the Flint Hills TEA Party and accepted a T-Shirt at the Lynn Jenkins meeting at the Depot. Rep. Lynn Jenkins encouraged TEA Party members to subscribe to her weekly email updates and keep her updated on the TEA Party.

Meeting was adjourned.

Since the meeting it has been decided that a Candidate Forum with the Manhattan American Legion will be held. Date and information will be sent when scheduled.

Holly and Rob have decided they are unable to plan a Constitution Day activity. Others will put together this activity and information will be issued when plans are finalized.

Were you aware that the following is actual LAW?

Public Law 108-447

SEC. 111. (a) The head of each Federal agency or department shall—

(1) provide each new employee of the agency or department with educational and training materials concerning the United States Constitution as part of the orientation materials pro-vided to the new employee; and

(2) provide educational and training materials concerning the United States Constitution to each employee of the agency or department on September 17 of each year.

(b) Each educational institution that receives Federal funds for a fiscal year shall hold an educational program on the United States Constitution on September 17 of such year for the students served by the educational institution.
