"The recession just outlasted us" Company town will cease to exist after falling victim to economic slump.

The recession has claimed many victims, but this could be the first town to be completely wiped off the map.

The mining town of Empire in Nevada, about 100 miles northeast of Reno in the Black Rock Desert, was created in 1923.

But from June 20, it will simply cease to exist, its 300 inhabitants will no longer live there, the ZIP code won't even exist any more. The welcome sign at the town of Empire, Nevada, which will cease to exist on June 20.

In fact the only thing remaining of the town, which was once home to the United States Gypsum Corporation, will be an eight-foot chain-link fence crowned with barbed wire sealing off the 136-acre plot and a sign saying Welcome to Nowhere – which has never proven so true.

Empire was a company town, completely built around the United States Gypsum Corporation, which is the nation's largest drywall manufacturer.

According to the Christian Science Monitor, the town of Empire has all it needed for its tiny population to survive – four dusty streets lined with cottonwoods, elms, and silver poplars, dozens of low-slung houses, a community hall, swimming pool, a cracked tennis court, and a nine-hole golf course called Burning Sands.

The residents of Empire were told just before Christmas that the town was to be no more, when 92 workers were told that, not only did they not have jobs, but they no longer had houses.

January 31 was the last workday for 95 of the 99 United States Gypsum employees at the mine and plant. They turned gypsum into sheetrock, a trademarked name and the most common wallboard used in the construction industry.

Four workers remain, but this will be whittled down to two by the end of the month.

Workers with families were allowed to stay for free in company-provided housing for another five months so their children could finish the school year.

The company reported losses of about \$1.5 billion over the past three years because what USG produces is not in high demand any more.

By the end of 2010, wallboard sales had dropped more than 50% since 2006, when the industry peaked and USG had \$297 million in profits.

They hiked drywall prices in an attempt to salvage the industry, but it didn't work.

Steve Conley, who began working there in the early 1970's told the Christian Science Monitor: "Every day we made it was a day closer to economic recovery. But the recession just outlasted us."

Once a noisy, bustling quarry, it is now silent, a veritable ghost town – the roads are blocked, the gates are up, the houses and lawns are rundown and the delighted squeals and shrieks of children playing in the streets are no more.

Residents say it now looks like a concentration camp.

Calvin Ryle, 62, began working in Empire on July 1, 1971. In January, he helped bring the last piece of drywall off the line.

Standing beside a conveyor belt in the factory, where his son and his daughter-in-law both worked, Mr. Ryle raised his hand and pressed the stop button for the last time.

He said: "I've been here for 39 years and seven months. I've never missed a single day, never been injured. The worst thing you can hear in a board plant is silence. You're a part of building America. It's not just making Sheetrock here."

The plants maintenance foreman, Aaron Constable, watched Mr. Ryle close the place down.

He said "He actually stood there and cried. He's up there at the main start-stop station. When they said, "You go ahead and shut her down." It took him some while before he actually pushed the button."

Many of the workers have managed to find jobs in Nevada's gold mines, since the price of the precious metal has sky rocketed in the recession.

Five miles down the road in Gerlach, where Empire's children were bused to school each morning, 23 employees of the Washoe County School District anxiously await news.

Ten of those 23 are teachers, and while a couple retired to stay here, the rest were guaranteed a spot in one of the Reno's schools.

There has also been talk that if the economy recovers, the plant could be reopened but most don't hold out hope that this will happen.

Mr. Ryle told the Christian Science Monitor he doesn't think this will happen, and will be leaving his gold hard hat – a reward for 25 years of loyal service – behind him in the house he has lived in for decades.

But he's not leaving everything behind. He says he'll transplant the rosebushes and a tree from his front yard when he moves to Fernley, Nevada, where he just bought his first home.

He said: "I planted that tree, so I'll dig that one up. They don't care. And it's my tree. I'm taking it with me."

Anthony Weiner Announces His Resignation from Congress-----

In a news conference marked by loud hacking, embattled Representative Anthony Wiener announced he would resign from Congress effective immediately, bowing to days of public pressure from members of his own party.

Weiner apologized for the "embarrassment" he had brought to his colleagues, his constituents and "most importantly" his wife.

"I had hoped to be able to continue the work that my constituents elected me to do," Weiner said. "Unfortunately, the distraction that I myself have created has made that impossible. So today I'm announcing my resignation from Congress."

He said he would leave Congress to allow his party to get back to the work of the American people and so that he and his wife could continue "to heal from the damage that I have caused."

Weiner's resignation came after nearly three straight weeks of drama, set off by the disclosure that he had sent lewd photos of his crotch to a 21-year-old Seattle college student over Memorial Day weekend.

The congressman initially claimed he had been hacked, but a week later, he admitted in a press conference that he had lied to his wife, his colleagues and to the media. He said he had sent the initial photo as a “joke” and admitted to risqué online dealings with at least six other women, several of whom subsequently came forward with lewd photos and texts they had exchanged with the congressman.

Weiner had repeatedly denied he would resign over the last week, rebuffing fellow Democrats who had urged him to leave Congress. On Saturday, top Democrats, including House Minority Leader Nancy Pelosi, went public with their resignation calls after word surfaced that police had investigated Weiner’s Twitter messages to a 17-year-old girl in Delaware.

Weiner, who denied his messages with the girl were “indecent,” announced he would enter “treatment” –and has been publicly out of sight until today, as Democrats considered options to put further pressure on the lawmaker to resign.

About an hour before the press conference, the disgraced congressman was spotted outside his apartment in Queens, New York, with his wife, Huma Abedin. A longtime aide to Secretary of State Hillary Clinton, Abedin married Weiner last June and is pregnant with the couple’s first child.

Abedin did not appear with him at his news conference in Brooklyn – Weiner has insisted the two are not divorcing and that she has supported him throughout the scandal. Still, it’s unclear if Abedin was as supportive of her husband as he suggested. While Weiner told fellow Democrats his wife had pressed him to ride out the scandal and stay in Congress, sources tell Politico that Abedin is “disgusted” and has been huddled with Clinton advisers trying to make sense of her husband’s situation.

In his news conference today, he apologized to his wife repeatedly, thanking her for sticking by him.

A major concern for Weiner is likely how to support his family. The disgraced lawmaker has no career to fall back on. He may well return to his previously announced plan to continue seeking “treatment” – though it’s still unclear exactly what Weiner has been under treatment for. Weiner’s seat will now be the subject of a special election – though there are rumors that his district could be phased out by congressional redistricting.

Still, Weiner’s announcement today seemed to be laying the groundwork for a political return someday. He repeatedly thanked his “neighbors” and “constituents” and touted his accomplishments in Congress – though much of that was drowned out by hecklers, who yelled questions about Weiner’s endowment and physique.

Executive Order 13575—Establishment of the White House Rural Council

June 9, 2011

By the authority vested in me as President by the Constitution and the laws of the United States of America and in order to enhance Federal engagement with rural communities, it is hereby ordered as follows:

Section 1. Policy. Sixteen percent of the American population lives in rural counties. Strong, sustainable rural communities are essential to “Winning the Future” and ensuring American competitiveness in the years ahead. These communities supply our food, fiber, and energy, safeguard our natural resources, and are essential in the development of science and innovation. Though rural communities face numerous challenges, they also present enormous economic potential. The Federal Government has an important role to play in order to expand access to the capital necessary for economic growth, promote innovation, improve access to health care and education, and expand outdoor recreational activities on public lands.

To enhance the Federal Government’s efforts to address the needs of rural America, this order establishes a council to better coordinate Federal programs and maximize the impact of Federal investment to promote

economic prosperity and quality of life in our rural communities.

Sec. 2. Establishment. There is established a White House Rural Council (Council).

Sec. 3. Membership. (a) The Secretary of Agriculture shall serve as the Chair of the Council, which shall also include the heads of the following executive branch departments, agencies, and offices:

- (1) the Department of the Treasury;
- (2) the Department of Defense;
- (3) the Department of Justice;
- (4) the Department of the Interior;
- (5) the Department of Commerce;
- (6) the Department of Labor;
- (7) the Department of Health and Human Services;
- (8) the Department of Housing and Urban Development;
- (9) the Department of Transportation;
- (10) the Department of Energy;
- (11) the Department of Education;
- (12) the Department of Veterans Affairs;
- (13) the Department of Homeland Security;
- (14) the Environmental Protection Agency;
- (15) the Federal Communications Commission;
- (16) the Office of Management and Budget;
- (17) the Office of Science and Technology Policy;
- (18) the Office of National Drug Control Policy;
- (19) the Council of Economic Advisers;
- (20) the Domestic Policy Council;
- (21) the National Economic Council;
- (22) the Small Business Administration;
- (23) the Council on Environmental Quality;
- (24) the White House Office of Public Engagement and Intergovernmental Affairs;
- (25) the White House Office of Cabinet Affairs; and such other executive branch departments, agencies, and offices as the President or the Secretary of Agriculture may, from time to time, designate.

(b) A member of the Council may designate, to perform the Council functions of the member, a senior-level official who is part of the member's department, agency, or office, and who is a full-time officer or employee of the Federal Government.

(c) The Department of Agriculture shall provide funding and administrative support for the Council to the extent permitted by law and within existing appropriations.

(d) The Council shall coordinate its policy development through the Domestic Policy Council and the National Economic Council.

Sec. 4. Mission and Function of the Council. The Council shall work across executive departments, agencies, and offices to coordinate development of policy recommendations to promote economic prosperity and quality of life in rural America, and shall coordinate my Administration's engagement with rural communities. The Council shall:

- (a)** make recommendations to the President, through the Director of the Domestic Policy Council and the Director of the National Economic Council, on streamlining and leveraging Federal investments in rural areas, where appropriate, to increase the impact of Federal dollars and create economic opportunities to improve the quality of life in rural America;
- (b)** coordinate and increase the effectiveness of Federal engagement with rural stakeholders, including agricultural organizations, small businesses, education and training institutions, health-care providers, telecommunications services providers, research and land grant institutions, law enforcement, State, local, and tribal governments, and nongovernmental organizations regarding the needs of rural America;
- (c)** coordinate Federal efforts directed toward the growth and development of geographic regions that encompass both urban and rural areas; and
- (d)** identify and facilitate rural economic opportunities associated with energy development, outdoor recreation, and other conservation related activities.

Sec. 5. General Provisions. (a) The heads of executive departments and agencies shall assist and provide information to the Council, consistent with applicable law, as may be necessary to carry out the functions of the Council. Each executive department and agency shall bear its own expense for participating in the Council.

(b) Nothing in this order shall be construed to impair or otherwise affect:

(i) authority granted by law to an executive department, agency, or the head thereof; or

(ii) functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.

(c) This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

(d) This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

Oil release not a political move: Geithner

(Reuters) – U.S. Treasury Secretary Timothy Geithner defended the decision by industrialized nations to release emergency oil reserves into global energy markets, saying on Friday that it was not a political move. "It's really as simple as this: there's a war in Libya, costs between one and two million barrels a day in lost output, I think 140 million barrels off the market so far" he said in response to a question in Dartmouth College, where he spoke on a panel.

"Reserves exist to help mitigate those kinds of disruptions and we helped to organize a coordinated global international response to help ease some of that pressure," he added.

The Paris-based International Energy Agency announced on Thursday that it was tapping member countries' emergency reserves -- some 60 million barrels over 30 days -- for only the third time since it was founded in 1974, to fill the gap in supplies left by the disruption to Libya's output.

The 28-nation IEA, which was set up after the Arab oil embargo as a counterweight to OPEC, said the move was a bid to boost the global economic recovery by holding down oil prices.

The United States will provide half of the total volume to be released.

The decision caught energy and financial markets by surprise and generated criticism from oil companies, members of the OPEC oil-producing cartel and Republican opponents of the Obama administration.

Since oil prices already had fallen from early-May peaks near \$115 a barrel, critics said the action appeared aimed at propping up President Barack Obama's popularity rating as much as helping consumers.

But Geithner, who met with local business leaders earlier on Friday in nearby Manchester before speaking at Dartmouth, said putting additional oil supplies on market was "sensible policy" that should give a lift to a slowly expanding economy.

"It will provide some modest help and relief" to the U.S. economy, Geithner told reporters afterward. "It was a prudent use of existing reserves."

High oil prices have put "significant" pressure on global growth, he said.

Geithner has limited his foreign travel this year, concentrating on trying to build support in Washington for a hike in the debt ceiling before August 2 when Treasury said the country will be at risk of default. But he has made several day trips to different regions, like Friday's to New Hampshire, urging business groups to tell Republican lawmakers that concluding a budget and debt deal is urgent.

In his remarks at Dartmouth, Geithner said many factors restraining U.S. economic expansion were temporary, including supply-chain disruptions from Japan's massive earthquake in March. He also said an adjustment in housing markets was about two-thirds over.

He said costlier energy and less vigorous worldwide growth would keep U.S. economic growth to around a 2 percent annual rate in the first half this year, but he insisted that underlying trends were improving.

Regarding budget talks in Washington, Geithner said he was confident Congress can still reach a deal, even after a top Republican lawmaker walked out of the talks this week. But he said tax increases cannot be taken out of the equation.

"You need to have modest changes in revenue," Geithner said. "There is no way to do a deal without it."

He said that business leaders whom he met with on Friday had some encouraging words about the environment they face.

"Things are gradually getting better," Geithner said, adding that the U.S. economy is still growing "a little slower" than had been expected.

U.S. economic growth in the first quarter was an annualized 1.9 percent, the Commerce Department said on Friday.

That was revised up from a previous 1.8 percent reading. But it is still too low to be an engine for job creation, with the high U.S. unemployment rate of 9.1 percent posing a reelection challenge for Obama.

The budget deal "needs to get done in a way that doesn't put too much pressure on the economy near term," said Geithner, calling for "the right kind of balance" and a deal that does not skew too much to elements that could hinder growth.

Business people badly want to see Washington reach a broad agreement on the budget, and soon, Geithner added. "A lot of people think that would be good for the economy, and I agree."
