DO YOU REMEMBER JANUARY 3, 2007?

The 3rd District Jobs Fair on Thursday was a tremendous success. We had a great turnout of both employers and prospective employees looking to earn a paycheck. Thank you to the Holiday Inn Overland Park West for letting us utilize space to put job seekers and employers face-to-face in an effort to get people back to work. While we have been working in Washington, D.C. to pass bipartisan legislation to help grow our economy, these jobs fairs provide a great opportunity locally and allow us to take matters into our own hands on the jobs front.

There were 50 employers who set up tables to advertise job openings. These employers ranged from small businesses to larger ones, and included industries like finance, manufacturing, transportation, health care service providers, information technology and more. All told, over 700 job seekers attended our 3rd District Jobs Fair in Overland Park this week.

I'm also very interested in helping veterans find employment once they return home from their tours. I believe it's a national tragedy that the unemployment rate for returning veterans is higher than the overall

national unemployment rate in our country. Incredibly, the jobless rate for veterans under the age of 25 years old is almost 30 percent. We made the first hour of our Jobs Fair exclusively for veterans so they had first crack at these quality job openings.

Veterans have risked their lives on the front lines abroad serving their country – they deserve to be at the front of the line for a good-paying job when they return home from service. Replacing the Defense Sequester The administration has repeatedly said the fast approaching “sequester,” or automatic budget cuts, would seriously weaken our armed forces and threaten our national security. To avoid these dangerous defense cuts, the House of Representatives passed the Sequester Replacement Reconciliation Act of 2012 in May that would reprioritize the \$98 billion cut in 2013 defense funding scheduled to take effect this January. This act would replace the sequester with common-sense savings and reforms, cut other mandatory non-defense programs, and reduce the deficit another \$243 billion beyond the original cuts from the Budget Control Act by eliminating bailouts, slush funds, and stopping fraud in taxpayer-funded programs. It is now time for the Senate Democrats and the administration to follow suit.

Last week, I voted in favor of H.R. 6365, the National Security and Job Protection Act that extended President Obama's deadline to present his plan on how to implement or replace the sequester, because he has failed to put forth a credible plan. In fact, the president violated the law he signed in August, the Sequestration Transparency Act of 2012. This law required President Obama to submit a detailed report by September 7, 2012, that explained to the American people what his proposed cuts were and who would be affected by the sequester, but the White House ignored the deadline. On September 14, the administration released a 394-page report outlining the details of the sequester, however [this report](#) “simply lists the dollar amount of the cuts but fails to address their real-world impact.”

Unfortunately, the Senate has not passed a bill either; they have not even proposed a plan. The House continues to work on this issue, but this is a bicameral legislature, and things cannot get done without both the House and the Senate.

House Republicans have acted responsibly to remain true to the Budget Control Act, and avoid the fiscal cliff that would thrust the economy back into a recession. President Obama and Senate Democrats have not taken a single action to resolve this potentially disastrous situation. This lack of leadership is hurting the economy and the country.

Protecting the Welfare Work Requirement In July, the Department of Health and Human Services (HHS) released a memo allowing states to waive the work requirement for those seeking public assistance. The work requirement was the key component to the success of the 1996 bipartisan welfare reforms that moved millions of Americans out of poverty, off government dependency, and into jobs.

The Personal Responsibility and Work Opportunity Reconciliation Act of 1996 replaced the Aid to Families with Dependent Children program with the Temporary Assistance for Needy Families (TANF) block grant program. The law promoted work as a central focus of helping low-income families achieve self-sufficiency. Individuals were required to work, prepare for work, or look for work as a condition of receiving public assistance. These work requirements are a big reason the 1996 reforms were successful. In the years that followed, the number of individuals receiving welfare dropped by 57 percent, poverty among all single mothers fell by 30 percent, and employment and earnings among single mothers increased significantly.

The welfare reform law specifically forbids any administration from changing the work requirements. This was confirmed by the nonpartisan Government Accountability Office, when it released a report on September 4, 2012, determining the administration cannot waive the welfare work requirement without Congressional approval. However, the administration has ignored this and attempted to circumvent Congress's authority. With nearly 23 million Americans struggling to find a full-time job in this weak economy,

we cannot allow the administration to roll back critical features of welfare reform and years of progress. This is why, as a member of the House Ways and Means Committee, I supported H. J. Res. 118 to block the administration from implementing its controversial waiver scheme, which passed the House this week. President Obama should work with Congress, instead of around it, on plans that will create jobs and lessen government dependency.

Stop the War on Coal; Create Jobs This week the House passed another bipartisan “jobs package” called H.R. 3409, Stop the War on Coal Act. The first part of the bill, the Coal Miner Employment and Domestic Energy Infrastructure Protection Act, will support U.S. energy production by prohibiting the Secretary of the Interior from issuing new regulations that could negatively impact mining jobs and our economy. This bill is a necessary measure to prevent the administration’s sweeping rewrite of coal mining regulation that will cost jobs and decrease American energy production.

The second part of the bill, the Energy Tax Prevention Act, will stop the Environmental Protection Agency from using the Clean Air Act to impose costly, greenhouse gas regulations that would drive up energy prices, send jobs overseas, and further hamper our economic growth. The Energy Tax Prevention Act will permanently prevent the EPA from levying a national energy tax under the Clean Air Act, all without weakening the Clean Air Act in any way.

The third part of the bill provides for more accurate accounting of the full cost of EPA rules. This bipartisan legislation requires analysis of the full economic impacts of certain environmental regulations so that Americans will be able to better understand how these policies affect U.S. manufacturing, global competitiveness, energy prices, and jobs.

Farm Bill Disappointment I am disappointed the House of Representatives was not able to bring H.R. 6083, the Federal Agriculture Reform and Risk Management Act, also known as the “Farm Bill”, to debate on the House floor prior to the November election. Many current farm bill policies expire[d] on September 30, 2012, and this bill is a critical part of the planning process for those who rely on sound agriculture policy during difficult economic times.

I have met with many farmers and ranchers in eastern Kansas who are asking Congress to provide certainty for producers as they head into the next planting season, and continued to voice my strong support for a five-year farm bill. I, along with many of my colleagues from both sides of the aisle, have asked House leadership to bring this bill up and let the House and Senate work out the differences to get the best possible legislation. This bill will now most likely be considered in November. In the meantime, I will continue to listen to concerns and suggestions on how to make this bill beneficial to farmers, ranchers, and consumers.

Frankly Speaking By Frank F. Clark

When the Civil War was coming on the horizon, God prepared the nation in advance. The first thing he did was to move some men in New York to pray for revival in the land. This became the Second Great Awakening, which stretched from the late 1790’s through the 1840’s. The nation experienced millions of conversions for Jesus and a tremendous growth in church attendance.

The major leaders included [Charles Finney](#), Lyman Beecher (Harriet Beecher Stowe’s father) and Peter Cartwright. The move of God was marked by an emphasis on personal piety. It was at a Cartwright revival meeting that Abraham Lincoln’s parents met.

After a series of debates in 1858 that gave Lincoln national visibility, he was invited to give a speech in New York City in 1859 denouncing slavery and its spread. It was a triumph making him an overnight political star. He was elected in 1860.

When [Lincoln was inaugurated on March 4, 1861](#), it had become obvious that the nation was on an inescapable path toward war. In fact, the Civil War began the next month with the [attack on Fort Sumter](#). It was the national return to Jesus that carried the soldiers and families on both sides through the war so that slavery, the major sin of the nation, could be purged.

Today, the nation is faced with another decision that is just as capable of destroying us forever. We have far exceeded the wickedness that existed in the 1790's with our pornography. The Truth about Regional Councils

The Area "Regional Planning Organization" is just another name for the new governance apparatus that is being pushed by the federal government and the Sustainable Development promoters. They are doing it at the national level such as with the President's Rural Council and the Governors Council (created by Executive Order 13528) and are marketed to "strengthen the partnership between federal and state governments."

These Regional Councils, Council of Governments and Regional Commissions are all setting up a top down centralized planning and governance system which will insulate the citizens from the government if not their elected representatives. To the extent elected representative will remain in place they will be ineffective

and their role will be meaningless, such as we are seeing with Congress.

In some cases public private partnerships (PPP) are involved and/or Non-Governmental Organizations (NGO). This is just another form of fascism, or as some call it now, corporatism. Under traditional fascism, the government controls business such as the Nazis did in Germany. But under Neo-fascism of today, it is often the business interest or NGO that controls the government.

Regional Councils and Soviets

These are the same thing as the USSR called “soviets” (councils) and are put in place to carry out the decisions and planning from on high. Some of the Regional Councils even do their planning on a five-year basis. This was, of course, the planning horizon for the USSR and Red China centralized planning.

The Constitution and Regional Councils

These regional councils are not a form of republican governance as guaranteed by Article IV §4 of the U.S. Constitution: ***“The United States shall guarantee to every State in this Union a Republican Form of Government...”*** This Article implicitly requires the states to maintain a republican form of government.

Oath to Support the Constitution and Regional Councils

An elected official or state employee cannot support the creation of these un-American, un-Constitutional soviets and remain true to their oath of office and to the Constitution, which is required by Article VI clause 3 of the U.S. Constitution: *“The Senators and Representatives before mentioned, and the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and of the several States, shall be bound by Oath or Affirmation, to support this Constitution.”*

Efficiency of Government

These councils are often promoted based on their efficiency. “Efficiency” basically means the extent to which the input is the most minimal to accomplish the output, it’s the relationship between the means and the end and often thought of as being related to time, with quicker being better.

An efficient government is one that can identify a problem or opportunity quickly and move quickly to ameliorate the problem or take advantage of the opportunity through policy implementation.

In a democratic constitutional republic, such as the United States, policy implementation will be at a very deliberate (slow) rate when the system is working correctly. Our system of government was designed not to be efficient. This is because our Founders realized that the most effective government for preserving the Liberty of the citizens and the principles of popular and state sovereignty was not an efficient government.

The Founders believed the best government to protect the Liberty of the citizens is a government that was accountable and responsive to the people. It is also a government tied down with checks and balances where the branches of government have oversight on each other and the state and federal governments have oversight on each other.

It is almost a socio-political axiom that there is an inherent tradeoff between Liberty and efficiency of government. The most efficient government for making socio –political change is a totalitarian government. The leadership decides what the problem is what is best to solve it, passes the required decree and off the policy goes.

Currently, what we are seeing in our governments is the increase of efficiency at the cost of Liberty and sovereignty of citizens and states. Worse yet we are seeing the federal government and a state governor that has a policy of implementing extra–state governmental organizations, i.e., regional commissions and councils, that are themselves structures to effectively make the federal government more “efficient.” These Regional Economic Planning organizations accomplish this efficiency by insulating the government from the people and removing the governments’ accountability to the people.

To “strengthen the partnership between the federal and state governments” is like having the dog you put out to keep an eye on the fox invite the fox into the hen house for their mutual benefit. It just does not work out well for the hens, and it will not work out well for our Liberty.

Federal Government can’t Mandate States Administrate or Participate in Federal Programs

There is a very long line of U.S. Supreme Court cases that hold that under the principles of federalism and dual sovereignty the federal government may not require (mandate) that a state administrate or participate

in a federal program. This would be a violation of the state's sovereignty.

In a more recent case, *Printz (& Sheriff Richard Mack) vs. United States*, the Supreme Court confirmed this principle even as to agents of the state such as sheriffs. This case involved the Brady handgun law that required sheriffs to do background checks on gun purchasers. In finding the law unconstitutional, the Court said:

"The question presented in these cases is whether certain interim provisions of the Brady Handgun Violence Prevention Act, Pub. L. 103-159, 107 Stat. 1536, commanding state and local law enforcement officers to conduct background checks on prospective handgun purchasers and to perform certain related tasks, violate the Constitution...."

It is incontestable that the Constitution established a system of "dual sovereignty." Although the States surrendered many of their powers to the new Federal Government, they retained "a residuary and inviolable sovereignty...."

We held in *New York* that Congress cannot compel the States to enact or enforce a federal regulatory program. Today we hold that Congress cannot circumvent that prohibition by conscripting the State's officers directly. The Federal Government may neither issue directives requiring the States to address particular problems, nor command the States' officers, or those of their political subdivisions, to administer or enforce a federal regulatory program. It matters not whether policymaking is involved, and no case-by-case weighing of the burdens or benefits is necessary; such commands are fundamentally incompatible with our constitutional system of dual sovereignty...."

Printz v. United States 521 U.S. 898 (1997) (Justice Scalia delivered the opinion of the Court.)

Just Going Along

Remember there were very few (two) sheriffs that filed suit against the federal government over this issue. The vast majority of them were going along with it in spite of the fact it violated the Constitution and their oath to the Constitution. Because the federal government wants to do it and passes a law to do it does not make it Constitutional. Because a vast majority of the states, the state legislators the sheriffs or the county commissioners are willing to go along with it does not make it Constitutional. And, just because everyone else is willing to go along with it does not relieve us patriots of our Constitutional duty.

Contracting Your Rights Away

I urge you to take extreme caution is supporting this unholy alliance. To the extent any of the counties or cities are required to do anything by the federal government it is because they have contracted away or have allowed someone else to contract away their rights.

Due Diligence to Duty

Before entering into such a "regional planning council" can even be considered, the following documents should be reviewed carefully and in detail.

Cooperative Agreement (HUD 1044 or similar agreement)

Notice of Funding Availability (NOFA)

Management and Work Plan

Uniform Administrative Requirements

Grantee's proposal

I would ask your county commissioners:

1. Have they identified and reviewed all the relevant agreements and documents including the above in detail?
2. Have they obtained a legal opinion as to what such requires of the county specifically and with particularity (and regarding 4 and 5 below)?
3. Have they made the documents (no.1 above) available to the public?
4. Have they identified the government agencies, state and federal, that will be involved in the organization and the process?
5. What will be the areas of involvement and the level of control by the government agencies, state and federal?
6. What specific provision is in any of the agreements / documents to protect the Liberty of citizens and their property rights? Do any of the documents even mention such?

If they have not done the above they have not done their due diligence. They do not have a right to rely upon the representations of those who are promoting this council. Most promoters of such councils have a personal interest in it through salary, etc., or are ideologically tied to Sustainable Development. Other questions to ask:

1. *Is anyone promoting such who is being paid, in whole or in part, by a government grant?*
2. *If so, how much and what grant?*
3. *Are they required/paid to promote such councils by the terms of the grant?*

Conclusion

It has been said that “fools rush in where angels fear to tread.” I will tell you fools rush in where patriots fear to tread. I would not support this for all the tea in China.
