### **A Sign of Our Unusual Times: [GOP Senators] Vratil, Owens Back Democrats**

In an unusual move in Johnson County politics, two longtime Republican political leaders, who served in the most recent session of the state Senate, are endorsing Democrats in the November general election to the state Senate.

John Vratil, a Republican from Leawood, and Tim Owens, a Republican from Overland Park, are lending their names to campaign literature as bona fide endorsers of Democratic candidates.

Vratil, who decided to retire from the Senate before the August primary, is endorsing Democrat Mike Delaney over Republican Jeff Melcher in the 11th district.

Melcher won the August primary against state Rep. Pat Colloton.

(Colloton is not endorsing Melcher — although she said Delaney is a “very, very quality candidate” — but she said she wants to remain active in the Republican Party.)

Owens, in his first term as senator, is formally endorsing two Democratic candidates for the state Senate. One is Lisa Johnston, who will face off against Jim Denning in the 8th District. Denning defeated Owens in the primary election. Owens also is endorsing Democrat Juanita Roy of the 21st District, who is running against state Rep. Greg Smith.

Vratil was first elected to the state Senate in 1998 and served as the Senate vice president since 2003. He was virtually pushed into retirement by the conservative wing of the Republican Party. He was too moderate in the eyes of Gov. Sam Brownback, who let it be known Vratil would be targeted. Vratil either decided it was too stressful to serve or was concerned that he might be defeated.

Owens also was targeted in a statewide conservative-led purge of Republican moderates in the Senate.

Both claim this is not sour grapes, but that they find more in common with the Democratic candidates than they do the ultra-conservative Republicans on the ballot.

Speaking of Delaney, Vratil said, “His views are closer to mine, and they are closer to the 11th Senate District.”

Owens will not put up a yard sign for Johnston, but will put up one that says “Vote Moderate,” he said. Johnston’s views are closer to Owens’ views than her Republican opponent’s.

Owens said he has been a Republican all his adult life, going back to college days. But he does not agree with much of the agenda of the ultra-conservatives.

“I agree with those who support education, are moderate on social issues, are opposed to changing the way we select judges in Kansas, and who do not agree with a budget that I think will be devastating,” Owen said.

One can hear the howls of “RINO” (Republican in Name Only) from conservative Republicans.

Vratil rebuts that. “I am a traditional Republican,” Vratil said. “They (the ultra-conservatives) are the RINOS, because they are no longer traditional.”

Admitting that Republican leaders endorsing Democrats for the legislature is quite unusual, Vratil responded, “These are very unusual times.” *In addition to these “Republicans that are now supporting Democrats. Roger Rietz, of the Riley County area, is also supporting the running Democrat, Tom Hawk. If these “Republicans” wanted to support the Democrat agenda why didn’t they run as Democrats? And, just for the record, “Traditional Republicans” have always been for SMALLER government. That is NOT new.)*

## BRYANT: The truth about Obamacare in Mississippi By Gov. Phil Bryant

*Taxpayers need jobs, not costly handout -- Monday, October 1, 2012*

When the Supreme Court ruled on the Obama administration's health care reform law a few months ago, the court upheld the right of the states to decline Medicaid expansion.

States throughout the nation are now looking at the enormous and growing percentage of their budgets already consumed by Medicaid expenses, and many simply cannot fathom shouldering the additional burden of even more Medicaid spending. Mississippi is certainly among those states opposed to expanding the program.

Beyond differences in philosophies on the role of government, beyond Obamacare's superficial approach to righting the issues in America's health care system and beyond this law's inability to put Americans to work in jobs with decent wages and health care benefits, one fact is certain: Government programs come with a price.

People tend to forget that government has no dollar that it has not gained through taxation or borrowing. Even the Obama administration cannot pay for its massive health care law without raiding funding from other programs and levying taxes against the American people. After all, the bills for these expansions will come due, and the money has to come from somewhere.

Mississippi, too, must decide where it would get the money to pay for more and more Medicaid. Do we drain money from public safety and education? Do we tax money out of private revenues and family checking accounts? As governor, I say we reject the expansion and find a better solution.

During fiscal 2012, the Mississippi Division of Medicaid -- just one of several state agencies responsible for paying Medicaid costs -- required \$3.62 billion in federal funds and \$763 million in state funds to directly administer the Medicaid program, with a conservative total operating cost of more than \$4.38 billion as of the Supreme Court ruling. This is without assuming the bill for Medicaid expansion that the Obama administration is attempting to lull taxpayers into accepting.

In fiscal 2012, Mississippi spent more than seven times as much money on the existing Medicaid program as we did on economic development and most of our state public safety efforts combined.

Furthermore, Medicaid spending is requiring an ever-increasing portion of resources while spending gaps in education continue to grow.

As governor, I cannot imagine directing money away from our children's education, our ability to keep our citizens safe and our ability to provide for ourselves through job creation in favor of funneling more money into a program that addresses none of these other critical needs.

Building a budget from the dollars entrusted to Mississippi by its taxpayers requires choices, and a Medicaid expansion clearly does not present good options for our state.

According to a Milliman report requested by the Mississippi Division of Medicaid, an estimated 400,000 people could be added to the Mississippi Medicaid rolls if we accepted the Obamacare expansion. Such an expansion could result in 1 in 3 Mississippians being on Medicaid and would balloon the state's associated cost burden.

Our budget then would show additional costs of more than \$1.6 billion over seven years, including an estimated \$427 million in 2020 alone. This is all on top of what we already spend on the current Medicaid program in our state.

I would personally rather see those 1 in 3 earn health care coverage through good-paying jobs in Mississippi's energy sector or our cutting-edge, advanced manufacturing operations.

Nonetheless, such cost increases would obliterate Mississippi's budget and force us into the position of choosing which other services to kill or maim in favor of funding Medicaid.

Tack on the additional \$81 million that the state would have to pay in the first three years of the expansion just to cover the increased administrative costs, and the situation becomes even more grim.

There is no doubt that quality health care is of utmost importance, but signing on for an enormous, expensive Medicaid expansion will not serve Mississippi well.

How much better off are we really if 1 in 3 can charge health care expenses to Medicaid but we cannot afford to fund our schools or make the infrastructure improvements that attract businesses and jobs?

Mississippi deserves more, and there are real solutions to improving health care without sacrificing our other core needs.

To start, each of us must assume personal responsibility for our own health and our own choices. Living a healthy lifestyle that includes regular exercise and a proper diet can help shrink Mississippi's obesity rate and the chronic diseases such as diabetes that accompany it. Hazardous activities such as smoking erode our health, and as governor, I am leading the fight to end the multi-consequential epidemic of teen pregnancy in Mississippi.

At the core is job creation. We must continue working, as we did during the 2012 legislative session, to create an

environment where businesses flourish so Mississippians can secure sound employment and fund their own health insurance.

Mississippi can and will do better. As governor, I will fight to protect our future -- our education, our safety and our jobs -- and that means that I will resist any effort to expand Medicaid in this state.

After all, all the filmmaker did was make a bad movie despotic governments we helped empower could use to incite rioting and direct the anger away from their own incompetence and toward the greatest force for freedom the world has ever known. Through state controlled media, they played this unknown video endlessly and spread it throughout the region. **Jobs and Politics; Protecting Health Care Choices; President's Tax Hike**

**Washington Keeps Playing Politics at the Expense of Jobs**

On Friday, the Bureau of Labor and Statistics reported the unemployment rate fell to 7.8 percent in September. This disappointing jobs report is an indication that the United States is still facing an anemic job market. The economy has only recovered about 4.1 million of the 8.8 million jobs lost prior to June 2009, and the unemployment rate topped 8 percent from February 2009 to August 2012, which was the longest period of time since 1948.

This week also marks 3 months until the sequester causes massive defense cuts, threatening mass layoffs by defense and other federal contractors. This is yet another example of the administration putting politics ahead of the American people. In compliance with the WARN act, federal law requires contractors to issue

layoff notices 60 days prior to the termination of a federal contract. But, in order to avoid bad news before the polls close, the White House had the Dept. of Labor ask these contractors to delay sending out pink slips.

Even worse, instead of working with Congress to solve the problem, the administration is busy covering their tracks. Following the initial guidance from the DOL, recommending these contractors circumvent the law and withhold information from their employees, the White House had the [Office of Management and Budget issue another memo](#) suggest that any legal fees filed against contractors who lay-off employees without proper notice, would be paid for by the contracting agency with taxpayer dollars.

This is a huge risk being imposed upon these employees. Hopefully, the Senate will act to avoid sequestration, but if we don't, the employees will be the ones left empty-handed with no time to find a new job in an already weak labor market.

I have voted to replace the sequester with spending reforms in the House of Representatives. This uncertainty could have been avoided if the administration had acted responsibly, and presented their own detailed plan for dealing with the sequester. Instead, the White House is preoccupied with playing politics.

### **Protecting Our Health Care Choices**

Next week I plan to send a letter, signed by myself and 44 of my colleagues in the House of Representatives, to President Obama asking him to direct the U.S. Department of Health and Human Services (HHS) and Secretary Sebelius to reconsider two parts of Obamacare that could jeopardize the future of Health Savings Accounts (HSAs). Recent HHS actions discriminate against HSA-qualified health plans, and will prevent them from being offered inside or outside insurance exchanges in the individual, small group and large group markets. Over time, these actions will eliminate HSA-qualified health plan availability in each of these markets.

Today, nearly 14 million Americans utilize Health Savings Accounts to help address the rising costs of health care, because Obamacare did not fix this problem. These accounts allow folks to set aside their own dollars on a pre-tax basis to pay for health care expenses, and we should protect their choice to continue to purchase health plans that will include HSAs.

For example, one HHS rule, the Medical Loss Ratio (MLR), requires that insurers spend 80 percent of premium money on medical claims. The MLR regulation discriminates against HSAs by only counting the dollars the insurer spends after the insured reaches their deductible. Since only 6 percent of all policy holders that have an HSA-qualified health plan reach their deductible, only 6 percent of the policy holders have expenditures to count towards the MLR regulation. In short, the insurance company will not allow HSA-qualified health plans to meet the MLR rule, and therefore, will not be compliant. The penalties associated with this rule will discourage insurers from offering HSA-qualified health plans.

We should not allow the federal government to make choices of this magnitude regarding individuals' health care. President Obama has voiced his support for HSA-qualified plans, and this letter urges him to consider overturning these harmful regulations. Consumers must be put back in charge of their health care decisions.

### **President Obama's \$4,000 Middle-Class Tax Hike**

The president repeatedly claims he wants to protect middle-class families, but new research shows President Obama's spending policies will eventually be paid for on the backs of middle-class Americans. According to an [American Enterprise Institute study](#) published this week, not only does the president not have a plan to address our fiscal crisis, his big government spending policies are making the problem much worse.

Researchers at the [American Enterprise Institute](#) found that in order to keep up with only the interest on the debt accumulated by President Obama, middle class families would have to pay \$4,000 in higher taxes each year for the next 10 years. That is an extra \$40,000 in taxes, in addition to the \$50,000 that every man, woman, and child already owes to pay for our current debt. This is why, not one Democrat or Republican supported the president's budget.

Raising taxes on the wealthy is not a solution either. According to the latest IRS data, only 13 percent of taxpayers earn more than \$100,000. And, even if we took every cent of income from every millionaire and billionaire, the total would only amount to 4 percent of our \$16 trillion debt.

Rather than empty rhetoric and false promises about protecting the middle-class, I voted for a real solution that creates fairness and cuts spending. Comprehensive, pro-growth tax reform would raise incomes for everyone, save us billions of dollars, and create one million jobs. It would level the playing field for folks and it should be one of Congress's top priorities.

## **From *The Patriot Post*, Voice of Essential Liberty -- Sept. 28, 2012**

After two weeks of steady denials that recent strikes on the U.S. consulate in Benghazi, Libya, and the U.S. embassy in Cairo, Egypt, were terrorist attacks -- along with blaming a YouTube clip for violence and unrest in all of the Muslim world -- this week opened with another smooth move from Team Hope-n-Change.

Kicking off his latest oratorical mini-seminar this week at the UN General Assembly, Barack Obama belted out a 30-minute paean to free speech and tolerance. He also grudgingly reserved only two paragraphs near the end of his screed to address what should have been his main point, the threat posed by Iran's nuclear ambitions. Although two weeks late-to-need, the speech was nonetheless underwhelming when it finally arrived.

While the majority of his remarks were supposed to be devoted to advocacy for free speech and mutual respect between differing religions and worldviews, Obama undermined his own case by once again rejecting the individual free speech rights of the producer of the 14-minute YouTube clip, "The Innocence of Muslims." He declared that the "crude and disgusting" video had "sparked outrage" among Muslims for its disparaging remarks about Mohammed. (As a side note, the man responsible for the video, Nakoula Basseley Nakoula, was arrested Thursday because unsupervised Internet activity allegedly violates his parole from a previous conviction.)

At once alienating the U.S. government from this particular individual's right to free speech, Obama apparently saw no irony in affirming a commitment to that constitutional right for Americans. He must have been thinking in terms of "collective rights" -- the only kind statisticians allow -- so this oversight is somewhat understandable. It's also interesting to note that just the day before this denunciation, Obama told the leftist gaggle on *The View* "the best way to marginalize that kind of speech is to ignore it." Obviously, he thinks the best way to "ignore" such a video is to denounce it in six different languages at the UN General Assembly.

Of course, immediately after stating that the U.S. Constitution protects free speech, he went on to make this pathetic addition: "I know that not all countries in this body share this particular understanding of the protection of free speech. We recognize that." If the video is indeed one of the causes of violence in the Muslim world, it becomes self-evident that those affected countries are not exactly huge fans of free speech and tolerance. Pakistan tops our list as "most tolerant," after Pakistan's railway minister offered \$100,000 to anyone who kills the maker of the video.

To be sure, Obama did attempt to make a case against extremism, reminding his audience, "Let us remember that Muslims have suffered the most at the hands of extremism." While technically correct, it's another Obama half-truth as most Muslim suffering is self-inflicted. None of these attacks and protests were the work of non-Muslims. (In related news, the New York display of the taxpayer funded "art" piece "Piss Christ," in which a crucifix is submerged in the artist's urine, did not cause rioting or murderous violence from Christians.)

Throwing gas on the fire, Obama let loose a string of "the future must not belong to" so-and-so remarks, including, "The future must not belong to those who slander the prophet of Islam." He followed up this statement with a quote from Gandhi and a pleasant bromide about condemning intolerance, generally. Which statement is more likely to be repeated by Muslim extremists?

Again, perhaps the president should have focused on the imminent danger posed to the world by Iran. The ongoing Iranian nuclear crisis warranted short shrift in Obama's speech -- clearly, the matter is not a priority for him. Maybe it should be, though: In his usual, even-keeled delivery, Iranian President Mahmoud Ahmadinejad this week again called for the "elimination" of Israel. We suppose this sounds slightly better than the phrase he used in 2005 -- that Israel should be "wiped off the map" -- but it still reflects deadly intent and nukes would be a tool to that end.

Nor would Obama meet with Israeli Prime Minister Benjamin Netanyahu, who warned that Iran will

effectively have a nuclear weapon by next summer, and helpfully drew a [literal red line](#) so the illiterates at the UN understand. The president was too busy chatting with the harpies on *The View* to be bothered with what he told "60 Minutes" was "noise." Obama's priorities are so out of whack, even NBC News Obamaphile Andrea Mitchell scolded, "This was not the moment to sit down with *The View*."

No, it was actually the moment to sit down with other world leaders, one-on-one, in serious discussions about grave matters, as many foreign heads of state -- including Israel's Netanyahu -- had asked him to do. However, that task fell to Secretary of State Hillary Clinton. No doubt foreign leaders were unimpressed by the president's acting like they didn't exist.

Something else didn't exist, either: respect from the president for those who were murdered in Libya. In that same "60 Minutes" interview, the tone-deaf Leader of the Free World referred to the violence in Egypt, Libya and elsewhere, including the context of four murdered Americans, as "bumps in the road." As columnist Charles Krauthammer notes, "If Romney had said that the death of our ambassador, the attack on our embassy, the death of three other Americans, the hoisting of the black al Qaeda flag over four U.S. embassies, and demonstrations all over the Middle East all the way to Indonesia including a burning in effigy of Obama in Sri Lanka of all places is a bump in the road, it would be a three day headline." Indeed. The president's statement is disgraceful.

We close where we started: remember those denials of terrorist attacks on American sovereignties abroad? Well, not so fast. Now Secretary Clinton has conceded "preliminary findings" that, yes, well, indeed these attacks might have been terrorist strikes after all. But don't judge the administration too harshly for having zero situational awareness on the entire set of events. After all, who could have known that rocket-propelled grenades (RPGs) used in coordinated attacks against American assets on the anniversary of 9/11 *might* suggest a link to terrorism?
