### ObamaCare - Part 2

Before I finish the section on how large businesses can avoid the taxes/penalties, I thought I would try to answer some questions that have been posed.

For those who are working for larger employers mentioned the question I am hearing a lot: “Why are so many employees being forced to go to “part-time” status.”

Within the law, the authors chose to lower what most consider full time to an average of ONLY 30 hours per week. Most of us have always believed that full time was a 40-hour week.

The move to a 30 hour per week label as full-time was chosen to force more employers to provide additional benefits – notably group health insurance – to anyone only working 30 hours per week. The expected affect was more people would be covered by the employer's group health plan.

#### **The administration is truly stupid!!!**

The owners, CEO'S and HR directors for the most part have decided that two can play this game. So now we are seeing a massive number of larger employers take those people to 29 or fewer hours per week. At that level, these people remain in the category of those not eligible for the group health insurance paid for, at least in part, by the employer.

So who has been hurt by the designers of ObamaCare? The lower to middle class employee who are now working fewer hours are the ones who are hurt. That extra 10 hours per week in lost work also resulted in less take home pay. Many now find themselves needing to find and work second jobs BUT STILL NOT getting the benefit of any employer helping to pay the cost of their health insurance.

Many are also seeing paid vacations and other employer paid perks disappear. This is again a result of the health care law.

The advertisement said, when it was being sold to the American people, the cost of health insurance would drop by at least \$2,500 per year for a family. Instead the cost has risen by more than \$4,500 per family and the law does not fully kick in until 2014. The projections by the IRS are that the costs will be from 50% to 400% **higher** than they were Last YEAR!

Profit margins in business don't go up that fast! So employers are forced to cut benefits, even to the full time employees, let alone part timers.

Given a choice of paying benefits or going out of business, there really isn't a choice.

ObamaCare is NOT good for the people of the United States. The law isn't even fully implemented and we clearly see it hurting the working American.

So who will it benefit – those with their hands out?

Actually that may not happen either, as I will point out in the next article.

## **MinutemenNews.com: Sheriff Arrested in Florida Defending the 2nd Amendment 6/5/13**

A number of Sheriffs around the country have pledged to abide by the Second Amendment and not enforce laws that they believe violate the Constitution.

Sixty-seven sheriffs in Florida signed one of those pledges declaring that they would uphold the Second Amendment and protect people's' right to keep and bear arms.

One of those signatories, Sheriff Nicholas Finch, was arrested by Governor Rick Scott in Florida for actions he took in a case in early March in which Finch made his stand for the Second Amendment.

Carl Causey has been appointed to replace him by Governor Scott until July when the case will be heard. The charge stems from an incident involving his Deputy Sheriff, James Hoagland.

On March 8, Sgt. James Hoagland arrested a man named Floyd Parrish who was carrying a concealing semi-automatic, fully loaded. As Parrish was being booked, one jail worker said Finch came in with a Parrish family member and spoke with Parrish. Finch then took possession of Parrish's arrest file and released Parrish and his gun. Several days later, Hoagland asked Finch about it and Finch said he believed in "Second Amendment rights." Court records showed that Parrish's name was whited-out from the county jail log. Hoagland did have a copy of the arrest record but the original record is missing.

Mr. Finch was arrested on a Third-Degree Felony charge of official misconduct for destroying or removing official documents from the county jail to cover up the arrest of Mr. Parrish. Finch was released on his own recognizance.

Finch's lawyer, Jimmy Judkins, released this statement:

"The records at the jail show exactly what happened in this case and the records speak the truth. The sheriff looked at the facts and said 'I believe in the second amendment and we're not going to charge him.' That is not misconduct at all. That is within the Sheriff's prerogative whether to charge someone or not."

Sheriff Finch was making a statement about the Second Amendment.

Many believe that Sheriff Finch's actions are within his authority. He certainly has the right to not charge Parrish. Since Finch did not charge Parrish, the records are then without value and Finch was within his rights to destroy those records.

**Kris Anne Hall** is a Constitutional lawyer. She believes that what Sheriff Finch did was within his right to do:

What do you believe? This is strictly a Second Amendment issue. It is not about cover-ups or the man who carried the concealed weapon. The sheriff believes the law he was told to enforce is unconstitutional.

AG Holder hasn't enforced immigration law or DOMA, among other laws, because he doesn't agree with those laws. Until Holder is arrested and convicted of failure to uphold the law, should we expect this sheriff to be convicted for not upholding a law he believes is unconstitutional?

It is for you to decide.

## 72 Year Old Granny Fends Off Home Intruder with .357 Magnum

One of my favorite topics to write on is when an American citizen fends off a potentially dangerous and life-threatening situation with their legally owned gun.

In the latest case I read about, 72 year old [Jan Cooper](#) of Anaheim, California was able to protect her wheelchair bound 85 year old husband from a home invasion. It was around 12:30am Sunday morning when she heard the prowler outside the house. The elderly couple's Rottweiler was furiously barking, but the suspect wasn't thwarted by the sound of the large dog.

Jan dialed 911 after grabbing her .357 Magnum Smith & Wesson revolver. She begged the dispatcher to send the police right away because someone was at her back sliding door trying to break in. She also informed the dispatcher that she had a gun.

While still on the phone with the 911 dispatcher, Jan said that she could see the man's silhouette through the blinds on the back door. Then she told the dispatcher that he was starting to slide the back door open. She told the dispatcher that she was firing, followed by the loud sound of a gunshot.

Jan was so angry at the man for trying to break into her house, she began cursing at him and telling him to back up and leave. The intruder began apologizing and begging her not to shoot again and that he was leaving. She informed the dispatcher that she wasn't sure if she hit the guy or not, but that he was still in her yard. Police were close enough to hear the gunshot and quickly apprehended 31 year old Brandon Alexander Perez. He was not hit by the bullet, but a police investigator said that it had to have come within a couple inches of his cheek. Jan had fired her gun through the opening in the door, narrowly missing Perez's head.

It turns out that Perez, who pleaded innocent to the attempted burglary charges, has a lengthy rap sheet that includes burglary and narcotics charges. He was also out on parole from earlier charges, which is one reason I am so against parole. I've seen and heard of too many crimes, even violent crimes being committed by criminals that are out on parole or probation. If they are sentenced to 5 years, then let them serve 5 years, not 16 months.

After things had calmed down, Jan Cooper was apologetic for getting so angry and swearing the way she did. She told reporters:

"I am a Christian woman and I'm very proud of it and I don't curse, but after I shot, rage took hold and I just blasted away, and, in fact, afterwards my husband said, 'I've never heard you talk like that!'"

When asked about the shooting, Jan replied: "I don't mean to shoot anybody, but whatever's necessary to literally stop them - he was not going to come into my home."

Fortunately, Jan's handgun was properly registered and she had been shooting at a pistol range with her husband for over 20 years. Even though she missed the intruder, she managed to shoot through the narrow opening of the sliding glass door without breaking the glass.

She is another shining example of why the Second Amendment is so crucial to the American people. Had Obama, Biden and the rest of liberal Democrats had their way, Jan Cooper wouldn't have had that handgun and would have had no way of defending her and her husband from the would be intruder. There is no telling what Perez may have done to the couple had he managed to get inside and confront them. Obviously her warnings and the barking Rottweiler didn't frighten him which makes me tend to believe that he was probably high on drugs and may have done anything to get what he wanted. Fortunately and thanks to Smith & Wesson, the Coopers didn't have to find out what could have happened. They are safe and sound.

This practice, which has been prohibited in the Judeo-Christian tradition since the days of Moses, was sanctioned by Muhammad and has been going on now for 50 generations (1,400 years) in the Muslim world.

This practice of inbreeding will never go away in the Muslim world, since Muhammad is the ultimate example and authority on all matters, including marriage.

The massive inbreeding in Muslim culture may well have done virtually irreversible damage to the Muslim gene pool, including extensive damage to its intelligence, sanity, and health.

According to Sennels, close to half of all Muslims in the world are inbred. In Pakistan, the numbers approach 70%. Even in England, more than half of Pakistani immigrants are married to their first cousins, and in Denmark the number of inbred Pakistani immigrants is around 40%.

The numbers are equally devastating in other important Muslim countries: 67% in Saudi Arabia, 64% in Jordan, and Kuwait, 63% in Sudan, 60% in Iraq, and 54% in the United Arab Emirates and Qatar.

According to the BBC, this Pakistani, Muslim-inspired inbreeding is thought to explain the probability that a British Pakistani family is more than 13 times as likely to have children with recessive genetic disorders. While Pakistanis are responsible for three percent of the births in the UK, they account for 33% of children with genetic birth defects.

The risks of what are called autosomal recessive disorders such as cystic fibrosis and spinal muscular atrophy is 18 times higher and the risk of death due to malformations is 10 times higher.

Other negative consequences of inbreeding include a 100 percent increase in the risk of still births and a 50% increase in the possibility that a child will die during labor.

Lowered intellectual capacity is another devastating consequence of Muslim marriage patterns. According to Sennels, research shows that children of consanguineous marriages lose 10-16 points off their IQ and that social abilities develop much slower in inbred babies. The risk of having an IQ lower than 70, the official demarcation for being classified as "retarded," increases by an astonishing 400 percent among children of cousin marriages. (Similar effects were seen in the Pharaonic dynasties in ancient Egypt and in the British royal family, where inbreeding was the norm for a significant period of time.) In Denmark, non-Western immigrants are more than 300 percent more likely to fail the intelligence test required for entrance into the Danish army. Sennels says that "the ability to enjoy and produce knowledge and abstract thinking is simply lower in the Islamic world." He points out that the Arab world translates just 330 books every year, about 20% of what Greece alone does.

In the last 1,200 years of Islam, just 100,000 books have been translated into Arabic, about what Spain does in a single year. Seven out of 10 Turks have never even read a book.

Sennels points out the difficulties this creates for Muslims seeking to succeed in the West. "A lower IQ, together with a religion that denounces critical thinking, surely makes it harder for many Muslims to have success in our high-tech knowledge societies."

Only nine Muslims have ever won the Nobel Prize, and five of those were for the "Peace Prize." According to Nature magazine, Muslim countries produce just 10 percent of the world average when it comes to scientific research measured by articles per million inhabitants.

In Denmark, Sennels' native country, Muslim children are grossly over represented among children with special needs. One-third of the budget for Danish schools is consumed by special education, and anywhere from 51% to 70% of retarded children with physical handicaps in Copenhagen have an immigrant background. Learning ability is severely affected as well. Studies indicated that 64% of school children with Arabic parents are still illiterate after 10 years in the Danish school system. The immigrant drop-out rate in Danish high schools is twice that of the native-born.

Mental illness is also a product. The closer the blood relative, the higher the risk of schizophrenic illness. The increased risk of insanity may explain why more than 40% of patients in Denmark's biggest ward for clinically insane criminals have an immigrant background.

The U.S. is not immune. According to Sennels, "One study based on 300,000 Americans shows that the majority of Muslims in the USA have a lower income, are less educated, and have worse jobs than the population as a whole." Sennels concludes: There is no doubt that the wide spread tradition of first cousin marriages among Muslims has harmed the gene pool among Muslims. Because Muslims' religious beliefs prohibit marrying non-Muslims and thus prevents them from adding fresh genetic material to their population, the genetic damage done to their gene pool since their prophet allowed first cousin marriages 1,400 years ago are most likely massive. This has produced overwhelming direct and indirect human and societal consequences.

Bottom line: Islam is not simply a benign and morally equivalent alternative to the Judeo-Christian tradition.

As Sennels points out, the first and biggest victims of Islam are Muslims. Simple Judeo-Christian compassion for Muslims and a common-sense desire to protect Western civilization from the ravages of Islam dictate a vigorous opposition to the spread of this dark and dangerous religion. These stark realities must be taken into account when we establish public policies dealing with immigration from Muslim countries and the building of mosques in the U.S.

Let's hope the civilized West and the North Americans wake up before a blind naiveté about the reality of Islam destroys what remains of our Judeo-Christian culture and our domestic tranquility. **Stopping this progressive destruction of the United States of America will NOT happen with citizens sitting on their hands, letting it all happen!! GOD did NOT give us hands, feet, and a BRAIN for us Not to use them. Get OFF YOUR DUFF and put forth some effort to take our Country back from this CORRUPT administration!! WHY SHOULD GOD do it for us? If our freedom and country is NOT worth fighting for do we deserve to have freedom??**

### **YOU WORRY ME!**

I've been trying to say this since 9/11, but you worry me. I wish you didn't. I wish when I walked down the streets of this country that I love, that your color and culture still blended with the beautiful human landscape we enjoy in this country. But you don't blend in anymore. I notice you, and it worries me. I notice you because I can't help it anymore.
