#### OBAMA SECRETLY SIGNING AWAY U.S. SOVEREIGNTY

#### Shock plan regulates food, medicine, financial markets, Internet freedom

Despite the government shutdown, the Obama administration has continued secret negotiations to complete what is known as the Trans-Pacific Partnership, or TPP.

The expansive plan is a proposed free-trade agreement between the U.S., Australia, Brunei, Chile, Canada, Japan, Malaysia, Mexico, New Zealand, Peru, Singapore and Vietnam.

The agreement would create new guidelines for everything from food safety to fracking, financial markets, medical prices, copyright rules and Internet freedom.

The TPP negotiations have been criticized by politicians and advocacy groups alike for their secrecy. The few aspects of the partnership leaked to the public indicate an expansive agenda with highly limited congressional oversight.

A New York Times opinion piece previously called the deal the “most significant international commercial agreement since the creation of the World Trade Organization in 1995.”

Last week, [the White House website released a joint statement](#) with the other proposed TPP signatories, affirming “our countries are on track to complete the Trans-Pacific Partnership negotiations.”

“Ministers and negotiators have made significant progress in recent months on all the legal texts and annexes on access to our respective goods, services, investment, financial services, government procurement, and temporary entry markets,” the White House said.

The statement did not divulge details of the partnership other than to suggest a final TPP agreement “must reflect our common vision to establish a comprehensive, next-generation model for addressing both new and traditional trade and investment issues, supporting the creation and retention of jobs and promoting economic development in our countries.”

#### Secrecy

In February, the Open The Government organization sent a letter to Obama blasting the lack of transparency surrounding the TPP talks, stating the negotiations have been “conducted in unprecedented secrecy.”

“Despite the fact the deal may significantly affect the way we live our lives by limiting our public protections, there has been no public access to even the most fundamental draft agreement texts and other documents,” read the letter.

The missive was signed by advocacy groups such as OpenTheGovernment.org, Project On Government Oversight, ARTICLE 19 and the Global Campaign for Freedom of Expression and Information.

The groups warned issues being secretly negotiated include “patent and copyright, land use, food and product standards, natural resources, professional licensing, government procurement, financial practices, healthcare, energy, telecommunications, and other service sector regulations.”

## Lack of oversight

Normally free -trade agreements must be authorized by a majority of the House and Senate, usually in lengthy proceedings.

However, the White House is seeking what is known as “trade promotion authority” which would fast track approval of the TPP by requiring Congress to vote on the likely lengthy trade agreement within 90 days and without any amendments.

The authority also allows Obama to sign the agreement before Congress even has a chance to vote on it, with lawmakers getting only a quick post-facto vote.

A number of lawmakers have been speaking out about the secret TPP talks.

Sen. Ron Wyden, D-Ore., recently proposed legislation requiring the White House to disclose all TPP documents to members of Congress.

“The majority of Congress is being kept in the dark as to the substance of the TPP negotiations, while representatives of U.S. corporations – like Halliburton, Chevron, PHRMA, Comcast, and the Motion Picture Association of America – are being consulted and made privy to details of the agreement,” said Wyden.

However, Obama has so far refused to give Congress a copy of the draft agreement.

Regulates food, Internet, medicine, commerce

The TPP is “more than just a trade deal,” wrote [Lori Wallach and Ben Beachy of Public Citizen’s Global Trade Watch in a New York Times op-ed last June](#).

“Only 5 of its 29 chapters cover traditional trade matters, like tariffs or quotas. The others impose parameters on nontrade policies. Existing and future American laws must be altered to conform with these terms, or trade sanctions can be imposed against American exports.”

Wallach and Beachy spotlighted several leaks in the proposed TPP text, including one that would regulate the price of medicine.

“Pharmaceutical companies, which are among those enjoying access to negotiators as ‘advisers,’ have long lobbied against government efforts to keep the cost of medicines down. Under the agreement, these companies could challenge such measures by claiming that they undermined their new rights granted by the deal.”

[Amnesty International USA warned](#) draft TPP provisions related to patents for pharmaceuticals “risk stifling the development and production of generic medicines, by strengthening and deepening monopoly protections.”

Another leak revealed the TPP would grant more incentives to relocate domestic manufacturing offshore, Wallach and Beachy related.

Jim Hightower, a progressive activist, wrote the TPP incorporates elements similar to the Stop Online Piracy Act.

[Hightower wrote](#) the deal would “transform Internet service providers into a private, Big Brother police force, empowered to monitor our ‘user activity,’ arbitrarily take down our content and cut off our access to the Internet.”

Indeed, Internet freedom advocacy groups have been protesting the TPP, taking specific issue with leaked proposals that would enact strict intellectual property restraints that would effectively change U.S. copyright law.

[The Electronic Frontier Foundation argued](#) the TPP would “restrict the ability of Congress to engage in domestic law reform to meet the evolving IP needs of American citizens and the innovative technology sector.”

In a petition signed by over 30 Internet freedom organizations, the group warned the TPP would “rewrite global rules on intellectual property enforcement.”

What difference will that make? Navigators are NOT trained to understand your needs and concerns about health insurance. They are prohibited by law from advising you as to what plan would be best for you. They can ONLY talk about plans offered within the exchanges. AND you have no way of knowing if they will protect your information! To date, few states are requiring back ground check on these people who will have access to your most protected personal information.

License Insurance agents are extremely knowledgeable. They are required to pass strict supervised licensing exams. They must continue to earn continuing education hours to maintain their licenses. The insurance departments check background thoroughly. They know most of the available plans you may need to know about. They can make recommendations on the plans best suited for you, outside of the exchanges. And they are REGULATED by the state department of insurance.

**Navigators are NOT regulated by insurance departments**, in most states.

2. There will be more individual and group plan choices **outside** of the exchanges. Yes, for companies that sell inside and outside of the exchanges, the plan designs and pricing of those plans sold inside the exchanges must be the same outside. However, they may also offer plans **outside** the exchanges that they do not offer inside the exchanges.

3. Many companies have chosen **not** to sell plans inside the exchange. **They will only sell plans outside the exchanges!** Companies like Cigna, United Health, Assurant, Time, Aetna and many more will have plan offerings for individuals to review. The Navigators will NOT tell callers about them.

Should you even wait to purchase a plan? **Now is the time to be purchasing your individual health insurance, especially if you are able to purchase it outside of the exchanges!**

These plans effective prior to the end of the year will allow you to keep that coverage through the next anniversary. Some even offer coverage to continue through 12/31/2014. They are price lower than plans that will be sold in 2014. They offer you more choices than will be available in 2014. They will also prevent you from being required to pay any penalty because they will meet the requirement of having a plan that meets the essential coverage definition even though they will not contain all the essential benefits.

Last week police were called to investigate an attempted armed robbery: The 71-year-old retired Marine who opened fire on two robbers at a Plantation, Florida, Subway shop late Wednesday, killing one and critically wounding the other, is described as John Lovell, a former helicopter pilot for two presidents. After robbing the cashier, the two men attempted to shove Mr. Lovell into a bathroom and rob him as well. They got his money, but then Mr. Lovell pulled his handgun and opened fire. He shot one of the thieves in the head and chest and the other in the head.

When police arrived, they found one of the men in the shop, K-9 Units found the other in the bushes of a nearby business. They also found cash strewn around the front of the sandwich shop according to Detective Robert Rettig of the Plantation Police Department.

Both men were taken to the Broward General Medical Center, where one, Donicio Arrindell, 22, of North Lauderdale died. The other, 21-year-old Frederick Gadson of Fort Lauderdale is in critical but stable condition.

Mr. Lovell was a pilot in the Marine Corps, flying former Presidents John F. Kennedy and Lyndon B. Johnson. He later worked as a pilot for Pan Am and Delta Airlines.

He is not expected to be charged authorities said. "He was in fear for his life," Detective Rettig said, "These criminals ought to realize that most men in their 70's have military backgrounds and aren't intimidated by idiots."

Something tells me this old Marine wasn't 'in fear for his life', even though his life was definitely at risk. The only thing he could be charged with is participating in an unfair fight. One 71-year YOUNG Marine against two punks. Two head shots and one center body mass shot.

**USSR, 1959:** I am a "young pioneer" in school. History classes remind us that there is a higher authority than their parents and teachers: the leaders of the Communist Party.

The story of young pioneer Pavlik Morozov is required reading. Pavlik reported his father to the secret police for disobeying government regulations. His life exemplified the duty of all good Soviet citizens to serve their government.

From the first year in school, all of us are made aware of our ethnicity (ethnic Russian, Jewish, Asian, etc.) and class (proletariat, intelligentsia), around which society is structured. This inherent divisiveness makes it easy for the government to stir ethnic and class tension and in this way distract from economic failure.

Newspapers and TV transmit government-approved news. Any critical voice is immediately suppressed and publicly denounced.

My parents, as all citizens of the USSR, work for state-run companies. All workers are unionized — another way the state controls the citizens. There is no private enterprise in USSR.

Whatever small private farms or shops that existed before 1930 have been taken over by the state. All medical care and schools are state entities. The government regulates what kind of technology, service and compensation are allowed.

From school age through adulthood, citizens are called to public service four to five times a year. Activities such as farming, cleaning places of work, and paper/metal scrap collections are mandatory.

Religious symbols are forbidden in schools or on state property. Most old religious buildings are transformed for secular use.

The Soviet government imposes the Iron Curtain. The state has strict control over our ability to travel abroad. This prevents us from realizing the discrepancy between the media's image of the great socialist country and the reality of our low standard of living.

**USA, 2009:** "Progressives" control the government. Children in some public schools sing songs about the president and study his directives.

Progressives view people not as unique individuals, but as groups. They play on class envy, or divide people by ethnicity (African-American, white, Hispanic, etc.). From early childhood they remind children of their ethnic identity. The idea of a color-blind society united under the American flag is not politically correct.

The mainstream media are aligned with the government. Those media outlets critical of government policy are publicly criticized by government officials and are in danger of suffering repercussions. Government seizes a majority stake in two major auto companies and, through TARP money, has control over major banks. Congress discusses capping salaries in private businesses and is in the process of increasing its control over the health care industry.

**RE: Candidate Wolf says his cousin Obama is right on taxes.**

Speaking to college Republicans Tuesday night (Oct. 29) in Manhattan, KS, Senate candidate Milton Wolf made it clear he supports efforts by his cousin, President Obama, to redistribute wealth and increase taxes on Americans.

In a short answer on taxes, Wolf said flatly, "Taxes, real quick the President is right what he says."

Wolf, in discussing his idea of tax fairness, also sent a strong signal that he agrees with Obama that taxes should be raised on higher income Americans, which is always the first step toward the Democratic goal of redistributing wealth: The ultra rich don't pay taxes. Right? You can sit there with a few hundred million dollars in the bank and what are you going to do? You're going to invest it in tax-free municipal bonds and you won't pay taxes.

Does Wolf want to wreck the municipal bond market, which is critical to cities and counties across Kansas? It is unclear and dangerous.

His comments Tuesday follow previous statements by Wolf, who uses rhetoric on taxes strikingly similar to the words used by his cousin Obama.

We have heard this rhetoric before. In 2011, President Obama said, "We need a tax code where everyone gets a fair shake, and everybody pays their fair share." We know what this rhetoric means. It means higher taxes. It means redistribution of wealth. It means class warfare.

Wolf also discussed the FAIR Tax, which is supported by Senator Roberts, who is a cosponsor of the bill to implement it.

Senator Roberts believes strongly that we must have a competitive, pro-growth tax code that treats all citizens equally and allows American businesses to thrive. He strongly opposes any plan to increase taxes on Americans and has fought hard against President Obama's class warfare that uses taxation to divide Americans.

Wolf's statement to college Republicans is striking for two reasons: Either Wolf actually agrees with his cousin Obama and wants to raise taxes on millions of Americans, or Wolf has a naive and simplistic view of federal tax policy that seriously calls into question his fitness to be a U.S. Senator.

Wolf's statement makes clear the growing realization that while Wolf can make a stirring speech on politics, he comes up way short on understanding the important nuances of public policy.

Senator Pat Roberts is the tough, tested and trusted conservative in the Kansas 2014 race.

Kansas does not need another Obama in Washington, or anyone who thinks like an Obama.

### **WOLF CAPITALIZES ON OBAMA CONNECTION** BY BRYAN RICHARDSON

Political affiliation is thicker than blood.

Milton Wolf, a TEA Party candidate running against U.S. Sen. Pat Roberts, R-Kan., in the 2014 primary, ripped into President Barack Obama during a Tuesday appearance at K-State.

It has been widely publicized that the super-conservative Wolf is Obama's second cousin once removed.

"You cannot choose your family, but you can choose to rise up and stop your family from destroying America," he said. "That's what I think Barack Obama is doing. I think my mission is to stop him."

The Wolf-Obama connection is through Obama's grandmother, who was a cousin of Wolf's mother. Wolf said his mother and Obama's mother were childhood friends growing up in Wichita.

Wolf, a Kansas City – based radiologist and advocate against the Affordable Care Act, talked to a group of about 25 people during a KSU College Republicans meeting also attended by Flint Hills Tea Party members.

He used the opportunity to set himself apart from Sen. Roberts, particularly pointing out that Roberts supported health secretary Kathleen Sebelius when she was nominated for the position.

Roberts, who started his D.C. career as an aide for Sebelius' father-in-law, Keith Sebelius, voted for her confirmation but recently called for the health secretary to resign.

"He calls for her to resign? That's too little, too late." Wolf said. "She wouldn't have that job if it was not for him."

Wolf stated his intention of seeking only two terms if elected. He mentioned that Roberts is in his 32<sup>nd</sup> year in Congress.

"One of the things that's wrong in America is we have too many career politicians," he said. "Career politicians in both parties have let us down."

Wolf has not previously served in any elected office.

He said Mike Lee, R-UT, Rand Paul, R-KY, and Ted Cruz, R-TX, fit into the same category prior to their elections.

“I don’t think it’s a coincidence that they’re the most influential senators today,” Wolf said. “They’re not beholden to any party bosses.”

Lorie Medina, Wolf’s field operations director, played a key role in Cruz being elected to the Senate as a founder of the Frisco, TX TEA Party. “I believe in Milton,” she said. “I love Milton with all my heart. I believe he’s going to be the next Senator from Kansas.”

During the talk, Wolf spoke about his beliefs and views on what should be addressed in Congress. Among his key points:

- Teach Republicans how to properly debate against Obamacare. Wolf said he would push his free market healthcare alternatives. “Anybody can stand against something,” he said. “That’s easy. It’s hard to stand for something.”
- Promote positive ideas rather than focusing on defensive efforts. “We can spend all day long telling everybody what someone else has done wrong, and we’d get nowhere.” Wolf said.
- Eliminate federal taxes and replace them with a consumption tax. Wolf explained that people would only pay taxes for what they spent.
- Keep entitlements but stop handouts. Wolf said people have paid into Social Security and Medicare and should get their benefits. He said people looking for a handout “need to get off the sofa, they need to hang up their free Obama phone and they need to get a job.”

The Second Amendment is a God-given right. “It doesn’t even matter what the Second Amendment says,” said Wolf. “No man can take away your right to self-defense.”

Chuck Henderson of the Flint Hills TEA Party said Wolf brings “energy and vigor,” and has been interested in their cause. And while Wolf has spoken at a previous TEA Party meeting, Henderson said neither Roberts nor any member of his staff has reached out during the local group’s four-plus years of existence.

“He’s still operating on a 20<sup>th</sup> century playbook, and we’re into the second decade of the 21<sup>st</sup> century.” Henderson said of Roberts.

Heritage Action, the conservative grassroots advocacy group, has rated Roberts as the fifth most-conservative Senator during the current Congress. “While his voting record is far from the worst in our point of view, why couldn’t it be even better?” Henderson asked. “Why is he only the fifth most-conservative? Is that what we need to settle for?”
