NYC Reporter Presses Obama on Whether He Deserves 'Blame' for Conflict in Washington

President **Barack Obama** sat down for a rare interview with a local New York City television reporter on Tuesday. As the financial markets grow more skittish with a deal to raise the nation's borrowing limit not yet agreed to, Obama urged calm. When pressed, Obama refused to concede that he deserves any blame for discord in Washington D.C.

WABC reporter **Diana Williams** sat down with Obama for 8 minutes on Tuesday for a wide-ranging interview about the standoff in Washington. She previewed portions of that interview for WABC's 4 p.m. broadcast.

"The real good news is that Democrats and Republicans are very close to agreement in the Senate," Obama said. "And what we've seen is a recognition on a part of a number of Senate Republicans that this whole strategy that they pursued of trying to extract ransom for keeping the government open was a bad strategy."

"Why have you not been able to create a bipartisan atmosphere here?" Williams asked. "And, do you take any of the blame yourself for that?"

"I think if you look at my track record over the last four years, I have consistently sought compromise," Obama replied. "Sometimes to the point where Democrats have been mad at me, but I didn't care because I did what I thought was best for the country."

Williams said the lack of concern among legislators for what happens in a default scenario led her to believe that there is still optimism that a deal will be struck which will avert crisis.

Finally, Williams asked Obama about the rollout of the Affordable Care Act. "My suspicion is what's going to happen is when it's working and everybody is really happy with it, the Republicans will stop calling it ObamaCare," he said.

As president he paid for all of his own travel expenses and food. Modern politicians have found a new level of success in cashing in on the Presidency, resulting in untold wealth. Today, too many in Congress also have found a way to become quite wealthy while enjoying the fruits of their offices.

Good old Harry Truman was correct when he observed, "My choices in life were either to be a piano player in a whore house or a politician. And to tell the truth, there's hardly any difference!"

How many of you carried lunches from home with you when you went to school? I lived on brown bag lunches through most of my school years including high school, college and through most of my working life. If I wanted to eat, I got up, fixed my lunch and carried it with me, as did millions of other people. One of the reasons I carried my lunch to school is that it was a lot cheaper than buying lunch in the cafeteria. However, thanks to the dictatorial socialist policies of Michele Obama, the days of brown bag lunches are vanishing.

First I received an email with a [link to the site of a deaf mom](#) identified only as Linda. She posted that her son Zion is a very picky eater and would not eat the lunches provided by the school. A month earlier, Zion's teacher sent a note home asking Linda to send lunches to school that Zion would eat because he wasn't eating anything at the school. Linda gladly complied and started sending lunches to school with Zion that he would eat.

Then Linda received another note from the school informing her not to send any lunches from home unless she had a doctor's note stating that it was necessary. Confused about the turn of events, she tried to call the health coordinator as the note stated, but could not get an answer or a response. Knowing that Zion would not eat the school provided lunch, she continued to pack a lunch and send it to school with her son.

Again, a note was sent home from the school with a handwritten message at the top from Zion's teacher. The message stated: "Please do not send a lunch to school unless a doctor's note is sent it with connection with this letter."

When I read this private website post, I wasn't sure if it was real or not. I went searching on the internet for any other references to schools banning brown bag lunches from home and I found another occurrence.

This time it took place in Chicago at [Little Village Academy](#), a public school on the West Side. Principal Elsa Carmona has banned students from bringing lunches from home. She explained saying:

"Nutrition wise, it is better for the children to eat at the school. It's about the nutrition and the excellent quality food that they are able to serve (in the lunchroom). It's milk versus a Coke. But with allergies and any medical issue, of course, we would make an exception."

When a reporter showed up at the school to investigate the policy 7th grader Fernando Dominquez stood up in the lunchroom and loudly asked his fellow classmates: "Who thinks the lunch is not good enough?"

Numerous students raised their hands and began loudly chanting: "We should bring our own lunch! We should bring our own lunch! We should bring our own lunch!"

Fernando turned to the reporter and said: "Do you see the situation?"

The school district says that the decision to ban lunches from home is up to the individual principals and that they generally make their decision for the nutritional benefits of their students. But what they aren't saying publicly is that by banning homemade lunches, it forces more students to take the school cafeteria lunches, which means more money for the company that provides those lunches.

Although more students at Little Village Academy are taking school lunches, many of them are throwing all or most of

the lunch into the garbage. [Erica Martinez](#), a parent of a student at the school said: “Some of the kids don’t like the food they give at our school for lunch or breakfast. So it would be a good idea if they could bring their lunch so they could at least eat something.”

The school may think they are providing a more nutritional lunch, but what good does it do if the students don’t eat it and throw most of it away? The end result is that more students are going hungry through the rest of the school day than they were before the ban on school lunches.

Michele Obama’s school lunch program is forcing more socialistic control over school children. Schools are taking the rights of the parents to feed and provide for their children away from them and giving more rights to the schools. Schools are controlling what the kids can and cannot eat often against parental wishes. Schools are monitoring the activities of students outside of school and punishing them for things that the school has no authority over and the courts are supporting the schools.

At the rate things are going, I expect more radical socialistic changes in the public schools under the Obama administration. If too many parents protest, I wouldn’t be surprised to see the parents lose custody of their children like what has been happening in Germany with parents who want to homeschool. ObamaCare Rollout & Enrollment Data Subpoena

This week the House Ways and Means Committee [issued a subpoena](#) to Centers for Medicare and Medicaid Services (CMS) to provide all enrollment data the agency has from the ObamaCare exchanges.

Each day, more and more Americans are finding out their health care plans have been canceled, and it is my committee's job to hold the administration accountable for the failed launch of the ObamaCare exchanges.

Administration officials have given Congress some cherry-picked statistics, but they refuse to give us the full picture. The lack of openness and transparency from the administration is hindering our oversight role as we work to mitigate this crisis for hardworking Americans and their families.

The enrollment data was originally requested during a House Ways and Means Committee hearing with CMS Administrator Marilyn Tavenner on October 29, 2013. Tavenner said she did not have the enrollment information, although we have learned both she and Secretary Sebelius have been briefed on these numbers. Chairman Camp demanded CMS provide the documents by close of business Friday, November 8. His latest letter can be read [here](#).

After nearly six weeks, the administration still has not solved the widespread problems with ObamaCare's rollout. In the weeks and months ahead, I am committed to focusing on ways to protect Americans from this broken health care law.

One of my efforts includes my bipartisan bill with Congressman John Barrow, the [“Restoring Access to Medication Act,”](#) that repeals an ObamaCare rule preventing people from using their medical savings accounts to buy over-the-counter (OTC) medications. With nearly 50 million Americans using medical savings accounts to manage their rising health care costs, this bill will help put consumers back in the driver's seat, and mitigate the negative effects of the president's health care law. I was pleased when Senator Pat Roberts and Senator Mary Landrieu [introduced a companion bill](#) in the Senate this week.

The following is the report sent to me by John D'Alola on Common Core education standards.

JoAnn and I attended a Common Core (CC) luncheon/presentation in Manhattan on Tuesday, 11/5, sponsored by Americans for Prosperity. About 80 people attended. The presentations, by three ladies, and the Q&A, lasted a bit over one hour.

The information they presented was informative — and troubling. After listening to them talk a bit, the light dawned - the rollout of CC mirrored the roll out of ObamaCare. An entirely new education system is being imposed without any idea if it will work or not — and maybe the ultimate goal is that it does not work, that it does not improve education, does not produce educated children — the goal for ObamaCare is failure so that single-payer health care can be imposed; **the goal for CC may well be a completely dumbed-down citizenry, compliant in the hands of those in power.**

No way I can regurgitate everything that was said.

Some of the take-a-ways from the presentations:

The purposes of CC include:

The shift of control over K-12 education *to the feds* through the bribery of state governments and the coercion of citizens. It is an end-around the Constitution and stands the Principle of Subsidiarity on its head. State and local school boards will be but puppets to federal puppet-masters.

Training worker-bees for industry and making a profit for the companies involved in developing the standards and supporting the associated testing. Education of children is not a purpose.

Gathering longitudinal data about each and every child from K thru college (and maybe even pre-K thru college) and merge that data with other data from government databases so that each child can be tracked and pigeon-holed as not only education achievements but also personal traits and beliefs. The data collected incident to CC includes health-care history, family income, religious affiliation, voting status, and who knows what else — *and the data is not protected by privacy laws.* [For more information on the data collection: <http://www.hslda.org/commoncore/Topic10.aspx> and <http://news.heartland.org/editorial/2013/03/23/education-department-helps-leak-students-personal-data>]

Preparing students for nonselective two-year community colleges, not four-year universities.

The standards being developed are in fact “progressive” educational ideas that progressives/socialists/tyrants have been trying to implement for a century or so — they relegate a classical education, and any parent input, to the trash bin.

As CC gets implemented, if parents expect their children to have the math and English skills necessary for a future in any technical/professional discipline, they are going to have to devote the time/effort/dollars to provide extra help — both the math and English standards through the grade levels are deficient, do not provide the level of knowledge that up to now has been expected of a high school graduate in preparation for life or an advanced degree.

Parents can “opt out” their children from CC testing, though they may have to push hard against school officials to do so. An opt-out form and instructions are available via a link at: www.kansansagainstcommoncore.com, a site that provides much information and links to other websites opposing CC.

Another source of information is the education section of the Heartland Institute’s website — start at <http://heartland.org/issues/education>. A Heartland staffer who has written much about CC is Joy Pullmann.

To extract Kansas from Common Core will require positive action on the part of the legislature. Time to join a group fighting Common Core and to start letting your displeasure be known to your legislators.

Keep Your Health Plan Legislation

Throughout the past several days, increasingly more **Americans have received notifications** from their insurance providers stating their current coverage policies would not be offered starting in 2014. My office has received numerous phone calls, emails and letters from Kansans telling me about their coverage being dropped. This is very upsetting news and shows the problems with the implementation of the Affordable Care Act will surely continue.

Last week, I cosponsored new legislation — **H.R. 3350, the Keep Your Health Plan Act of 2013** — that would allow Americans to keep their current healthcare coverage plans. This bill is commonsense and is an easy step for bipartisan action in Congress to make sure American families aren't kicked off the plans they like and forced to purchase something different.

On Wednesday of last week, **Health and Human Services Secretary Kathleen Sebelius testified before Congress** to answer questions about the horribly coordinated rollout of the Affordable Care Act website and about Americans losing their current coverage. A recent news story **reveals Administration officials knew three years ago that millions of Americans would not be able to keep their coverage**. It is crystal clear the Administration was not prepared for this rollout, and sadly millions of Americans are now paying the price.

Working On Common Ground In Congress

While we continue to learn about the problems surrounding ACA implementation, I took a moment to speak on the House floor about the important issues that Congress does agree on, and that we must continue to work together to find solutions to solve our nation's most serious problems. This week, Kansas was front and center in the debate over implementation of the Affordable Care Act. As the only Kansas member of Congress on the House Energy and Commerce Committee, I had an opportunity to ask our former governor, HHS Secretary Kathleen Sebelius, about the Affordable Care Act's growing problems and their impact on our home state. The key takeaway: The Affordable Care Act was sold on a massive deception: "If you like your plan you can keep it." The website is a debacle — that's according to Secretary Sebelius herself. But this is not simply about the website. It is about the way Kansans are able to ensure that they and their families are kept healthy. I asked Secretary Sebelius why she feels that the insurance Kansans have and like is no longer good enough (Democrats are calling them "substandard" plans and worse). Secretary Sebelius told me that the thousands of cancelled policies weren't really "true insurance." What? This is completely disingenuous.

During Secretary Sebelius' time as insurance commissioner and then governor of Kansas, there was never any question about whether the insurance policies people chose were "true insurance." During her time in state office, she not only approved these exact same plans, but she also allowed them to be sold to tens of thousands of Kansans. If Kansans liked what they found and bought those policies, it was their choice. Apparently, she has changed her mind. She now claims those policies were never "true insurance." In my view, the policies being issued under the President's health-care law are what are substandard — expensive, very hard to get, and often not allowing Kansans to see the doctors they want to see.

This is a classic bait-and-switch. One resident of the 4th District contacted me the moment he received his cancellation letter to express his outrage. He felt he had been sold a bill of goods. And he was sold a bill of goods. Whereas our public officials have a responsibility to tell the truth and keep their promises, President Obama sold his health-care reform to the American public saying that "if you like your health care, you can keep it." KANSAS (EX-)GOVERNOR MARK PARKINSON TO HELM BIGGEST NURSING-HOME LOBBYING GROUP By Jeffrey Young *9/13/2010, 2:13pm CT*

Kansas Governor [Mark Parkinson](#) will become chief executive officer of the largest trade group representing nursing-home companies, including [Kindred Healthcare Inc.](#) and [Sun Healthcare Group Inc.](#)

Parkinson, 53, will assume the top leadership position at the American Health Care Association after his term as governor ends on Jan. 10, the Washington-based group said in a statement today. He will also head the affiliated National Center for Assisted Living.

The governor and his wife, Stacy, had owned and operated 10 long-term care facilities in Kansas and Missouri for more than 15 years before he ran for lieutenant governor in 2006, when Governor [Kathleen Sebelius](#) won re-election. He took her place when she left to become the U.S. Health and Human Services Secretary in April 2009.

“Upon leaving office, we assumed we would resume our business of building one nursing home at a time,” Parkinson said in a [statement today](#). “Instead, I now have the opportunity to significantly increase our impact on the profession.”

Parkinson, a Republican who became a Democrat before running in 2006, will succeed 68-year-old [Bruce Yarwood](#), who has been president and CEO of the 11,000-member nursing home group since 2005.

Concerned About Nuclear Deal with Iran — On Saturday, President Obama announced that the United States and our international negotiating partners reached a six-month agreement with Iran in which Iran gets sanctions relief in exchange for

halting the advancement of its nuclear program. Troublingly, Iran made no commitment to dismantle its nuclear program, or even aspects of it. Iran's track record of deception and refusal to abide by past international demands make me gravely concerned about this deal. Now is not the time to ease up on the pressure and turn the other way, allowing Iran to make further progress in achieving its goal. The agreement reached with Iran also gives the Iranians access to billions of dollars that can be used to fund terrorist activities and support Syria's dictator Bashar al-Assad, all the while allowing Iran to continue committing serious human rights abuses—including the imprisonment of American pastor Saeed Abedini.

Congress should pass additional sanctions so that if Iran breaks the agreement, President Obama can not only reverse the sanctions relief granted by this deal but immediately impose more sanctions. We must do everything we can to prevent Iran from acquiring a nuclear weapons capability.

Senate Democrats Alter Senate Rules for More Control — On Thursday, Majority leader Harry Reid breaking the rules of the Senate to force through executive nominations. In my view, this looks like an attempt to divert Americans' attention away from the chaos and broken promises of ObamaCare. Senate Democrats continue to use the same procedural tactics they used when ObamaCare was forced through Congress without a single Republican vote. If health care reform had been passed with careful deliberation and input from all those elected to represent the American people, Democrats might not be watching their flagship “achievement” and the healthcare security of their constituents unravel before their eyes today.

We Can Do Better Than ObamaCare — The failure of the HealthCare.gov website has captured a lot of attention this past month, but the real cost and consequence of ObamaCare is much greater. I wish the problems with ObamaCare could be solved by simply fixing this website, but that is not the case. The troubles of this law run much deeper. On Thursday, I spoke on the Senate floor about these problems as well as the things we can do to actually improve health care in this country and reduce costs.

The fact that millions of Americans are losing their health coverage is not an unintended consequence of ObamaCare or even an unfortunate accident—it is the result of the law working just as its authors expected. ObamaCare takes the freedom to make health care decisions for you and your family and gives it to the federal government. And despite the headaches, frustration and anger the American people are experiencing right now, the Obama Administration is unlikely to offer any real relief, because doing so would risk the entire scheme ObamaCare was designed to put in place. This is why I believe ObamaCare needs to be repealed and replaced.

Introducing Amendments to the National Defense Authorization Act — This week, the Senate took up the National Defense Authorization Act. I submitted a number of amendments to the bill, including: Protecting National Guard Role in Cyber Missions — This amendment would support the Kansas National Guard and Department of Defense (DoD) Reserve Components by protecting their ability to carry our cyber missions in support of DoD and safeguarding our nation. As part of the DoD strategy requirement in Section 945 of the Senate version of the NDAA, passage of this amendment would halt, and likely prevent cuts to the 177th Information Aggressor Squadron (IAS) based at McConnell Air Force Base in Wichita. The 177th is critical not only to Kansas National Guardsman, but also as a national security asset for the DoD and other organizations that require cyber mission support.

Today from Representative Kevin Yoder's Nov. 25, 2013 Newsletter: Iran Nuclear Agreement Concerning

I have grave concerns about the administration's announcement that it will reduce sanctions on Iran without Iran eliminating its nuclear program. A nuclear-armed Iran is a tremendous threat to the United States and our allies, and now is the time to be steadfast and resolute in our opposition to Iranian efforts to build a nuclear weapon.

These sanctions have had a significant impact on the Iranian economy. Since sanctions were ramped up in 2011, Iranian oil exports have been cut from 2.5 million barrels per day to 1 million barrels per day. Additionally, the loss of revenue from these reductions in oil exports, as well as rising inflation, has led to Iran's economy retracting by 5 percent since 2012.

In fact, it is these very sanctions that are driving Iran to the negotiating table for the first time. Now is not the time to turn back. I cannot support a peace agreement that allows Iran to continue to enrich uranium and continue to advance its nuclear ambitions. I fear that this agreement is cosmetic, that Iran has no intention of abandoning its nuclear ambitions and is simply using our lack of resolve to buy time.

The only acceptable peace agreement is one in which Iran gives up its nuclear program permanently.

House Passes American Energy Independence Bills

The House debated and passed several pro-energy, pro-growth bills on the floor last week. These bills will not only **further develop and increase American energy independence** by cutting red tape and fostering increased domestic energy production, but will also boost our economy by supporting new and high-paying energy sector jobs.

We learned last week that the **U.S. has produced more domestic oil than it imported** for the first time in nearly two decades as U.S. oil producers added 137,000 more barrels than we imported as the start of November.

I spoke on the House floor about the importance of promoting an All-of-the-Above energy policy, increasing American energy independence through bipartisan legislation, and boosting the U.S. economy by creating jobs.

DEMOCRAT WANTS AMNESTY SO ILLEGAL IMMIGRANTS CAN ENROLL IN OBAMACARE

A Colorado Democrat who wanted ObamaCare waivers for some of the country's wealthiest patrons of ski resorts wants the law's individual mandate to apply to today's illegal immigrants, which can only happen if they are given a pathway to citizenship.

Rep. Jared Polis (D-CO) said on Friday that the House should pass comprehensive immigration reform with a pathway to citizenship for all of the country's illegal immigrants so they could get on ObamaCare.

"American citizens are essentially being forced to pay for the health care costs of people who are here illegally every day, until we pass comprehensive immigration reform," he **said**. "We're wondering why rates are going up... It's no surprise. When somebody doesn't have insurance, their costs are shifted onto other people that do."

Last month, Polis **said** he would ask for ObamaCare waivers for residents of some of the wealthiest ski resort town in his state of Colorado. As the *Washington Times* **noted**, "illegal immigrants are one of the few categories of people in the U.S. who aren't subjected to ObamaCare's individual mandate requiring all people to have health insurance coverage." Illegal immigrants also "aren't eligible for taxpayer subsidies" to buy ObamaCare on the insurance exchanges.

Polis said if the House can pass a pathway to citizenship for the country's illegal immigrants, "people who are here illegally will have to get insurance on their own instead of forcing Americans to pay for their insurance."

This week, House Speaker John Boehner (R-OH) and other House leaders ruled out going to conference on the Senate's immigration bill this year, but those who are championing a pathway to citizenship for the country's illegal immigrants--like Sen. John McCain (R-AZ)--have **indicated** they will make one more push for the legislation after the Republican primaries next year.

The Congressional Budget Office **determined** that the pathway to citizenship provision in the Senate's immigration bill would lower the wages of working class Americans and "end up costing \$82.3 billion over the next decade in higher ObamaCare subsidies."

IT DOES NOT MATTER WHAT WE DO — Those NOT WILLING to pay for their own health insurance are NOT GOING TO PAY FOR THEIR OWN HEALTH INSURANCE. The rest of us ARE paying for it regardless of how it comes out — if they are just going to an Emergency Room or IF the Federal Government just pays for it — it is all the same — the rest of us pay the tab in our increased premiums.
