



Department of Veterans Affairs Scandal Reveals More Troubles

Despite the resignation of Secretary of Veterans Affairs Eric Shinseki, widespread reports of veterans being forced to wait for necessary medical care continue to surface around the country. No cabinet level budget has been increased more by Congress in the last five years, making it clear that this is not simply an issue of resources, but rather the result of systematic failures, poor management, and overall lack of accountability by the Administration. Recently, [I visited the Kansas City, Missouri VA hospital](#) to meet with officials and veterans. We discussed the local efforts in place to ensure that all our veterans are receiving quality care in a timely manner.

Last week I voted for the VA Management Accountability Act, which is a step in the right direction, but there is still more work to be done. Our veterans need more options, such as the ability to seek health care outside of the VA system, especially those who find themselves trapped on long waiting lists. The Inspector General released a report last week pinpointing 1,700 veterans who were waiting for a primary care appointment, yet hadn't been placed on the system's waiting list. This same report showed average wait times to be 115 days, a far cry from the VA's reported average of 24 days. It's clear there is still work to be done before this problem is resolved.

Restoring the Fourth Amendment

I enjoyed discussing my bill, H.R. 1852, the Email Privacy Act, with Maria Bartiromo on Fox Business Friday morning. The law governing email was written in 1986. Like most Americans, I didn't get my first email account until 1994, eight years after the ECPA law was first enacted. There is no question that technology has evolved since then and this law needs to be updated to reflect the advances in how Americans correspond electronically.

As it currently stands, entities such as the SEC, IRS, and other government agencies have the ability to access your email without a warrant. It is imperative that Congress pass reforms that extend the 4th Amendment beyond postal mail and paper documents to protect Americans' personal digital correspondence.

Bipartisan support for the Email Privacy Act continues to grow

I joined my ECPA cosponsor, Congressman Jared Polis (D-CO), to discuss email privacy at a Google Hangout on Wednesday evening. The Hangout was attended by people across the country to discuss the need for an updated ECPA law.

The bipartisan support for the Email Privacy Act, H.R. 1852, continues to grow as the bill now has 214 cosponsors, only four shy from having the support of the majority of Congress. This is one of the most fundamental privacy laws in our country. The government shouldn't have access to American's electronic communications without warrant.

Appropriations Committee Approves FY15 Agriculture Bill

The Appropriations Subcommittee on Agriculture debated and approved legislation that will fund our nation's agriculture programs for the upcoming fiscal year by a vote of 31-18 on Wednesday. As Vice Chair, I worked hard to ensure this bill does not increase unnecessary spending, however, maintains appropriate funding for vital agricultural and food programs, animal and plant health programs, rural development, farm services, and marketplace oversight.

Commerce, Justice, Science, and Related Agencies Appropriations Act passes

Early Thursday morning the House passed the Commerce, Justice, Science, and Related Agencies Appropriations Act by a vote of 321-87. The bill provides funding for the Department of Commerce, Department of Justice, the National Science Foundation, the 70th anniversary of the D-Day Invasion I like to share a Aeronautics and Space Administration (NASA), and other important agencies. I was pleased to vote for the legislation as it cuts spending. The bill spends \$398 million less than last year and saves \$250 million by eliminating 33 unnecessary programs.

We need to THANK Representative Yoder for his efforts in Washington DC to improve our lives in Kansas.

On piece of history that you all know if you saw the War World II movie back in the late 1990s called; **Saving Private Ryan**⁽¹⁾.

In the opening scenes of the D-Day landing there is a scene where G.I.s are walking up a road that leads from the beach to the top of the hills. At the top of the hill a G.I. dozer operator is standing next to his dozer and telling them as they are coming up that here are Germans ahead and their locations.

I believe that scene was based on Frank L. Sedlacek SR.* from Waterville, Kansas.

Frank was a contractor that did soil conservation work when I was working for the Soil Conservation Service in the 1970s. One day when we were talking, Frank mentioned he had landed on D-Day⁽²⁾. Until that time I had not known he had been in the service. He went on to say that he was on his dozer when a German plane made it strafing run on the beach and went right by him. He was so close that he could see the pilot face. Frank said he could have hit the plane easy with his rifle that was on the dozer, but they were order not to shot at the planes⁽³⁾. Then he went on to say that after completing removing beach obstacles he made a road up the hill and was at the top telling the guys where the Germans were. Frank mentioned that he was the only survivor from his company⁽⁴⁾. He was the only individual that I have known that landed on D-Day.

Now you know the rest of the story!

1) **Saving Private Ryan** is a 1998 American epic war film set during the invasion of Normandy in World War II. It was directed by Steven Spielberg and written by Robert Rodat. I'm not sure how Mr. Rodat learned about this event, but it would be interesting to know.

2) Frank was at the local cemetery he helped care for when he told me about his D-Day experience. This may have been the reason he mentioned it to me. Frank was a Tech 5, 38th Engineering Company.

3) I found out some years later that the Army Air Force were to evacuate them when they got away from the beach area.

4) This would have been 180 to 200 soldiers. There were about 200,000 soldiers that landed on D-Day, the overall loss rate was about 80%. However, some units suffered much higher losses.

* Frank was a Senior at the time of D-Day with the birth of his son 13 Nov 1942.

The following is my response:



Rand Paul Suggests Trading five (5) Democrats for Marine Held in Mexico

While addressing the GOP convention in Fort Worth, Texas, Sen. [Rand Paul](#), R-Ky., jokingly suggested trading five [Democrats](#) for Andrew Tahmooressi, the Marine reservist held in Mexico, [CNS News](#) reported Sunday.

According to Paul, a delegate he spoke to said, "There is one guy who is kind of deserving we ought to try to get home, and that's the Marine who accidentally carried his guns into Mexico."

"So here's what I'm thinking: Mr. President, you love to trade people," Paul said, referring to the prisoner exchange that secured the release of Bowe Bergdahl.

"Why don't we set up a trade? But this time, instead of five [Taliban](#), how about five Democrats?" he asked to applause and laughter. "I'm thinking John Kerry, Hillary Clinton, Nancy Pelosi – couldn't we send them to Mexico?"

The 25-year-old Tahmooressi has been in custody in Mexico since the end of March. At the time of his arrest, he was in possession of three [legally-registered firearms](#).

Having served two combat tours in Afghanistan and currently suffering from PTSD, Tahmooressi said he entered Mexico accidentally. According to his mother, Jill, he made a wrong turn and found himself in Mexico.

Several lawmakers, including Rep. Duncan Hunter, R-CA, have pressed the administration to take stronger action to get the Marine veteran back.

"Andrew is neither a criminal nor a weapons trafficker, and his incarceration is an extraordinarily unfortunate occurrence," Hunter said in a letter. "I am confident this situation can be resolved quickly through the continued attention and support of the U.S. State Department, but I remain concerned for Andrew's safety and well-being as a prisoner in Mexico."

Last Thursday, [CNS](#) added, State Department spokeswoman Marie Harf said the Obama administration is "working very hard to discuss with the Mexican authorities the path forward here."

"Look, he entered — he reportedly entered Mexico with several weapons and ammunition, circumstances which would normally result in arrest in Mexico. So we are letting the process work itself through," Harf said when asked if working with Mexico would be easier than negotiating with the Taliban. "The Mexican authorities provided prompt notification of his arrest, have allowed regular consular access. We'll continue working with them."

In late May, Secretary of State John Kerry told CNN he has mentioned the topic to his Mexican counterparts.

"We are working on determining whether or not certain evidence that has been presented is meeting the standard that's necessary to be able to hold that young Marine, and we're trying to find out exactly what the fact pattern is, but we are working on that," he said.

Bergdahl Release Unprecedented, Troubling:

The more information that comes out surrounding the exchange for Sergeant Bergdahl, the more concerned I get. Not only did the President fail to give required notice to Congress, but it does not appear that we have been given sufficient assurances that the five terrorists released will not plan future attacks on Americans. This type of public swap with a terrorist organization is basically unprecedented, and puts our soldiers at risk. For this type of high-profile swap to occur for a soldier, who reports indicate was a deserter, seems completely irresponsible.

Ensuring Rural Communities Have Access to Quality Care:

Access to quality health care in our rural communities continues to be one of my top priorities. Congress must ensure our rural hospitals are able to sustain a health care system that provides folks the care they require, and we need cost-effective solutions to incentivize physicians to practice in these areas.

This week, I introduced bipartisan legislation with Congressman Emanuel Cleaver (D-MO) that will provide greater access to anesthesiology professionals for our rural hospitals and help to improve the shortage of access to anesthesiology medical care in rural communities.

[H.R. 4781, the Medicare Access to Rural Anesthesiology Act of 2014](#) will allow certain rural hospitals to use Medicare Part A funds on a “pass-through” basis to attract and retain physician anesthesiologists to provide services to rural patients. To believe the Obama administration narrative about the swap of five Taliban/al-Qaeda-related kingpins for Sgt. Bergdahl, we must accept the following:

1. Sgt. Bergdahl was in ill health; thus the need for alacrity. Surely we will expect to see him in an enfeebled state on his return to the U.S.
2. Sgt. Bergdahl was in grave and sudden danger from his captors; thus the need for alacrity. We expect to see proof of that on his return to the U.S.
3. The five Taliban detainees will be under guard in Qatar for a year. We expect in June 2015 to know that they are still there in Qatar.
4. The five Taliban detainees [don't really pose a grave threat](#) to U.S. troops, given that we will be gone from Afghanistan in 2016. We expect not to hear that any of the five [are reengaged in the war effort](#) to kill Americans between 2015-16.
5. Sgt. Bergdahl served with “honor and distinction.” We expect to have [confirmation of that fact](#) once his intelligence file is released and more evidence is adduced that all of his platoon-mates were wrong (or perhaps [vindictive and partisan](#)) in stating that he voluntarily left their unit — deserted — to meet up with the Taliban.
6. Sgt. Bergdahl was captured on the “field of battle”; we expect to have confirmation that he was taken unwillingly by the enemy amid a clash of arms.
7. Sgt. Bergdahl was not a collaborator. We expect to learn confirmation of the fact that he did not disclose information to his captors.
8. Bergdahl's fellow soldiers in his platoon are either partisan operatives or sorely misinformed, and we will shortly learn that their accounts of Bergdahl's disappearance were erroneous.
9. The U.S. has traditionally negotiated to bring home even deserters, and did so frequently, for example, both during and after the Korean War when GIs crossed into North Korea.
10. The timing of the swap amid the VA scandal and the press conference with the Bergdahl family [were not predicated on political considerations](#).
11. There is no law stopping the president from releasing terrorists from Guantanamo, [only legal fictions](#) promulgated by right-wing critics of the president.
12. The five Taliban terrorists [are now old outliers](#), rusty, and mostly irrelevant to the war in Afghanistan.

For the deadly Benghazi attack on 9/11/2012, the Obama administration would have us believe:

1. A spontaneous demonstration erupted over a right-wing hate video of Mr. Nakoula, who was deservedly condemned for causing the deaths of four Americans by the Obama administration. His subsequent jailing was solely due to a parole violation.
2. The United States consulate in Benghazi was adequately secured before the attack and had expressed no prior serious warning about inadequate defenses.
3. There was no reasonable chance that U.S. military forces could have come to the aid of those killed in Benghazi.
4. President Obama was engaged in overseeing responses during the night of the attack.
5. Susan Rice simply relayed reasonable intelligence reports at the time that confirmed the violence was spontaneous and arose over a video. The president and Secretary Clinton seconded her assessment [and have no reason to alter their judgment](#).
6. Intelligence operatives, not White House personnel, are largely responsible for any inconsistencies about the origins of the attack. There were no administration efforts to alter intelligence synopses.
7. CIA operatives in Benghazi were engaged in transparent and routine efforts to secure the Khadafy arsenal.
8. The Benghazi deaths were not connected to the general chaos in Libya that followed the lead-from-behind intervention to remove Khadafy.
9. Nearly two years after Benghazi, [what difference does it make](#) now?

For the IRS-targeting-conservatives scandal, the Obama administration would have us believe:

1. Some low-level bureaucrats may have proved over-zealous in targeting some non-profit groups.
2. There was no real pattern in the political affiliations of those who were inordinately targeted by the IRS.
3. A number of conservative groups were unlawfully engaging in blatantly partisan activities, in ways not true of their liberal counterparts. So it is understandable why they in theory might have drawn the attention of IRS auditors.
4. We should not infer much from Lois Lerner's pleading of the 5th Amendment, given right-wing attempts to smear and destroy a noble public servant.
5. The targeting of so-called Tea-party groups between late 2010 and late 2012 [had no effect](#) on the 2012 election.
6. The Obama administration has conducted a thorough investigation that now has mostly exonerated the IRS from the excesses of a few regional officials. The result is not even a smidgeon of corruption.
7. The Obama administration had no real contacts with the IRS director during the period in which the agency pursued conservative groups.

8. If any good comes from this melodrama, at least reactionary groups will think twice about their partisan giving.

For the Obamacare scandal, we are asked to believe:

1. The Obama administration consistently [published up-to-date and accurate information](#) about the number of ongoing enrollees and those who have paid their premiums.
2. The president's promises that Americans could keep their health plans and doctors [were misinterpreted](#); in fact, he referred only to those who had existing legitimate health plans, not substandard ones that of course were in need of government intervention and substitution.
3. Kathleen Sebelius and the president [met frequently](#) over the Affordable Care Act rollout and foresaw many of the problems beforehand.
4. The collapse of the website and general chaos upon implementation are the normal sorts of problems that accompany [ambitious new government programs](#).
5. Because of Republican obstructionism, it became necessary for the president to delay a few of the provisions of the ACA in order to protect the interests of the formerly uninsured.
6. Most of the problems with the ACA have resulted from Republican obstructionism and nihilism that sought to deny the poor and needy access to health care.
7. The few million who lost their health care plans eventually will come to appreciate the president's leadership, once they discover that they now have more comprehensive ACA coverage at cheaper costs.
8. Stories of patient, doctor and insurance chaos [are largely partisan narratives](#) promulgated by those who always opposed the ACA.
9. There is still a good chance, as Republican stonewalling wanes, that the ACA will lower insurance premiums and increase small-business competitiveness as originally promised. Likewise the ACA will help lower the deficit as promised.
10. That a large number of the new ACA enrollees simply switched over to Medicaid programs is either untrue or irrelevant.
11. The ACA will not fundamentally affect levels of Medicare coverage.


For the VA mess, the Obama administration would have us believe:

1. The mess, to the extent that it was a mess, was largely a result of prior policies of the Bush administration as Barack Obama pointed out as early as 2008.
2. The Bush wars in Afghanistan and Iraq were largely responsible for the delays in service, as hundreds of thousands of new vets were dumped into the system.
3. The problem at the VA was not necessarily the fault of Gen. Shinseki, an iconic figure who bravely opposed the Iraq war and a public servant who has largely been demonized by those seeking partisan advantage.
4. The VA scandal, such as it is, highlights why President Obama overhauled the health care system and gave us the ACA.
5. The VA scandal is, like the IRS brouhaha, mostly a regional matter [with no national implications](#).

1. Almost all illegal aliens arrive here to work; very few are old, young, sick, criminal, unskilled, uneducated, or those seeking public assistance
2. The border is a fluid construct originally designed by largely illiberal interests to artificially claim land that was indigenously owned.
3. Mexico is an enlightened partner that wishes to help the U.S. with its labor needs.
4. At a time of worker scarcity, we desperately need more low-skilled laborers [to keep the U.S. economy humming along](#).
5. The arrival of millions of illegal aliens is a boon to the economy; the few who depend on public assistance or [encounter the criminal justice system](#) or impact health & education services are more than balanced by the millions who work hard at cheap wages and pay taxes for services they rarely draw on.
6. Opposition to illegal immigration is entirely race-driven by an angry but shrinking white minority, who need to "get over it" and accept the new demographic reality.
7. There have been no real violations of immigration law. Such calcified statutes reflected race and class biases and therefore have no sanctity. Progressive interpretations of border controversies are far more ethical and deserve greater legal weight.
8. Current de facto immigration policy is merit-based and not predicated on racial or ethnic considerations. Proposed "meritocratic" changes to base immigration on education and skill sets are thinly disguised ways of discriminating against people of color.

Ve could go on, with the NSA, AP, Fast & Furious scandals, but you get the picture: the Obama administration does what it wishes, says what it pleases, and assumes the media will offer the necessary mythologizing — and Americans will get over it.

This oversight is essential, as insurers must keep reserves of cash to respond in the event of a catastrophe. Working with insurers, actuaries and



analysts, the Commissioner ensures an insurer keep adequate funds on hand, without limiting the amount of insurance a company can sell. This person also oversees Rate Controls: Certain insurance products are legally required in every state to ensure that every resident is protected in the event of an accident. Part of the Insurance Commissioner's responsibility is regulating the rates an insurer charges to prevent the industry from taking advantage of the requirement. The Commissioner balances an insurance company's right to achieve a profit with the consumer's right to obtain affordable insurance coverage. To that end, the Commissioner approves the rates for certain products before they are put into effect. *During a presentation, DAVID told us that Kathleen Sebelius put lots of rules & regulations in KS that were all wrong for the KS Insurance world. DAVID will begin correcting these problems as soon as the swearing-in ceremony is over. DAVID is working for us now & has been 37 yrs.*
