What if 20 Million Illegal Aliens Vacated America?

I, Tina Griego, journalist for the Denver Rocky Mountain News wrote a column titled, "Mexican Visitor's Lament."

I interviewed Mexican journalist Evangelina Hernandez while visiting Denver last week. Hernandez said, "Illegal aliens pay rent, buy groceries, buy clothes. What happens to your country's economy if 20 million people go away?"

Hmmm, I thought, what would happen?

So I did my due diligence, buried my nose as a reporter into the FACTS I found below.

It's a good question... it deserves an honest answer. Over 80% of Americans demand secured borders and illegal migration stopped. But what would happen if all 20 million or more vacated America? The answers I found may surprise you!

In California, if 3.5 million illegal aliens moved back to Mexico, it would leave an extra \$10.2 billion to spend on overloaded school systems, bankrupt hospitals and overrun prisons. It would leave highways cleaner, safer and less congested. Everyone could understand one another as English became the dominant language again.

In Colorado, 500,000 illegal migrants, plus their 300,000 kids and grandchildren would move back "home," mostly to Mexico. That would save Colorado an estimated \$2 billion (other experts say \$7 billion) annually in taxes that pay for schooling, medical, social-services and incarceration costs. It means 12,000 gang members would vanish out of Denver alone.

Colorado would save more than \$20 million in prison costs, and the terror that those 7,300 alien criminals set upon local citizens. Denver Officer Don Young and hundreds of Colorado victims would not have suffered death, accidents, rapes and other crimes by illegals.

Denver Public Schools would not suffer a 67% dropout/flunk rate because of thousands of illegal alien students speaking 41 different languages. At least 200,000 vehicles would vanish from our gridlocked cities in Colorado. Denver's 4% unemployment rate would vanish as our working poor would gain jobs at a living wage.

In Florida, 1.5 million illegals would return the Sunshine State back to America, the rule of law, and English.

In Chicago, Illinois, 2.1 million illegals would free up hospitals, schools, prisons and highways for a safer, cleaner and more crime-free experience.

If 20 million illegal aliens returned 'home,' the U.S. Economy would return to the rule of law. Employers would hire legal American citizens at a living wage. Everyone would pay their fair share of taxes because they wouldn't be working off the books. That would result in an additional \$401 billion in IRS income taxes collected annually, and an equal amount for local, state and city coffers.

No more push '1' for Spanish or '2' for English. No more confusion in American schools that now must contend with over 100 languages that degrade the educational system for American kids. Our overcrowded schools would lose more than two million illegal alien kids at a cost of billions in ESL and free breakfasts and lunches.

We would lose 500,000 illegal criminal alien inmates at a cost of more than \$1.6 billion annually. That includes 15,000 MS-13 gang members who distribute \$130 billion in drugs annually would vacate our country.

In cities like L.A., 20,000 members of the '18th Street Gang' would vanish from our nation. No more Mexican forgery gangs for ID theft from Americans! No more foreign rapists and child molesters!

Losing more than 20 million people would clear up our crowded highways and gridlock. Cleaner air and less drinking and driving American deaths by illegal aliens!

America's economy is drained. Taxpayers are harmed. Employers get rich. Over \$80 billion annually wouldn't return to the aliens' home countries by cash transfers. Illegal migrants earned half that money untaxed, which further drains America's economy which currently suffers an \$8.7 trillion debt. \$8.7 trillion debt!!!

At least 400,000 anchor babies would not be born in our country, costing us \$109 billion per year per cycle. At least 86 hospitals in California, Georgia and Florida would still be operating instead of being bankrupt out of existence because illegals pay nothing via the [EMTALA Act](#) (see id of EMTOLA act at end of article). Americans wouldn't suffer thousands of TB and hepatitis cases rampant in our country - brought in by illegals unscreened at our borders.

Our cities would see 20 million less people driving, polluting and grid locking our cities. It would also put the 'progressives' on the horns of a dilemma; illegal aliens and their families cause 11% of our greenhouse gases.

Over one million of Mexico's poorest citizens now live inside and along our border from Brownsville, Texas, to San Diego, California, in what the New York Times called, 'colonias' or new neighborhoods. Trouble is, those living areas resemble Bombay and Calcutta where grinding poverty, filth, diseases, drugs, crimes, no sanitation and worse. They live without sewage, clean water, streets, roads, electricity, or any kind of sanitation.

The New York Times reported them to be America's new 'Third World' inside our own country. Within 20 years, at their current growth rate, they expect 20 million residents of those colonias. (I've seen them personally in Texas and Arizona; it's sickening beyond anything you can imagine.)

By enforcing our laws, we could repatriate them back to Mexico. We should invite 20 million aliens to go home, fix their own countries and/or make a better life in Mexico. We already invite a million people into our country legally annually, more than all other countries combined. We cannot and must not allow anarchy at our borders, more anarchy within our borders and growing lawlessness at every level in our nation.

*EMTALA -- Mandated and non-mandated care*<sup>[edit]</sup>

*Congress passed EMTALA to combat the practice of "patient dumping," i.e., refusal to treat people because of inability to pay or insufficient insurance, or transferring or discharging emergency patients on the basis of anticipated high diagnosis and treatment costs. The law applies when an individual has a medical emergency "and a request is made on the individual's behalf for examination or treatment for a medical condition."<sup>[1]</sup>*

*The U.S. government defines an emergency department as "a specially equipped and staffed area of the hospital used a significant portion of the time for initial evaluation and treatment of outpatients for emergency medical conditions."<sup>[9]</sup> This means, for example, that outpatient clinics not equipped to handle medical emergencies are not obligated under EMTALA and can simply refer patients to a nearby emergency department for care.<sup>[9]</sup>*

*An emergency medical condition is defined as "a condition manifesting itself by acute symptoms of sufficient severity (including severe pain) such that the absence of immediate medical attention could reasonably be expected to result in placing the individual's health [or the health of an unborn child] in serious jeopardy, serious impairment to bodily functions, or serious dysfunction of bodily organs." For example, a pregnant woman with an emergency condition must be treated until delivery is complete unless a transfer under the statute is appropriate.<sup>[9]</sup>*

*Patients treated under EMTALA may not be able to pay or have insurance or other programs pay for the associated costs but are legally responsible for any costs incurred as a result of their care under civil law.*

### **Non-covered medical conditions**

Not all medical problems are covered by EMTALA, meaning that a person cannot assume that if they are ill, they will be treated. Specifically, EMTALA does not cover non-emergency situations. The hospital is allowed to determine that there is no emergency, using their normal screening procedure, and then refuse EMTALA treatment <sup>[1]</sup>.

**The following is taken from the Board of Riley County Commissioners meeting minutes of the December 15, 2014 meeting. Riley County Commissioner Bob Boyd, who represents the Northern part of Riley County, wrote these comments.**

**PBC Process Comments**

**12.15.2014**

**By Bob Boyd**

**1.** Congratulations to the Riley County Commission and County Staff for completing this process. This detailed and arduous process began with a request for BOCC priorities in early 2013, advanced to an internal study of facilities needs and costs, then to a County leaders’ retreat where top priorities were determined and the need for a PBC to finance these priorities. The BOCC and staff developed a due diligence plan for financing county priorities, researching and educating themselves of all options available. The clear choice to finance the County’s priorities was to form a Public Building Commission.

**2.** To my fellow Commissioners, I apologize for the tumult, which we encountered at the public meetings. It was I who advocated strenuously for public input and rationale, which compelled us to conduct various public input sessions and two public meetings. We received input from a very small segment of our community and very little rationale at the two public meetings. My only defense for advocating such a process is that it was the correct course of action; public comment, no matter how irrational, no matter how small a cross-section of the population, is the right process to follow for public officials. We government leaders will never achieve the greater public participation in local government we desire, unless we adhere to a course of continual public

discussion on various subjects. We did receive several suggestions at various public sessions. We debated all and some we incorporated into the draft bylaws. Thank you to Joe Knopp and others who followed the process and made sensible, pragmatic suggestions.

**3.** The Public Building Commission decision was a conventional executive decision, typical of decisions made by elected bodies throughout our nation. The Riley County staff comprehended the reality of the situation the County faced long before the current Commission was seated; great needs which had been deferred for years and the limited ability of Riley County to finance such projects. Their tasking, as assigned by the BOCC, was to educate us, to research data and procedures, to seek out experts to address us and to do so in a balanced manner depicting the advantages and disadvantages. This they did most professionally. Commissioner Wells and I had many of the same initial hesitations citizens voiced in our Public sessions. Commissioner Lewis had encountered these concerns in prior years and was more advanced in his due diligence than we were. All of our concerns were addressed and given lengthy and deliberate considerations. Upon completion of our due diligence the course forward was evident; a public building commission was required. We debated the course forward and elected to proceed with public input sessions and public meetings. We also further researched the effectiveness of existing building commissions in Kansas, which confirmed the advantages of a building commission. We have concluded this process today and will move forward addressing Riley County priorities.

**4.** Thank you to Commissioner Dave Lewis and to Commissioner Ron Wells for seeing this process through at this time. To those who choose to criticize the timing of this decision, I say your criticism is disingenuous and trifling. Commissioner Lewis was elected to office after an arduous primary and general election. He swore an oath to serve all the citizens of Riley County, not just the majority of 17% of Republican primary voters of the most recent election. Elections do have consequences, as do terms of office.

**5.** For the second time in my life I have endured an irrational, fervent abhorrence of my associates and me. The first occasion of such abhorrence we veterans experienced upon our return from Vietnam. Then it was mostly younger ultra liberals who opposed the government's actions in Southeast Asia, but were ignorant of how the government functioned and how to affect change in society. Today such abhorrence is displayed in older, ultra conservatives who oppose local government actions, but are unaware of how government actually functions and how to affect change in society. Some who oppose government actions do so with a perception of government, which deviates from reality; rather they view government operating as they want it to be rather than how it actually functions. We see the same perception/reality errors when citizens encounter our judicial system, thus the need for lawyers to guide citizens through the system for equitable outcomes. In the Vietnam era, protesters wanted "... all to get along, live and let live." Today's harsh critics want a smaller, cheaper government of yesteryear with the services of tomorrow. The Vietnam era protest movement withered and died in the succeeding years mostly because the participants matured; they had families, mortgages, and jobs then became successful members of society. It also died from a lack of vision for America, at least one shared by more than a very small segment of society, and a plan to obtain that vision and deal with America's paramount issues. In short it died of lack of leadership. As America has evolved since Vietnam, we recognized the abhorrence displayed towards those who risked their lives in service to the nation was greatly misplaced and a regrettable portion of our history. Today's harsh critics will only grow older and require more government services and interaction with the institution they loathe, thus time will not necessarily blunt their objections to government. What will cause their criticisms to wither is their lack of vision for America, which appeals to most Americans. Most Americans recognize that the world and the United States are moving away from their vision of groups of isolated societies, self sustaining in all manner. How history will evaluate the abhorrence of today I cannot estimate. For me and my house, we will not let it diminish our love for this country and respect for our fellow man nor impede our service in its advancement.

**6.** I believe most citizens of Riley County, of Kansas and of the United States desire their governments to function responsibly in an effective, efficient, economical manner cooperating and coordinating with other governments and enterprises for the betterment and protection of their citizens. Our citizens expect their elected leaders to be executives of their government not caretakers of that government. We must insist our elected leaders be executives, analyze competing data and make wise choices for our future. They must have a vision for that future and articulate it to the citizens, then develop strategies to achieve that vision. It requires executive skills to navigate the realm of issues before us; from budget to elections to cash flow to mental health to road maintenance back to community health on to emergency preparedness to IT systems to community

corrections to tax appraisal to GIS to registering deeds, to museums on to waste transfer and noxious weeds. Life today is complex, family life is very complex and many of our citizens struggle to manage day to day, while some fail. Our government as an institution cannot solve these issues; however community leaders, including government leaders, can address these issues. Leaders all over America are working together to address a whole range of our issues making a difference from coast to coast. The citizens of today are tested in their daily management of life, they depend more heavily on their elected officials to be their executives; can we provide anything less?

Bob Boyd apologizes for the “tumult” encountered at the public meetings? What he doesn’t understand is the reason for “tumult” because the citizens of Riley County, the ones he represents, were angry because Bob Boyd WAS NOT/WOULD NOT consider the peoples’ feelings of having their “RIGHT TO VOTE” taken away from them. HE wanted public input – That is he wanted it until the public did NOT agree with him. He was elected to REPRESENT us, NOT RULE US. I am sincerely sorry Mr. Boyd and all Vietnam veterans were treated, as they were when they came home from that horrible war. There was NOTHING about that war the veterans had to be ashamed of and the way they were treated was a shame many Americans should apologize for. The troops in Vietnam were only and simply following orders and needed to be thanked and praised. I apologize to Bob Boyd for any and all bad treatment he received after serving in the Armed Forces in Vietnam. However, for, as he calls it – “an irrational, fervent abhorrence” at the public meetings on the PBC – he was treating the “public” just as he had been treated after Vietnam – and JUST AS UNJUSTLY!!! Mr. Boyd does not understand that what the Citizens at the public meetings were objecting to was THEIR RIGHT TO VOTE on the debts to be repaid BY those same citizens. They were not necessarily objecting to other aspects of the PBC, but objecting to NOT BEING able to vote on which debts they want to repay and which ones they wanted to avoid. What the Riley County Commissioners do NOT understand is that every need does NOT need to be filled by building a new building. **Alert: Support HB 2296!**

*Out of control government is not just in Washington D. C.; it is here in our local governments. Public corporations, known as Public Building Commissions, can enter into contracts to lease or rent properties to our local governments, creating huge amounts of debt without public consent. This, in actuality, puts a lean on our property without the right to vote. In many cases this will be indebting our children and grandchildren for up to 50 years or more.*

*The Public Building Commission, as currently defined in state statutes, is a useful tool for financing building projects without the constraints of the three per cent limit on general obligation bonds which govern bonded indebtedness in Kansas counties. These bond limitations were implemented in the 1930’s (KSA 10-306) and the PBC’s were created in the 1960’s (KSA 12-1757 thru 12-1770) as a way of bypassing those limitations. While we realize the spending limit of three percent of the assessed valuation of a county is an unreasonable limit in rapidly growing areas, we are opposed to having taxes levied on our property without the **right to vote** and with **no limits** on the amount of money that may be spent.*

*In KSA 12-1761, there is a provision which allows voters in cities with populations between 175,000 and 200,000 to vote on projects being funded with revenue bonds by the PBC. We propose striking the language that creates a special class for such cities, thereby giving all residents of the state the right to vote on projects being funded by the PBC. In order to avoid the problem of having to have elections on every small project, we propose a spending authorization, such as one or two percent of the assessed valuation of the county, before requiring an election. This would retain a useful financial tool while creating community consensus.*

## **TENNESSEE COP LETS MUSLIM DRIVE OFF WITH DEAD CHILD IN TRUNK**

Dead body in the trunk of your car? It's OK, if you are Muslim.

What would happen to most people if they were pulled over by the police for a traffic offense and in the course of the traffic stop, they announced there was a dead body in the trunk of the car?

At the very least, the police officer would order the driver to open the trunk so the officer could inspect the body. It could be a lot worse than that.

Unless you are in Tennessee and you are Muslim.

This happened in [Millersville](#), Tennessee, on Dec. 9. [Millersville](#) is a small town just north of Nashville. On Wednesday, a [Millersville police](#) officer stopped a vehicle on Interstate 65. The driver presented the officer a Saudi Arabian driver's license. Shockingly enough, a Saudi driver's license is valid in Tennessee.

Then the driver told the officer his child was dead in the trunk, and he wanted to go bury the child in accordance with his Muslim religion.

What happened next is absolutely shocking.

The officer asked to see the child and the driver refused because it was "against his religion." The police officer then let the driver go and reported the event to his superiors.

Can anyone imagine the scenario if the driver of the car had presented a Tennessee driver's license, announced there was a dead child in the trunk and told the officer he could not look in the trunk because it violated his beliefs as a Baptist?

The car disappeared. Police are looking for it and the driver.

Yesterday, I voted for new, principled, conservative leadership in the House of Representatives. Too bad, the insiders won.

When politically correct, tolerant, and culturally diverse societies agree to Muslim demands for their religious privileges, some of the other components tend to creep in as well. Here's how it works. So long as Muslim population remains under about 2% in any given country, they are for the most part regarded as a peace-loving minority, and not a threat to other citizens, although symptoms, episodes or disruptive events seen in other countries with greater Muslim populations are not unknown or even uncommon. [Such is the case in: United States — Muslim 0.6%; Australia — Muslim 1.5%, Canada — Muslim 1.9%, China — Muslim 1.8%, Italy — Muslim 1.5%, Norway — Muslim 1.8%](#)

At 2% to 5%, they begin to proselytize from other ethnic minorities and disaffected groups or individuals, often with major recruiting from the jails and among street gangs.

From 5% on, they exercise an inordinate & disproportionate influence out of step with their presence in the population. For example, demands for the introduction of halal (clean by Islamic standards) food, thereby securing food preparation jobs for Muslims. They will increase pressure on supermarket chains to feature halal on their shelves — along with threats of violence for failure to comply. [This is occurring in: France — Muslim 8%, Philippines — 5%, Sweden — Muslim 5%, Switzerland — Muslim 4.3%, Netherlands — Muslim 5.5%, Trinidad & Tobago — Muslim 5.8%](#)

At this point, Muslims work to get governments to allow self-rule (within their ghettos) under Sharia, the Islamic Law. The ultimate goal of Islamists is and has [always](#) been to establish worldwide Sharia law.

When Muslims approach 10% of the population, they increase lawlessness as a principle means of complaint about their conditions. In Paris, we see frequent car-burnings. Any non-Muslim action offends Islam and results in uprisings and threats, as in Amsterdam, with opposition to Mohammed cartoons and films about Islam. [Such tensions are seen daily, particularly in Muslim sections in: Guyana — Muslim 10%, India — Muslim 13.4%, Israel — Muslim 16%, Kenya — Muslim 10%, Russia — Muslim 15%](#)

After reaching 20%, nations can expect hair-trigger rioting, jihad militia formations, sporadic killings, and the burnings of Christian churches and Jewish synagogues, as seen in: [Ethiopia — Muslim 32.8%](#)

At 40%, nations experience widespread massacres, chronic terror attacks, and ongoing militia warfare: [Bosnia — Muslim 40%, Chad — Muslim 53.1%, Lebanon — Muslim 59.7%](#)

From 60%, nations experience unfettered persecution of non-believers of all other religions (including non-conforming Muslims), sporadic ethnic cleansing (genocide), use of Sharia Law as a weapon, and Jizya, the tax levied on infidels, as in: [Albania — Muslim 70%, Malaysia — Muslim 60.4%, Qatar — Muslim 77.5%, Sudan — Muslim 70%](#)
