## **Congresswoman Jenkins Calls For Criminal Charges To Be Brought Against Planned Parenthood**

**WASHINGTON, D.C.** – After a horrifying video of Planned Parenthood’s Senior Director of Medical Research Debra Nucatola was released yesterday, Congresswoman Lynn Jenkins (KS-02) sent a letter to Attorney General Loretta Lynch calling for an investigation into these actions and for criminal charges to be brought against Ms. Nucatola and Planned Parenthood for their violation of federal laws.

“The idea of making money from the sale of the tissue of an unborn baby is unconscionable,” **said Congresswoman Jenkins**. “Yet this horrific and heart wrenching practice was apparently treated as normal business in this appalling video. The practices discussed by a senior official from the central office of Planned Parenthood are clearly illegal and morally unjust. I sent a letter to Attorney General Lynch to immediately investigate these actions, and demand that criminal charges be brought against this sick violation of the law. It is now up to President Obama and HHS Secretary Burwell to stand up, denounce, and halt these disturbing practices. Life is too precious to be treated as a commodity.”

*This morning I received an update from Congresswoman Jenkins office as follows:*

Morning - After viewing the first video last Tuesday, **Conference Vice Chair Lynn Jenkins (KS-02) immediately sent a letter to Attorney General Loretta Lynch calling for an investigation into Planned Parenthood**, including Senior Director of Medical Research Debra Nucatola, the practices used at its affiliates, and the role the central office plays in allowing this practice to occur within the organization. Congresswoman Jenkins also called for criminal charges to be brought against Planned Parenthood and Ms. Nucatola.

*I received the following from Congresswoman Lynn Jenkins' Topeka Office:*

Yesterday afternoon Attorney General Lynch answered that call and said the Department of Justice (DOJ) will “review all the information and determine what steps, if any, to take.” **Congresswoman Jenkins issued the following statement after Attorney General Lynch announced DOJ will investigate Planned Parenthood:**

*“I am pleased to see Attorney General Lynch has heeded my call for an investigation into Planned Parenthood. As I said then, their clearly illegal, morally unjust actions must be investigated and all appropriate measures, including criminal action, must be taken against the responsible parties. I will not forget the unconscionable, horrifying words in these videos and I will continue to pressure the DOJ to do their job and prosecute this crime to ensure terrible actions like this never happen again.”*

I want to thank the Congresswoman’s office for keeping me informed. This incident is absolutely & completely horrifying to me. To start I don’t understand any woman being OK with the murder of her child, but then to “harvest parts” of that baby for profit or any other reason simply blows my mind. ## OBAMA PLEDGES TO USE LAST 18 MONTHS IN OFFICE PUSHING GUN CONTROL

President Obama on Thursday pledged to use his last 18 months in office to work on gun control, calling it "the one area where I feel that I've been most frustrated and most stymied."

"If you ask me where has been the one area where I feel that I've been most frustrated and most stymied, it is the fact that the United States of America is the one advanced nation on earth in which we do not have sufficient, common-sense gun safety laws – even in the face of repeated mass killings," he told the BBC in an interview.

"And if you look at the number of Americans killed since 9/11 by terrorism, it's less than 100. If you look at the number that have been killed by gun violence, it's in the tens of thousands," Obama continued.

"For us not to be able to resolve that issue has been something that is distressing, but it is not something that I intend to stop working on in the remaining 18 months."

In the U.S., at least 34 Americans have been killed in terror attacks since 9/11. Those attacks include the 2009 killing of 13 people at Fort Hood, Texas, the 2013 Boston Marathon bombing, and the Chattanooga, Tennessee shootings last week, which cost the lives of four U.S. Marines and a sailor.

Abroad, another 363 U.S. citizens have been killed in terror attacks since 9/11, according to data accumulated from State Department country reports on terrorism – or in years where data is incomplete, from the department's Bureau of Consular Affairs' record of citizens killed due to "terrorist action."

The annual breakdown of terrorist fatalities abroad is 24 in 2014, 16 in 2013, 10 in 2012, 17 in 2011, 15 in 2010, 9 in 2009, 33 in 2008, 19 in 2007, 28 in 2006, 56 in 2005, 74 in 2004, 35 in 2003 and 27 in 2002.

*These figures have nothing to do with Gun Control of United States citizens. Citizen guns have nothing to do with these killings. It has been shown most of these killings are committed by mentally ill & criminals. If Obama finds a way to prevent those people from having guns he won't have to take guns away from normal, healthy citizens. Perhaps we should have laws like Switzerland.*

## THE BLACK DILEMMA

"For almost 150 years the United States has been conducting an interesting experiment. The subjects of the experiment: black people and working-class whites.

The hypothesis to be tested: Can a people taken from the jungles of Africa and forced into slavery be fully integrated as citizens in a majority white population?

The whites were descendants of Europeans who had created a majestic civilization. The former slaves had been tribal peoples with no written language and virtually no intellectual achievements. Acting on a policy that was not fair to either

group, the government released newly freed black people into a white society that saw them as inferiors. America has struggled with racial discord ever since.

Decade after decade the problems persisted but the experimenters never gave up. They insisted that if they could find the right formula, the experiment would work, and concocted program after program to get the result they wanted. They created the Freedman's Bureau, passed civil rights laws, tried to build the Great Society, declared War on Poverty, ordered race preferences, built housing projects, and tried midnight basketball.

Their new laws intruded into people's lives in ways that would have been otherwise unthinkable. They called in National Guard troops to enforce school integration. They outlawed freedom of association. Over the protests of parents, they put white children on buses and sent them to black schools and vice-versa. They tried with money, special programs, relaxed standards, and endless hand wringing to close the achievement gap. To keep white backlash in check they began punishing public and even private statements on race. They hung up Orwellian public banners that commanded whites to Celebrate Diversity! *and* Say No to Racism. Nothing was off limits if it might salvage the experiment.

Some thought that what W.E.B. DuBois called the Talented Tenth would lead the way for black people. A group of elite, educated blacks would knock down doors of opportunity and show the world what blacks were capable of. There is a Talented Tenth. They are the black Americans who have become entrepreneurs, lawyers, doctors and scientists. But ten percent is not enough. For the experiment to work, the ten percent has to be followed by a critical mass of people who can hold middle-class jobs and promote social stability. That is what is missing.

Through the years, too many black people continue to show an inability or unwillingness to function and prosper in a culture unsuited to them. Detroit is bankrupt, the south side of Chicago is a war zone, and the vast majority of black cities all over America are beset by degeneracy and violence. And blacks never take responsibility for their failures. Instead, they lash out in anger and resentment.

Across the generations and across the country, as we have seen in Detroit, Watts, Newark, Los Angeles, Cincinnati, and now Ferguson, rioting and looting are just one racial incident away. The white elite would tell us that this doesn't mean the experiment has failed. We just have to try harder. We need more money, more time, more understanding, more programs, and more opportunities.

But nothing changes no matter how much money is spent, no matter how many laws are passed, no matter how many black geniuses are portrayed on TV, and no matter who is president. Some argue it's a problem of culture, as if culture creates people's behavior instead of the other way around. Others blame white privilege.

But since 1965, when the elites opened Americas doors to the Third World, immigrants from Asia and India, people who are not white, not rich, and not connected have quietly succeeded. While the children of these people are winning spelling bees and getting top scores on the SAT, black youths are committing half the country's violent crime, which includes viciously punching random white people on the street for the thrill of it that has nothing to do with poverty.

The experiment has failed. Not because of white culture, or white privilege, or white racism. The fundamental problem is that American black culture has evolved into an un-fixable and crime ridden mess. They do not want to change their culture or society, and expect others to tolerate their violence and amoral behavior. They have become socially incompatible with other races by their own design, not because of the racism of others - but by their own hatred of non-blacks.

Our leaders don't seem to understand just how tired their white subjects are with this experiment. They don't understand that white people aren't out to get black people; they are just exhausted with them. They are exhausted by the social pathologies, the violence, the endless complaints, and the blind racial solidarity, the bottomless pit of grievances, the excuses, and the reflexive animosity. The elites explain everything with racism, and refuse to believe that white frustration could soon reach the boiling point.

You can't legislate the poor into freedom by legislating the wealthy out of freedom. What one person receives without working for, another person **must work for without receiving**. The government can't give to anybody anything that the government doesn't first take from somebody else. When half of the people get the idea that they don't have to work because the other half is going to take care of them, and when the other half gets the idea that it does no good to work because somebody else is going to get what they work for, that my friend, is about the end of any nation. You cannot multiply wealth by dividing it.

Greetings,

This week, National Review declared that my discovery of the secret side deals that are at the very center of the Iranian nuclear deal was the [story of the week](#) and a Washington Post columnist named Me and Sen. Cotton [distinguished pols of the week](#). Whether Congress is able to stop this dangerous deal with the world's largest state sponsor of terror will actually be the story of our generation. Since Sen. Cotton and I brought this news to Congress's attention, the White House and State Department have come forward with many excuses as to why Congress wasn't informed of their existence. But their effort to "set the record straight" will never offer a good explanation as to why Ayatollah Khamenei knows what is in the secret side deals, but President Obama and Congress do not.

National Security Advisor Susan Rice said that the Iranian secret side deals [don't matter](#). Though she also has said that Bowe Bergdahl's service was honorable and the four Americans in Benghazi were killed because of a video. Secretary Kerry has said that the Iran deal is based not on trust, but on verification. But how can we verify a deal we can't see?

I had the chance to ask Sec. Kerry about the two secret side deals. He admitted he hasn't read the side deals, has no copy of them and yet he approved the Iran deal without knowing its details. In this meeting, Sec. Kerry offered to brief Congress on the complete contents of the two secret side agreements to the Iran nuclear deal. Sen. Cotton and I have since written a letter to Sec. Kerry, taking him up on this offer.

Sen. Cotton, House Speaker John Boehner, and Senate Majority Leader Mitch McConnell, and I sent a [letter to President Obama](#) requesting the two secret side agreements between the IAEA and Iran be provided to Congress. The details in these side agreements are not minor technical issues. They get to the heart of whether the deal can be verified. The first of the secret side deals is about inspections at the notorious nuclear test site – Parchin, Iran. The second of the side deals details the requirements for Iran to come clean on its past military activities related to nuclear weaponry. Every expert knows you cannot conduct useful inspections without knowing the history of Iran's actions. These agreements were among the last to be negotiated. They form one of the centerpieces of the deal.

Without access to these secret side deals, it is incomprehensible to me how a member of Congress could, in good faith say, "I understand the terms of this deal, I voted to approve it because I'm convinced that we now have a verification regime that will keep the Iranians from developing a nuclear program."

This is not partisan. The deal must rise or fall on its merits. I truly believe the vote on the Iran deal will be one of the single most important votes I will take as your Congressman.

The choice is not this deal or war. The choice is: do we grant the Ayatollahs relief from sanctions that threaten their grip on power or do we demand a deal that truly strips Iran of its capacity to build a nuclear weapon. That deal was achievable. It would have required leadership. We need Congress now to lead and I am optimistic that the American people, as they learn more about this deal, will demand that we do.

## A German's View on Islam – well worth reading

*This is one of the best explanations of the Muslim terrorist situation I have ever read. His references to past history are accurate and clear. Not long, easy to understand, and well worth the read. A man, whose family was German aristocracy prior to World War II, owned a number of large industries and estates. "My family lost everything. I ended up in a concentration camp and the Allies destroyed my factories.

"We are told again and again by 'experts' and 'talking heads' that Islam is a religion of peace and that the vast

majority of Muslims just want to live in peace. Although this unqualified assertion may be true, it is entirely irrelevant. It is meaningless fluff meant to make us feel better, and meant to somehow diminish the specter of fanatics rampaging across the globe in the name of Islam.

“The fact is that the fanatics rule Islam at this moment in history. It is the fanatics who march. It is the fanatics who wage any one of 50 shooting wars worldwide. It is the fanatics who systematically slaughter Christian or tribal groups throughout Africa and are gradually taking over the entire continent in an Islamic wave. It is the fanatics who bomb, behead, murder, or honor-kill. It is the fanatics who take over mosque after mosque. It is the fanatics who zealously spread the stoning and hanging of rape victims and homosexuals. It is the fanatics who teach their young to kill and to become suicide bombers.

“The hard, quantifiable fact is that the peaceful majority, the 'silent majority,' is cowed and extraneous. Communist Russia was comprised of Russians who just wanted to live in peace, yet the Russian Communists were responsible for the murder of about 20 million people. The peaceful majority were irrelevant. China's huge population was peaceful as well, but Chinese Communists managed to kill a staggering 70 million people.’

“The average Japanese individual prior to World War II was not a warmongering sadist. Yet, Japan murdered and slaughtered its way across South East Asia in an orgy of killing that included the systematic murder of 12 million Chinese civilians; most killed by sword, shovel, and bayonet. “History lessons are often incredibly simple and blunt, yet for all our powers of reason, we often miss the most basic and uncomplicated of points: peace-loving Muslims have been made irrelevant by their silence. “Peace-loving Germans, Japanese, Chinese, Russians, Rwandans, Serbs, Afghans, Iraqis, Palestinians, Somalis, Nigerians, Algerians, and many others have died because the peaceful majority did not speak up until it was too late.

“Now Islamic prayers have been introduced in Toronto and other public schools in Ontario, and, yes, in Ottawa, too, while the Lord's Prayer was removed (due to being so offensive?). The Islamic way may be peaceful for the time being in our country until the fanatics move in. In Australia, and indeed in many countries around the world, many of the most commonly consumed food items have the halal emblem on them. Just look at the back of some of the most popular chocolate bars, and at other food items in your local supermarket. ## **Is An Officer Who Returned Fire at the Chattanooga Recruiting Station Going to Face Charges?**

*A Navy officer and a Marine fired their sidearms hoping to kill or subdue the gunman who murdered five service members last week in Chattanooga TN, according to multiple military officials familiar with internal reporting on the tragedy.*

*It remains unclear whether either hit Muhammad Abdulazeez, who was shot and killed on July 16 after he gunned down four Marines and a sailor at the Navy Operational Support Center in Chattanooga. It's also unclear why they were armed, as it is against Defense Department policy for anyone other than military police or law enforcement to carry weapons on federal property.*

From there, people immediately began to worry that both would face charges. Those fears were stoked by a Facebook post by LTC (and former Congressman) Allen West.

**Ladies and gents, resulting from the text message I received yesterday, I can confirm that the United States Navy is bringing charges against Lt. Cmdr Timothy White for illegally discharging a firearm on federal**

**property.**

The text message asked if it would be possible for Lt. Cmdr White to reach out to me. To wit I replied, affirmative.

Would they prefer that Abdulazeez had been able to kill all the Marines and Sailors at the Naval Support Reserve Center? He deserves a medal, not an indictment,” Webb wrote on Twitter. “Before tweeting last night, we confirmed with a defense official that the Navy was seriously considering charging LCDR Timothy White. The charge being considered is illegally discharging a firearm on federal property. No on-the-record comment was offered.”

Now, as believable as it is, and I don't put anything by the military in this regard, it appears simply to be not true:

Navy Lt. Cmdr. Tim White has not been charged for firing his personal weapon at a lone gunman during the July 16 attacks on two military sites in Chattanooga, according to the Navy, despite weekend rumors that White had been charged for his actions.

The Navy denied that White has been charged in a statement on their official Facebook page on Saturday. The statement did not refute the claim that the Navy is planning to charge White.

“There is still a long way to go in reviewing the facts of this tragic incident, but at this time we can confirm no service member has been charged with an offense,” the statement read.

So here is my reading on it all. LCDR White clearly violated policy. Hard to even argue that. Easy to argue that the policy is idiotic and short sighted, but there is a policy, and it was clearly violated. So, LCDR *could* face some sort of judicial proceeding. But it is beyond my ability to believe that the Navy would be so stupid as to actually try and do something about it.
