TRUMP DECLARES 'NO MORE DACA DEAL, ' BORDER-CROSSERS WANT 'IN ON' AMNESTY

On Easter Sunday, President Trump announced he would no longer be pursuing a deal with the Republican establishment and Democrats to give amnesty to at least 1.8 million illegal aliens in exchange for a few pro-American immigration reforms.

In a series of tweets, Trump signaled a return to his “America First” immigration agenda, mentioning that he will no longer try to negotiate a deal between the GOP establishment and Democrats on the issue of giving amnesty to potentially millions of illegal aliens shielded from deportation by the President Obama-created Deferred Action for Childhood Arrivals (DACA) program.

“NO MORE DACA DEAL,” Trump wrote on Twitter, while also saying that Republicans “must go to Nuclear Option to pass tough” legislation that ends the “Catch and Release” program which releases border-crossers into the U.S. while they await trial:

Donald J. Trump @realDonaldTrump

Border Patrol Agents are not allowed to properly do their job at the Border because of ridiculous liberal (Democrat) laws like Catch & Release. Getting more dangerous. “Caravans” coming. Republicans must go to Nuclear Option to pass tough laws NOW. NO MORE DACA DEAL! 8:56 AM - Apr 1, 2018

The Catch and Release program was recently expanded with Trump’s signing of the omnibus spending bill with more illegal aliens set to be released this year into the interior of the country than the year before.

The “caravans” Trump mentions to in the Twitter post refers to the approximately 1,500 Central Americans who are traveling through Mexico and will soon reach the U.S. border where they will likely request refugee status in the country, as Breitbart Texas reported.

In another tweet, Trump threatened to take the U.S. out of the North American Free Trade Agreement (NAFTA)—where between 2000 and 2014, there have been about five million American manufacturing jobs lost—if Mexico did not crackdown on stopping migrants traveling through the country to take advantage of generous asylum and refugee laws in the U.S.

Trump reiterated in the tweet, “NEED WALL!” after the Republican and Democrat-passed spending bill he signed barred him from building his border wall:

What do you call 68 Democrats choosing not to participate in Government??

The students at Marjorie Douglas High School returned to school to enhanced security measures. Now, after weeks of demanding the government violate their rights, they are upset that the government has violated their rights.

ACCORDING TO THE HILL, a Marjory Stoneman Douglas High School student said the increased security measures her school is taking in the wake of February's mass shooting will make going back to school following spring break even more difficult.

"It feels like being punished...it feels like jail, being checked every time we go to school," said Isabelle Robinson, a senior at the Parkland, Florida high school. **Failing to grasp the hypocrisy in their actions** after demanding the government violates their rights and the rights of others who are completely innocent of the mass shooting, the students are now massively offended that they've had their rights violated.

"A lot of the people I've talked to are dreading going back," Robinson told CNN. "I'm not happy with it. Why are you punishing me for one person's actions?" Tyra Hemans, 19, a Stoneman senior, told CNN.

Earlier this month, millions of students across the country were encouraged by the Democrats, mainstream media, and even their own school systems to walk out of class and demand the government take away their rights. It was, by no means, a challenge of authority and, in fact, it was a celebration of it.

Schools across the country not only sanctioned it, but they supported it and actually punished those who chose to abstain. The walkout was little more than young people conforming to government authority by parroting the government-approved message in a government-approved venue—even at the government-approved time.

The message was simple: we want the government to take our rights away.

Young Americans across the country marched to demand less freedom from their rulers and the mainstream media, celebrities, and politicians alike shoved this down our throats as some grassroots heroic political activism. However, it was the opposite, and now even the cheerleaders of this movement, David Hogg, Emma Gonzalez, et. Al., are beginning to realize what happens when you beg the state to take away your rights. They take away your rights – *The Free Thought Project*.

When the Parkland students return this week to school after their spring break, they will be allowed only to carry clear backpacks on campus. In addition, students at the school will also be mandated to wear identification badges while in the school, according to a letter sent to families last month by Superintendent Robert Runcie. Florida Governor Rick Scott is also adding additional law enforcement officers to the school and the district is "exploring options for consolidating points of entry for students and staff to include utilizing metal-detecting

wands and potentially installing permanent metal detectors.”

Since the shooting, students have become vocal advocates for gun control, demanding that lawmakers pass new gun laws and violate the right of innocents to prevent future shootings. Now they've had their rights violated by the government and they don't seem to like it very much.

Maybe now these students may grasp how it feels to have their most basic fundamental human rights violated because someone else committed an atrocity. Perhaps this will be the wake-up call needed, however, we wouldn't count on it. Hypocrisy runs deep and when it comes to the violation of rights, most Americans just don't care until it happens to them.

It shouldn't – In my opinion those students were convinced they needed special protection – I'm not disagreeing with that point, however, they did NOT want to be controlled/told what they can and can not do. LAWMAKERS VOCALIZE HOPES OF SHOVING PEOPLE OF FAITH OUT OF PUBLIC LIFE

April 2, 2018

Yes, some lawmakers do want to drive faith-based organizations out of the public sphere. The debate over the Adoption Protection Act revealed they're coming for churches. They're coming for hospitals. They're coming for the YMCA and private colleges or any organization founded on religious principles.

Until they began debating the Adoption Protection Act, most legislators steered clear of saying out loud that they wished people would relegate their religious practices to a back closet in their homes—never to see their faith put into action in the outside world. But it's not a secret anymore, after 16 Kansas senators voted in favor of an amendment that would strip any government funds from faith-based adoption agencies. The apparent hostility to religion was displayed more broadly in the Kansas House, where 64 House members opposed the current practice of allowing faith-based agencies to operate according to their faiths.

Senate President Susan Wagle said the prejudice Senators displayed towards Catholics was “extremely disappointing.”

“The faith that houses, clothes, feeds and provides health care to people all over the world was referred to as ‘sick’,” Wagle said.

Yes, Sen. Barbara Bollier used the word “sick” to refer to the tenets of Catholicism during Senate debate. The newspapers lauded her for it. In the future, other Senators are likely to view religious hostility as a way to reap glowing praise from papers. Bollier's comments fully exposed why the Adoption Protection Act is necessary.

It's important to note faith-based adoption agencies do not receive taxpayer money for placing children for adoption. That requires repeating: No faith-based adoption agencies in Kansas receive state funding for adoption placement services. They do not, and they have not. The agencies the state contracts with for foster placements are exempt from protections offered to faith-based organizations under the Adoption Protection Act. Organizations with state contracts do not receive the same protections as faith-based organizations under the proposal.

Though faith-based agencies don't receive government funds for adoption placements, they do sometimes receive fees from the state for other services, just like any other business in the state.

A fee for service works like this: Let's say a state agency needed to provide food for a staff luncheon, and they hire the catering services of a provider that conducts business according to a faith. Perhaps, the catering operation offers

kosher meals. If the state agency plans to serve bacon cheeseburgers at the event, they're unlikely to hire a kosher catering service. However, if the state agency orders something the kosher caterers offer and the caterers deliver, the agency will pay the caterers using taxpayer funds, or money in their budget. Whether the cooks pray before they cook or only use kosher products is not relevant to the final transaction.

Similarly, faith-based adoption agencies may be contracted to conduct home studies for placing children in foster care, for example. These include determining whether there are enough bedrooms in a potential placement home, whether the potential parents have the resources to provide for a foster child, whether they're prepared to accept a child into their homes, as well as background checks. A faith-based organization sometimes performs home studies, for which they may receive a payment for that service from the state.

Faith-based organizations are under attack through lawsuits and legislation in other states. They've been denied licenses to operate, sued, or forced to offer services counter to their beliefs. Many have closed their doors. In the aftermath, fewer children find forever homes, but the ACLU gets a victory. The primary losers are children in need of loving families.

During committee hearings on the preemptive legislation, Kansas lawmakers learned how many private adoptions work. They heard the story of [Cara DeCoursey](#). When she was a teenager, DeCoursey used a Catholic adoption agency 28 years ago when she faced an unplanned pregnancy. She wanted to give her baby the best life possible, and for the then-teenager, that meant placing her baby in a loving home headed by a Catholic mother and father.

"I was born and raised Catholic, and this is what I wanted for my son," she told one committee.

Those who oppose faith-based agencies would rip that option from her, stripping a loving, selfless birth mother of the right to make a choice for a child she sacrificed to bring into the world.

Opponents of the Adoption Protection Act offered breathless testimony warning that the status quo denies the rights of some individuals to adopt. Many of the opponents were adoptive parents who didn't meet the guidelines of some faith-based agencies. Most were same sex couples who were able to adopt in Kansas. These prospective parents weren't denied the opportunity to grow their families, despite the continued existence of faith-based agencies. The Adoption Protection Act wouldn't change that in the future.

The debate on the Senate floor, however, devolved into attacks on people of faith. That should strike fear into the hearts of all people. In a wanton display of religious bigotry, Sen. Lynn Rogers proposed revoking any taxpayer monies—even fees for services—for faith-based agencies.

A few months ago, Trump drew ire when he suggested cutting retirement benefits and reducing weekly mail delivery in order to help get the struggling agency back under budget.

WHATEVER THE LEFT TOUCHES IT RUINS

The only way to save Western civilization is to convince more people that leftism – not liberalism – is a nihilistic force. Quite literally, whatever the left touches it ruins.

So, here is a partial listing of the damage done by the left and the Democratic Party: The most obvious – and, therefore, the one more and American can resonate with – is the near destruction of most American universities as places of learning. In the words of Harvard professor Steven Pinker – an atheist and a liberal – outside of the natural sciences and a few other disciplines (such as mathematics and business), “universities are becoming laughing stocks of intolerance.”

If you send your children to a university, you are endangering both their mind and their character. There is a real chance they will be more intolerant and more foolish after college than they were when they entered college.

When you attend an American university, you are taught to have contempt for America and its founders, to prefer socialism to capitalism, to divide human beings by race and ethnicity. You are taught to shut down those who differ with you, to not debate them. And you are taught to place feelings over reason — which is a guaranteed route to eventual evil.

The left has ruined most of the arts. The following three examples are chosen because they are scatological, a favorite form of left-wing artistic expression. Before the left poisoned the arts, art was intended to elevate the viewer (or listener). But to the left, “elevate” is a meaningless term; it is far more at home depicting urine, fecal matter and menstrual blood.

In 2011, a lifelike German sculpture depicting a policewoman squatting and urinating — even the puddle is sculpted — received an award from a prestigious German foundation, the Leinemann Foundation for Fine Art.

In 2013, the Orange County Museum of Art in California placed a huge 28-foot sculpture of a dog outside the museum, where it periodically urinates a yellow fluid onto a museum wall.

In 2016, one of the most prestigious art museums in the world, the Guggenheim in New York, featured a pure-gold working toilet bowl, which visitors were invited to use. The name of the exhibit was “America” — so one could literally relieve oneself on America.

Thanks to the left, The Philadelphia Orchestra, one of the greatest orchestras in the world, allowed itself to become of a voice of leftist hate last week. It featured the premiere of Philadelphia Voices, “a political rant put to musical garbage,” as some musically knowledgeable Philadelphians described it to me. In the fifth movement, titled “My House Is Full of Black People,” the black teen narrator chants the following lines: “The county is full of black people/ All wanting to be heard/ While old white men draw lines on maps/ To shut all of them up.” Later in the movement, he yells, “If you would all just f—ing listen!”

Uplifting, no?

On the left, that’s considered art.

And, of course, such politicization of the arts is accepted as the norm.

Indeed, that’s part of the left’s poisoning of everything — its politicization of everything.

The left is increasingly poisoning sports. In most football stadiums this past season, one could not attend an NFL game without being subjected to left-wing contempt for America and its flag.

So, too, one cannot watch late-night television if one desires to simply be entertained before drifting off to sleep. Jimmy Kimmel, Stephen Colbert and other hosts have changed late-night TV into left-night

The left has poisoned mainstream religion. Mainstream Protestantism, non-Orthodox Judaism and much of the Catholic Church — including and especially Pope Francis — are essentially left-wing advocacy groups with religious symbols.

The left is destroying the unique American commitment to free speech. Almost half of incoming college freshmen do not believe in free speech for what they deem “hate speech” (merely taking issue with a left-wing position is, in the left’s view, “hate speech”). They do not understand that the whole point of free speech is allowing the expression of opposing ideas, including what we consider “hate speech.”

The left has poisoned race relations. America is the least racist multiracial society in the world. On a daily basis, Americans of every race and ethnicity get along superbly. Here is a quick summary of the day I sent someone:

So last Saturday morning we show up at the Capitol and the conservative caucus calls a meeting at 9:30 am. At the meeting we are told that the Senate's school finance bill will be run on the House Floor and get gutted and replaced by a modified House school finance bill.

We went into Republican caucus at 9:45 and were told a similar story.

At 10 am we went on the House Floor and, after about an hour of mellow debate, the bill passed with 63 votes (the exact number it needed). I voted against the bill.

About 10 minutes before the vote we all received an email with a 2 page summary of the bill. That is the written information we received on the amended bill.

All day long there were about a hundred KNEA red-shirted activists lining the halls, cheering the legislators who they like as they walk through the lines.

The Senate passed it at 12:20 am Sunday morning with 21 votes (the exact number needed).

And yesterday, the KS Assoc. of School Boards sent out an email saying there was an error in the bill that would cause schools to receive about \$80 Million less than what the bill actually said.

A BIG STEP TOWARD REAL WELFARE REFORM

Work requirements for welfare go a long way to lifting people out of the cycle of dependency.

President Donald Trump signed an executive order this week entitled “Reducing Poverty in America by Promoting Opportunity and Economic Mobility,” and House Republicans unveiled the 2018 Agriculture and Nutrition Act, the \$844 billion farm bill. Both items focus on getting people working and off of welfare. No wonder the stats are angry. As Investor’s Business Daily put it, “If increased dependence on the federal government is your goal, anything that moves in the opposite direction is a bad thing.”

Trump recently said, “I know people that work three jobs and they live next to somebody who doesn’t work at all. And the person who is not working at all and has no intention of working at all is making more money and doing better.” The president thereby expressed the sentiment of millions of Americans who are willing to take on an extra job to pay the bills rather than be on the public dole but are frustrated by those who benefit from another choice.

But haven’t we done this before? What about the welfare reform efforts of Newt Gingrich and Bill Clinton in 1996?

Barack Obama effectively undid that good work by directing the Department of Health and Human Services to dismantle the work requirement for welfare recipients in 2012. Last year, President Trump ordered HHS to reinstate that work mandate.

But the president isn’t stopping there. The administration announced that states will be able to include work requirements for Medicaid and require SNAP recipients to work after three months of benefits. Additionally, tougher requirements for those receiving assistance under the Temporary Assistance for Needy Families program are being considered, as well as mandating weekly work hours for recipients of housing benefits.

Presidential domestic policy council director Andrew Bremberg says, “Part of President Trump’s effort to create a booming American economy includes moving Americans from welfare to work and supporting and encouraging others to support common-sense reforms that restore American prosperity and help them reclaim their independence.”

Helping people to reclaim their independence isn’t a novel idea, but it’s one that politicians reflexively push aside in favor of government programs that merely perpetuate a **caste system** in which people born into poverty have no way out.

And that’s the real difference in President Trump’s approach to welfare reform. While other presidents have talked about the need to address poverty, the Trump administration seems to realize that the only way to make a real difference in the lives of the poor is to create real jobs and implement pro-growth economic policies.

Naturally, critics of welfare reform or welfare-to-work policies claim that reducing government benefits, or suspending them altogether after a period of years, places a burden upon those unable to support themselves with a good job. Indeed, once millions of people receive regular assistance from the government, breaking the cycle of dependency creates a burden.

Yet the burden becomes greater when politicians force American jobs overseas, make it harder for small businesses to thrive, and leave some of the most vulnerable populations in our country, including blacks, more

likely to fall into poverty.

To those asking whether welfare-to-work policies actually work, Republican Gov. Sam Brownback of Kansas implemented a program four years ago known as Temporary Assistance for Needy Families. The result was that the number of Kansans on welfare decreased by 17,000, and within two years those who were employed had more than doubled the amount of income they had been receiving on welfare.

For all the critics of welfare reform, the new approach doesn't eliminate the government's helping hand. Kristina Rasmussen, vice president of federal affairs at the Foundation for Government Accountability, [stated](#), "By strengthening the work requirement for able-bodied adults on food stamps and approving states' waivers for Medicaid work requirements, agencies can ensure that resources are preserved for the truly needy."

And that's what we're really talking about here: helping those who really need it. Others who are able to work and earn a living should be encouraged to do so, but no one is suggesting that people unable to fend for themselves be neglected. The difference is that the Trump administration seems poised to take a serious look at free-market solutions to the problems government can't solve.

While care should be taken to shore up the safety net, a healthy society and its government should encourage people to break free from dependency and become productive, self-sufficient citizens.

President Trump's executive order is a serious first step in weakening the Left's class-warfare rhetoric, empowering people to gain independence, and creating a society that's great not because of government handouts but because of government getting out of the way.

I remember when I was a kid of hearing my parents talking of a "Government" program that gave people money to live on for a short period of time until they could find a "job" to support themselves. Then my Father lost his job, but there was NO WAY he was going to take money from the Government to pay our bills until he got another job. He worked 3-4 part time jobs until he could secure a full time one, but there was NO WAY he was going to take "government" money. Very few of those on "Government money" think of it that way. But another way to think of it is – all Government money is really money belonging to the citizens. After all where is the Government get it?? There is no shame of being on "government" money for a short time, but to live that way all or most of your life is NOT good. Think about it – Sounds like President Trump is headed in the right direction.
