# Turnaround Day Has Passed

## *Carlson's Committee Can Still Work On Bills*

The Legislature is quickly reaching the halfway point of the 2011 session – commonly known as turnaround

The official turnaround deadline is Friday, Feb. 25. In order to be considered for the remainder of the session bills introduced in the House must be passed before Friday while those not passed will be considered dead for the remainder of the session.

However, a select group of bills are exempt from the deadline and work on those pieces of legislation can continue after turnaround, even if not passed out of the House My Taxation Committee is one of the exempt committees so I can hear new bills all session. Post turnaround, our primary focus will be on legislation, which passed the Senate.

### **Workman's Compensation**

On Wednesday, the House debated HB 2134, which revises portions of the Workers Compensation Act. The first piece of workers compensation legislation was adopted in Kansas over 100 years ago to ensure the care of injured workers while also protecting employers. However, 17 years have passed since the existing statutes were revised and court action dictated the need for updating workers compensation law in Kansas.

HB 2134 is the work of labor and business interests who negotiated the main provisions of the bill to ensure its fairness for employers and employees. I supported the bill as I felt the compromises were fair to both employers and employees.

HB 2134 reinstates the \$75,000 functional impairment cap and raises the permanent partial and total caps by \$30,000 while increasing death benefits from \$250,000 to @300,000. The measure clarifies that employers are only responsible for injuries experienced while at work and protects them from civil litigation. Bill provisions allow employees to collect compensation for work related injuries without needing to prove the fault of negligence of their employer HB 2134 raises the threshold required for monetary payment from an accident by removing opportunities for multiple permanent total disability claims, creating new qualification standards for work disability and clarifying injury reporting requirements.

### **Illegal Immigrant Tuition**

In 2004 the Kansas Legislature passed legislation establishing statutory criteria for determining the eligibility of illegal immigrants to qualify for in-state tuition and fees at Kansas post secondary institutions.

Current law allows such student to qualify for in-state tuition if they attended an accredited Kansas high school for three or more years; graduated from a Kansas high school or obtained a Kansas, GED certificate; have been accepted to a Kansas post secondary institution and have filed an affidavit stating they have begun the process of legalizing their immigration status, are working to become a U.S. Citizen or their parents have filed for such applications.

House bill 2006 would repeal the above provisions allowing illegal immigrants to be considered in-state residents for the purposes of paying fees and tuition at Kansas post-secondary institutions. The bill declares anyone unlawfully present in the United States is not a resident of Kansas and is prohibited from receiving in-state fees and tuition at any Kansas postsecondary institution. Debate on this legislation was scheduled for Monday, February 21.

I have voted to repeal the in-state tuition in the past for illegal immigrants and will continue to support that position. I will vote in favor of HB 2006.

## ***Carlson Describes Contents of Several Bills***

### **Late Term, Partial Birth Abortions**

House Bill 2035 places further restrictions on late term abortion procedures, expands parental consent requirements for minors seeking abortions and strengthens the state's partial birth abortion law to where it better aligns with lighter federal law. This particular measure is a combination of legislation passed during prior sessions that was vetoed by democratic governors Sebelius and Parkinson.

Key provisions: of the bill:

- Requires a specific medical diagnosis for a late-term abortion to occur.
- Requires women seeking abortions to be provided with information that states they procedure will terminate the life of a human being.
- Allows for civil lawsuits against doctors who violate late-term abortion law.
- Mandates additional reporting of sex abuse evidence on minors wanting an abortion.
- Clarifies when courts can bypass parental consent requirements.

On Thursday, February 24, the House passed HB2035 by a vote of 96 to 25 and I voted in favor of the bill.

### **Fetal Pain Abortion Regulations**

**House Bill 2218** enacts new restrictions on certain late term abortions by adding provisions addressing the ability of an unborn child to feel pain. I also supported this bill.

### **Voter Identification**

The secure and Fair Election (SAFE) Act. Contained in House Bill 2067, was another bill I supported and it requires all Kansas voters to show photo identification before voting, requires proof of citizenship when registering to vote, and extends the power to prosecute alleged cases of voter fraud to the Secretary of State's office. At the polls, voters must show government issued photo ID before casting their ballot. The measure requires voters who request an advance or main-in ballot must include their driver's license number or a photocopy of their ID with their ballot application.

The bill strengthens the penalties for voting without being qualified, voting multiple times during the same election, for tampering with elections, falsely impersonating another voter and for illegally handling advance ballots.

Opponents argue the measure is a modern day poll tax that disenfranchises the disabled, poor and elderly. In response, current provisions in the bill allow low-income Kansans to get a free ID or birth certificate if they reside in a household with an annual income of 150% of the federal poverty level (approximately \$33,000 for a family of four). For residents over the age of 65, an expired driver's license or photo ID can be used in lieu of a current form of photo ID.

On Friday, February 25, the House passed HB 2067 by a vote of 83 to 36.

### **Union Contributions to PACs**



**House Bill 2130**, known commonly as paycheck protection – helps ensure labor, public employee and professional employee union members’ wages are not automatically withheld for political contributions. Current law permits these organizations to use paycheck deduction for the political activities. The bill changes that law to give union members the freedom to chose how they would like their contribution to be spent. Union members still have the option of donating funds through personal payments to union PAC activities. If the union uses an employee’s paycheck deduction improperly, the bill allows the employee to sue the union for damages.

If workers want their financial support to go to a political candidate, they are still given the opportunity to direct their money to that respective candidate. If workers would like their funds to go towards negotiations or other union activity, then those dollars must be specifically directed to those endeavors.

This was certainly our most explosive issue this week, with union workers arriving at the Capitol to protest the final action vote Thursday. While spirited dissent and thorough debate has always been a cornerstone of our democratic process – some of the tactics employed this week by the unions during their visit crossed the line of civility and rational dissent. Regardless, the bill easily cleared the House, and I trust you will hear more on the issue as the Senate considers the bill. This type of coercion by a few is precisely why I supported this bill. All Kansans, whether union members or not, deserve the states protection from coercion from their union or employer.

*(Editor’s note: The lobbyist that “crossed the line of civility and rational dissent” was taken from the House and will NOT be permitted back during this session.)*

On Thursday, February 24, the House passed HB2130 by a vote of 75 to 46.

### **NAF Funding Resolution**

Senate Concurrent Resolution 4605 urges the United States Congress to fund the construction of the National Bio and Agro-defense Facility (NBAF) in Manhattan, The concurrent resolution also encourages the Department of Homeland Security to advance the sale of the Plum Island Animal Disease Center so the proceeds of that sale can be directed to assist with the funding of NBAF.

SCR 1605 passed the Senate with a unanimous voice vote on Thursday, February 24. The House passed SCR 1605 on Friday, February 25 by a vote of 119 to 0. I am hopeful the federal government funds the construction of NBAF quickly. This facility will bring hundreds, if not thousands, of good paying and stable jobs to Kansas.

### Legislative Report 3-18-2011

Last week the House passed H.Sub SB 1, March to Economic Growth Act (MEGA) which will significantly change the direction of Kansas tax policy toward one of pro-growth and over a period of years will allow Kansas to join the high growth states which have no income tax. While it has passed the House, we now will see what the Senate does.

House Speaker, Mike O’Neal , a Republican from Hutchinson, said it will create an atmosphere in the state that’s conducive to genuine growth, instead of imposing high taxes on Kansas residents.

“Some of us want to earn revenue the old fashioned way, by earning it rather than going to an existing tax base and continuing to increase their taxes,” O’Neal said. “We’re wanting to grow the pie bigger, reduce the tax burden on those that have already chosen to make Kansas their home.” Quote: Kansas [Reporter.com](#)

Quotes from the Wichita Eagle: "Income tax does not get cut by a dime until revenues increase," said Taxation Committee Chairman Richard Carlson, R-St. Marys."There's very little risk to the state," added Rep. Kasha Kelley, R-Arkansas City. "If we don't grow, we don't reduce."

The MEGA bill reduces the corporate and individual income tax with a trigger based on growth. If state tax receipts increase over the immediately preceding fiscal year, then a corresponding reduction in both taxes will

occur. The overall goal of this bill is institutional change that will shift to more consumption (sales) taxes and less production (income) taxes. The House is committed to collecting Kansas tax revenue by growing the economy rather than increasing the tax rate on current revenue streams. By providing a consistent and less complicated tax structure, this bill limits the role of state government and fosters business growth and investment. People vote with their feet. From side-by-side comparisons we know that states without individual income tax experience population and revenue growth at a consistently higher rate than states with high rates.

Kansas experienced a net out-migration of over 17,000 workers during the last ten years. Kansas Government cannot sustain even the present levels of service to our citizens if we do not increase our tax base through additional growth of revenues. Any additional expenditures in future years, be it for our disabled, Medicaid recipients, or our public school system can only be funded two ways: increased revenues or higher taxes. If government wants more of something, it taxes it less, if it wants less of something it taxes it more. Government has the history of doing it in exactly the opposite manner. For years, Kansas economic growth has lagged behind most of midwestern neighbors, H.Sub SB1 will begin to reverse that trend, encouraging business leaders from across the nation to consider Kansas as the destination headquarters for companies wishing to expand and create more high paying jobs for our workers. Reducing the tax burden on productive income and capital investment allows more cash to be invested in our Kansas economy, broadening the tax base and increasing total revenues to state and local governments.

It is often quoted Kansas needs to retain the three legged stool of tax policy. Equal amounts of Income, property and sales taxes. 100 years ago this made some sense when the total tax burden on our citizens was very small. Today the three legged stool needs to be updated, taxes have become a burden on our productive society. Tax policy in Kansas will influence where capital will invest and jobs are created. A pro-growth stable tax policy needs to be adopted, H.Sub SB 1 does just that.

President Reagan proved without a doubt the revenue pie is not static. Reducing productive taxes (income & capital) will spur economic growth and expansion of revenues, creating a larger pie, whereby both government and the citizens' benefit. All sectors of the economy grow, both private and public, without increasing the tax burden upon its people. President Reagan's pro-growth tax policy created the longest lasting economic boom America has seen in recent memory.


Creating jobs for 100,000 unemployed Kansans through a pro-growth economic policy is our highest priority. Destroying jobs in the private sector with a tax increase is not an option. H.Sub SB 1 will begin the march to pro-growth, making Kansas look less like California and more like Texas. People talking with their walking out of Kansas needs to stop, staying in Kansas and growing in Kansas with a pro- growth tax policy simply makes good common sense.

# The Bankers Manifesto of 1892

**Revealed by US Congressman Charles A. Lindbergh, SR from Minnesota before the US Congress sometime during his term of office between the years of 1907 and 1917 to warn the citizens.**

“We (the bankers) must proceed with caution and guard every move made, for the lower order of people are already showing signs of restless commotion. Prudence will therefore show a policy of apparently yielding to the popular will until our plans are so far consummated that we can declare our designs without fear of any organized resistance.

The Farmers Alliance and Knights of Labor organizations in the United States should be carefully watched by our trusted men, and we must take immediate steps to control these organizations in our interest or disrupt them.

At the coming Omaha Convention to be held July 4<sup>th</sup> (1892), our men must attend and direct its movement, or else there will be set on foot such antagonism to our designs as may require force to overcome. This at the present time would be premature. We are not yet ready for such a crisis. Capital must protect itself in every possible manner through combination (conspiracy) and legislation.

The courts must be called to our aid, debts must be collected, bonds and mortgages foreclosed as rapidly as possible.

When through the process of the law, the common people have lost their homes; they will be more tractable and easily governed through the influence of the strong arm of the government applied to a central power of imperial wealth under the control of the leading financiers. People without homes will not quarrel with their leaders.

History repeats itself in regular cycles. This truth is well known among our principal men who are engaged in forming an imperialism of the world. While they are doing this, the people must be kept in a state of political antagonism.

The question of tariff reform must be urged through the organization known as the Democratic Party, and the question of protection with the reciprocity must be forced to view through the Republican Party.

By thus dividing voters, we can get them to expand their energies in fighting over questions of no importance to us, except as teachers to the common herd. Thus, by discrete action, we can secure all that has been so generously planned and successfully accomplished.”

## Fleming Health Care Repeal Update

### The New Health Care Reform Law One Year Later & Getting Worse by the Day

Today, on the one year anniversary since government-approved health care was signed into law, a look at the implementation of the new health care reform reveals how the legislation has failed to deliver on costs, premiums, spending and preserving Americans' existing coverage:

**19** – States where parents can no longer buy child-only insurance policies as a result of the law.

**30** – States suing to block the law from taking effect, or requesting waivers from its requirements.

**51** – Percentage of American workers who will lose their current health coverage by 2013, according to the Administration’s own estimates.

**1,270** – New bureaucrats requested the the Internal Revenue Service to implement th law this year.

**\$2,100** – Increase in individual insurance premiums due to Obamacare, according to the Congressional Budget Office.

**\$2,500** – Premium reduction promised by candidate Obama “by the end of my first term as President”

**6,578** – Pages of new regulations issued implementing Obamacare through March 14, 2011.

**800,000** – Reduction in the American labor force due to Obamacare provisions that “will effectively increase marginal tax rates, which will also discourage work,” according to the CBO.

**2,624,720** – Total individuals in 1,040 plans granted waivers thus far exempting them from the law’s insurance mandates; nearly half of whom participate in union plans.

**7,400,000** – Reduction in Medicare Advantage enrollment as a result of Obamacare, resulting in a loss of choice for seniors and millions of beneficiaries losing their current health plan.

## [Stop Sending Jobs Overseas](#)

Today, the Labor Department released its [monthly jobs report](#) showing that the U.S. economy added 216,000 jobs in March and unemployment fell to 8.8 percent. Despite these encouraging numbers, Americans still consistently tell pollsters that [jobs and the economy are the most important problems facing the country](#). And yesterday, Gallup [released a poll](#) showing that the number one way Americans would like to see more United States jobs created is to stop sending new jobs overseas. That is a fabulous idea, and the simplest way to accomplish it would be to lower our nation's corporate tax rate.

The United States was once a leader in tax rate reduction. In 1981, President Ronald Reagan passed a [broad tax cut package](#) to encourage economic growth. How well did it work? Just compare the drops in unemployment from both the Reagan and the Obama economic recoveries. Since the Obama recovery began 21 months ago, the national unemployment rate has fallen only 0.6 points, from 9.4 percent in July 2009 to 8.8 percent today. Contrast those anemic results with the robust job growth that occurred during the Reagan recovery in the '80s. By the 21-month mark of the Reagan recovery, unemployment had dropped from 10.8 percent to 7.5 percent—a 3.3 point drop.

And Reagan didn't stop there. In 1986 he went on to [lower the federal corporate tax rate from 46 to 34 percent](#). The results speak for themselves: when Reagan left office in January 1989, the nation's unemployment rate was just 5.3 percent. The world not only noted Reagan's success but then went on to copy his successful tax cutting policies. In 1989 the developed nations in the Organization for Economic Cooperation and Development (OECD) had an average top marginal corporate tax rate well above the U.S.'s

34 percent rate. [Since that time the world's industrialized nations have dropped their average corporate tax rate to about 25 percent.](#) The U.S., meanwhile, has gone in the opposite direction. We now have a 35 percent rate at the federal level that rises to 39 percent once the average of state corporate taxes are mixed in. And today, Japan is scheduled to implement its own corporate rate reduction, which will officially make our 35 percent rate the highest corporate tax rate in the world.

Owning the world's highest corporate tax rate is a job killer. Imagine you are a global corporation looking to invest in a new factory that will produce goods for American consumers. Do you build your factory with hundreds of new manufacturing jobs in Canada, where [the top central government tax rate is 16.5 percent?](#) Or do you choose a location in the United States, where the top tax rate is 35 percent? Is that even a choice? Our high corporate tax rates are a huge manufacturing job repellent.

Liberals have long argued that [corporate tax cuts are not necessary](#) since the effective corporate tax rate (calculated by dividing the amount businesses pay in taxes by their incomes) is comparable to other OECD countries. But gaming the tax system to reduce your effective tax rate is not free. It requires a substantial investment in tax lawyers and lobbyists for major corporations to get your tax bill down. So again consider a foreign investor or medium-size corporation looking to expand production. Neither of the firms has the tax lawyers and lobbyists needed to lower their effective tax rate. Do they choose low-tax Canada, where they can focus on their core business and pay low taxes? Or do they choose the U.S., which requires significant resources devoted to tax law compliance and lobbyists in Washington to assure a low tax rate? Again, is this even a choice?

The U.S. economy is slowly beginning to finally add jobs to the economy. But so is the rest of the world, and many economies are growing much faster. If we want to stay competitive, if we want to stop sending jobs overseas, we must lower our corporate tax rate.

## ***Mary Pilcher Cook, State Senator on Stopping the Spend Trend***

First of all, I want to thank you those of you who attended the first Mondays with Mary meeting last evening. It was a diverse crowd, with people from many walks of life, including a health insurance underwriter, a teacher, a doctor and businessmen – all very important to our economy and our way of life. It gave me an opportunity to listen to several views and I truly appreciated the questions!

As "Turnaround" approaches in Topeka, the debate is increasing in the legislature about how to reduce spending and bring fiscal responsibility back to state government. With a Governor and a strong majority in the Kansas House committed to budgetary discipline, many eyes have turned to the Senate to see if we will follow the similar path of fiscal restraint, or maintain the big spending policies of the past.

Before I go forward, I encourage you to view this week's (and past week's) detailed legislative report on my website by clicking [here](#). This week's report details broader issues as well as specific legislation we dealt with on the floor as well as in my committees. With 212 bills introduced in the Senate and 354 in the House, this session is proving to be a busy one, so if you have questions about any particular issue, don't hesitate to contact me.

**Stopping the spend trend is something we simply must make a priority for the economic health of our state.** On that note, I was disappointed this week, when considering the Fiscal Year 2011 Rescission Bill, the Senate, by a vote of 16-23, failed to adopt an amendment by Sen. Ty Masterson which would have brought the Senate bill in line with the proposals from the House and the Governors, which I voted for. The broader bill then passed the Senate, which I voted against because I simply refuse to vote for proposals which continue the free-spending ways of the past.

The major source of contention is an alleged \$25 million needed for special education to meet a requirement from the federal government. However, it is an unknown amount needed for "maintenance of effort" so that the state can receive matching funds. The specifics will not be given until late April or May. The governor and the House of Representatives have made it clear that getting the budget in fiscal order is a priority, and there has been no forfeit of educational funding.

Due to the differences between the House and Senate versions, the Rescission Bill is now in a conference committee, where it is my hope a bill will come out that is more in line with the House. In both this particular instance as well as when we begin debating the FY 2012 budget, I will continue fighting for limited government, fiscal responsibility, and economic liberty. **The debate in the Senate will continue to be a vigorous one, and I will keep you up to date as to our progress.**

One of the key areas we're looking at is education -- as I have indicated before, **what we have right now is not a revenue problem, but a structural budget challenge.** Soon, I will be releasing a comprehensive outlook at education spending from a statewide basis as well as the De Soto and Shawnee Mission School Districts. When considering education spending, it is critical we know all the facts about how we got to this point so we can determine the best course going forward.

In fact, when considering spending on any state agency, program, or system, we must first institute a system of zero-based budgeting, where every dollar, every year, has to be justified. Our practice in the past has been to use the spending levels of the previous year, which were often too high to begin with, as the basis for establishing spending for the current year. This simple change of focus will mean a great deal in terms of both reducing spending and also ensuring efficiency in the programs we do determine to fund.

Finally, we must ask ourselves the following questions when considering legislation:

***Is this a good idea? If it is a good idea, is this something the government should be doing? If it is***

*something the government should be doing, can we afford it?*

If we can't answer those questions in a positive way, we shouldn't fund it and instead look for alternatives. Over the next few months, I look forward to working with Governor Brownback and my colleagues in the legislature as we review every program in the state to ensure your tax dollars are being used appropriately, as well as looking for ways to return those tax dollars to you.

## [Bravery and Common Sense Prevail in Wisconsin](#)

In what [Reuters](#) is calling "a confrontation with unions that could be the biggest since then President Ronald Reagan fired striking air traffic controllers nearly 30 years ago," the Wisconsin Senate approved a scaled-down version of Governor Scott Walker's (R) budget-repair bill last night that would rein in government union collective bargaining powers. After securing [approval from three widely respected nonpartisan agencies](#)—the Legislative Fiscal Bureau, the Legislative Council, and the Legislative Reference Bureau—Senate Majority Leader Scott Fitzgerald removed the appropriations measures from Walker's budget, thus eliminating the need for any of the 14 truant Democratic Senators to be present for the vote. The State Assembly will [take up the new version of the bill at 11 a.m. today](#), and if it passes, Walker will have achieved a significant victory for taxpayers everywhere.

The courage of the Wisconsin Senate conservatives cannot be understated. Before the vote, [lawmakers were threatened with death and physical violence](#). After the vote, [thousands of protesters stormed into the capitol building, ignoring announcements from police that the building was closed](#). Once inside, and at great risk to the public welfare, [activists handcuffed some doors to the capitol shut](#). When security escorted the Senators to another building, [a Democrat tipped off the mob, which then surrounded their cars and tried to break their windows as Senators returned home](#).

Senate Democrats, who are still hiding in Illinois, are now claiming that the majority's committee meeting that broke up the budget-repair bill violated [Wisconsin's Open Meetings Law](#). But the [Open Meeting Compliance Guide](#) clearly states that when there is "good cause," only two hours' notice is required. [The Senate majority did provide the two hours' notice](#). If the Senate Democrats' 19-day refusal to show up for work wasn't "good cause" enough, certainly minimizing the opportunity for union mob violence is.

The passion coming from liberal activists is understandable only if one believes in their apocalyptic rhetoric. Democratic Senator Timothy Cullen said the bill will ["destroy public unions."](#) And Senator Chris Larson has said, ["collective bargaining is a civil right"](#) that if removed will ["kill the middle class."](#) This is all false. First of all, since unions care more about seniority than good government, [public-sector unions kill middle-class jobs; they do not protect them](#). Second, [collective bargaining is not a right](#). And finally, Walker's bill will in no way "destroy public unions." Government unions are still perfectly free to practice their First Amendment rights to freedom of association, and in fact still retain more bargaining power than all unionized federal employees. They only difference is that now they will have to actively recruit members instead of forcing government employees to join them, and they will have to collect their own dues instead of getting the state government to take them directly out of workers' paychecks. And there are many more benefits as well. Governor Walker

writes in today's [Wall Street Journal](#):

When Gov. Mitch Daniels repealed collective bargaining in Indiana six years ago, it helped government become more efficient and responsive. The average pay for Indiana state employees has actually increased, and high-performing employees are rewarded with pay increases or bonuses when they do something exceptional.

Passing our budget-repair bill will help put similar reforms into place in Wisconsin. This will be good for the Badger State's hard-working taxpayers. It will also be good for state and local government employees who overwhelmingly want to do their jobs well.

Even in good economic times, the case for government subsidies for [radio stations](#), [cowboy poetry](#), and union dues is very weak. But in a time of fiscal crisis, all of these subsidies are patently absurd. Taxpayers throughout the country should be inspired by Walker's stand for common sense. We need more leadership like this in every state capitol and here in Washington.
