Dear Friends,

What a whirlwind last week was! After fourteen town halls in one week, I am only one shy from hitting 100 since last January! We'll keep going until we visit every county in the Big First. Pictures are available on both my [Facebook page](#) and my [Flickr page](#). We discussed many topics during the town halls, ranging from taxes to energy to health care to immigration to debt. While of course it is impossible to sum up 14 one-hour meetings into a few sentences, I think it is fair to say that Kansans are fed up with Washington. Unlike many inside the Beltway, most Kansans believe that getting the economy back on track requires less government, not more. **There is no need for additional overspending, over borrowing, and over regulating to return America to a prosperity she once knew. America needs a serious plan that balances the budget, reins in out-of-control regulations, and meets our obligations to our seniors.** In refusing to fulfill the promises made to Americans to cut spending, Washington is leaving future generations a massive legacy of debt. It used to be that you left things better than you found them; what happened to that practice? **Need for Obama-Care Repeal Intensifies!!** In last week's update I talked about how three of my colleagues and [I introduced The State Health Flexibility Act](#) in order to empower states to serve better the health care of their poor. By granting the states a Medicaid block grant - free of burdensome red tape and big federal government mandates - states can be more responsible and accountable. The majority of our states - but not Kansas - now dedicate larger shares of their budgets to Medicaid than to K-12 education. The ballooning costs are due in part to states having to meet these massive federal requirements that may or may not prove best for Kansas. **Rather than more rules from Washington, our states need greater flexibility. Rather than more spending, our taxpayers deserve accountability for the money that is already spent.** The challenges facing Medicaid are only going to get worse. Not only is the program not administered the best, many current beneficiaries are receiving subpar care and providers are not being reimbursed sufficiently. And worst of all, the Medicaid rolls will soon EXPLODE in numbers. **The President's new health care law is expected to add at least 17 million and up to 25 million more people to Medicaid - and at a cost of \$118 billion to the states! On top of that, the nonpartisan Congressional Budget Office released new numbers this week showing that as many as 20 million people could lose their employer-provided health insurance as a result of the President's health care law.** Those 20 million people could end up on Medicaid, further worsening the existing problems. With this news it is even more apparent that we need to repeal ObamaCare NOW! There is no time to waste in taking this destructive law off the books. It is bad for patients, it is bad for our providers, and it is bad for hardworking taxpayers and America's fiscal health. While we look forward to the Supreme Court's decision on the constitutionality of the law, it is important to remember that the Supreme Court can evaluate only the constitutionality - not the merits of the law. Even if the Court does say it is within the law, it does not make it good policy. **Farm Bill Field Hearing:** On April 20, 2012 at 9 AM the Committee on Agriculture will host an official farm bill field hearing in Dodge City, Kansas. I look forward to hosting my colleagues in Kansas, especially Committee Chairman Frank Lucas (R-OK) and Ranking Member Collin Peterson (D-MN). I hope you will be able to attend. **Opportunities for Teens & Young Adults: Military Service Academy Nominations:** Do you know a young man or woman interested in attending one of the nation's military service academies? “The Obama administration's proposed defense budget calls for military families and retirees to pay sharply more for their health care, while leaving unionized civilian defense worker' benefits untouched.”

“Several congressional aides suggested the move is designed to increase the enrollment in Obamacare's state-run insurance exchanges.”

“The disparity in treatment between civilians and uniformed personnel is causing a backlash within the military that could undermine recruitment and retention.”

“Significantly, the plan calls for increases between 30 percent to 79 percent in Tricare annual premiums for the first year. After that, the plan will impose five-year increases ranging from 94 percent to 345 percent – more than three times current levels.”

Think about this – and imagine how *you* would campaign against Obama on just this one issue.

Let's face it. **Our liberties don't seem real every year when tax time rolls around. Today is Tax Day:** The day when hardworking American taxpayers are required to file our Federal and State Tax returns.

Every year I do this I get more and more angry. It's an annual reminder that the U.S. tax code a broken system. It's an annual reminder that the U.S. tax code a broken system. **Washington's tax system is a patchwork of special favors and election year gimmicks.**

Did you know the U.S. Tax code is 3.8 million words long! That's nearly five times the size of the Bible. And four times the size of the Complete Works of Shakespeare. What's the Matter with Kansas? The Ghost of Kathleen Sebelius lives.

Will Kansas Governor Sam Brownback pick up where Kathleen Sebelius left off?

Health care by government mandates. That's the Barack Obama - Kathleen Sebelius way. Before Sebelius became Secretary of HHS, she served as Kansas governor and before that, state insurance commissioner. During her tenure, she imposed one mandate after another on what services health insurance companies must provide. The result? Sebelius chased nearly a dozen insurance companies out of the state and left 40,000 Kansans without insurance due to the increased costs of her mandates.

That's the Kathleen Sebelius health care way. Will the new Kansas Governor, Sam Brownback, embrace the Sebelius government-centered society approach to health care?

The Republican-controlled Kansas House of Representatives recently passed by HB 2764, yet another government-imposed health insurance mandate, by an overwhelming margin, 92 to 30. Mandates are always for good causes that poll well. This one happens to be for autistic children. I don't know the inner working of the senate, but based on the house margin, I'd guess it will pass.

I reject the Barack Obama - Kathleen Sebelius approach to health care.

Advocates of the autism mandate miss why these families do not already have adequate coverage in the first place. They say it's because of the "greedy" health insurance companies but does that make sense? Auto insurance in Kansas, free from these oppressive mandates, is affordable. Are we to believe that car insurance companies are any less "greedy" than health insurance companies? In fact, does there exist any company that is not "greedy"?

The cure for greed is competition. Kansans can purchase car insurance from any company in America and therefore these companies are forced to compete for their business, including keeping premiums low and service high. Health insurance escapes free market competition and instead plays by government mandate and price-control rules. Which is more effective? It's not even close.

As the government health insurance mandates expand, the cost of insurance to Kansas families increases. This is unavoidable. The statist's solution to the problem they've created is to impose still more mandates to help the people who were victimized by the first round of mandates. It's a vicious cycle but there's a better way.

Eliminate all insurance mandates. Allow Kansans -- free Americans -- to purchase whatever insurance they choose. This eliminates the state boundary rule that grants an oligopoly to Kansas health insurance companies. It's ironic that those who claim Kansas health insurance companies are "greedy" are the same people who grant them an oligopoly in the state which, by its very nature, raises costs. The best antidote to their supposed greed is to force them to face competition from companies in all 50 states. The giant sucking sound you'll hear will be the rapidly falling insurance premium costs.

I don't have any inside information but I suspect that Governor Brownback will sign this latest Kathleen Sebelius government mandate into law.

It's time conservatives grow spines. And brains. The Left always accuses conservatives of being heartless and turning their backs on helpless kids. Sadly, self-described conservatives have been making the Left's arguments for them. It's just as easily refuted.

When supporters of mandates say you're turning your back on helpless kids, ask them why they are turning their backs on dads with heart attacks or moms with breast cancer or kids with leukemia. Because among the 40,000 Kansans victimized by Sebelius' mandates were these patients who could no longer afford health insurance. Ask them how well the Sebelius approach to health care has worked. Ask them how it could be that car insurance companies are run by

angels but health insurance companies are run by greedy devils -- or if maybe the difference is the government-imposed mandates and the oligopoly they create.

Kansas patients deserve a system that works rather than one that just makes us feel good about ourselves. It's time we judge laws by results, not intentions.

In fact, Gov. Brownback has picked up where Former Governor Sebelius left off. The medical plan being implemented in Kansas right NOW is OBAMACRE with the wording scrambled. Instead, he joins forces with race hustler Al Sharpton and escalates a tragic shooting into an inflamed, full-blown national race fight. What happened? Not everyone in the president's family is so inclined toward knee-jerk racial profiling. Through the grace of marriage and the miracle of adoption, our family - the president's and mine - boasts a rich ethnic diversity: European, American Indian, black, Chinese, Korean, Latino and Asian Indian. Only in America would a family look like ours.

Yet sadly, President Obama, rather than celebrating this fact, embraced those who prey upon our demons rather call on our better angels. For 20 years, the president faithfully sat in pews absorbing hate-filled messages from the Rev. Jeremiah Wright, such as how the “U.S. of KKK A.” lied about “inventing the HIV virus as a means of genocide against people of color.”

Is it any wonder, then, that Mr. Obama's knee-jerk reaction to the recent shooting of Trayvon Martin was very similar to his knee-jerk reaction to the disorderly-conduct arrest of black Harvard professor Henry Louis Gates? In both cases, without having the facts, the president somehow just knew that the lighter-skinned participants were racist.

The mainstream media's disgraceful attempts to manipulate the public rather than inform them of the events surrounding the Trayvon Martin shooting have been well-documented and are too numerous to detail here. A few highlights include ABC News using on-screen graphics to hide injuries to the head of alleged shooter George Zimmerman, which at least partially corroborate Mr. Zimmerman's account that he shot Trayvon in self-defense. NBC News doctored a recording of a 911 call attributed to Mr. Zimmerman to falsely indicate racism.

Perhaps most egregious, though, is the media's manipulative use of outdated photos to portray Trayvon as an innocent baby-faced boy and Mr. Zimmerman as a criminal. That a 17-year-old died unnecessarily is a tragedy whether Mr. Zimmerman acted justifiably or criminally, but Trayvon's tragedy did not begin on Feb. 26, the night he was shot.

Recent photos of Trayvon - the ones the media don't want you to see but those Trayvon chose to identify himself - tell a sad story. The once-smiling, baby-faced boy adopted a street “gangsta” persona with gold teeth and tattoos. Tweeting under a racially inflammatory handle, Trayvon boasted of his descent into violence, misogyny, prostitution and drugs.

It is thoroughly heartbreaking to see so many young black men in America adopt this destructive lifestyle rather than pursue the American dream, and it's time we find the courage to ask ourselves why. Mr. Obama piously declared, “All of us have to do some soul-searching.” He's right, but not for the reason he thinks. Racism, real or imagined, cannot explain why the black teenage unemployment rate is a staggering 40 percent and the American dream seems hopelessly out of reach.

Complex problems rarely have simple solutions, and this is no exception. Moreover, decades of failed social engineering prove there is no government program that can replace a loving mother and father who teach their kids to respect themselves and others. While this problem certainly is multi-factored, there are two

areas in particular where our government is actively sabotaging our young black men: (1) forcing them into woefully inadequate education and (2) erecting prohibitive barriers to gainful employment.

The federal experiment in education is an abject failure. Established in 1980, the Department of Education is a relatively new entity in American history. Since its founding, federal spending on education has risen “stratospherically,” as the Cato Institute describes it, and still standardized test scores remain flat. The money can be replaced, but the lost lives of young victims cannot. Shift those dollars to the states (and from the states to school boards) and let your kids’ principal and teachers call the shots rather than Washington bureaucrats.

The federal minimum wage law effectively has removed the bottom rungs from the ladder of success. The black teenage unemployment rate of 40 percent is roughly double that of white teens. In the 1940s and 1950s, when in some quarters a black man couldn’t sit at a lunch counter, let alone sit behind the desk in the Oval Office, black and white teen unemployment were both around 10 percent. The difference? The essential absence of minimum-wage laws enabled teens to get their first jobs - and skills - without the government pricing them out of the job market.

Meanwhile, where is our president as America erupts into yet another unnecessary race fight? Race hustler [Al Sharpton](#) screams that protests should “escalate” and the same New Black Panther Party to whom [Mr. Obama](#) gave a free pass for obvious voter intimidation against whites offer a \$10,000 reward for [Mr. Zimmerman](#) - “dead or alive” - and still there’s deafening silence.

America deserves a president who will calm nerves and channel our passions rather than inflame them, a president who has the courage to challenge destructive forces in America even if they are politically popular, a president who celebrates that America produces families like his own. America deserves the post-racial president [Barack Obama](#) promised he would be.
