To all my friends, particularly those conservatives who are despondent over the searing betrayal by Chief Justice John Roberts and the pending demise of our beloved country, I offer this perspective to convey some profound hope and evidence of the Almighty's hand in the affairs of men in relation to the Supreme Court's decision on Obamacare.

I initially thought we had cause for despondency when I only heard the results of the decision and not the reason or the make-up of the sides. **I have now read a large portion of the decision and I believe that it was precisely the result that Scalia, Alito, Thomas, Roberts and even Kennedy wanted and not a defeat for conservatism or the rule of law.** I believe the conservatives on the court have run circles around the liberals and demonstrated that the libs are patently unqualified to be on the Supreme Court. Let me explain.

First let me assure you that John Roberts is a conservative and he is not dumb, mentally unstable, diabolical, a turncoat, a Souter or even just trying to be too nice. He is a genius along with the members of the Court in the dissent. The more of the decision I read the more remarkable it became. It is not obvious and it requires a passable understanding of Constitutional law but if it is explained anyone can see the beauty of it.

The decision was going to be a 5–4 decision no matter what, so the allegation that the decision was a partisan political decision was going to be made by the losing side and their supporters. If the bill was struck down completely with Roberts on the other side there would have been a national and media backlash against conservatives and probably strong motivation for Obama supporters to come out and vote in November. With today's decision that dynamic is reversed and there is a groundswell of support for Romney and Republicans, even for people who were formerly lukewarm toward Romney before today, additionally Romney raised more than 4 million dollars today.

Next, merely striking the law without the support of Democrats and libs would have left the fight over the commerce clause and the “necessary and proper” clause and the federal government’s role in general festering and heading the wrong way as it has since 1942. As a result of the decision the libs are saying great things about Roberts; how wise, fair and reasonable he is. They would never have said that without this decision even after the Arizona immigration decision on Monday. In the future when Roberts rules conservatively it will be harder for the left and the media to complain about the Robert’s Court’s fairness. That’s why he as Chief Justice went to the other side for this decision not Scalia, Alito, Thomas or Kennedy, all of whom I believe would have been willing to do it.

Next let’s look at the decision itself. Thankfully Roberts got to write it as Chief Justice and it is a masterpiece. (As I write this the libs don’t even know what has happened; they just think Roberts is great and that they won and we are all going to have free, unlimited healthcare services and we are all going to live happily ever after.)

He first emphatically states that Obamacare is unconstitutional under the Commerce Clause saying you cannot make people buy stuff. Then he emphatically states that it is unconstitutional under the “necessary and proper” clause which only applies to “enumerated powers” in the US Constitution. Justices Ginsberg, Breyer, Sotomayor and Kagan all went along with these statements. They never would have gone along with that sentiment if that was the basis for striking the law in total. This is huge because this means that the Court ruled 9-0 that Obamacare was unconstitutional under the Commerce clause which was Obama’s whole defense of the bill. They also ruled 9–0 on the “necessary and proper” clause. Even better, both of these rulings were unnecessary to the decision so it is gravy that we got the libs to concede this and it will make it easier to pare away at both theories in the future, which we must do. Well done.

Roberts, through very tortured reasoning, goes on to find that the taxing law provides the Constitutionality for the law. Virtually everyone agrees that the Federal government has the power to do this as it does with the mortgage deduction for federal income taxes. This too is huge because Obama assiduously avoided using the term “tax” and now he has to admit this law is a tax and it is on everyone, even the poor. That will hurt him hugely in the polls and will help Romney. More importantly though is the fact that this makes this a budgetary issue that can be voted on in the Senate by a mere majority instead of 60 votes needed to stop a filibuster. That means that if the Republicans can gain a majority in the Senate, it can vote to repeal Obamacare in total.

Finally the Court voted 7–2 to strike down the punitive rules that take away money from states that do not expand Medicare as required in Obamacare. This too is huge because we got Kagan and Breyer to join this decision and it can easily be applied to many other cases of extortion the Federal government uses to force states to do things they don’t want to. This is also amazing because Obamacare has no severability clause so by striking the Medicaid mandate portion as unconstitutional the whole bill should have been struck. If that happened none of these other benefits would have been accomplished. I haven’t read far enough to know how he did it but I am sure it is brilliant.

So to recap the Roberts court through a brilliant tactical maneuver has: strengthened the limitations of the commerce clause and the necessary and proper clause by a unanimous decision, made Obama raise taxes on the poor and middle classes, converted Obamacare into a tax program repealable with 51 votes in the Senate, enhanced Romney’s and Republican’s fundraising and likelihood of being elected in November, weakened federal extortion and got the left to love Roberts and sing his praises all without anyone even noticing. Even Obama is now espousing the rule of law just 2 weeks after violating it with his deportation executive order.

That is why I have decided this was a genius decision and that I did in fact get a great birthday present today not to mention U. S. Attorney General Eric Holder being held in contempt. What a day.

THE DAY THE CONSTITUTION DIED

It is June 28, 2012 and on this day in history five Justices of the U.S. Supreme Court joined with President Obama and members of Congress to declare the U.S. Constitution and our free Republic dead. The justices accomplished all of this by issuing a bizarre opinion on the Constitutionality of the “Affordable Health Care Act” commonly known as Obamacare.

In August of 2009 I wrote my first blog article on the Constitutionality of the proposed health care

bill. H.R. 3200. I noted a number of Constitutional objections to it with the primary one being the violation of Article, Section 8, of the Constitution that limits the powers of Congress. I argued that nothing in that article, including the Commerce Clause, gave Congress the power to either regulate health care, or to turn over the power to do so to the Executive Branch of government.

Ironically the Supreme Court agreed with me today on the Commerce Clause issue, but then did something that by its own past admissions; it has no Constitutional authority to do. The Court took a clearly unconstitutional law passed by Congress and essentially rewrote it in order to declare it Constitutional. I'm referring specifically to the "penalties" imposed on Americans who fail to comply with the individual mandate requiring them to buy health insurance. Under the law these people can be "fined" by the IRS for non-compliance.

If you remember, when Obamacare was being proposed, the President, members of his cabinet, Democrats in Congress, and members of the mainstream news media were all assuring the American people that this was not a new "tax". Now John Roberts, the Chief Justice of the Supreme Court has written a majority opinion saying essentially that these were all lies, but he is going to fix it by declaring that this is a tax, and therefore falls within the powers of Congress.

In a nutshell, we have a situation where the Congress passed a law that it had no authority under the Constitution to pass, and that further unconstitutionally granted extraordinary new powers to the Executive Branch, that are not authorized by the Constitution. Now we have the U.S. Supreme Court upholding this, and making a power grab of its own by saying that it can ignore the Constitution and rewrite the laws passed by Congress.

The implications of this are staggering. The Supreme Court has now decided that the Federal government can use its powers of taxation to force the American people to do its will, even if individual freedoms guaranteed by the Bill of Rights are taken away in the process. Obama is already using the authority of the health care law to attach freedom of religion, and now when can you expect him to go much further.

Imagine this, you are obese and government declares that since that is a danger to your health, you will be taxed if you don't lose weight. If you have dangerous weapons in your homes like firearms, and Obama orders you to surrender them to the Federal government, you can be taxed if you fail to do so. What about going to political websites on the internet that the Feds decide are inappropriate and endanger your emotional well being; there is a tax for that. It sounds incredible, doesn't it?

Unfortunately, it could all happen as a result of today's Supreme Court decision. Justice Roberts and the other four Justices who signed off on this opinion have increased the power of the Federal government for beyond what was intended by the founding fathers who wrote the Constitution, and for that matter the Declaration of Independence.

Today the Constitution and our Republic were given the last rites to the progressives on the Supreme Court, but I am not ready to kick the dirt in on our freedom yet. I believe that many Americans are not just angry but are as infuriated as I am. The election in November, if we are allowed to have a free and fair one, is one that must be won across the board. If Obama is re-elected and Democrats continue to control the Senate, then the demise of the United States will be official.

Well, maybe not. There is one other alternative and it is stated clearly in the Declaration of Independence when Thomas Jefferson wrote about our inalienable rights.

"Would these truths to be self evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness. That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed. That whenever any form of government becomes destructive to these ends, it is the right of the people to alter or to abolish it, and to institute new government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness."

Perhaps it would be wise for those who are celebrating the death of America today, to remember that as long as there is one American left that is willing to defend the Constitution and the Republic, there will always be a spark of life that has not been extinguished. I intend to be one of those sparks.

Young Guns in the GOP

A key component to Barack Obama's 2008 success was a strong wave of support from first-time voters. That might not be the case in 2012 if a youth movement in Kansas has anything to say about it. The Kansas Young Republicans, including Dalton Glasscock, Dawson Whitaker, Jamison O'Connor, Jace Mills, Lauren Hunter and Morgan Anderson visited Liberal Thursday to campaign for local candidates, and their view of what it means to be a Republican may differ from those who have a "big tent" mentality. "If you don't follow the platform, you are not a Republican in my opinion," Glasscock said. "Just because you call yourself a Republican does not magically make you one. A lot of people run for office that way because they know it is the only way they can get elected here. If you are not pro-life, pro-family, pro-small government, you are not a Republican in my opinion."

Mills said that being a Republican was easy to see in a person's focus on true freedom. "What it means to be a Republican is smaller government, and lower taxes," he said. "The difference between Republicans and Democrats is Republicans promote free thinking, free enterprise, and free markets. Democrats don't."

For young people, there seems to be a split between some conservative views and some liberal views, according to O'Connor. But that split does not follow the Republican view.

"I think for a lot of young people, it is common sense to be fiscally conservative, but it's cool to be socially liberal," O'Connor said. "You are not a Republican if you are pro-choice, pro-gay. You're not. You can say the Second Amendment is good, capitalism is good, but no on the other stuff. You are not Republican."

Mills said the younger Republicans want to hold their party members accountable. "Republicans for abortion, increasing taxes, against Second Amendment rights, we have to call them on the carpet," Mills said. "We have to get to a point where we can call them on it. If you don't want to be a Republican, switch parties. If you want to be a Republican, follow the platform so we can get Kansas on the right track and get people back to work."

Glasscock said it was better for those who don't really associate with the Republican platform to be a Democrat rather than remain as a Republican. "I will do anything in my power to get you out of there," he said. "I would rather have a Democrat in there, where I know they are the enemy rather than have a Republican in name only and not know they are the enemy. They are an enemy in disguise."

While the young Republicans may tow a tight line on party affiliation, they are like most Kansans when it comes to wanting to see a stronger economy. "I hear about the economy and how it is affecting teens," Glasscock said. "They see their parents tightening their pocket books and not being able to achieve the American Dream. They can't succeed because there are no jobs out there."

Mills said that young people see the same increases at the pump and at the grocery store that everyone else sees. "You know it costs more to fill up your tank," he said. "It costs more to go to the store or rent a movie. Unemployment among young people is the highest since they started to record the data in 1948. We are speaking for young people without jobs that find it hard to put money in the gas tank. Young people care about those things. Green energy, they are not as concerned about that as what affects us on a day-to-day basis. We may not understand everything in the political process, but we know taxes affect the company that you want to work for. As young conservatives, I don't think our generation is liberal, they just don't get it, and those that are liberal get put on a pedestal."

Their solution is easy — let them make decisions on their own.

"The government needs to get out," O'Connor said. "I know how I want to live, I know how to make it happen. I don't need your help. Protect my inalienable rights and that's it. You can't sway much from what the founding fathers established — less government."

Mills said the private sector is better equipped to be efficient, which saves money.

"The government should only do what people can't do for themselves," Mills said. "Protect the rights given to us by God. Everything else is up to the individual. It is more efficient and effective. Virgin Mobile is sending people to space cheaper, more efficient and getting the same results. The government needs to get out of our lives, and quit telling us what to eat and drink."

He also believed that failure is a positive tool, and the effort to remove it cheats people from achieving at the highest level.

"There is nothing wrong with failure," he said. I love the WD-40 story. He tried to make the perfect formula 39 times. Companies and organizations that can't make it need to fail. We become smarter and more efficient."

And that focus on conservative values among young people has Mills believing that the result in 2012

will be starkly different than it was in 2008.

“We are swinging back toward Reaganesque values,” he said. “In 2008, the young people were fooled by Obama. In 2012 it won’t happen again.”

Obamacare Endorsements: What the Bribe Was!!

As the suicidal Democratic congressmen proceed to rubber-stamp the Obama healthcare reform despite the drubbing their party took in the '09 elections, the president trotted out the endorsements of the AMA and the AARP to stimulate support. But these – and the other endorsements – his package has received are all bought and paid for.

Here are the deals:

The American Medical Association (AMA) was facing a 21 percent cut in physicians’ reimbursements under the current law. Obama promised to kill the cut if they backed his bill. The cuts are the fruit of a law requiring annual 5 percent to 6 percent reductions in doctor reimbursements for treating Medicare patients. Bravely, each year Congress has rolled the cuts over, suspending them but not repealing them. So each year, the accumulated cuts threaten doctors. By now, they have risen to 21 percent. With this blackmail leverage, Obama compelled the AMA to support his bill...or else!

The AARP got a financial windfall in return for its support of the healthcare bill. Over the past decade, the AARP has morphed from an advocacy group to an insurance company (through its subsidiary company). It is one of the main suppliers of Medi-gap insurance, a high-cost, privately purchased coverage that picks up where Medicare leaves off. But President Bush -43 passed the Medicare Advantage program, which offered a subsidized, lower-cost alternative to Medi-gap. Under Medicare Advantage, the elderly get all the extra coverage they need plus coordinated, well-managed care, usually by the same physician. So more than 10 million seniors went with Medicare Advantage, cutting into AARP Medi-gap revenues.

Presto! Obama solved their problem. He eliminates subsidies for Medicare Advantage. The elderly will have to pay more for coverage under Medigap, but the AARP – which supposedly represents them – will make more money. (If this galls you, join the American Seniors Association, the alternative group; contact sbarton@americanseniors.org. This e-mail address is being protected from spambots. The drug industry backed ObamaCare and, in return, got a 10 year limit of \$80 billion on cuts in prescription drug costs. (A drop in the bucket of their almost \$3 billion projected cost over the next decade.) They also got administration assurances that it will continue to bar lower-cost Canadian drugs from coming into the U.S. All it had to do was put its formidable advertising budget at the disposal of the administration.

Insurance companies got access to 40 million potential new customers. But when the Senate Finance Committee lowered the fine that would be imposed on those who don’t buy insurance from \$3,500 to \$1,500, the insurance companies jumped ship and now oppose the bill, albeit for the worst of motives.

The only industry that refused to knuckle under was the medical device makers. They stood for principle and wouldn’t go along with Obama’s blackmail. So the Senate Finance Committee retaliated by imposing a tax on medical devices such as automated wheelchairs, pacemakers, arterial stents, prosthetic limbs, artificial knees and hips and other necessary account remnants of healthcare.

So these endorsement are not freely given, but bought and paid for by the administration that is intent on passing its program at any cost.

A few years ago, in the business section of *USA Today*, a story appeared that described how businesses are returning to some inner cities to set up shop. The article is encouraging. Real estate is plentiful and prices are low. Many who work downtown also live there. That's the good news.

Of course, once these companies become successful, politicians will tax the daylights out of them. It's these taxing policies that end up killing the goose that lays the golden egg.

In addition to the upbeat nature of the story of small companies of trying to make it big downtown, there was an educational statistic that was shocking:

“The inner harbor of Baltimore has a 20% poverty rate and a 50% high school dropout rate.”

Uneducated teenagers have few marketable skills. They can't work to learn new skills because (1) wealth transfer payments via welfare make it unprofitable to work and (2) minimum wage legislation prices them out of the job pool, especially in this tough economic climate.

Further in the article we learn that “unemployment and poverty were at least 50% higher than in the surrounding area.” These conditions can mostly be attributed to government taxing policies. This is why poverty is a self-inflicted disease.

The irony here is that if the inner cities are to be saved, it will be the inner cities that will have to do it. Jobs could be plentiful and high paying. Of course, this will require skilled, mostly college educated workers. But companies cannot survive on computer programmers and engineers alone. They need a diverse work force.

One of the companies has started a mentoring program for at-risk Baltimore high school students. None of the students has dropped out. Where government education and public policy programs fail, private enterprise succeeds. Time will tell if these inner city businesses will make it. Politicians, social theorists, special interest groups, and unions are perched like vultures ready to pick the place clean if the inner cities ever become prosperous again.
