## Obama's Dismal Jobs Record

The unemployment rate is now 8.1 percent, marking 43 months straight that it has stayed at 8 percent or above. At least 12.5 million Americans are out of work. Yet President Obama has been trying to convince people that he's a job-creating President.

Have 4.5 million new jobs been created under President Obama, as several speakers in Charlotte have claimed this week?

A fact check shows that under President Obama, the U.S. economy has created a net 415,000 private-sector jobs—less than 0.2 percent of the 155 million-member American workforce. But even that statistic does not tell the full story, since the [workforce itself has shrunk dramatically](#) in size since Obama took office. Labor force participation is at 63.5 percent, its lowest level since 1981. In other words, a large chunk of Americans have simply given up looking for work. A significant number are collecting disability insurance instead, according to [new research](#) from Heritage's James Sherk.

In fact, the share of the adult population with jobs has remained flat for the past two years. The only reason the unemployment rate edged down slightly in August was that fewer people looked for work and thus no longer count as unemployed. The percentage of people participating in the labor force dropped by 0.2 percent—the same amount the unemployment rate dropped. As Sherk has explained, we are in the slowest recovery in 70 years, and job creation has not recovered since the recession began in 2007.

The economy is treading water and struggling for breath. This is exactly the wrong time to raise taxes. Yet with Taxmageddon bearing down on the economy, that is exactly what some members of Congress have proposed. This would be a terrible mistake.

The Congressional Budget Office (CBO) reported recently that if Congress and the President do not act before the end of the year to prevent Taxmageddon, America will have another recession on its hands in the coming year. With 12.5 million Americans already out of work, imagine a fresh recession.

[Taxmageddon](#), scheduled to hit on January 1, 2013, will be the largest tax increase in American history. It's a one-year, nearly \$500 billion tax hike that will hit businesses, families, young people—its impact will be devastating. Heritage has calculated that a middle-class family of four will see their taxes go up by more than \$4,100 just next year. [\[See how Taxmageddon will impact you.\]](#)

If Congress and the President do not prevent Taxmageddon, the CBO said sluggish economic *growth* won't be our problem next year. Instead, the U.S. economy will actually *shrink*. It will shrink by 0.5 percent,

and the unemployment rate will spike to 9.1 percent.

That will mean even more jobs lost. Heritage's J.D. Foster [explains](#): Forget percentages—what does this mean in actual jobs lost if President Obama and Congress fail to act? It means roughly 1.6 million more Americans will be out of work—on top of the 12.8 million who already want to work but can't find jobs.

A shrinking economy. More than a million jobs out the window. The country cannot afford this. The time for political speeches is over. It's time for Congress and the President to do the one thing that matters most before the end of the year: preventing an economic catastrophe from happening on New Year's Day.

## The FIVE Reasons to Re-elect Obama by Larry Elder

The case for re-electing President Barack Obama rests on five arguments, the most important of which is that Romney/Ryan represent sexism, racism, homophobia and fascism.

1) Obama "inherited" the worst set of economic conditions since World War II.

**False.** Based on unemployment, inflation and interest rates, the recession of 1981-82 was worse. Unemployment during the early '80s reached 10.8 percent, inflation 13.5 percent, and prime interest rates reached 21.5 percent. During this so-called "Great Recession," the numbers peaked at 10.2 unemployment, 5.6 percent inflation and 7.25 percent for the prime interest rate.

2) Obama's economic policies "rescued the economy from falling off a cliff."

**False.** Nearly 350 economists, including several Nobel laureates, publicly urged Obama to follow the path President Reagan pursued -- cutting taxes, slowing the growth of domestic spending and continuing deregulation.

Most business economists think Obama's "stimulus" plan accomplished little, if anything, with some academic economists, like Stanford's John Taylor, believing that stimulus actually made things worse: "I just don't think there's any evidence. When you look at the numbers, when you see what happened, when people reacted to the stimulus, it did very little good."

TARP, begun under President George W. Bush, supposedly prevented financial institutions from collapsing. But Neil Barofsky, in his new book called "Bailout: An Inside Account of How Washington Abandoned Main Street While Rescuing Wall Street," argues that TARP completely failed in its mission: to increase liquidity to jumpstart lending.

The reason for intervention in the first place is that banks had become "too big to fail." Not only did the banks park the money and make risk-free profits off the spread, but banks became bigger than ever after TARP.

ObamaCare promises to provide health insurance to nearly 30 million Americans currently uninsured. Obama said it would bend the health care cost curve down, that it would decrease the deficit and that if you like your doctor or your current health insurance plan, you can keep it.

But Jonathan Gruber, the economist who designed both RomneyCare and ObamaCare, now admits some are going to pay more -- and some a lot more -- for their health insurance: "It is true that even after tax credits some individuals are 'losers,' in that they pay more than before (Obama's) reform." Rick Foster, the chief Medicare actuary, testified that it is "false, more so than true" that ObamaCare bends down the cost curve. He also said it is "not true in all cases" that if you like your plan you can keep your plan.

What about the "investments" in the green jobs of the future? At \$529 million dollars of lost taxpayer money, Solyndra is one of many money-hemorrhaging "clean energy" flops. Other belly-flops backed by federal loans include Beacon Power and Abound Solar. A Washington Post investigation traced \$3.9 billion in grants and financing to 21 companies that were backed by firms connected to five Obama administration staffers and advisors. Cronyism?

3) Bush's irresponsible tax cuts and "unpaid-for wars" of Afghanistan and Iraq caused the deficit.

False. Obama frequently bemoans the "cost" of \$700 billion in tax cuts for "millionaires and billionaires." CNN's Fareed Zakaria blames the "Bush tax cuts" for the deficit. But the \$700 billion Obama speaks of is spread over 10 years. This comes to a mere 5 percent of the deficit.

As to the costs of the Iraq and Afghanistan wars, a study by Brown University estimates the costs at between \$3.2 trillion and \$4 trillion. This, too, is over about 10 years (the approximate duration of the wars), or an average of \$360 billion per year. This comes out to about 25 percent of the estimated \$1.5 trillion deficit.

## **FOUR MORE YEARS... WOULD BE EIGHT YEARS TOO MANY!!!!**

### **Who Does Obama Think He's Fooling With Spin on Jobs?**

Even the pro-Obama media can't spin hard enough to make the latest jobs numbers sound good for the president.

Headlines across the nation yesterday and today scream that 96,000 jobs were created in August and unemployment fell 0.2 percent, but any read of the data below the headlines is dismal for Democrats coming off a weak convention that was topped Thursday by a lackluster performance from the Great Bloviator himself.

The number of jobs created is about 30,000 or more below expectations, depending on whose predictions you use, and even that number is barely at the level the country would need to break even for the month.

The important number for the month is 368,000. That's how many formerly employed Americans gave up hope of finding a job in August and fell off the government's tables.

The number of people employed in August actually decreased by 119,000, according to the Bureau of Labor Statistics. But because of the huge number of people dropping out of the job market altogether, the total number of people counted as unemployed shrank by 250,000, producing an illusory decrease in unemployment from 8.3 percent to 8.1 percent.

The previous month, when unemployment rose to 8.3 percent, the administration had argued hard that it was "really" a rounded up number, that it was barely over 8.2 percent and statistically insignificant. This month, a phony 0.2 percent improvement is gospel.

The BLS also revised the employment numbers for July and June, noting that there were 19,000 fewer jobs in June and 22,000 fewer jobs in July than previously reported.

The mainstream media explanation for the poor jobs performance is, as the Washington Post put it, that corporations (those evil corporations) are just "sitting on a pile of cash," and not hiring amid slow growth around the world.

The media actually are trying to use the numbers to bolster Obama's convention claim that the economy is recovering, he just needs more time.

Obama has already benefited by dragging out this recession. According to the American Enterprise Institute's James Pethokoukis, if not for the people who left the job market entirely in August, the jobless rate would have risen to 8.4 percent, and if the number of people in the job market was currently the same as when Obama came into office, the unemployment rate would be 11.2 percent.

Meanwhile, the U-6 unemployment number, which many people believe to be a truer accounting of the unemployment situation in the country, remains at 14.7 percent, down from 15 percent the month before, also a beneficiary of the shrinking labor pool.

In 2008, voters gambled on an unknown to "change" the country. No matter how you spin the numbers, Obama's Administration has been one long, losing bet for America.

Undeterred, Mr. Schiff went on to interview a number of delegates about corporate profits. Their responses were shocking. Well, not really. These were Democrats. And so many of them with the same views. Scary

When Schiff asked a delegated whether corporations should lose money, she said, "Yeah, I think so." Another delegate agreed: "Maybe we should have corporate losses."

These interviews took place in the Time Warner Cable Arena. The last night, September 6th, was originally scheduled to be held at the 72,000-seat Bank of America Stadium, where President Obama was to

deliver his acceptance speech. It was moved inside the arena in order to accommodate a smaller crowd.

There wouldn't be an arena or a stadium if corporations didn't make profits. Who would risk investing in equipment, hiring employees, and paying their insurance, Workman's Compensation, Social Security, and Medicare and then spend millions of dollars to build either of these venues if there wasn't a sizeable profit in it for them?

The cost of the Time Warner Cable Arena was estimated to cost around \$260 million. The Bank of America Stadium cost \$368 million. Time Warner Cable employed 48,500 people in 2011. The only corporations that have enough money to rent these venues are those that make a lot of money. They, too, are in business to make a profit.

If you want to know what a nation looks like when people are not allowed to make a profit, go to North Korea. Cuba's closer.

What do people do with profits? They spend them, invest them, distribute them to share holders, and save them. If they invest them, the money goes to help other companies to build things. To build things means that they'll need to hire people.

There is an economic ripple effect in the profit motive. Spending also means that other people benefit with no need of government. Liberals believe that taxation is a better distributor of wealth. This is nonsense since the wealth is only redistributed to groups that will vote for the tax confiscators. Since the money was not earned, politicians have no concern for what government programs cost. Any time they need more money for a new program or to prop up a failed one, they pass laws to tax more people at a higher rate.

**Ronald Reagan** understood how government works:

"Government's view of the economy could be summed up in a few short phrases: If it moves, tax it. If it keeps moving, regulate it. And if it stops moving, subsidize it."

Corporations don't have this authority and power.

A dependent class of voters is created in order to keep the redistribution process going. The bureaucracy that is needed to confiscate and then redistribute the money costs a multi-million-dollar fortune.

Schiff then asked some of the delegates if they would be in favor of a law that would put a cap on corporate profits. Do these people have any idea what would happen if such a law were to pass? People would only work up to the profit level allowed by the government and then close up shop for the rest of the year. This would mean fewer items produced at a higher cost to consumers.

One delegate said that she would support anything her president wanted to do. Schiff asked, "Anything?" She said, "Anything." People always wonder how the sane people in Germany went insane in electing Adolf Hitler. Wonder no longer.

There's a lesson here for people who claim there's no difference between Mitt Romney and Barack Obama. The major difference is in the people who support each man.

## EDITORIAL: You belong to Barack; Government is the master; we are the servants

The Obama campaign has disavowed a Democratic National Convention video that said, "Government is the only thing we all belong to." It's odd President Obama would try to distance himself from that idea since in his heart he knows it's right. Of course, in our guts, we know it's nuts.

The video, entitled "Welcome to Charlotte," aired Tuesday. It was produced by the convention host committee,

not the Obama campaign or Democratic National Committee, though presumably representatives from both organizations vetted and approved it before it ran. The clip sent exactly the wrong message at the wrong time for the Democrats because it echoes "you didn't build that" and the general belief that government, not individual initiative, is America's motive force.

There are two ways to read the sentence. One is that a citizen's relationship to government is like belonging to a great big club. Of course, this club will send you to jail for nonpayment of dues.

The other, more chilling way to read it is that people are creatures of government. That the government, by right, can exercise almost unlimited control over peoples' lives. That the proper relationship between the state and the individual is that between master and servant. This is why the Obama campaign quickly threw the approved welcoming-committee video under the bus -- its underlying tenet was just a little too blatant. The trick to collectivizing America is never admitting the objective. The end of freedom comes with the promise of "dignity" and the imposition of "fairness." It starts with "hope and change" and ends with individual mandates.

Mr. Obama's defenders claimed "You didn't build that" was taken out of context, but it wasn't. In that July 13 speech, The One laid out a vision for government action based on the premise that active state involvement was necessary for prosperity. In later speeches, he has discussed plans for economic recovery in which government plays the central role. In his acceptance speech Thursday night, the president is expected to propose more such state-centric solutions, funded by money the government doesn't have and promising the same results that his previous attempts failed to deliver. Mr. Obama knows no other way. He is intellectually, temperamentally and emotionally wedded to the idea that government isn't everything, it's the only thing.

As the preamble to the Constitution says the government was ordained and established by "We the People." Before that, Americans declared independence, fought a war to realize it and established the Articles of Confederation. Even before those events, Americans carved a civilization out of the wilderness and began to forge the first new nation. Governments have come and gone but the people remain.

In 1886, in the case of *Yick Wo v. Hopkins*, Supreme Court Justice Stanley Matthews commented eloquently on the nature and origins of government. Sovereignty "is the author and source of law," he wrote, but "sovereignty itself remains with the people, by whom and for whom all government exists and acts." He continued that "the very idea that one man may be compelled to hold his life, or the means of living, or any material right essential to the enjoyment of life at the mere will of another seems to be intolerable in any country where freedom prevails, as being the essence of slavery itself." What voters have to decide in the upcoming election is who belongs to whom.

The convention pleas of Barack Obama for more time to fix the economy sounded more like begging for mercy than a plan of action. Only someone with a completely numbed brain who hadn't been paying attention for the past four years could have fallen for it.

Naturally, the Democrat faithful lapped it up.

King Obama has already had too much time to fix the economy, as Friday's unemployment numbers showed.

The Democrats' demagogic faith in their "tax 'em to help 'em" strategy has kept the country at above 8 percent unemployment for 43 months. During that time, millions of unemployed people have given up hope of ever finding another job and dropped out of the labor pool entirely.

According to the American Enterprise Institute, if the labor pool included the same number of people today that it did when Obama first entered office, the unemployment rate today would be over 11 percent, not hovering just above 8 percent.

In a very real way, Mr. Hope and Change has benefited from Americans' loss of hope that the economic picture will change.

The just-released figures for unemployment in August are a perfect example. The headlines have touted the creation of 93,000 jobs, but far more people lost jobs during the month, 119,000, according to the Bureau of Labor Statistics. Just to keep up with population growth, the U.S. economy needs to create between 150,000 and 200,000 jobs net per month.

Because 368,000 people fled the labor force in August, shrinking the pool included by the government in its figures, the unemployment rate "shrank" to 8.1 percent.

The more people give up, the better the numbers look for Obama, who has accomplished nothing substantial in his first four years of "fixing" the economy.

If the labor pool continues to shrink under Obama's and the Democrats' misguidance, at some point

there will be nothing left to fix.

#### **'When somebody does not do the job, we gotta let 'em go.'**

"The nation has now endured 43 months of unemployment officially above 8 percent. The details paint an even bleaker picture. No doubt many of the media outlets determined to get this president re-elected will tout the fact that the unemployment rate dropped from 8.3 percent to 8.1 percent, even as they bury the reason why: 368,000 Americans simply gave up looking for work. That exodus dropped the labor force participation rate to 63.5 percent, a 31-year low. For perspective's sake, if the number of people in labor force had remained the same as last month, the unemployment rate would be 8.4 percent. If the labor force were as large as it was when Obama took office in 2009, the unemployment rate would be a staggering 11.2 percent. Yet it gets even worse. The previous two month's jobs totals were 'revised.' 41,000 jobs were lopped off the totals for June and July, as reality caught up with the Bureau of Labor Statistics' (BLS) overly optimistic 'guesstimates.' ... And when one gets past the 'official' unemployment rate and examines the BLS's U-6 number -- representing Americans who have been out of work for six months, along with those who are involuntarily part-time workers, due to cutbacks in their days or hours -- the under-employment rate has held steady for months at around 15 percent of the workforce. Add those who have given up looking for work and that number jumps to 19 percent."
