The Campaign to Defeat Barack Obama 2012

Friends, the "chickens are coming home to roost" for Barack Obama. The headline in today's edition of Politico tells the story: "Angst grows among Obama supporters." Obama's supporters are in panic mode over his awful debate performance, his plunging poll numbers and the growing scandal concerning his cover-up of the Benghazi terrorist attack.

Calling Obama's Bluff

Less than a year ago, voters went to the polls in Ohio and resoundingly rejected Obamacare's individual mandate. Actually, that's an understatement. Voters in all 88 counties of Ohio rejected it, and in all but seven of those counties they did so by a margin of at least 20 percentage points. Even in Cuyahoga County, where Cleveland is located and where Barack Obama beat John McCain by a margin of better than two-to-one (68 to 30 percent), voters not only rejected Obamacare's individual mandate but did so by a margin of 16 points (58 to 42 percent). To be sure, Ohioans don't have the power to cancel out Obamacare's individual mandate any more than the residents of any other single state do (unless, of course, Ohio becomes the deciding state in the presidential election). If Obamacare isn't repealed, then its individual mandate would be imposed on Americans in every state. The Ohio vote, therefore, was essentially symbolic, but what it demonstrates is this: The individual mandate is likely the most unpopular part of President Obama's horribly unpopular centerpiece legislation. As such, it's perhaps his greatest political vulnerability.

Forty-four years ago, in 1968, I had just turned 18 years old, graduated high school, gone through US Marine boot camp. I had arrived in Vietnam a week or two earlier. I had enlisted in the Marine Corps knowing

that I would be going there.

Back home, 1968 was a turbulent time. Demonstrations were everywhere. It was an election year. Lyndon Johnson had decided not to seek re-election, so the race for President was between Richard Nixon and Hubert Humphrey, with the election day being 5 November, just a few weeks ahead. The outcome of this election could be rather important to me, here in a combat zone.

There was only one problem. At 18, I was old enough to fight for my country, but not old enough to vote. It seemed a little odd to me, but that was the way it was. Three years later, the voting age was lowered from 21 to 18. I felt cheated, as the next election, in 1972, I would have been old enough to vote anyway.

I exercised my right to vote in the Presidential election of 1972. Since then, I have not missed an opportunity to vote my opinion, or displeasure. I have taken seriously this great honor of determining the best person for each office and casting a vote for that person.

There has rarely been a more critical time to exercise the right to vote. In a time when our elected officials completely disregard the wishes of the majority of its constituents, virtually thumbing their noses at the people, every vote counts. Did you want the government to control 1/6 of our economy, mandating how and where you spend your money. Do you want to add a 20-25% Value-added Tax to everything you purchase, on top of the existing income tax system? Do you want Cap and Trade to further cripple small business and the economy? “How dare they?” Mrs. Vaughn asks. “They put a target on my son’s back and even on my back. But a little over 90 days later, my son was dead.” Aaron Vaughn and 21 other Navy SEALs, “most of whom belonged to Team 6, the unit whose members were involved in the raid that killed Osama bin Laden,” according to ABC, died in Afghanistan when a helicopter he was riding on was shot down.

The video, released by the conservative Veterans for a Strong America, shows Vice President Joe Biden talking about the raid during a public event and Defense Secretary Robert Gates complaining that an agreement to keep the raid details secret “fell apart” as the result of such comments.

'NUFF SAID'

BAD WEATHER SAVED GM, NOT BIG GOVERNMENT

Last September, I [wrote a post](#) about the auto bailout which read in part:

... if I have to hear left-wingers touting the “success” of the auto bailout one more time, I might as well toss a chair through my window. It’s patently false to say that the auto bailout was a success. Furthermore, it was more of an United Auto Workers union bailout than it was for the auto industry. [As Amy Payne of Heritage wrote back in June:](#)

The Treasury Department estimates that taxpayers will lose \$23 billion on the auto bailout. Sherk and co-author Todd Zywicki [both are economists for Heritage] find that none of these losses came from saving jobs, but instead went to prop up the compensation of some of the most highly paid workers in America. [They write:](#)

We estimate that the Administration redistributed \$26.5 billion more to the UAW than it would have received had it been treated as it usually would in bankruptcy proceedings. Taxpayers lost between \$20 billion and \$23 billion on the auto programs. Thus, the entire loss to the taxpayers from the auto bailout comes from the funds diverted to the UAW.

Now, Hans Bader, from the Competitive Enterprise Institute, [wrote on October 15](#) that the weather also had a part in “saving” GM. In fact, Bader wrote that “General Motors never would have recovered as it did if not for the [massive Japanese earthquake and Tsunami that devastated its rivals](#), such as Toyota. The tsunami so crippled Toyota that GM could regain market share despite the Obama administration leaving GM’s uncompetitive, inefficient work rules and high labor costs largely intact.” As a result of these disasters, GM was able to become the number one carmaker in the world.

Furthermore, the massive recalls Toyota had to execute in 2010, “helped move Ford and GM move forward at a time when overall auto sales were rising rapidly.” In the end, it cost the Japanese automaker 18,000 sales in the United States during the month of February of that year.

Also, it helps when the “massive Thai floods in 2011... inundated and shut down Japanese car-parts factories in Thailand for many months, crippling Japanese automakers’ global supply chains. On Dec. 8, Toyota “[cut its profit forecast by more than half](#) after Thailand’s worst floods in almost 70 years disrupted output of Camry and Prius vehicles.” The [World Bank estimates](#) the floods did [\\$45 billion in damage](#) to the Thai economy and left half its factories under water for substantial periods.” Hence, “by harming Japanese automakers, the Thai floods gave a huge boost to their competitor, General Motors, enabling it to survive despite the Obama administration’s [costly coddling](#) of the [UAW union in the bailout](#), which threatens the automaker with [future losses](#) in the billions,” said Bader.

However, Bader notes that “GM now is concealing the depth of its problems by financing auto sales with risky loans that may never be paid back, resulting in GM’s increasing [reliance on selling cars to people who can’t pay for them](#).” Investors Business Daily’s GM Ramps Up Risky Subprime Auto Loans To Drive Sales noted that “the automaker is relying increasingly on subprime loans, 10-Q financial reports shows. Potential borrowers of car loans are rated on FICO scores . . . Anything less than 660 is generally deemed subprime. GM Financial auto loans to customers with FICO scores below 660 rose from 87 percent of total loans in Q4 2010 to 93 percent in Q1 2012.”

Lastly, as the Obama administration seeks to increase CAFE standards on American cars, which hurts us more in the global market than it does our competitors, Bader said he expects [50-100,000 autoworker jobs to vanish](#) in the coming years. Bin Laden may be dead, but GM is about to go on life support.

Retirees, Taxpayers Ripped Off to Subsidize UAW

Obama accused critics of his [decision](#) to give control of Chrysler to the United Auto Workers Union of being “speculators.” But it turns out that many of them are [pension funds](#) representing the interests of retirees, who are being fleeced to enrich the politically better-connected UAW.

“Indiana Treasurer Richard Mourdock revealed this week that his state’s police and teacher pension funds have lost millions of dollars in the Chrysler ‘restructuring.’ Indiana’s State Police Fund and Major Moves Construction Fund, which finances roads and bridges, together lost more than \$1 million. And the Teacher’s Retirement Fund ‘suffered, at a minimum, a loss of \$4.6 million due to the action of the Federal government,’ reports Mr. Mourdock. Far from being speculators, these funds represent retired public employees, including cops and teachers. The funds paid a premium to buy ‘secured’ status, only to discover that they were politically outranked by the United Auto Workers in the White House hierarchy. ‘In the past, to be secured meant an investor was first in line in the event of a bankruptcy and ‘non-secured’ creditors would receive value after secured-creditors were paid,’ Mr. Mourdock says. ‘In the Chrysler bankruptcy, however, secured creditors received \$.29 on the dollar even as non-secured creditors [the UAW] received higher values and ended up with a 55% ownership of the new company, which is fundamentally wrong and a dangerous precedent to the capital markets.’”

The government is now doing the same thing at General Motors, giving much of the [company’s stock \(plus \\$10 billion](#) in taxpayer dollars) to the UAW while refusing to make good on GM bonds, which were [purchased](#) by some people to put their kids through college (and by some non-union employees to help fund their own retirement).

When public-employee pension funds suffer, as they did at Chrysler, taxpayers do, too. Public employee pensions are already underfunded by perhaps a [trillion dollars](#), and taxpayers will likely end up being forced to pay for any additional shortfalls through increased taxes.

Jobs will disappear, too, as companies find it more difficult to raise money through bonds and loans. In response to Obama’s ripping off bondholders and lenders to enrich the UAW, hedge funds now say they may [not lend to unionized companies](#), and Indiana’s treasurer says that he will [not invest](#) in manufacturing companies or insurers that are participating in the TARP program. Chrysler still faces a [difficult future](#), burdened by excessive wages that even union members were [surprised](#) to see stay high.

Obama’s \$800 billion stimulus package, which [guts](#) welfare [reform](#) and contains provisions that [keep](#) states from cutting the wages of overpaid public employees, is also [harming the economy](#). The stimulus [ignited trade wars](#) with Mexico and Canada that destroyed over 40,000 jobs.

It is no secret that President Obama's and green-energy supporters' (from both parties) foray into venture capitalism has not gone well. The fact that some companies are not under financial duress does not make the policy a success. It simply means that our taxpayer dollars subsidized companies that would've found the financial support in the private market.

So far, 34 companies that were offered federal support from taxpayers are faltering — either having gone bankrupt or laying off workers or heading for bankruptcy. This list includes only those companies that received federal money from the Obama Administration's Department of Energy and other agencies. The amount of money indicated does not reflect how much was actually received or spent but how much was offered. The amount also does not include other state, local, and federal tax credits and subsidies, which push the amount of money these companies have received from taxpayers even higher.

The problem begins with the issue of government picking winners and losers in the first place. Venture capitalist firms exist for this very reason, and they choose what to invest in by looking at companies' business models and deciding if they are worthy. When the government plays venture capitalist, it tends to reward companies that are connected to the policymakers themselves or because it sounds nice to "invest" in green energy.

The 2009 stimulus set aside \$80 billion to subsidize politically preferred energy projects. Since that time, [1,900 investigations have been opened](#) to look into stimulus waste, fraud, and abuse (although not all are linked to the green-energy funds), and nearly 600 convictions have been made. Of that \$80 billion in clean energy loans, grants, and tax credits, at least 10 percent has gone to companies that have since either gone bankrupt or are circling the drain.

The National Renewable Energy Lab did receive \$200 million in stimulus funding, but it is a government laboratory.

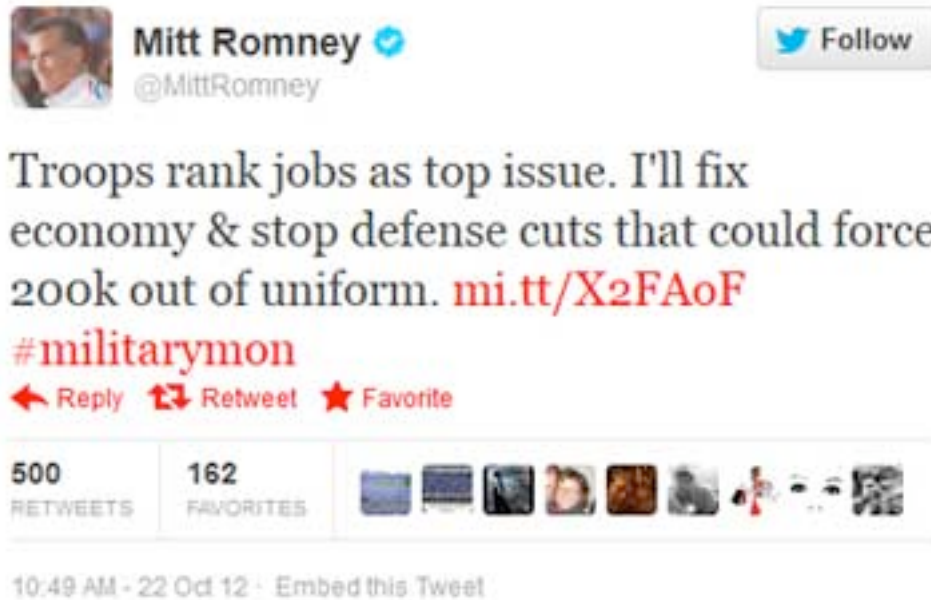
