I'll be 63 soon. Except for one semester in college when jobs were scarce, and a six-month period when I was between jobs, but job-hunting every day, I've worked, hard, since I was 18. Despite some health challenges, I still put in 50-hour weeks, and haven't called in sick in seven or eight years. I make a good salary, but I didn't inherit my job or my income, and I worked to get where I am. Given the economy, there's no retirement in sight, and I'm tired.

I'm tired of being told that I have to "spread the wealth around" to people who don't have my work ethic. I'm tired of being told the government will take the money I earned, by force if necessary, and give it to people too lazy or stupid to earn it.

I'm tired of being told that I have to pay more taxes to "keep people in their homes." Sure, if they lost their jobs or got sick, I'm willing to help. But if they bought McMansions at three times the price of our paid-off, \$250,000 condo, on one-third of my salary, then let the leftwing Congresscritters who passed Fannie & Freddie and the Community Reinvestment Act that created the bubble help them — with their own money.

I'm tired of being told how bad America is by leftwing millionaires like Michael Moore, George Soros and Hollywood entertainers who live in luxury because of the opportunities America offers. ## A Physician's New Reality: Patients Ask Me to Break the Law By Dr. Peter Weiss November 24, 2012 – 12:00am

Ironically, but expectedly, the ones who do this now are likely to have supported Obamacare

Obama won, Obamacare is the law, and, as my wife says, I will just have to learn to
dance to a new song.

Now, don't get me wrong, Obamacare is awful. Forget all the "free stuff" it provides. Children covered on their parents' plan until 26 years of age? A scam, making young adults — excuse me, children — pay for complete, comprehensive health insurance when all they need and should pay for is major catastrophe insurance. Then there is the "annual " or "preventative" exam, which according to Obamacare is "free."

You gotta love this stuff. I wish I had the chutzpah of the people who wrote Obamacare. What they did not tell you, and I am, is that it covers absolutely nothing more than the bare minimum.

I have now posted a notice in my office and each exam room stating exactly what Obamacare will cover for those yearly visits. Remember Obama promised this as a free exam — no co-pay, no deductible, no charge. That's fine and dandy if you are healthy and have no complaints. However, we are obligated by law to code specifically for the reason of the visit. An annual exam is one specific code; you cannot mix this with another code, say, for rectal bleeding. This annual visit covers the exam and "discussion about the status of previously diagnosed stable conditions." That's the exact wording under that code — insurance will not cover any new ailment under that code.

If you are here for that annual exam, you will not be covered if you want to discuss any new ailment or unstable condition. I cannot bait and switch to another code — that's illegal. We, the physicians, are audited all the time and can lose our license for insurance fraud.

You, the patient, will then have to make a decision.

Do you want your "free" yearly exam, or do you want to pay for a visit which is coded for a particular, new problem? You can have my "free" exam if you only discuss what Obamacare wants me to discuss.

This happened to me personally, as a patient, when I went for my physical. It is the law. If you are complaining of a new problem, then you have to reschedule, since Obamacare is very clear as to what is covered and what is not. Obamacare — intentionally — makes it as difficult to be seen and taken care of as possible.

Patients can be very tricky. I have had patients make an "annual" exam, only to want to discuss and be treated for another ailment. I can't do it.

I can hear the complaints from you guys already — I become the bad guy. "Why don't you just take care of the problem, and not bill out any different code? You're a rich doctor, and we are entitled to free stuff."

It doesn't work that way. First, doctors are not rich and, like most of you, actually work terribly hard for a living. Second, Obamacare is the law — and as I said earlier, we are audited all the time now.

Also — I don't ask for free gas when I go to the gas station, or ask for free food from the supermarket. Additionally, Obamacare has a 23% cut in Medicare reimbursement to doctors and hospitals.

These lower payments won't cover the cost of staying in practice to take care of the patient.

Private doctors are becoming a thing of the past. By 2014, less than 25% of physicians will be in private medicine. Obama was right in stating you can keep your doctor if you want to — the problem is he or she will rarely be available.

On top of all of that, doctors will be obligated — that's right, obligated — to talk to you about things you may have no interest or need to talk about.

You may just want to have a pap smear or check your cholesterol. However, I am now mandated by the government to talk to you about your weight, exercise, family life, smoking, sexual abuse(!), and even to ask if you wear seat belts. And I am mandated to record your answers.

I am a physician. But I need to tell you to wear a seat belt and then record your answer.

I have received interesting responses from my patients since I put up the notice. Almost all are supportive and totally understand. The very few who complain? The same patients who always ask for free samples, who always complain that we do not validate parking. These are also the same patients who call my office and ask for free samples even when they are not even being seen.

Obamacare and its 2,000-plus pages are here to stay. I will still give my patients 100% of my time, energy, and knowledge. I still love being a doctor — my patients' doctor. I will, however, abide by the law and follow it to the letter. I will have to learn this new dance. "Free" has its price.

From the sound of this it is going to take a great effort for the Dr. to follow the law. IF we want to keep our good Drs. we will have to control our questions to help our Dr. comply with the rules Obamacare forces on them. IF have the "Free" exam you'll have to do what Obamacare dictates. If your willing to forgo the "Free" exam then you can discuss what you want with your Dr. What good is a "Free" exam if it doesn't cover your need? I'm assuming you can just skip the "Free" exam & make an appointment to fit your needs & not waste the Drs. Time.

### Higher Gas-Tax Idea Joins Fiscal-Cliff Talks by Josh Mitch

States and business advocates are maneuvering to use the current budget negotiations in Washington to win support for a long-sought increase in the federal gasoline tax—one of a grab bag of proposals various groups are seeking to tuck into a deal.

The White House and Congress are trying to craft a broad deficit-reduction deal to substitute for the so-called fiscal cliff, a \$500 billion combination of tax increases and spending cuts set to begin Jan. 2. State highway officials and industries that stand to benefit from increased highway spending—including road builders and heavy-equipment makers—are among those pressing lawmakers to raise the 18.4-cent-a-gallon federal gasoline tax as part of an agreement.

Other industries also are moving to have initiatives attached to a budget deal—as part of either a short-term agreement this year or a longer-term plan reached next year to overhaul spending and taxes. Casinos are pushing a measure to legalize Internet poker games nationally. Small banks are pressing to extend a program that gives unlimited federal guarantees to certain bank deposits. Governors want additional aid to cover

destruction wrought by Hurricane Sandy. The financial industry is pushing to loosen regulations on complex financial derivatives.

"Basically, you've got a bunch of people waiting in the wings to stick the collection plate out and grab whatever they can grab," said Dan Kish, senior vice president for policy at the Institute for Energy Research, which advocates for free-market energy policies. The group, which receives funding from the oil industry and other energy producers, has criticized efforts to get a tax on carbon emissions included in a budget deal.

So far, it isn't clear which, if any, proposals are gaining traction, or whether a broader deal will be reached, given disagreement between the White House and lawmakers over taxes and spending.

The federal gas tax was last raised in 1993 and 1990, each time as part of a deficit-reduction plan. After failing for years to overcome public opposition, supporters of another increase see the current talks as a once-in-a-generation chance to raise the tax, which finances highway and transit construction.

# CONGRESSMAN: OBAMA'S TAX INCREASES FUND GOVERNMENT FOR EIGHT DAYS (Yes, you read it right -- 8 days.)

President Barack Obama has proposed raising taxes on the rich to put America's fiscal house in order, but critics say federal spending is so massive that the wealthy don't have enough money to cover the nation's unprecedented debt.

In an interview with MSNBC's Andrea Mitchell, Rep. Tom Price (R-GA) said President Barack Obama's plan to raise taxes on the wealthy would only generate enough revenue to fund the federal government for eight days.

"The president's plan to increase taxes on the upper two percent covers the spending by this federal government not for eight years, not for eight months, not for eight weeks but for eight days. Eight days only," said Mr. Price. "It's not a real solution. So, again, I'm puzzled by an administration that seems to be more interested in raising tax rates than in gaining economic vitality."

The problem is that the rich don't have enough money to put so much as a dent in America's \$16 trillion national debt. "If the IRS grabbed 100 percent of income over \$1 million, the take would be just \$616 billion," writes John Stossel. "That's only a third of this year's deficit. Our national debt would continue to explode."

Still, Mr. Obama's supporters persist in proposing tax hikes on the wealthy. On Sunday, billionaire Warren Buffett proposed a minimum tax for America's top earners. "We need Congress, right now, to enact a minimum tax on high incomes. I would suggest 30 percent of taxable income between \$1 million and \$10 million, and 35 percent on amounts above that."

There's just one problem with such an approach, says author Mark Steyn:

If you took every single penny that Warren Buffett has, it'd pay for 4-1/2 days of the US government. This tax-the-rich won't work. The problem here is the government is way bigger than even the capacity of the rich to sustain it. The Buffett Rule would raise \$3.2 billion a year, and take 514 years just to pay off Obama's 2011 budget deficit.

Indeed, even Mr. Buffett seems to concede that he and the president's "soak the rich" proposals are more an act of political theater designed to generate an emotional response than serious solutions: Mr. Buffett told Matt Lauer he believes his proposal would boost the "morale of the middle class."

No amount of tax increase will do any good until expenses/spending is drastically cut in multiple places.

## Muslim Brotherhood Advising Obama?

Outspoken Republican congressman Louie Gohmert is continuing to press for investigation of the Muslim Brotherhood's influence on the federal government, contending in an interview that a probe is necessary because of the Obama administration's "horrendous decisions" in backing the so-called "Arab Spring" revolutions in the Middle East.

The East Texas lawmaker was one of five Republican Congress members who stirred bipartisan controversy in June by raising concern about Muslim Brotherhood infiltration in the nation's capital.

In an interview Tuesday on Gohmert charged that the administration was taking advice from the Muslim Brotherhood, the Egypt-based movement formed after the demise of the Ottoman Turkish empire with the intent of helping establish Islamic rule worldwide.

"You look at the decisions [the Obama administration] made, especially in the last two years, in going through the revolutions in Northern Africa and across the Middle East and to the Far East," said Gohmert, "and the only way you can explain the horrendous decisions that were so completely wrongheaded would be if the administration had a bunch of Muslim Brotherhood members giving them advice."

In July, Gohmert, along with Rep. Michele Bachmann, R, Minn., and three other Republican House members, pointed to Hillary Clinton's top aide, Huma Abedin, as a possible Muslim Brotherhood influence on U.S. policy. The lawmakers asked the inspector generals at the departments of Homeland Security, Justice and State to investigate, prompting Democrats and Republicans to rush to Abedin's defense.

# OBAMA DEMANDS \$1.6 TRILLION TAX BOOST, AND AN UNLIMITED CREDIT CARD from the DC Reader on 11/30/12 at 3:11 AM

President Barack Obama has dramatically upped his demands in the fiscal crisis negotiations: He wants Congress to levy twice as much in extra taxes from Americans as he urged during the election campaign, give up its control over the nation's debt limit, and fund an immediate \$50 billion stimulus for his political priorities.

In exchange, Obama offered to consider — but not necessarily accept — GOP proposals for cutting \$400 billion from Medicare and other programs strongly favored by off-year voters.

That listening session would take place sometime in 2013, giving the president plenty of time to wrap the unpopular demand around the necks of the GOP legislators before the 2014 midterm elections.

The surprise package was given to Republican House Speaker John Boehner on Thursday by Treasury Secretary Timothy Geithner.

Geithner presided over Obama's four-year spending spree, which has left 23 million Americans unemployed, underemployed or out of the workforce. That spending has been funded by \$7 trillion in borrowed funds or government-printed cash, generating additional debt of roughly \$20,000 per person.

The budget package is slated to avoid the economic pain due from the scheduled Jan. 1 imposition of planned budget cuts and tax increases, worth \$500 billion during 2013.

Boehner and other Republicans derided Obama's wish list, which was described by the <u>New York Times</u> as "a detailed proposal ... loaded with Democratic priorities and short in detailed spending cuts."

The Washington Post described the package as lacking "any concessions to Republicans, most notably on the core issue of where to set tax rates for the wealthiest Americans... Sen. [Jerry] Moran voted for the Feinstein-Lee (Rand Paul) amendment which does nothing to fix the problem with the unconstitutional citizen detention provisions of NDAA 2012 but is yet another attempt of controlled confusion to deceive the public. This amendment is simply a rewrite

of Feinstein's Due Process Guarantee Act of 2011, which amends the Non-Detention Act (NDA) of 1971.

The NDA amended Title II, the Emergency Detention Act (EDA), of the McCarran Internal Security Act (ISA) of 1950. EDA authorized the detention of suspected subversives without the normal Constitutional checks required for imprisonment. You see we have been down this road before and apparently did not learn from our past mistakes.

The Feinstein-Lee Amendment requires "express" Congressional authorization to detain U.S. citizens and lawful permanent residents. However, this is meaningless because:

- 1. The Bush administration, in a citizen detention case, argued that the NDA only applies to civil prisons, not military detentions. A reading of the NDA supports this position. (Note 1.) If this is true the amendment does nothing.
- 2. Some have argued by Congressional intent the NDA relates to both civil and military detention. (Note 2.)
- 3. Either way the Supreme Court has held that the AUMF 2001 was "explicit" authorization for the detention of the U.S. citizen in question. Express and explicit are synonymous. Therefore the amendment does nothing.
- 4. The NDAA 2012 is itself "expressed" authority for citizen detentions. "Or, as Rep. Justin Amash (R-Mich.) put it, "that Act of Congress is the 2012 NDAA, which renders the rest of the Feinstein amendment meaningless." (Note 3.)
- 5. Persons on both sides of the civil v. civil / military argument agree that the NDA applies "...except in those cases of emergency when martial may properly be invoked...." (Note 2.)

We are in a state of "emergency" now. And, more to the point, as the NDAA, by Congressional intent, has established the U.S. as part of the battlefield the U.S. is colorably under the Law of War and martial law. As such the amendment does nothing.

Sen. Moran, your vote for this meaningless amendment tells me you are not reading or analyzing what you are voting on. If you need more help, please hire it and don't make my Liberty pay for your being uninformed.

Neither Moran nor Roberts did anything to cure the unconstitutional problems with the NDAA 2012. They have both violated their oath of office.

#### Fiscal Cliff Poker: Call Obama's Bluff! By Jeffrey L. Scribner on Dec. 11, 2012

The president and the speaker of the House are playing poker. The imagined stakes are whether we go over the "fiscal cliff" on January 1, 2013. The actual stakes are the direction of the country -- whether we will see any GDP growth, put our people to work, and get out of the doldrums of the past four years, and whether the president will be able to demoralize the Republican Party and make it easier to take the country farther left.

There have been several good suggestions for compromise along the lines of Simpson-Bowles. (See for example Glenn Harlan Reynolds's advice in *USA Today*.) However, even if the suggested strategy worked, which is not a sure thing, deficits would continue for many years into the future.

Some pundits think the president will gain most of what he wants by "going over the fiscal cliff." Taxes will go up for just about everyone, and sequestration cuts Defense more than any other part of the budget. The theory is that the president then gets to blame the tax hike on the Republicans. He can then propose a "tax cut" for those making less than \$200K per year and blame any failure to pass that on the Republicans, too! Meanwhile, the sequestration budget cuts amount to only three percent of spending over the next decade, so we have almost status quo ante with a little more tax

revenue for a year or so if the economy doesn't take a nosedive.

Some other pundits say that the president can't risk going over the fiscal cliff because the shock to the economy will be too great and may leave him mired in recession and/or very slow growth for the bulk of or the whole of his second term, ruining his chances of a positive legacy. Moreover, it is not clear that everyone or even a large minority will agree that it is the Republicans that are at fault for going over the fiscal cliff.

The speaker is unable to produce a majority (even with Democrats) that will agree to the president's demand that tax rates be raised on those making more than \$200K per year. The speaker probably could produce a majority to close loopholes, lower tax rates, and bring in more revenue. This becomes even more of a problem because the president proposes that the corresponding spending cuts are pushed off and spread out over several years in the future. So even if the speaker wanted to give in on the raising tax rates point, he realistically can't.

So it looks like the president's hole card can be played only if the Republicans do not surrender and we go over the fiscal cliff. He then proposes a "tax cut," as described above.

But the speaker has a better hole card, and he can show it before we go over the fiscal cliff and play it for keeps afterward. The president already suspects that this hole card exists, and he is already nervous about it.

The hole card is the debt ceiling. The play before the cliff is to outline what things will look like if the president refuses any compromise on tax rates, loopholes, and spending cuts. There will be sequestration affecting defense, in particular, and "discretionary spending." There will be a tax hike for everyone. The "payroll tax holiday" will end, the tax rates for all brackets will rise, and other adjustments will increase the effective tax even on the lowest-paid workers. In addition, all of the new taxes in ObamaCare will become effective. All this additional drag on the economy will tend to further reduce the currently anemic growth rate and may result in a return to recession as the new year develops.

At this point, the House of Representatives will refuse to extend the debt ceiling. This will implement the spending cuts that the president wants to avoid, and while he will win some new revenue -- if the economy doesn't contract further -- he will experience the inability to do anything else for the remainder of his term in office, or at least until after the next midterm election.

Refusing to extend the debt ceiling will stop deficit spending. It will force the president and Congress to cooperate to decide how to allocate shortages.

Contrary to what Democrats might say, it is in fact possible to run the government, defend the country, and even pay Social Security without borrowing any money and loading our excess on our children and grandchildren. Not increasing the debt ceiling will make us be more responsible. And most of all, it will send a message to domestic and foreign markets that we intend to be responsible. This will tend to increase GDP even in the face of the tax hikes that will take place on January 1, 2013. It provides an end-run around the tax hike vs. spending cut impasse that has plagued us for the past four years. Moreover, it will effectively put an end to bailouts and other misuses of federal money, since there won't be any excess for that kind of expenditure.

It has become apparent to even the casual observer that absent a drastic measure like capping the debt ceiling, we are going to continue spending beyond our means. We are going to continue selling our birthrights and those of our children and grandchildren because of our own timidity in the face of the failure of our federal elected officials to do the job they were elected to do.

We need to draw a line in the sand and prevent ourselves from crossing it. We can do it in a few months by actually capping the debt ceiling. I ask the speaker to count his votes in the House. If there is support for this course, he can send it to the president and see if the president wants to compromise. One way or another, spending is going to have to go down.
