### **Congressman Huelskamp rejects the 2013 NDAA and its Unconstitutional Citizen Detention Provisions** written by Richard D. Fry, General Counsel, Patriot Coalition

Once again Congressman Huelskamp voted against a National Defense Authorization Act (NDAA). The 2013 NDAA is the 51st such bill to be passed by Congress. Its purpose is to authorize funding for programs and the military that support our national security policy.

In 2012 the NDAA was 1844 pages and this year it was over 1100 pages. The House passed its version of the 2013 NDAA in May. The Senate did not pass its version until December. So like last year, there was a mad scramble to get it finalized, - the funding of the military hanging in the balance.

The 2013 NDAA was for \$640.7 billion (640,700,000,000.00), there were grave concerns expressed last year by members of Congress, watchdog groups and grass roots groups over the constitutionality of the citizen detention provisions of the bill and a New York federal District Court in September found these provisions to be unconstitutional. Yet, the Senate floor debate of the 2013 NDAA Conference Report, which will ultimately be sent to the President later this month, lasted about one (1) hour.

The NDAA 2012 did not just authorize funding for national security policy. It established new policy by greatly expanding the September 18, 2001 "Declaration of War" that resulted from the 9 11 attacks.

Members from Kansas' Congressional delegation Mike Pompeo (an attorney), Kevin Yoder (an attorney) and Lynn Jenkins voted for both the 2012 and the 2013 NDAA's. Last year Jenkins sent a joint letter to the conference committee which said the citizen detention provisions of the bill were unconstitutional and requesting their removal. The committee did not remove the unconstitutional provisions. Yet, Jenkins voted for the bill she had previous said was unconstitutional. She admitted this to a 9-12 group at the Kansan Grill in Topeka on Friday the 13th of January, 2012, and explained her action by saying "I thought the Supreme Court would straighten it out."

I spoke to the offices of our Congressional delegations and to Yoder personally. Each argued that these provisions did not apply to citizens. I offered to fly to Washington with the legal team of the Patriot Coalition and Oath Keepers that had been assembled as part of their joint project in response to NDAA, The Intolerable Acts. One of the attorneys was Stewart Rhodes, a former paratrooper and Yale Law School grad who specialized in the application of the Law of War to citizens, while at Yale. No takers.

Last summer Yoder told a group in Johnson County that he "did not want to extend Constitutional

rights to terrorists who had snuck into our country to do us harm” as justification for voting against the Smith – Amash amendment that would have corrected some but not all the constitutional problems. It is well-settled law that most of the protections of the Bill of Rights apply to all persons in the U.S. whether they are citizens, visiting foreign nationals, or illegal aliens. So what he was saying in reality is he believes Congress has the power to take away constitutional rights from some people.

The actions of Pompeo and Yoder tell me we have a crisis in our law schools regarding teaching the Constitution.

In the last two years Rep. Jenkins introduced 17 bills, 5 of which related to the shoe industry. An example is HR 2697 The Affordable Footwear Act of 2011. (Congressman Yoder co-sponsored this bill as did Pompeo.) Was Rep. Jenkins friends with former Philippine Dictator Ferdinand Marcos' wife, Imelda, who had over 3,000 pairs of shoes? Will her excuses for violating her oath be any more ridiculous? Perhaps, thanks to Jenkins, Yoder, and Pompeo we can look forward to pacing back and forth in comfortable shoes during our indefinite detention. Our constitutional rights would be better served if she was working in the shoe department of Payless Shoes and Yoder and Pompeo were working on the K Street Project.

Come on people! Only one of our elected legislators, Tim Huelskamp, was and is fighting for our Liberty. And when I say that, considering the NDAA, I mean it literally!

These guys are a threat and danger to our Liberty and our Republic. They do not support the same fundamental principles we hold so dear for ourselves and our children, namely to be left alone by our government. They are supporting and protecting a law which allows the President on a mere suspicion that we are “terrorist” to have the military indefinitely detain us without an arrest warrant, without an attorney, without showing us the “evidence” against us or being allowed to confront witnesses against us, or to have a trial by our fellow citizens. We declared our independence from England over such abuse. Perhaps it is time we declare our independence from these guys before we lose that ability.

These guys are going to be home over Christmas break. Write them and call them and go see them in person and ask them what the hell they think they are doing to us. Remind them you are the boss and this dangerous, subversive conduct, which is treason to the Constitution, is no longer acceptable. This is not only your duty, it is imperative to your Liberty. If you do not act, history will remember America as that great Republic blessed with the greatest freedom and Liberty that died from apathy, and political correctness.

## Gov't Motors Employees to Receive Bonuses up to \$7,000 Each

Profit-sharing bonuses for United Auto Workers' members at Ford Motor Co. (NYSE: F) and General Motors Co. (NYSE: GM) are expected to be at least as large as last year's payout at General Motors and larger than the year-ago bonuses paid at Ford. Approximately 55,000 GM hourly workers and 40,000 Ford employees are in line for the payments.

GM workers can expect bonuses of between \$5,500 and \$7,000, and Ford's employees could receive a payment of more than \$8,000 each, according to a report in The Wall Street Journal. The payments are based on a formula that gives workers a \$1 bonus for every \$1 million in North American operating profit at the two companies.

U.S. auto sales are on track to top 14.5 million units in 2012, up 14% over last year's sales total. In the first three quarters of the year, GM has posted operating profit of \$5.55 billion and Ford's profit totals nearly \$6.5 billion. And the fourth quarter looks good too.

## Guns Aren't the Problem by John McPherson, Contributing Writer to the Manhattan Mercury

Another tragic shooting, I join the world in sorrow for the inconceivable and thoughtless slaughter of those children and faculty members. But make sense of it? Good lick with that.

I can, though, give an explanation. It's complicated and many faceted, so bear with me. Available space doesn't allow me to give more detail or references, but this is all easy enough to verify via the Internet.

The root of it all is evil men. They exist in abundance throughout the world. With evil and mad men

there is no sense or reason. From the beginning of time they've existed. They infiltrate us and, sadly, seldom look the way we expect evil to look and act. They're camouflaged as next-door neighbors, chums, businessmen, schoolmates, the clergy and most dangerously, politicians. Until they act, we seldom have any idea of who they are. They earn our trust and then pounce. Coupled with the nuts, we also have the very real terrorists who are honored to give their lives to butcher the innocent. To borrow and paraphrase a quote, "These evildoers may be crazy but they sure as hell ain't stupid."

### **Deaths in perspective**

Government in the name of society does all it can to prevent injury, suffering and death to its citizens while forgetting that, well, people die. Sometimes stupidly, but always they die. Ropes, four-wheelers, darts, drugs, alcohol, automobiles, paint, roller skates, baseballs, ice picks, falling pianos, et al. Being born begins the risk, but come the time, we're gone.

Consider the accidental death rate for medicine and automobiles in relation to guns.

Guns, which are designed to kill, have a lower death rate than either of the other two. Discounting suicides and criminal-on-criminal killings, we have had 89,100 actual gunshot deaths in the civil public at large in the past 10 years; that's 8,910 per year – 25 per day. Many of these are justifiable homicides by innocent civilians on criminals.

Medicine is for curing illness and relieving suffering. Medical mistakes are responsible for 197,000 deaths each year – 539 per day. This is acceptable to most because it's collateral from doing good. That's **21 times** more deaths than from gunshots.

As for motor vehicles, the 2011 low average figure shows automobiles killed 88 people each and every day. The yearly average of 39,150 deaths involving vehicles is acceptable to most because of automobiles' convenience and usage. The 10-year average of 107 deaths per day is **more than four times as high as firearm deaths.**

Medicine and automobile collateral damage are accepted because medicine and autos do more good than bad. Firearm deaths do less bad than the others while doing good. Figures I presented in a letter in February 2011 show that guns could be saving as many as one and a quarter million lives a year.

Why guns?

The founders of this once great country knew full well that guns kill but also that free men were in fact not free if they did not have the right to self defense from not only individuals but, most importantly, from the government itself.

The Second Amendment states, "**A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.**"

People of today have argued about the word "militia." Militia? People? There is no argument or controversy. In the mindset of all peoples of that era, including the founders who wrote the rules, the people *were* the militia. The militia *was* the people. They were one and the same. You need only read the writings of these men and the constitutions of several of the colonies or states from that period to see that.

"The right of self-defense never ceases. It is among the most sacred, and alike necessary to nations and to individuals." President James Monroe (Nov. 16, 1818).

The Second Amendment is not about hunting. It's about defense of self – a right, **not** a privilege. It is a natural right to protect yourself. It's a privilege, on the other hand, to drive that automobile. A friend said he could see no reason for assault weapons and high capacity magazines. My comment to him was that these were the exact arms that the founders were referring to.

The founders specified protection from the state and tyranny over and over again but never once said the people should be limited to match lock muzzleloaders, a precursor to the most modern flintlock weapon of the time. They were fully aware of evil tyrants – they were in the process of kicking one out. You can't stop the evildoers on masses if armed with a squirrel gun.

Guns in the hands of the people are the one guarantee that "We, The People" retain control over those who run the country. Not shotguns and .22 rifles, but guns fully capable of standing up for our rights. In Germany in the 1930's, restrictive gun laws made it easy for Hitler to make sure his opponents couldn't get permits and thus would have no access to firearms. In 1938 Hitler effected total gun control for the Jews.

As per history, both recorded and current, millions upon millions of lives and human suffering could have been saved and still could be saved if only the people were armed.

### The roots of mass murder

Every mass shooting has three elements: the killer, the weapon and the cultural climate. As soon as the shooting stops, partisans immediately pick their preferred root cause with corresponding pet panacea. Names are hurled, scapegoats paraded, prejudices vented. The argument goes nowhere.

**Let's be serious:** (1) **The Weapon:** Within hours of last week's Newtown, massacre, the focus was the weapon and the demand was for new gun laws. Several prominent pro-gun Democrats remorsefully professed new openness to gun control. Sen. Dianne Feinstein (D-CA) is introducing a new assault weapons ban. And the president emphasized guns and ammo above all else in announcing the creation of a new task force. I have no problem in principle with gun control. Congress enacted (and I supported) an assault weapons ban in 1994. The problem was: It didn't work. (So concluded University of Pennsylvania study commissioned by the Justice Department.) The reason is simple. Unless you are prepared to confiscate *all* existing firearms, disarm the citizenry and repeal the Second Amendment, it's almost impossible to craft a law that will be effective.

Feinstein's law, for example, would exempt 900 weapons. And that's the least of the loopholes. Even the guns that are banned can be made legal with simple, minor modifications.

Most fatal, however, is the grandfathering of existing weapons and magazines. That's one of the reasons the '94 law failed. At the time, there were 1.5 million assault weapons in circulation and 25 million large-capacity (i.e., more than 10 bullet) magazines. A reservoir that immense can take 100 years to draw down.

**The Killer:** (2) Monsters shall always be with us, but in earlier days they did not roam free. As a psychiatrist in Massachusetts in the 1970s, I committed people often right out of the emergency room as a danger to themselves or to others. I never did so lightly, but I labored under none of the crushing bureaucratic and legal constraints that make involuntary commitment infinitely more difficult today.

Why do you think we have so many homeless? Destitution? Poverty has declined since the 1950s. The majority of those sleeping on grates are mentally ill. In the name of civil liberties, we let them die with their rights on. A tiny percentage of the mentally ill become mass killers. Just about everyone around Tucson shooter Jared Loughner sensed he was mentally ill and dangerous. But in effect, he had to kill before he could be put away and (forcibly) treated. Random mass killings were three times more common in the 2000s than in the 1980s, when gun laws were actually weaker. Yet a University of California at Berkeley study found that states with strong civil commitment laws have about a one-third lower homicide rate.

**The Culture** (3) We live in an entertainment culture soaked in graphic, often sadistic, violence. Older folks find themselves stunned by what a desensitized youth finds routine, often amusing. It's not just movies. Young men sit for hours pulling video-game triggers, mowing down human beings en masse without pain or consequence. And we profess shock when a small cadre of unstable, deeply deranged, dangerously isolated young men go out and enact the over learned narrative.

If we're serious about curtailing future Columbines and Newtowns, everything guns, commitment, culture must be on the table. It's not hard for President Obama to call out the NRA. But will he call out the ACLU? And will he call out his Hollywood friends?

The irony is that over the last 30 years, the U.S. homicide rate has declined by 50 percent. Gun murders as well. We're living not through an epidemic of gun violence but through a historic decline.

Except for these unfathomable mass murders. But these are infinitely more difficult to prevent. While law deters the rational, it has far less effect on the psychotic. The best we can do is to try to detain them, disarm them and discourage "entertainment" that can intensify already murderous impulses.

But there's a cost. Gun control impinges upon the Second Amendment; involuntary commitment impinges upon the liberty clause of the Fifth Amendment; curbing "entertainment" violence impinges upon First Amendment free speech.

That's a lot of impingement, a lot of amendments. But there's no free lunch. Increasing public safety almost always means restricting liberties.

We made that trade after 9/11. We make it every time the Transportation Security Administration invades your body at an airport.

# What They're Not Telling Us About What Happened at Columbine

If you've been following news about the shooting at Sandy Hook Elementary School, you've learned that so much of what has been written has been incorrect or not substantiated. For example, there's no real evidence that Adam Lanza's mother took him to a firing range or that she was a "prepper." Lionel Shriver of *The Guardian* comments: "Multiple stories have pegged [Nancy Lanza] as a 'prepper' – a survivalist gearing up for economic collapse by stocking weapons and tinned food. Yet this gonzo tag hails from a single, biased source, Nancy's sister-in-law, and has since been contradicted by friends. An acquaintance said she seemed 'high-strung' – an opaque and prospectively neutral adjective that went viral, repeated to insinuate that the mother herself might have been unbalanced. And tut-tut: she never seemed eager to invite neighbours into her home."

Today's media are all about agenda journalism. There was a day when journalists worked long and hard to get to the facts straight no matter where the facts took them.

In the debate over gun control and protecting schools against the unknown lunatic who might believe he's playing a role in a violent video game where death and blood are little more than so many pixels on a screen, the media are ill-equipped to deal with the truth. Consider this comment in the Opinion section of *USA Today* (Dec. 24, 2012, 7A) that first appeared in *National Review* online: "Columbine High School had a sheriff's deputy on scene when the shooting broke out.

"That's right, but it isn't like the deputy was **sitting around** eating doughnuts during the Columbine massacre. He traded fire (that is, he *drew fire*) with Harris for an extended period of time, during which Harris's gun jammed. The deputy and the backup he immediately called for exchanged fire with the shooters a second time and helped begin the evacuation of students, all before the SWAT teams and the rest of the cavalry arrived, and before Harris and Klebold killed themselves in the library.

"Harris and Klebold had an assault plan – a sloppy plan, but a plan nonetheless. They had dozens of IEDs, some of which detonated, others of which did not. And there were two of them. In this highly chaotic tactical environment, the deputy acted both bravely and prudently, and who knows how many lives he saved by engaging Harris."

An armed guard does not guarantee that nothing will happen, but it does lessen the odds for those who wish to do harm regardless of the consequences to them.

Dear Patriot,

We don't talk about the first day of spring in 1974. It's been that way for as long as I could remember. March 20<sup>th</sup> started off like any other as my 8 year old brother headed off to school wearing his blue ball cap and backpack. My mom remembers him yelling back into the house, 'I Love You Mom' before shutting the door.

That was the last time she saw my brother, Cliff.

The Dekalb County Chief of Police told my mother we would never know what exactly happened in the bedroom of the nanny that afternoon. The police report later revealed the nanny heard Cliff begging, "Please help me." A shot rang out. When she ran into the room it was too late. Her 12-year-old son was standing over my brother's lifeless body. In his hands was his parent's rifle, which he had just used to shoot my brother through the heart at point blank range.

The motive was never determined. One suspicion was the boy was possibly jealous of the affection his mother showed my brother. Cliff had been dubbed "The Mayor" by the neighborhood because of his outgoing personality. He spent many hours playing games with the seniors who lived in the complex.

Losing Cliff was too much for my mother to bear. She had recently been divorced. Within the year before my brother's murder, she had lost her father and mother to cancer. In a rare moment of remembrance she once told me that the loss of her parents was heartbreaking enough – but the loss of Cliff was so devastating that for years she wished every breath taken would be her last.

Last Monday, like so many parents of young children across America, I found an excuse to visit my child's classroom. As I stood outside the door of my son's Kindergarten classroom before lunch, I heard his teacher remark to the class that there was a new rule: every classroom door was going to be closed and locked. If someone came to the door, the students were to first get the teacher before opening even if it was a parent or a fellow student.

I fought back tears as I listened to the little voices ask questions regarding the new policy and a sense of anger was rekindled. Adam Lanza not only took the lives of 26 innocent victims on December 14th, but he also stole the security of many families across this nation. Gone are the days where you could walk down a school hallway and hear a chorus of children's voices, answering questions, or laughing at a story being read by their teacher. Now, school hallways are becoming as sterile as the corridors of a hospital. It makes one wonder if a child can really grow in such a cold, silent environment.

My anger turns to pain as I hear the children, excitedly lining up for lunch, debating over whose dessert was better or what side dish they were going to be serving. I realized there were 20 sets of parents who were never going to hear the chatter or any other debate again from their child and I immediately thought of my mother.

While you might think my mother would be a strong [anti-gun](#) proponent, she realized it was not the guns' fault for the death of Cliff. It was a failed system and irresponsible parenting who were as much to blame as anything.

As I grew up, my mother insisted I learned to defend myself. If Cliff's death had taught her anything it was that. Whether it be hand-to-hand self-defense, environmental defense or with a gun, I have been raised to respect the power of a weapon. I received the highest accuracy rating and grade in my concealed hand gun permit class. I also pride myself on better aim than my former Army officer husband.

Since the events of December 14th, there have been countless numbers of articles and interviews over gun owner's rights, particularly from those opposed to them. I am beginning to think those on the left were waiting for a tragedy like this to happen just so they could reignite the argument over gun control. Taking the advice of Rahm Emanuel, they were quick to "not let a serious crisis go to waste."

The hypocrisy of their claims are amazing considering this is the same administration who put guns in the hands of Mexican drug lords to use against law enforcement. The propagandists also cavalierly dismiss the numerous examples of public shooting sprees halted because of a legal gun permit holder's actions for fear it would encourage legal gun ownership.

My child might not remember these differences down the road. But I will. Most of us will. We will weep at the loss of this innocence and wonder how did our Country change from being a Norman Rockwell portrait to a scene from inside a horror film?

Evil will use whatever tools it needs to commit its crime. We must remember in the next few months as the victims of Connecticut are used as propaganda by those who want to see evil prevail, their first move will be to take away from the virtuous their ability to defend and protect their own.

It is important to stress that most of these accounts have not simply been temporarily suspended, they have been shut down completely. Some are now being reinstated after complaints. Accounts that have been suspended can still be seen but posting rights have been revoked.

A 24 hour suspension was also placed on the Alex Jones Facebook account due to an image that another user had posted in which Alex Jones was tagged.

One of the messages being received by users having their accounts suspended is displayed below. In most cases, users are not even being informed of why their page was suspended or deleted, with Facebook merely referring them to the company's guidelines.

**I haven't been on Facebook for quite awhile – now they won't recognize my password. Oh, well, they probably wouldn't like what I have to say most of the time and would suspend my account. So be it.**

## **Thanksgiving 2022 -- I can see it coming!**

"Winston, come into the dining room, it's time to eat," Julia yelled to her husband.

"In a minute, honey, it's a tie score," he answered.

Actually Winston wasn't very interested in the traditional holiday football game between Detroit and Washington.
