2013: Time to Address Spending

According to the Congressional Budget Office this week, the federal government ran a \$293 billion deficit during the first quarter of 2013 (the 2013 fiscal year began in October 2012). If we continue on this track, our annual budget deficit will top \$1 trillion for the fifth-straight year under President Obama.

The lack of leadership from Washington on having an honest debate to curtail our spending problem is one of the most frustrating parts of my job. For far too long, even modest spending reforms have been met with extreme, political rhetoric as we saw with the recent fiscal cliff debate and previously with the House-passed budget. Now, with the Treasury Department having reached its legal borrowing limit yet again, it is time for the President to put real spending reforms on the table.

Every budget expert has warned it is impossible to tackle our annual deficits and our more than \$16 trillion debt without addressing mandatory spending programs like Medicare and Social Security. Until we can discuss ways to strengthen and reform these programs, funding problems will only get worse and future changes will become even more drastic. It is impossible to control spending when you refuse to touch 60 percent of the budget.

Having the courage to act now, will ensure we will be able to protect current seniors and those near retirement age from seeing their benefits changed. However, the longer we take to fix these programs, with Medicare insolvent in 12 years and Social Security a few years later, the larger the risk of negatively affecting the health and well-being of our parents and grandparents. The only way we can make sure these programs are here for future generations is by having these discussions today.

Forbes Field Selected as Finalist for Air Force KC-46A Tankers

On Wednesday, the [United States Air Force announced](#) the selection of both Forbes Airfield in Topeka and McConnell Air Force Base (AFB) in Wichita as finalists for the basing of the KC-46A tanker program. Forbes Airfield is a finalist for one of two Main Operating Bases competing against other Air National Guard-led, Active Association bases.

Last August, I met with Kansas National Guard 190th Air Refueling Wing leadership and was advised about this possibility. I am very pleased to receive confirmation that Forbes Field is indeed a strong candidate for the new KC-46A air-refueling tanker. Kansans play an essential role in our national defense and Forbes Field's ideal, central location, exemplary personnel, and capable facilities make it an excellent choice as the Air Force updates its missions. I applaud the decision, and look forward to the potential final outcome with regards to the future sustainability and viability of the 190th as they continue to serve in this critical role.

Due to rising costs, the United States Air Force has made transitioning from 50-year-old KC-135 tankers to KC-46A tankers a top priority. The 190th Air Refueling Wing stationed at Forbes Field has provided air-refueling capabilities since 1978, and currently flies the KC-135R Stratotanker air-refueling tanker.

Rep. Yoder Introduces Pay-Cut; Pension Elimination Bills 01/10/13

Representative Yoder Introduces Pay-Cut; Pension Elimination Bills

WASHINGTON, D.C. – To begin the 113th Congress, Representative Kevin Yoder continued his efforts to help reign in federal government spending by introducing two separate bills to cut the salary of Members of Congress, and to eliminate the Federal Employee Retirement System (FERS) pension program for Members no longer serving in Congress.

The first bill Representative Yoder introduced, H.R. 150, applies a 5 percent salary cut for all Members of Congress, as well as eliminates the automatic yearly cost-of-living adjustment (COLA) raise. Presently, the law states automatic COLA raises kick in each year unless Members vote and reject the raise. The second bill, H.R. 151, eliminates the FERS program for Members of Congress. By law, all Members are currently required to participate in the Federal Employees Retirement System, and are not able to opt out of the system. FERS then pays pension benefits to Members if they have served in Congress for at least 5 years before retiring or leaving office. Both bills have been referred to the House Committee on Administration and the House Committee on Oversight and Government Reform.

"Reducing benefits and pay for Members of Congress is an important step towards

restoring accountability and trust with the American people," stated Congressman Yoder. "In the 113th Congress, I will continue my efforts to take needed steps to bring government spending under control. In this effort, Congress must show the American people that it is willing to cut its own costs and eliminate its own benefits. The vast majority of the American people do not receive lifelong pensions, Members of Congress should not either. These tough economic times require all of us to sacrifice to rebuild this country, certainly our elected representatives can lead the way."

Wal-Mart to Hire More Than 100,000 Recently Discharged Veterans

The Walton family in Bentonville, Arkansas still owns the majority of Wal-Mart Stores Inc. The company has grown to become the largest retailer in the world with almost 9,000 locations and 2.2 million employees (1.4 million here in the US). They are the world's third largest public corporation and the largest private employer in the world. Their annual gross income for 2012 was just under \$450 billion dollars. Their subdivisions include Sam's Club, Walmex, Asda and Seiyu Group.

Over the past few years, Wal-Mart has received some scathing media coverage, mostly about how they discriminate against women in management and how they treat their employees by not providing benefits or enough hours to qualify for benefits. Earlier this week they were the target of reports that they had halted all orders for ammunition for their sporting goods departments because of the impending gun control laws from President Obama. However, the company quickly countered those reports by publicly saying that it is business as usual and they intend to continue supplying their customers' needs.

In the wake of all of the negative publicity Wal-Mart receives, I thought I would share a positive story for a change. Bill Simon, president and CEO of Wal-Mart Stores Inc. announced at the National Retail Federation convention in New York that company plans on [hiring at least 100,000 veterans](#) over the next five years. Anyone who has been honorably discharged from the military within the past 12 months will be given a serious consideration for employment in their retail and warehouse stores as well as in their distribution centers.

Simon told the audience: *"Let's be clear; hiring a veteran can be one of the best decisions any of us can make. Veterans have a record of performance under pressure. They're quick learners, and they're team players. These are leaders with discipline, training, and a passion for service. There is a seriousness and sense of purpose that the military instills, and we need it today more than ever."*

Wal-Mart executives have been in communication with the Obama administration on their plans to hire veterans. In response, the administration will be working with the Departments of Defense and Veteran Affairs as well as other major employers in an effort to get more companies involved in hiring and training America's military personnel upon their arrival back into civilian life.

For once, I have to give Wal-Mart a big thumbs up for willing to help those who defend us adapt back into the workforce. Well done Wal-Mart.

The New "Ron Paul" and Audit the Fed By John A. Heffern, Jr. on Fri., Jan. 25, 2013

Heffern: My name is John Heffern Jr. I appreciate the time you're taking to see me. We're set on pushing this audit the Fed agenda.

Congressman Broun: Well, thanks for your help 'cause I think it's absolutely critical that we audit the Fed and also introduce the bill to get rid of the Fed. So hopefully, demand that we get rid of it and we go to a gold standard which is the third bill that I introduced that same day.

Heffern: Well, a sound currency is one of our three pillars. Additionally, The Project would like to see a balanced budget amendment. And we believe Americans should keep 80 percent of their income.

Congressman Broun: I think if 10 percent's good enough for the Lord, it ought to be good enough for Uncle Sam.

Heffern: I've heard this before, however, we go by the [Laffer Curve](#). But there are a lot of people that agree with you and say, "why not go for 10 percent?"

Congressman Broun: Well, if we cut the outrageous spending that's going on here in Washington, if we returned to the Constitution as it was intended by our founding fathers which I believe very firmly in, then 10 percent's too much.

But we're headed towards an economic collapse of this nation if we don't stop the outrageous spending that both parties are guilty of doing up here.

And that's the reason I introduced in the last couple of congresses my balanced budget amendment, which is the toughest one out there. That's the reason I introduced the bill to audit the Fed and get rid of the Fed as well as the bill to go to a gold standard. So we've got to get this country back on a fiscal course that's sustainable. What we're doing today is going to lead us to be just like Greece. The President was talking about raising taxes on the millionaires and billionaires but the reality is even today some of the people in his own party, and I believe himself, think that we ought to raise taxes on everybody and continue the spending.

Heffern: With the payroll increase, almost everybody was hit already in their first two weeks. Everyone's gotten paid so far this year by today... So everyone's seen a decrease of at least 2.4 percent in their paychecks.

Congressman Broun: Sure.

Heffern: On a slightly different note, I saw that your father was a Democratic Senator for decades it looked like...

Congressman Broun: 38 years.

Heffern: 38 years, and serving in Georgia as well. So a household of politics... Could you tell when you were growing up or was it always kind of in the back of your mind that you were predestined for politics?

Congressman Broun: No, no, not at all. In fact, what started my political activism occurred much into my adult life. What began the process was I loved to hunt and fish. I became a member of conservation organizations and was concerned about my ability to own a farm and to be able to hunt. That led into studying the Constitution, what our founding fathers originally meant for the government to be under that document. And thus began to understand how far we've gotten away from it as a nation. I'm a Marine, I believe in freedom and liberty and I joined the Marine Corp to fight for that, to volunteer my services to try to keep us a free people. And we're losing our freedom, we're losing our liberty because both parties are spending too much. We are having too much intrusion on our lives.

As a physician, my medical practice is highly controlled by the federal government and it needs to stop. That's what's running up the cost of not only healthcare but all goods and services in this country. And I believe in the Constitution as our founding fathers meant it, means that my job should be a part-time job here in Washington.

I should be a full-time doctor in Georgia, come up to Washington periodically to vote, to make sure we have a strong national defense, make sure our foreign affairs are in the best interest of this country, vote only on the 18 things that Article 1, Section 8 gives us the authority to vote on, and then go back home and practice medicine. That's what it should be and that's what I'm fighting for here in Washington.

Heffern: You mention you are a doctor... I understand your new bill is identical to Dr. Ron Paul's. Do you have the same number of co-sponsors that the initial bill had?

Congressman Broun: Oh, no, no, not yet. We just introduced it last week, so we're just beginning the process. We have 100 plus co-sponsors already. Ron Paul had 274 if I remember correctly.

And it passed the House overwhelmingly with Democrat as well as Republican support. So we're just building support here in the House. Hopefully we can have a companion bill in the Senate and hopefully enough Americans will put pressure on Harry Reid so he'll stop his obstructionism.

Heffern: So there were 98 against it the first time around? Have you done anything to go to those 98 representatives to ask why they opposed it to try to flip them this time around?

Congressman Broun: We haven't gone that far. What we've been doing is just trying to get co-sponsors for the bill as it passed. If we have 300 plus vote for it and if 98 vote against it, then that's fine.

We still have a lot of socialists here in the U.S. House that like secrecy and they like government control of everything and everybody's lives, so those kind of people aren't going to want to see the Fed audited.

Heffern: For sure. And so you mentioned how it got obstructed in the Senate. Do you want to expand at all on that with what Harry Reid had done to not vote on it or why exactly would you say it flat lined over at the Senate?

Congressman Broun: Harry Reid has been the obstructionist for everything we've done here in the House, just about. We've passed bills to create millions of new jobs, to get our economy going, to lower the cost of gasoline and all the energy sources as well as passing the bill to audit the Fed. But Harry Reid throws them in the trashcan. He and Barack Obama are the big obstructionists. Their policies have failed. A good example is the stimulus bill. It was abject failure. It's not created a stronger economy.

The House has passed bills that would have created millions of new jobs, would have created a stronger economy. We would be a whole lot better off as a nation and a lot of people who are out there searching for a job today would have long since had one except for Barack Obama and Harry Reid's obstructing everything that we try to do over in the House that makes sense.

So he has obstructed every effort to have sound fiscal policy. Harry Reid, Barack Obama, and Nancy Pelosi want to continue spending money that we don't have. They want to continue the outrageous debt that they have created and want to create more.

Heffern: What would you recommend people do to really make sure that this is a key issue that isn't

just thrown in the trashcan this time around?

Congressman Broun: The most powerful political force in America is embodied in the first three words of the U.S. Constitution, "We the people." And what that means is that we the people need to rise up and say no to the outrageous spending, no to a fed that is totally secretive and nontransparent, need to say no to this socialistic agenda that the President is promoting in his dictatorial rule that he's been doing in many issues.

So I suggest that we try to get the readers to do everything that they can, post it on Facebook and Twitter. Talk about how we need to audit the Fed and that it's absolutely critical for people across this nation to contact their member of the U.S. Senate, their member of the U.S. House, and demand that we pass the audit the Fed bill. And that's what's going to turn the tide and make it happen. It's going to break through the obstructionism that Harry Reid is doing today when enough people put enough pressure on their member of Congress in the House and the Senate to do so.

Former U.S. Senator Everett Dirksen one time said when he feels the heat he sees the light. What he means by that is he's concerned about his re-election bid and if enough people contact him saying, "Buster, you're heading in the wrong direction," then he'll start seeing the light and will change directions. There are many members of Congress that need to feel that heat so that they can see the light and then we the people need to get a bunch of those folks to see the door if they don't.

So people must not stop talking about fiscal responsibility, spending control, auditing the Fed, a balanced budget amendment to the Constitution, and those types of issues. That's what's going to change Washington. I won't be able to do it except for through trying to continually get people engaged in this process of demanding a different kind of government that's here in Washington.

Heffern: I actually listened to a couple of your older interviews on your website, Countdown to the Shutdown. It's now not up, it's a blank screen obviously, it's a new year. But how successful was that? What was the format of that website?

Congressman Broun: It was an effort to try to show the American people that I believe that Barack Obama, Harry Reid, and Nancy Pelosi wanted to shut the government down and I thought that they would very likely do it to try to blame Republicans. And I think we're going to see that same effort on their part. I think everything that you'll see from this President and from Harry Reid will be geared towards trying to get Nancy Pelosi, the Speaker of the House, in the 2014 elections so that Barack Obama will have an unfettered reign to continue his radical, socialistic, Marxist agenda. And I think everything that they do will be geared towards that. I would not be surprised at all if they go to the point of shutting the government down to try to bring Republicans so that Barack Obama can establish himself in a very dictatorial manner like he's trying to rule right now today.

Heffern: In light of the obstructionists at play, it's great that you're really pushing hard for this transparency effort, and we support you fully in your audit the Fed measure. We will do what we can.

Last Saturday (1/19/13) a "grass roots leader" was telling grass roots leaders and members of the Liberty movement we should all sing the praises of Sheriff Denning for his "statement on gun control." Well I am from the Sheriff's county, I know the Sheriff and in fact have dealt with the Sheriff.

Knowing Sheriff Denning, I was very suspicious of any statement he would make in support of the citizens constitutional rights (more about that later.)

My suspicion of Sheriff Denning proved to be warranted. First, let's look at the text itself:

"I will never support, nor advocate for, ANY legislation at ANY level (local, state or federal) that would restrict the legal possession or ownership of any type of firearm (or high-capacity magazine) by lawful, law-abiding, tax-paying citizens of Johnson County, Kansas and of the United States of America." (Note 1)

This statement should give no literate or thinking citizen any comfort in the least. This language is not a commitment that the Sheriff will uphold his duty to protect the Constitution or anyone's Constitutional rights. It is purely a political statement meant to gain political or popular goodwill where none is deserved.

Note that the good sheriff is not saying he will not enforce a law that "restricts the legal possession or ownership of any type of firearm (or high-capacity magazine) by lawful, law-abiding, tax-paying citizens of Johnson County, Kansas and of the United States of America." He is simply saying he will not "support, nor advocate" such [proposed] legislation.

Well he would do well not to since the support and advocacy of such a law would violate his oath of office to protect the Constitution.

There are two much more relevant and important questions to be answered. First, will he enforce or assist in enforcing such an unconstitutional act? Under the principles of federalism he cannot be required to enforce a federal law, but will he? Some Sheriffs and other politicians are under the mistaken belief that any federal law is supreme to state law and that they are required to enforce or follow them. This is absolutely false.

The Sheriff's duty is governed by Article VI clauses 2 and 3 of the Constitution. Under clause 2 only those federal laws "made in Pursuance" of the Constitution "shall be the supreme Law of the Land..." In "Pursuance" means pursuant to both the procedural requirements and the substantive limits of the Constitution.

Under clause 3 the Sheriff had to take an oath "... to support..." the Constitution. Under his oath the sheriff is required to have a working knowledge of the Constitution. This oath establishes an affirmative, active and personal duty on the Sheriff.

The combination of clause 2 and 3 requires that the Sheriff personally make a determination that a law he is going to enforce is in fact constitutional. He may not wait for someone else to make a determination nor may he rely upon someone else's determination. He may not simply presume that anything Congress passes is constitutional. That is the antithesis of the purpose of the separation of powers. He must personally make such a determination and he is personally accountable for such a determination.

Secondly and more importantly is whether he will protect Kansas citizen from federal agents (or Kansas law enforcement) if they attempt to enforce such law i.e., arrest Kansans. The good Sheriff does not bother to answer these real questions.

The technique he uses is deflection. It is often used by politicians to change the subject on an issue which the politician does not want to give an answer. It is deceptive if not dishonest.

I met and had an in depth discussion with Sheriff Denning regarding the fact that the National Defense Authorization Act (NDAA) of 2012 violates over a dozen provisions of the Constitution and the Bill of Rights. I wanted to know if he would sign a resolution against the NDAA by which he acknowledged it was unconstitutional and he would not enforce such or would not assist in its enforcement.

He was to call me if he had any questions and we were to get back together to discussion his decision. After numerous attempts to follow up with the elected Sheriff it was clear he would no longer return my e-mails or calls.

Yes my public "servant" who had an obligation to be responsive to me and who agreed to follow up with me was giving me the brush off. This was my first indication that Sheriff Denning did not understand or was not respectful of the proper relationship between an elected official and a citizen. It was not his last indication of such.

I ran into Sheriff Denning at the Johnson County GOP primary watch. The conversation was as follows:

RDF: "Why are you not returning my e-mails?"

Sheriff: "Well you would not like my answer."

RDF: "You work for me. I have a right to your response."

Sheriff: "I won't answer in writing."

Wow what integrity by the Sheriff. He will not answer a question by one of his bosses as to whether he

will denounce and not enforce the unconstitutional citizen detention provisions of the NDAA 2012.

Not only will he not say he won't take away your guns he will not answer the question as to whether he will take you away under an unconstitutional NDAA law. If you are "captured" under the NDAA you will not have to worry about your Second Amendment rights. Those that put the Second Amendment above personal Liberty are idiots. Let me repeat: If you are "captured" under the NDAA you will not have to worry about your Second Amendment rights.

Has Johnson County Kansas Sheriff Frank P. Denning now found the Constitution and his Duty? No he is trying to perfect a political ploy to deceive the people he is obligated to protect.

E-mail Sheriff Denning and ask him: "*Sheriff, will you enforce the citizen detention provisions of the NDAA 2012 and will you stop others from enforcing the 2012 NDAA in Johnson County?*"
