He lambasted the media's outrage at Brent Musburger's flattering comments about Alabama beauty queen

Katherine Webb during the BCS National Championship.

In the second portion of his interview with Hannity, Carson argued he didn't craft his message based on who was going to be in attendance. In other words, wasn't trying to stick it to Obama in his speech.

"It really didn't matter who I was sitting in front of, because I always pray before I give a speech and I ask God to give me the right things to say. And I think that it's very rare these days for people to speak the truth," he said. "Meanwhile, the fabric of our nation is being destroyed.

One of the "real dangers" facing America, according to Carson, is the fact that people don't know "anything" about things like history or technology. "They don't think for themselves," he added.

Seizing upon what many of Carson's supporters are probably wondering, Hannity asked him if he would ever consider running for president. The doctor did not rule it out, but said God would have to "grab him by the collar and make him do it."

The Wall Street Journal too in an opinion piece titled "[Ben Carson for President](#)" called up his potential for the Oval Office. Here's a bit from WSJ regarding Carson's "un-PC" ideas at the White House prayer breakfast, which included flat tax and healthcare:

Dr. Carson tossed over the PC police years ago. Raised by a single mother in inner-city Detroit, he was as he tells it "a horrible student with a horrible temper." Today he's director of pediatric neurosurgery at Johns Hopkins and probably the most renowned specialist in his field.

Not surprisingly, a practicing physician has un-PC thoughts on health care:

"Here's my solution: When a person is born, give him a birth certificate, an electronic medical record, and a health savings account to which money can be contributed—pretax—from the time you're born 'til the time you die. If you die, you can pass it on to your family members, and there's nobody talking about death panels. We can make contributions for people who are indigent. Instead of sending all this money to some bureaucracy, let's put it in their HSAs. Now they have some control over their own health care. And very quickly they're going to learn how to be responsible."

The Johns Hopkins neurosurgeon may not be politically correct, but he's closer to correct than we've heard in years.

Marines Were Disarmed for President Obama's Second Inaugural Parade

He's gutted their healthcare, plans to cut their pay and apparently, doesn't trust them either. David Codrea over at Gun Rights Examiner points out that Marines marching in President Obama's second inaugural parade recently were caring rifles without bolts, meaning they were removed.

"Didn't know the Marines had to take the bolts out of their rifles for the Inaugural," an email

forwarded to Gun Rights Examiner from a United States Marine Corps source observed. "Wonder if someone can explain why [they] would be marching in the inaugural parade with no bolts in their rifles!"

The email linked to a YouTube video of the 57th Presidential Inaugural Parade, embedded in this column, featuring Bravo Company Marines from the Marine Barracks Washington. Sure enough, the observation in the email is confirmed by watching the video, with screen shots provided in the photo and slide show accompanying this article.

This prompted an internet search to see if others had also noticed, and the Blur-Brain blog had. "The bolts have been removed from the rifles rendering them unable to fire a round," the post stated. "Apparently Obama's Secret Service doesn't trust the USMC. Simply searching each guy to make sure he didn't have a live round hidden on him wasn't enough, they had to make sure the guns were inoperable. Wondering if this may be an inauguration policy of long standing that transcends administrations, Gun Rights Examiner made a cursory search and found something even more curious. In the 2009 Inaugural Parade, the United States Navy marched with rifles that had not been so disabled (see 1:24 into that video plus the final slide).

Fort Hood Hero Says President Obama 'Betrayed' Her, Another Victim of Obama's

Three years after the White House arranged a hero's welcome at the State of the Union address for the Fort Hood police sergeant and her partner who stopped the deadly shooting there, Kimberly Munley says President Obama broke the promise he made to her that the victims would be well taken care of.

"Betrayed is a good word," former Sgt. Munley told ABC News in a tearful interview to be broadcast tonight on "World News with Diane Sawyer" and "Nightline."

"Not to the least little bit have the victims been taken care of," she said. "In fact they've been neglected."

There was no immediate comment from the White House about Munley's allegations.

Thirteen people were killed, including a pregnant soldier, and 32 others shot in the November 2009 rampage by the accused shooter, Major Nidal Hasan, who now awaits a military trial on charges of premeditated murder and attempted murder.

Tonight's broadcast report also includes dramatic new video, obtained by ABC News, taken in the immediate aftermath of the shooting, capturing the chaos and terror of the day.

Munley, since laid off from her job with the base's civilian police force, was shot three times as she and her partner, Sgt. Mark Todd, confronted Hasan, who witnesses said had shouted "Allahu Akbar" as he opened fire on soldiers being processed for deployment to Afghanistan.

As Munley lay wounded, Todd fired the five bullets credited with bringing Hasan down.

Despite extensive evidence that Hasan was in communication with al Qaeda leader Anwar al-Awlaki prior to the attack, the military has denied the victims a Purple Heart and is treating the incident as "workplace violence" instead of "combat related" or terrorism.

Munley and dozens of other victims have now filed a lawsuit against the military alleging the "workplace violence" designation means the Fort Hood victims are receiving lower priority access to medical care as veterans, and a loss of financial benefits available to those whose injuries are classified as "combat related."

Some of the victims "had to find civilian doctors to get proper medical treatment" and the military has not assigned liaison officers to help them coordinate their recovery, said the group's lawyer, Reed Rubinstein.

"There's a substantial number of very serious, crippling cases of post-traumatic stress disorder

exacerbated, frankly, by what the Army and the Defense Department did in this case," said Rubinstein. "We have a couple of cases in which the soldiers' command accused the soldiers of malingering, and would say things to them that Fort Hood really wasn't so bad, it wasn't combat."

Pentagon Press Secretary George Little said the Department of Defense is "committed to the highest care of those in our military family."

"Survivors of the incident at Fort Hood are eligible for the same medical benefits as all service members," said Little. "The Department of Defense is also committed to the integrity of the ongoing court martial proceedings of Major Nidal Hasan and for that reason will not at this time further characterize the incident."

Secretary of the Army John McHugh told ABC News he was unaware of any specific complaints from the Fort Hood victims, even though he is a named defendant in the lawsuit filed last November which specifically details the plight of many of them.

"If a soldier feels ignored, then we need to know about it on a case by case basis," McHugh told ABC News. "It is not our intent to have two levels of care for people who are wounded by whatever means in uniform."

Some of the victims in the lawsuit believe the Army Secretary and others are purposely ignoring their cases out of political correctness.

\$9-\$9-\$9: Herman Cain Calls Obama's Minimum Wage Increase 'Dead Wrong' On Fox

When President Obama [proposed raising the minimum wage to \\$9 per hour](#) during Tuesday night's State of the Union address, references to former GOP presidential candidate Herman Cain's 9-9-9 economic plan immediately began flowing on social media. While Cain's plan was based around the number nine, it did not include a provision to raise the national minimum wage. And Wednesday afternoon on Fox News, he told host [Neil Cavuto](#) why he thinks Obama's plan is such a bad idea.

Cavuto began by showing data that demonstrates a correlation between high minimum wage and high unemployment in certain states. He then asked Herman Cain, who as former CEO of Godfather's pizza has some experience with low-wage workers, what business owners around the country are going to do if Obama's wage increase goes into effect.

"Well, they're either going to have people work less hours or they're going to hire less people. That's typically what happens," Cain said, when minimum wage goes up. "Here's where the president is dead wrong," he continued, arguing that raising the minimum wage from \$7.25 to \$9 is "not going to get anybody out of poverty." Cain added that if business owners keep their employees on, the extra cost will just get "passed on to the consumer."

Looking back at his Godfather's experience, Cain said that he would occasionally raise the salaries of his employees above the mandated minimum wage "because of a shortage of workers. So allow the marketplace to do its thing. This illustrates his advisers' total lack of business literacy."

Cain finally addressed the inherent connections between the president's plan and his own 9-9-9 platform, saying, "9 is my favorite number, but not in this case."

President Obama last night continued his hijacking of the American Dream. Using language long accepted as part of the American tradition, he struck a pose as a defender of hard work, responsibility, and other traditional values. We should not be fooled. His vision of the American Dream is not the real deal. Rather, it is an imaginary vision long dreamed of by America's progressives, but also long rejected by the American people.

Obama's "North Star," a phrase he used in last night's State of the Union speech, is to redefine what Americans expect of their government, and in turn, to transform what the government has a right to do to Americans.

He claims he wants to restore the "basic bargain that built this country." If that were true, he would be reducing the dependence of people on government. After all, for most of its history, Americans looked to themselves, not government, to get ahead in life.

It's about government benefits and services. It's not what people should be given a right and freedom to do for themselves.

When the President says he wants to restore an American where "you can get ahead, no matter where you come from, no matter what you look like or who you love," you can rest assured he doesn't mean what most Americans are hearing. It sounds as if he's raising a flag in defense of self-reliance and responsibility. But that's not what he's doing. From all the new government programs he has proposed it's clear he means the exact opposite: doubling down on the welfare state and adding a crippling debt that mortgages our children's future.

When he talks about building "new ladders of opportunity into the middle class," you can bet he doesn't mean empowering individuals with the equality of opportunity. He doesn't think of liberalizing the economy to get it growing again, which would help bring lower-income people into the middle class. Rather, he means using government programs for lower-income people, which traps them in poor and dangerous neighborhoods.

When he calls for stronger families, you would think that he means reducing that welfare dependency that has accompanied the breakup of families in low-income neighborhoods. But in reality, he has only doubled down on the welfare state that has decimated these families.

When he suggests encouraging "free enterprise," you would think he means cutting regulations so

businesses can start hiring again. But his support for the Dodd-Frank financial bill and other regulations imposed on the economy is moving the country in the opposite direction.

Here's an idea: How about we start a truth in advertising campaign concerning the American Dream? No spin. No twisting of meanings of words. Just a straightforward understanding of what it has meant to Americans down the ages.

Maybe then, at least the American people would understand where Obama is taking the country.

Tide is Turning in Abortion Debate—Liberals Run Scared

According to a Gallup poll, Americans aged 18-29 are trending toward a more pro-life set of beliefs.

The following is an excerpt from the Gallup data:

"The [poll] focused on public support for the 'legal under any circumstances' option in Gallup's abortion question. There is a somewhat different pattern in the trends by age for those choosing the 'illegal in all circumstances' position...Two important changes are apparent. One is a significant drop in the percentage of seniors saying all abortions should be illegal...This long-term 11-point decline among seniors compares with a 9-point increase — from 14% to 23% — in support for the 'illegal in all circumstances' position among 18- to 29-year-olds since the early 1990s."

This trend is causing the aggressively pro-abortion advocacy group NARAL to freshen up its image. According to Janie Lorber: "NARAL leaders have not been shy about acknowledging an "intensity" gap, making it a major theme of last week's event...Advocates on both sides of the debate agree that young adults fighting abortion are much more engaged." For a group like NARAL to have to attempt such a reinvention shows signs of fear amongst the liberal, pro-choice base.

With advances in ultrasound technology, and the availability of pro-life information online; maybe the tide is turning in the abortion debate. It seems to me that young pro-life advocates are pushing back so hard because they are fighting for life. That would account for such an enthusiasm gap. Young pro-life advocates are crusading for the lives of the unborn.

The youth on the Left are fighting for nothing. If you ask a young pro-choicer *why* they believe what they believe, you are likely to hear platitudes about "a woman's body," and "a woman's right to choose." Delve deeper, and ask them if they know the procedures involved in an abortion; they will become indignant, and try to lure you back into a maze of circular logic, ending right back at "a woman's right to choose." Young pro-choicers lack enthusiasm because—beyond Liberal surface level talking points—they have **no idea** what they are fighting for.

What it comes down to is platitudes versus actual, fact-based information. Platitudes may be flashy, and they may go down easy, but facts—no matter how unpleasant—always triumph in the end. This enthusiasm gap between young pro-lifers and pro-choicers can only become larger.

What is a Hollow Military Force?

A hollow tree looks healthy on the outside, but its core wood is rotten. One strong wind, a heavy snow, sleet, or freezing rain cracks it open and it crashes.

A naval warship cannot move if:

1. Its metal starts to rust for lack of paint,
2. Wear parts cannot be lubricated or replaced,
3. It has no fuel, and/or
4. The crew is not available to care for it.

A warship cannot survive in combat if:

1. It runs out of bombs, torpedoes, missiles, ammunition,
2. It has no properly trained people to guide the ship, detect the enemy presence, or use its weapons with superior skill. and/or
3. The ship’s defensive weapons are useless because the technology cannot detect and destroy an enemy’s weapons before they can do their damage.

An Air Force is hollow when pilots climb into aircraft that are:

1. Older than their pilots (average aircraft age is 25 years, some are over 50 years old),
2. With flight training cut to the bone,
3. Have obsolete avionics,
4. Have deferred maintenance for lack of spare parts,
5. Have unrepairable stress cracks in their airframe,
6. Have no chance of survival against modern surface-to-air missiles, and

7. The enemy has superior aircraft with highly-trained pilots flying them.

The US Army has a hollow force if:

1. Their training is inadequate to prepare them for their combat roles,
2. The enemy controls the sky above them,
3. They cannot get to the enemy in time to make a difference,
4. Their equipment is worn out with over-use,
5. They lack the supplies, weapons and close air support to sustain their mission,
5. They lack the communication, intelligence, security and reconnaissance to make a successful mission possible,
6. They lack search and rescue,
7. They cannot service their equipment, and/or
8. Run out of food, shelter, ammunition and weaponry.

Drones are not the only answer

Remotely piloted aircraft (RPA, UAV) mistakenly called “drones” do not have a piloted aircraft’s reaction speed. Pilot/aircraft communication requires time. Routers, network switches, uplinks, cross-links and downlinks repeat, strengthen, encrypt and decrypt everything. Pilots also share bandwidth. That activity slows reaction speed.

Therefore, RPAs cannot live in hostile airspace or takeoff/land in hostile ground space. If communication satellites are blown to pieces or rendered useless, unpiloted aircraft are useless.

If sequestration becomes reality, our military risks a hollow force. As we get closer to March 1st, we approach our #1 enemy – namely ourselves. Without Congressional and Presidential action, automatic budget cuts of \$1.2 Trillion will happen. The defense budget will be reduced about \$55 billion per year until 2021 with 42.7 billion in the remaining seven months of this year. This cut is over and above the \$50 billion per year reduction that already occurred. The Air Force share of this extra hit is \$12.4 billion over the seven months remaining in the current fiscal year.

The problem is even worse because everything the US Military buys will increase about 10% per year caused by inflation of our currency. If any production contracts require termination or a quantity reduction, the change-order costs will waste any potential savings.

The short-term effects are devastating:

1. Up to 800,000 DOD employees could be put on a four-day work week starting in April 2013, resulting in reduced pay for each person.
2. The stock market for the Defense Industry sector already is in free-fall. These corporations and their secondary suppliers already are issuing 60-day layoff notices anticipating that sequestration will occur.
3. Up to 35% of our ROTC graduates will not receive their Commission.
4. Flight hours will have to be reduced by a third.
5. Weapon system sustainment would be cut by as much as 18%. That reduction severely reduces aircraft availability and mission capability.
6. Two million private-sector jobs will be lost according to a 2012 study by Dr. Stephen Fuller at George Mason University. I cannot find one example where we cut defense to this degree while, at the same time, fight a war.

I frequently remind people that the Preamble to the Constitution says “ ... provide for the common defense, promote the general welfare ...” “Provide” is a mandate. “Promote” is a marketing project. In reality, the verbs (at least here in Washington) seem to be swapped.

These political leaders took a solemn oath to preserve and protect our Constitution. Many of them step all over our supreme law of the land with impunity. They violate their oath without concern or reprisal.

Politicians must hear our voices about the effects of sequestration. Secretary Panetta said this. “Instead of being a first rate power in the world, we’d turn into a second rate power.” It is irresponsible to let this happen after so much sacrifice.

“... after so much sacrifice.” I doubt if there is an American family that has lived legally in this country for 10 or more that has not had a family member in the military, police force, fireman or maybe a member that was killed in the line of duty in one or more of these services. Have our loved ones served and/or died in vain? If we let those that intend to

completely destroy the United States of America to continue toward their goal that is exactly what it will be - our loved ones will have died in vain. We must fight in every way we can to stop the destruction of our country. I pray we will not have to another Revolutionary War, but we must be prepared and if we let them take the Second Amendment from us or render it useless we won't have a chance. When we ask/beg you to call, email, write our Congress members or Kansas Legislators we are asking because it is important. We must stop Obamacare, decrease Federal spending, keep our Military strong, take control of our schools curriculum, and secure our borders. "We the People" can do this - if everyone does their part. DHS Nullifies Fourth Amendment Rights of Millions of Americans

“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”

If you live anywhere in Connecticut, Delaware, Florida, Hawaii, Maine, Massachusetts, Michigan, New Hampshire, New Jersey or Rhode Island, DHS says the search zones encompass the entire state. If you live anywhere in any of the designated search zones, the feds claim to have the right to invade your privacy and conduct an unconstitutional search of your private possessions without any probable cause or warrant.
