### **Gun makers fight back!**

Six gun companies are fighting back against the federal, state and local governments who have enacted strict gun laws.

Their various statements emphasize that such laws create a class of government employees with rights and a class of citizens without rights. Thus, they refuse to aid the enforcement of such inequality.

The announcements read:

#### **LaRue Tactical**

Effective today, in an effort to see that no legal mistakes are made by LaRue Tactical and/or its employees, we will apply all current State and Local Laws (as applied to civilians) to state and local law enforcement / government agencies. In other words, LaRue Tactical will limit all sales to what law-abiding citizens residing in their districts can purchase or possess.

#### **Olympic Arms**

Due the passing of this legislation, Olympic Arms would like to announce that the State of New York, any Law Enforcement Departments, Law Enforcement Officers, First Responders within the State of New York, or any New York State government entity or employee of such an entity - will no longer be served as customers.

In short, Olympic Arms will no longer be doing business with the State of New York or any governmental entity or employee of such governmental entity within the State of New York - henceforth and until such legislation is repealed, and an apology made to the good people of the State of New York and the American people.

#### **Extreme Firepower Inc, LLC**

The Federal Government and several states have enacted gun control laws that restrict the public from owning and possessing certain types of firearms. Law-enforcement agencies are typically exempt from these restrictions. EFI, LLC does not recognize law-enforcement exemptions to local, state, and federal gun control laws. If a product that we manufacture is not legal for a private citizen to own in a jurisdiction, we will not sell that product to a law-enforcement agency in that jurisdiction.

#### **Templar Custom**

We will not sell arms to agents of the state of New York that hold themselves to be "more equal" than their citizens. As long as the legislators of New York think they have the power to limit the rights of their citizens, in defiance of the Constitution, we at Templar will not sell them firearms to enforce their edicts.

Templar Custom is announcing that the State of New York, any Law Enforcement Departments, Law Enforcement Officers, First Responders within the State of New York, or any New York State government entity or employee will no longer be served as customers.

## York Arms

Based on the recent legislation in New York, we are prohibited from selling rifles and receivers to residents of New York. We have chosen to extend that prohibition to all governmental agencies associated with or located within New York. As a result we have halted sales of rifles, short barreled rifles, short barreled shotguns, machine guns, and silencers to New York governmental agencies.

## Cheaper than Dirt

Recently, companies such as LaRue Tactical and Olympic Arms have announced that they will no longer sell prohibited items to government agencies and personnel in states that deny the right to own those items to civilians. It has been and will continue to be Cheaper Than Dirt's policy to not to sell prohibited items to government agencies and/or agents in states, counties, cities, and municipalities that have enacted restrictive gun control laws against their citizens. We support and encourage other companies that share in this policy.

Personally, I find this action in complete accordance with the Constitution and my own feelings about gun control. The 2nd Amendment will NOT be infringed upon. It is NOT negotiable.

"Sequestration," which sounds like an impolite stomach ailment that almost nobody can spell and few

understand, now gets really interesting. With the sequestration deadline having passed, the [White House](#) is under siege by reality.

President [Obama](#) and his liege men have been crying from the rooftops for weeks that if he doesn't get to further plunder taxpayer pockets, airplanes will fall from the sky, classrooms will empty, fire and brimstone will ruin every hearth because there won't be anybody at the firehouse to answer the telephone, crooks and criminals will roam the land doing all manner of evil because the cops will be on furlough, babies will cry in vain for milk, men will join bread lines like we haven't seen since the 1930s and women will weep tears of bitter reproach, tsunamis will rise from the river, bayou and creek, locusts will devour failing crops, and we'll all be dead by the [Fourth of July](#) (if not Memorial Day). Woe is definitely us.

With Judgment Day at hand, the only thing left for the [White House](#) to do is to kill, or at least grievously wound, as many bearers of bad news as the president's men can find. Blaming the press is always popular, because the press deserves whatever abuse it gets. Richard Nixon kept an "enemies list," and it was taken as the threat the [White House](#) meant it to be. Everyone immediately thinks of an IRS audit. John F. Kennedy once canceled a subscription to the late New York Herald-Tribune, which was a nominally Republican newspaper, because he didn't like something he read there. For several days there was quite a row in all the newspapers.

The Obama [White House](#) gets particularly exercised by grunions of the cult who dare question or criticize the messiah from Chicago. When Lanny Davis, a senior aide to President Clinton and a loyal Democrat, summoned the courage to needle the Obama administration early on in a column in [The Washington Times](#), the newspaper got a call suggesting that it should print no more op-ed contributions from Mr. Davis if it knew what was good for him, and it. The Times told the [White House](#), as any serious newspaper would, that the newspaper and not the [White House](#), any [White House](#), decides when and what to print.

## When Cutting 8 Days of Spending is Seen as Disastrous, We're Doomed

Everybody's panic over President Obama's proposed and then phonily condemned sequester—federal

budget cuts across the board—is really something to behold. But is it any wonder?

Obama has been telling people that if these cuts go through, they and their kids won't be able to eat, that the roads and bridges of America will crumble, that our military will be so weakened that who knows if we'll be able to defend ourselves against a North Korean or Iranian nuclear missile?

His fellow Democrats in Congress are doing their part in helping to spread the fear, with Congresswoman Maxine Waters warning that “over 170 million jobs could be lost” if the cuts go into effect. Considering that there are only 140 million jobs in America, it can be reasonably deduced that Waters is one of either a liar or an incompetent.

There are a couple funny aspects to the panic.

For one thing, while the sequester is a cut in the budget only technically, the government will still spend more in 2013 than it did in 2012. Spending is still going up in spite of this cut.

Additionally, the amount to be cut from the federal budget by the sequester is \$85 billion. The 2013 budget is \$3.8 trillion. That means the government plans on spending \$10,410,958,904 per day this year. I'd double-check my math with Maxine Waters, but if I'm correct, that means that the \$85 billion sequester amounts to eight (8) days of federal spending. Eight days. We're panicking over eight days' worth of spending.

To be sure, \$85 billion is a lot of money. But in the context of our yearly budget? To give a sideburns analogy (my favorite kind of analogy), it would be like getting upset that your barber trimmed one of your sideburns half an inch shorter than you wanted. That's it. And meanwhile, you've still doused your scalp in Miracle-Gro so that your hair grows faster than it did last year.

In order to take away Obama's ability to spread fear over this offensively small cut, the Republican-controlled House passed a bill to allow him to direct precisely where the cuts are made rather than to proceed with across-the-board cuts. But in order to make sure Obama could continue to stand his fear-mongering ground, the Democrat-controlled Senate didn't allow that bill to pass.

The Democrats pretend they don't want the sequester to take place, but of course they do. That's why they and Obama have done nothing about it. And in order to ensure a general Democratic victory in the 2014 midterm elections, they've ginned up terror over the sequester, warning that it will turn us into a third-world toilet, much like the socialist-dictated countries Obama is always trying to get us to emulate – and that it's all the fault of Republicans! All that has been missing from Obama's disingenuous warnings that the sequester must not happen is the slogan, “Vote Democrat in 2014.”

The worst part of it all is that the Democrats have been successful in scaring people away from fiscal responsibility. They are convinced that a 2-percent cut in spending – a cut which doesn't even account for half of the federal government's own claimed waste and fraud – will hurt us.

If the public is so easily fooled into freaking out over such a miniscule cut, what will the reaction be at the news that the sequester is a mere fraction of the cuts we actually need to make for the country's own survival? If they won't even stomach \$85 billion, this country is done.

Quite possibly the only way for the Republicans to gain control of the Senate and retain control of the House is for ALL AMERICANS TO VOTE. ## **Training Sheep To Know Their Place: Boy Suspended For Disarming Gunman**

On a school bus returning students to their homes, a fifteen-year-old boy pointed a .22 revolver point blank at another student's chest. [WFTX reports](#),

"The student grappled the gun away from the 15-year-old suspect on the bus ride home Tuesday after witnesses say he aimed the weapon point blank at another student and threatened to shoot him. The student, who Fox 4 has agreed not to identify because he fears for his safety, says there's 'no doubt' he saved a life by disarming the gunman... 'I think he was really going to shoot him right then and there,' the student said. 'Not taking no pity.' The student says he wrestled the .22 caliber RG-14 Revolver away from the suspect, a football player, who witnesses say threatened to shoot a teammate because he had been arguing with his friend. 'No doubt,' the student said, 'he was going to shoot him point blank.' The teen we spoke to and authorities both confirm the Revolver was loaded. According to the arrest report the suspect, who Fox 4 is not naming because he is a minor, was 'pointing the gun directly' at another student and 'threatening to shoot him.'"

The police confirmed to the media that the handgun was loaded. Nevertheless, the school suspended the boy for three days for being involved in an "incident" that involved a weapon.

So what are we to make of this? DHS puts out instructional videos telling disarmed people to grab scissors and confront the shooter. But when one of the sheep actually puts himself in danger to help someone out, he gets punished for taking action. Was he supposed to go huddle in a corner and pray for police to arrive? Perhaps he should have adapted the advice given to college women to dissuade a rapist by peeing on himself or throwing up?

In the meantime, we see [a seven-year-old suspended from school](#) for nibbling his generic "pop tart" into the shape of a mountain, but which a teacher decided must really be a gun. ## **The Massacre of Free Enterprise**

In an unbelievable turn of events, both the Kansas Senate and the Kansas House turned away legislation that would have slightly eased the burden of alternative energy mandates, which currently requires 20% of Kansas electric power to be produced by alternative energy by 2020.

This 20% mandate will, according to Kansas Policy Institute, increase the average household electricity bill by \$660 per year; commercial businesses by an average of \$3,915 per year; and industrial businesses by an average of \$25,516 per year. These are real dollars out of YOUR pocket.

The Senate Committee of the Whole passed SB82 for final action, only to defeat it in emergency final action with a vote of 17 yeas and 23 nays. This represents 15 Republicans joining with Democrats (the Senate is made up of 32 Republicans and 8 Democrats) sending a message that Kansas will continue to embrace crony capitalism/government control of industries through energy mandates, burdening consumers with ever increasing utility rates.

Kansas currently has the highest utility rates in the Midwest region. Our industrial rates are 36% higher than Oklahoma, 47% higher than Louisiana and unbelievably slightly higher than the State of New York!

Wind energy advocates state wind is the cheapest form of energy. If that is true, then let's repeal the mandates. However, facts do not and will not back up wind advocates' assertion as rates continue to rise, subsidies from the federal government continue to cost all taxpayers and property taxes are abated FOREVER on all alternative energy production plants/wind farms.

On the House side HB2241, a stronger free market bill extends the timeline of mandates and caps it at 15%, was sent back to Utilities committee to die without debate on a 63-59 (there are 92 House Republicans) unrecorded vote.

According to leadership, Rep. Richard Carlson, who was chairing the House Committee of the Whole, purposely rushed the vote and ignored the call to record the vote to "protect our delegation from the wind

energy industry.” Really? What happened to transparency, the right of the people to know how their Representative votes on ALL issues?

Calls from conservative leaders across Kansas to Speaker Ray Merrick requesting that he reassign the bill to an exempt committee were fortunately heeded. According to his Chief of Staff, the Speaker has reassigned HB2241 to the Appropriations Committee, which hopefully will give conservatives time to marshal the votes needed in the House to pass this important piece of legislation.

One last question: Where was the governor on this important reclamation attempt for free enterprise in Kansas? Was he behind the scenes manipulating the process to reflect his strong support of green energy in Kansas?

**Pray for our leaders to find the courage to stand on conservative principles while representing the good people of Kansas.**
