#### Jesse Jackson: Get The UN Involved in the Zimmerman Case

The idea of getting the federal Department of Justice involved in what should have remained a local story is preposterous. But Eric Holder announced recently that his department would be opening an investigation and will possibly bring civil rights charges against Zimmerman. We'll see. Holder may have bitten off more than he can chew, since there isn't any real evidence that Zimmerman "profiled" Martin *because* he was black.

As over-the-top as it is, getting the DOJ involved just isn't enough for some people. Take a look at what [Jesse Jackson](#) said:

"Congress must act. And it's time to call on the United Nations Human Rights Commission for an in-depth investigation of whether the U.S. is upholding its obligations under international human rights laws and treaties."

All because a jury decided that Zimmerman was not guilty? Earlier, Jackson was complaining that there were [no men or blacks on the jury](#). Only women. White women:

"Well, it was a stretch, trying to avoid the obvious. There was no—you speak of jury of your peers: there was no man on the jury—Trayvon was a black boy—there was no man, no black on the jury. So at least the idea of jury of your peers was a stretch all the while."

The "jury of your peers" is something that applies to the person being accused of a crime. That would be George Zimmerman. And he was afforded a jury of his peers (except that they were women).

Jackson balks at an "unfair" jury composition, but then says we need to get an international body involved to determine whether or not we're abiding by international human rights laws. But we are. Zimmerman was given a fair trial. Many argue that he shouldn't have even been prosecuted in the first place because of a lack of evidence. That doesn't mean that he was innocent; just that there wasn't enough to prove one way or the other. That's another one of those "human rights" that I'm sure Jesse Jackson doesn't want to bring up in the context of this trial – the presumption of innocence until the accused is proven guilty. Even the UN's Universal Declaration of Human Rights acknowledges that one.

If the UN doesn't deliver for Jesse Jackson, I'm sure he can call on the Galactic Republic.

## **EDITOR FIRED OVER 'SHOVE IT' OBAMA HEADLINE**

'This newspaper will not permit violations of its standards'

The Chattanooga Times Free Press editorial page editor who criticized President Obama's jobs plan by telling the president to "shove it" is now out of a job.

Drew Johnson's editorial, titled "[Take your jobs plan and shove it, Mr. President: Your policies have harmed Chattanooga enough,](#)" went viral and drew national attention earlier this week when President Obama visited the city.

Johnson, who had been with the newspaper for just over a year, [addressed his firing with a classic comment on Twitter.](#)

“I just became the first person in the history of newspapers to be fired for writing a paper’s most-read article,” he tweeted. “We change headlines all the time without incident or issue.”

Worse yet, Johnson said the policy he reportedly broke “did not exist” when he changed the headline.

“It was created after people complained about the headline & was applied retroactively,” he [tweeted](#).

Johnson added: “To answer a question I’ve gotten a lot: I feel confident that if the headline had referenced Bush instead of Obama, I would still have a job.”

In an interview with Fox News, he said his criticism of the president’s jobs plans was in line with the views of many readers, but his bosses were dealing with complaints.

“[The editor] said that she was disappointed in the headline, that she thought it was crass and she’d gotten a lot of complaints by Obama supporters,” he said, recalling a meeting he had with the editor earlier in the week.

The newspaper released a statement Thursday saying Johnson had been fired for “placing a headline on an editorial outside of normal editing procedures.”

“The headline was inappropriate for this newspaper,” the statement read. “It was not the original headline approved for publication, and Johnson violated the normal editing process when he changed the headline.”

The newspaper denied Johnson’s firing had anything to do with the content of his editorial.

“The Free Press page has often printed editorials critical of the president and his policies,” the newspaper stated.

“This newspaper places high value on expressions of divergent opinion, but will not permit violations of its standards.”

The newspaper has since removed the original “shove it” headline and replaced it with the generic line, “[President Obama’s policies have harmed Chattanooga enough.](#)”

As WND reported, the no-holds barred commentary greeted Barack Obama in an entirely new way as he traveled to Chattanooga, Tenn., to visit an Amazon.com business center and lobby for his newest strategy to try to create jobs for Americans.

“Forgive us if you are not greeted with the same level of Southern hospitality that our area usually bestows on its distinguished guests,” [editors admonished](#).

“You see, we understand you are in town to share your umpteenth different job creation plan during your time in office. If it works as well as your other job creation programs, then thanks, but no thanks. We’d prefer you keep it to yourself,” the newspaper said. “That’s because your jobs creation plans so far have included a ridiculous government spending spree and punitive tax increase on job creators that were passed, as well as a minimum wage increase that, thankfully, was not. Economists – and regular folks with a basic understanding of math – understand that these are three of the most damaging policies imaginable when a country is mired in unemployment and starving for job growth.”

At Amazon’s Chattanooga fulfillment center, Obama boasted of creating “7.2 million new jobs over the last 40 months” because of the “grit and resilience of the American people.”

The newspaper noted “64 percent of Chattanooga respondents said they would rather you hadn’t chosen to visit our fair city,” but the editorial said it actually was good that Obama visited.

“It will give you an opportunity to see the failure of your most comprehensive jobs plan to date, the disastrous stimulus scheme, up close and personal,” the editorial said.

Johnson’s termination was the talk of the paper’s [Facebook](#) page, with most visitors taking the newspaper to task for firing an opinion page editor.

“Free Press means free to print as long as the Politburo approves it, right?” one person asked.

“You have FREE PRESS in your name, but someone get’s fired for their opinion. WOW,” added another person.

“So... fired the guy who wrote his opinions against the president? That’s cool. ... Free Press? Right,” opined another Facebook user.

Johnson revealed via Twitter that his firing comes just two weeks before his wedding.

He vows to continue defending liberty and free-market principles when he lands another job.

**A Speech Every American High School Principal Should Give.**

To the students and faculty of our high school:

I am your new principal, and honored to be so.

There is no greater calling than to teach young people.

I would like to apprise you of some important changes coming to our school. I am making these changes because I am convinced that most of the ideas that have dominated public education in America have worked against you, against your teachers and against our country.

**First**, this school will no longer honor race or ethnicity.

I could not care less if your racial makeup is black, brown, red, yellow or white. I could not care less if your origins are African, Latin American, Asian or European, or if your ancestors arrived here on the Mayflower or on slave ships. The only identity I care about, the only one this school will recognize, is your individual identity -- your character, your scholarship, your humanity. And the only national identity this school will care about is American.

This is an American public school, and American public schools were created to make better Americans. If you wish to affirm an ethnic, racial or religious identity through school, you will have to go elsewhere. We will end all ethnicity, race and non-American nationality-based celebrations. They undermine the motto of America, one of its three central values – e pluribus Unum, "from many, one." And this school will be guided by America 's values. This includes all after-school clubs. I will not authorize clubs that divide students based on any identities. This includes race, language, religion, sexual orientation or whatever else may become in vogue in a society divided by political correctness.

Your clubs will be based on interests and passions, not blood, ethnic, racial or other physically defined ties. Those clubs just cultivate narcissism -- an unhealthy preoccupation with the self -- while the purpose of education is to get you to think beyond yourself. So we will have clubs that transport you to the wonders and glories of art, music, astronomy, languages you do not already speak, carpentry and more. If the only extracurricular activities you can imagine being interested in are those based on ethnic, racial or sexual identity, that means that little outside of yourself really interests you.

**Second**, I am uninterested in whether English is your native language. My only interest in terms of language is that you leave this school speaking and writing English as fluently as possible. The English language has united America 's citizens for over 200 years, and it will unite us at this school. It is one of the indispensable reasons this country of immigrants has always come to be one country. And if you leave this school without excellent English language skills, I would be remiss in my duty to ensure that you will be prepared to successfully compete in the American job market. We will learn other languages here -- it is deplorable that most Americans only speak English -- but if you want classes taught in your native

language rather than in English, this is not your school.

**Third**, because I regard learning as a sacred endeavor, everything in this school will reflect learning's elevated status. This means, among other things, that you and your teachers will dress accordingly. Many people in our society dress more formally for Hollywood events than for church or school. These people have their priorities backward. Therefore, there will be a formal dress code at this school.

**Fourth**, no obscene language will be tolerated anywhere on this school's property -- whether in class, in the hallways or at athletic events. If you can't speak without using the f-word, you can't speak. By obscene language I mean the words banned by the Federal Communications Commission, plus epithets such as "Nigger," even when used by one black student to address another black, or "bitch," even when addressed by a girl to a girlfriend. It is my intent that by the time you leave this school, you will be among the few your age to instinctively distinguish between the elevated and the degraded, the holy and the obscene.

**Fifth**, we will end all self-esteem programs. In this school, self-esteem will be attained in only one way -- the way people attained it until decided otherwise a generation ago -- by earning it. One immediate consequence is that there will be one valedictorian, not eight.

**Sixth**, and last, I am reorienting the school toward academics and away from politics and propaganda. No more time will be devoted to scaring you about smoking and caffeine, or terrifying you about sexual harassment or global warming. No more semesters will be devoted to condom wearing and teaching you to regard sexual relations as only or primarily a health issue... There will be no more attempts to convince you that you are a victim because you are not white, or not male, or not heterosexual or not Christian. We will have failed if any one of you graduates this school and does not consider him or herself inordinately fortunate -- to be alive and to be an American.

Now, please stand and join me in the Pledge of Allegiance to the flag of our country. As many of you do not know the words, your teachers will hand them out to you.

**Judge refuses to dismiss law enforcement officers from false-detention lawsuit**

A federal judge in Richmond, Va., has refused to dismiss from a lawsuit several FBI and Secret Service agents as well as local police officers who arrested a military veteran based on an opinion from a counselor who had never met him that he might be a danger.

The officers had confronted the veteran, Brandon Raub, after he expressed criticism of the U.S. government on a social networking page.

They arrested Raub and kept him in custody for an evaluation based on the long-distance opinion from Michael Campbell, a psychotherapist hired by the local county. But when the case came before a judge, his ruling found the concerns raised by the officers were “so devoid of any factual allegations that it could not be reasonably expected to give rise to a case or controversy.”

Raub then sued the officers for taking him into custody.

The latest ruling rejected a request by the officers to end the case.

“Brandon Raub’s case exposes the seedy underbelly of a governmental system that continues to target military veterans for expressing their discontent over America’s rapid transition to a police state,” said John W. Whitehead, president of The Rutherford Institute.

“While such targeting of veterans and dissidents is problematic enough, for any government official to suggest that they shouldn’t be held accountable for violating a citizen’s rights on the grounds that they were unaware of the Constitution’s prohibitions makes a mockery of our so-called system of representative government. Thankfully, Judge Hudson has recognized this imbalance and ensured that Brandon Raub will get his day in court,” he said.

The decision came from U.S. District Judge Henry Hudson, who essentially said there is not enough information at this point in the case to dismiss the law enforcement defendants. He ordered limited discovery.

The Rutherford Institute called the decision a victory for free speech and the right to be free from wrongful arrest.

Raub, a decorated Marine, had been taken into custody by “a swarm” of FBI, Secret Service agents and local police and forcibly detained in a psychiatric ward for a week because of controversial song lyrics and political views posted on his Facebook page, Rutherford reported.

Hudson said the Rutherford Institute, which is representing Raub, had alleged sufficient facts to indicate that the involuntary commitment violated his rights under the U.S. Constitution’s First and Fourth Amendments.

Institute attorneys had filed the civil rights lawsuit in federal court on behalf of Raub, alleging that his seizure and detention were the result of a federal government program code-named “Operation Vigilant Eagle” that involves the systematic surveillance of military veterans who express views critical of the government.

The complaint alleges that the attempt to label Raub as “mentally ill” and his subsequent involuntary commitment was a pretext designed to silence speech critical of the government.

It was Aug. 16, 2012, when Chesterfield police, Secret Service and FBI agents arrived at Raub’s home, asking to speak with him about his Facebook posts. Like many Facebook users, Raub, a Marine who has served tours in Iraq and Afghanistan, uses his Facebook page to post song lyrics and air his political opinions.

Without providing any explanation, levying any charges against Raub or reading him his rights, law enforcement officials handcuffed Raub and transported him to police headquarters, then to John Randolph Medical Center, where he was held against his will.

The Institute reported in a hearing on Aug. 20, government officials pointed to Raub's Facebook posts as the reason for his incarceration. While Raub stated that the Facebook posts were being read out of context, a special justice ordered Raub be held up to 30 more days for psychological evaluation and treatment.

But Circuit Court Judge Allan Sharrett ordered Raub's immediate release a short time later, and the lawsuit was initiated.
