Now I am going to tell you."

At this point, Martha Cothren went over to the door of her classroom and opened it. Twenty-seven (27) U.S. Veterans, all in uniform, walked into that classroom, each one carrying a school desk. The Vets began placing the school desks in rows, and then they would walk over and stand alongside the wall. By the time the last soldier had set the final desk in place those kids started to understand, perhaps for the first time in their lives, just how the right to sit at those desks had been earned.

Martha said, "You didn't earn the right to sit at these desks. These heroes did it for you. They placed the desks here for you. They went halfway around the world, giving up their education and interrupting their careers and families so you could have the freedom you have. Now, it's up to you to sit in them. It is your responsibility to learn, to be good students, to be good citizens. They paid the price so that you could have the freedom to get an education. Don't ever forget it."

By the way, this is a true story. And this teacher was awarded Veterans of Foreign Wars Teacher of the Year for the State of Arkansas in 2006. She is the daughter of a WWII POW.

## **ObamaCare - How to avoid the taxes/penalties - PART 11**

## **WARNING!! WARNING!!**

Here is another alert!

Even though the PPACA Employer Mandate has been delayed until January 1, 2015, the rest of PPACA is still in effect!

For example, many employers, particularly in the construction and service industries, large and small, have had a lengthy waiting period before newly hired employees could get on their group health insurance plan. That has changed!!

Full time employees (30+ hours/week) must now be offered group's health insurance with no more than a 90-day waiting period. Specifically, they must come onto the health insurance at not later than the 91<sup>st</sup> day. Because insurance companies add them on the 1<sup>st</sup> of the month following the waiting period most insurance companies are changing the rules about when an employee is added.

Insurance companies are lowering the maximum waiting period to be the 1<sup>st</sup> of the month following 60 days of full time employment. That way all employees will be on the plan within the 90-day requirement.

The new PPACA Excise taxes also kick in. This is a daily excise tax of \$100 per day per affected individual in one instance and a percentage of revenue or the price of a service in the case of other excise taxes.

What are these Excise taxes?

1. The first one to kick in was the 10% Excise tax on Indoor Tanning Services. That is now in effect.

2. The annual fee on Medical Device Manufacturers and Importers as a percent of sales to generate \$2 Billion per year. In effect.
3. The annual fee on Brand name Prescriptions to generate \$2.3 Billion per year. Now you know why your prescriptions cost more.
4. The annual fee Insurance Companies must now pay as a percentage of the premium they received during any year. Now you know why your cost of health insurance went up. This excise tax increases each year so your premiums will increase.
5. The excise tax for having a health plan that is too good! Because the cost is going up due to the items 1 thru 4, it may prove impossible to stay below the limit set in the law, everyone may soon learn that they are paying an excise tax because they have a plan that is too good!! What's affordable about that?? ALL of these taxes are now in effect to pay for ObamaCare.

One final note is that the Employer Mandate Delay may hurt more than it helps. Here is some food for thought.

If you are an "Applicable Large Employer" or you are not sure if you are, when the Delay happened, YOU LOST ALL YOUR "SPECIAL TRANSITION RULES!"

2014 was supposed to be the year these transition rules were used. You could count employees differently and had special measuring periods to arrive at your employee count. GONE!

So you better be ready to go in 2015. You don't get any "give me's."

## ObamaCare - How to Avoid the Taxes & Penalties - PART 12

This Article is a clarification of news that has hit the talk shows this week!

The story about everyone now facing larger out-of-pocket costs is in fact a "sky is falling" Chicken Little – story.

The real problem is that because it only affects VERY FEW individuals or groups, those with insurance coverage and those wanting to purchase coverage after 1/1/2014 will see insurance rates going up substantially.

#### The REAL STORY

In the February 20 FAQ put out by the Departments of Labor, Treasury and HHS there was an administrative decision made to delay until 2015 the CAPS on out-of-pocket expenses, but only for some employer

plans!

These plans PROBABLY DO NOT INCLUDE THE PLAN YOU HAVE!

In fact, the plans affected are only those plans that have separate administrators for the separate bundled parts of the health insurance coverage.

What does that mean?

If the plan you are covered by has a separate administrator for the:

1. Major Medical health insurance portion, and/or
2. The prescription (drug coverage) portion, and/or
3. Sometimes, the children's dental services portion,



That could result in these plans being able to double – or even triple – the \$6,250 single and \$12,500 or more family out-of-pocket health care costs next year.

So the administration delayed the caps for ONLY these select groups so the insurers and employers can find ways to merge those caps.  
PLANS WITH ONLY ONE ADMINISTRATOR OVERSEEING ALL TYPES OF COVERAGE ARE NOT EXEMPTED FROM THE SPENDING CAP!!!

Probably 90 – 95% of all plans in place only have one administrator. For the most part this would be your Blue Cross/Blue Shield; Aetna; Coventry; United Health Care; Time Insurance and so on – plans.

The only possible catch would be if an insurance company wants to stretch the decision and say this implies they won't have the CAP because that company does not include the "children's dental services" in the coverage they offer. This might allow them to get away with not having the CAP requirement enforced?

So how does this affect you?

There is a 90-95% chance that your rates will see some large increases when your policy renews after 1/1/2014 due to the flood of people with severe medical conditions buying health insurance through your insurance company.

Keep in mind that the healthy, young, bulletproof individuals probably will not buy coverage. Why spend money for something you are not using! Not buying it now when it is cheap, why buy it next year when it costs more?

Because the insurance companies will be paying out more in claims than they are taking in from NEW PREMIUMS of these people, everyone else that has coverage with that insurance company will have to pay for this upside down cash flow. Remember the claims-free, healthy people are not in the plans paying premiums, so those GOOD dollars aren't available to spend!

More dollars out than are coming in forces everyone to pay more!

I still strongly believe, of the 35 to 45 million uninsured people, the only ones who will buy guaranteed, no pre-existing condition coverage are those with severe health issues. The reason HHS is saying they expect 7 million to enroll in exchanges in 2014 is that is about the number that fall into the severe medical problem group.

The rest aren't buying it today when it is cheaper! What real brain trust thinks they will rush out to buy it when it costs more? The B.S. that they will, because they get better coverage is more smoke and mirrors! These people don't care about the coverage now.

Getting MORE of something they are not using, in reality, has no appeal.

Here is an idea. Why not have the government provide insurance for that 7 million people with the severe medical problems at a cost of about \$50 Billion dollars (GAO numbers), but save the U.S. taxpayers \$1.7 Trillion dollars?

Tuesday, Sept 10<sup>th</sup>, Tom and I went to the Kansas State Fair in Hutchinson. We spent several hours in the Meadowlark Building in David Powell's booth. ## Massachusetts Outlawing Pledge of Allegiance?

The highest court in the state of Massachusetts will begin hearing a case where the [Pledge of Allegiance itself is on trial](#). An anonymous atheist couple has brought suit against the state for the mandatory recitation of the Pledge of Allegiance. The focus of the lawsuit is the simple phrase “under God”, which despite years of use, continues to offend the eminently offendable atheists. The Supreme Court of Massachusetts will consider Doe v. Action-Boxborough Regional School District on Wednesday. Their verdict will rule on whether or not the required recitation of the pledge violates the rights of students.

In the past, plaintiffs have attacked the phrase “under God” as being prejudicial to atheists and even non-Christians, in an effort to remove the pledge from our schools. This time around, the legal team representing the plaintiffs will argue that compulsory recitation of the pledge represents an attack on the state’s equal rights laws, which guarantee equal protection for everyone under those laws. This is very similar to the route that gay-marriage supporters recently used in a similarly successful case argued before the Massachusetts Supreme Court.

A lawyer for the defendants, who are represented by the Becket Fund for Religious Liberty, says that if the Court rules in favor of the plaintiffs, “*you would then see a rash of state court lawsuits challenging the pledge all over the country.*” Meanwhile, he continued, “*A win for us would completely avoid that unnecessary harm. And it would affirm that it is not discriminatory to have the words ‘under God’ in the pledge.*”

The left argues that the Pledge of Allegiance somehow discriminates against the godless, but fails to show evidence of said discrimination. What they miss is that the affirmation of God in our society is what protects the unbeliever from discrimination. If there are no moral absolutes attributable to a Righteous and Holy God, then every man should be free to do what is right in their own mind. This is what the left argues for without considering the

consequences – without an absolute moral law one cannot judge evil. If one cannot judge evil by an absolute code, then it is left to the will of the majority to decide what is right and what is wrong. Once that happens, the rights of the minority no longer exist.

So, the truth of the matter is the phrase “under God” is exactly the reason that the godless are able to live unhindered in America today.

This latest case continues the onslaught of the culture war upon the traditional values at the very core of our national identity. Instead of attacking the root causes of the problems in our society, the left has been content to attack symbols of our traditional heritage. It must be obvious now, even to the most casual observer, that the left is interested only in the destruction of traditional American culture and the domination of the post-modern liberal ethos. #### **A Russian Immigrant Sees U.S. Making Same Mistakes As USSR**

Commenting on my column last month ("Today's 'Useful Idiots' Are Just Like Those In USSR" — Aug. 6), a reader lamented:

"Authors writing about socialism need to know what socialism is. The author of this article would rather just go into a tirade about the problems in our country ... and automatically jump to the conclusion the problem is socialism. Huh? What? Where is the socialism you're talking about?"

An old Soviet joke goes as follows: "A Soviet and an America journalist argued about whose society is freer. The American declared, 'I can stand in front of the White House and yell that our president is a fool!' 'Big deal,' responded the Russian, 'I can stand in front of Kremlin in Moscow and yell that your president is a fool too!'"

This joke is at least 40 years old. But today in the US, very much as it was in the USSR, a rodeo clown's livelihood is in peril because he dared to make a joke about the president. One can measure level of socialism by the number of lives wasted, humiliated or destroyed by a centralized government that is pursuing its agenda and control.

Some people don't need to hit the wall to understand reality. Being brainwashed from childhood, I had to personally experience real life as an adult in the Soviet Union to have my illusions and naiveté about fairness shattered.

Living in a socialist country for 30 years of my life, and required to study the theory of Marxism/Leninism from elementary school through college, I am familiar with some distinct characteristics of socialism. They include:

## **POLICE NOT INTERESTED IN BRUTAL BEATING ON TAPE**

Officer tells victims 'zero' chance of finding attackers

A couple's early-morning walk in the world-famous French Quarter of New Orleans turned into a nightmare when they were beaten savagely by three black attackers in a horrifying scene that was caught on camera.

According to the local CBS affiliate, the three perpetrators surrounded, verbally abused and then attacked the two victims as they walked through the French Quarter around 6am on Saturday.

The woman was punched in the mouth, while the man was tackled and had his face stomped as he lay helpless on the ground. The male victim suffered a concussion and a severely broken jaw that required surgery.

The video, despite breaks, caught most of the action leading up to the violence. It shows the two victims, both white, crossing the street as they are stalked by three young, African-American males who then surround and strike them.

After a break in the footage, the two victims are shown, clearly hurt. The surveillance camera also picked up their friend, who flagged down the obstinate officer for help and talked with him for about six minutes.

The officer is never seen getting out of his vehicle in the footage, but police officials stated to local media that he got out of his car sometime during his response.

Despite the evidence shown in the video and the report of the victims' friend to the responding officer, the policeman ruled the call "unfounded" and didn't write a report of the incident.

The officer, who was about to go off his shift at 7am, even told the friend who detailed the crime to him that there was "zero" chance of the assailants being caught.

Police have since changed their tone and are now investigating the incident, but the victims' families still believe the police are not doing enough.

The suspects are still on the loose and police have released the surveillance footage in the hope that members of the public will come forward to identify the suspects.

To Colin Flaherty, the award-winning journalist and author of "White Girl Bleed A Lot: The Return of Racial Violence to America and How the Media Ignore It," the incident is an all-too-familiar sight in the country today.

"Black mob violence is severely under-reported in this country," Flaherty told WND. "This is just the latest example. The cop did not investigate. Did not file a report. This also happened recently in Green Bay, where a mob attacked two off-duty policemen. And it happened this summer in Minneapolis, where a black mob robbed and beat a local radio personality. Police did not take a report and even asked him what he expected being in that part of town. One witness said the police even called the man a 'pussy.'

"This happens a lot. And I hear about it in emails. And read about it on new sites throughout the country," Flaherty added.

Yes, at the Iowa State Fair, no less – during what one cop called Beat Whitey Night. Peoria, Illinois? Absolutely: As many as nine race riots in 2011 alone – right in the middle of Middle America. Milwaukee? Yes, on the Fourth of July, after looting a nearby convenience store, a crowd of nearly 100 blacks set upon some white teens on a picnic. After beating one white woman, a black woman noted, “Oh white girl bleed a lot.” And the Milwaukee State Fair is probably the most explicit and public hate crime anyone has seen in years. Hundreds of black people roamed the fairgrounds, targeting white people for violence.

### COLORADO VOTERS REMOVE GUN CONTROL LAWMAKERS FROM OFFICE

**DENVER** - Voters ousted two Colorado Democratic lawmakers Tuesday in that state's first-ever legislative recall, launched over their support for stricter gun laws after last year's mass shootings.

Senate President John Morse and Sen. Angela Giron both lost their jobs in an election seen as a national measure of popular support for gun legislation.

Morse faced a tough election in the Republican stronghold of Colorado Springs, where he won re-election by just a few hundred votes in 2010. He lost by 343 votes, with 51% of voters backing the recall.

"We as the Democratic Party will continue to fight," Morse told supporters in Colorado Springs as he conceded the race.

Republican Bernie Herpin, a former Colorado Springs city councilman, will replace him.

Giron lost by a bigger margin in a largely blue-collar district that favors Democrats, with 56% of voters voting to recall her. She tried to encourage her supporters, telling them the defeat will ultimately make them stronger.

"We will win in the end because we are on the right side," she said.

Angered by new limits on ammunition magazines and expanded background checks, gun-rights activists filed enough voter signatures for the recall elections - the first for state legislators since Colorado adopted the procedure in 1912.

The recalls were seen as the latest chapter in the national debate over gun rights - and, for some, a warning to lawmakers in swing states who might contemplate gun restrictions in the future. But gun rights activists' efforts to force recall elections for two other Colorado Democrats failed this year.

Tuesday's vote also exposed divisions between Colorado's growing urban and suburban areas and its rural towns. Dozens of elected County Sheriffs have sued to block the gun laws, and some activists are promoting a largely symbolic measure to secede from the state.

Morse Recall organizer Timothy Knight said voters were upset that Colorado's Democrat-majority Legislature seemed more inclined to take its cues from the White House than its constituents. The gun laws passed this year with no Republican support.

"If the people had been listened to, these recalls wouldn't be happening," Knight said.

Both legislators voted for 15-round limits on ammunition magazines and for expanded background checks on private gun sales after the 2012 mass shootings in Aurora and Newtown, Conn. The legislation was signed into law by Democratic Gov. John Hickenlooper.

The National Rifle Association and NYC Mayor Michael Bloomberg lined up on opposite sides of the recalls.

Reported contributions to Morse and Giron totaled about \$3 million, dwarfing the amount raised by gun activists who petitioned for the recall, though some independent groups didn't have to report spending. Both the NRA and Bloomberg contributed more than \$300,000 to the pro- and anti-recall campaigns.

Preliminary figures showed roughly 17,000 people - just 15 percent of registered voters - cast ballots in Morse's election, and that more Republicans turned out to vote than Democrats. Turnout in Pueblo County was about 30 percent, with more than 32,000 people voting.

Unlike most recent elections, there are no automatic mail ballots, so voters had to cast their ballots in person.

"This is a good, old-fashioned knock and drag operation - knocking on doors and dragging them to the polls," said Colorado Democratic Party chairman Rick Palacio, who worked Giron's district on Tuesday.

Morse, a former police chief in a Colorado Springs suburb, was first elected to the Senate in 2006.

Hickenlooper initially rejected calls for stronger gun control laws after 12 people were killed and 70 injured in an Aurora movie theater in July 2012. The governor changed his mind right before the December 2012 Newtown massacre, in which a gunman killed 20 children and six women at Sandy Hook Elementary School.

Hickenlooper, who is up for re-election in 2014, kept a low profile in the recalls. A recent statewide poll by Quinnipiac University suggested that 52% of voters disapproved of his gun policy while only 35 percent approved.

Years from now, historians may regard the 2008 election of Barack Obama as an inscrutable and disturbing phenomenon, the result of a baffling breed of mass hysteria akin perhaps to the witch craze of the Middle Ages. How, they will wonder, did a man so devoid of professional accomplishment beguile so many into thinking he could manage the world's largest economy, direct the world's most powerful military, execute the world's most consequential job?

Imagine a future historian examining Obama's pre-presidential life: ushered into and through the Ivy League, despite unremarkable grades and test scores along the way; a cushy non-job as a "community organizer;" a brief career as a state legislator devoid of legislative achievement (and in fact nearly devoid of his attention, less often did

he vote "present"); and finally an unaccomplished single term in the United States Senate, the entirety of which was devoted to his presidential ambitions.

He left no academic legacy in academia, authored no signature legislation as a legislator. And then there is the matter of his troubling associations: the white-hating, America-loathing preacher who for decades served as Obama's "spiritual mentor;" a real-life, actual terrorist who served as Obama's colleague and political sponsor. It is easy to imagine a future historian looking at it all and asking: how on Earth was such a man elected president?

Not content to wait for history, the incomparable Norman Podhoretz addressed the question recently in the Wall Street Journal: To be sure, no white candidate who had close associations with an outspoken hater of America like Jeremiah Wright and an unrepentant terrorist like Bill Ayers, would have lasted a single day. But because Mr. Obama was black, and therefore entitled in the eyes of liberal Dom to have hung out with protesters against various American injustices, even if they were 'a bit' extreme, he was given a pass. Let that sink in: Obama was given a pass - held to a lower standard - because of the color of his skin. **(And "they" say Conservatives are racists!!)**

Podhoretz continues: And in any case, what did such ancient history matter when he was also so articulate and elegant and (as he himself had said) "non-threatening," all of which gave him a fighting chance to become the first black president and thereby to lay the curse of racism to rest? **(Racism is worse in the USA now than before Obama's election.)**

Podhoretz puts his finger, I think, on the animating pulse of the Obama phenomenon - affirmative action. Not in the legal sense, of course. But certainly in the motivating sentiment behind all affirmative action laws and regulations, which are designed primarily to make white people, and especially white liberals, feel good about themselves.

Unfortunately, minorities often suffer so that whites can pat themselves on the back. Liberals routinely admit minorities to schools for which they are not qualified, yet take no responsibility for the inevitable poor performance and high drop-out rates which follow. Liberals don't care if these minority students fail; liberals aren't around to witness the emotional devastation and deflated self-esteem resulting from the racist policy that is affirmative action. Yes, racist. Holding someone to a separate standard merely because of the color of his skin - that's affirmative action in a nutshell, and if that isn't racism, then nothing is.

And that is what America did to Obama. True, Obama himself was never troubled by his lack of achievements, but why would he be? As many have noted, Obama was told he was good enough for Columbia despite undistinguished grades at Occidental; he was told he was good enough for the US Senate despite a mediocre record in Illinois; he was told he was good enough to be President despite no record at all in the Senate. All his life, every step of the way, Obama was told he was good enough for the next step, in spite of ample evidence to the contrary.

What could this breed if not the sort of empty narcissism on display every time Obama speaks? In 2008, many who agreed that he lacked executive qualifications nonetheless raved about Obama's oratory skills, intellect, and cool character. Those people - conservatives included - ought now to be deeply embarrassed. The man thinks and speaks in the hoariest of clichés, and that's when he has his Teleprompters in front of him; when the prompter is absent he can barely think or speak at all. Not one original idea has ever issued from his mouth - it's all warmed-over Marxism of the kind that has failed over and over again for 100 years. (An example is his 2012 campaign speeches, which are almost word-for-word his 2008 speeches.) And what about his character? Obama is constantly blaming anything and everything else for his troubles. Bush did it; it was bad luck; I inherited this mess. Remember, he wanted the job, campaigned for the task. It is embarrassing to see a President so willing to advertise his own powerlessness, so comfortable with his own incompetence. (The other day he actually came out and said no one could have done anything to get our economy and country back on track). But really, what were we to expect? The man has never been responsible for anything, so how do we expect him to act responsibly? In short: our president is a small-minded man, with neither the temperament nor the intellect to handle his job. When you understand that, and only when you understand that, will the **current erosion of liberty and prosperity** make sense? It could not have gone otherwise with such an impostor in the Oval Office.
