 Greetings,

I am back in Washington, D.C., today. We are working to accomplish twin goals that have been clearly communicated to me by so many of you--eliminating the Affordable Care Act (ACA) and keeping government from shutting down. While it's not clear how the next few days will unfold, the likelihood of achieving both these goals combined seems low. The President seems determined to move forward with his health care takeover.

I voted to repeal the ACA. Last night, the House of Representatives agreed to compromise. I voted only to a one-year delay of ACA and to eliminate one of its worst tax hikes. Senate Majority Leader Harry Reid, D-Nevada, says he won't listen to the American people's demand that he delay this law for everyone and not just Senator Reid's friends in big business and labor unions. Reid is wrong—as elected officials, we should listen to the American people. While our success may not be certain in the short run, the American people's will, over time, be recognized.

Over the last few weeks, we have been asking you all to send us your experiences with ACA. We received lots of feedback. A handful of you said that you had seen some good from ACA, but the overwhelming majority of you presented exactly the experiences that I feared: From Mary in Wichita: "The health insurance company we've had since 1989 is discontinuing their traditional policies as of 12-31-13. They informed me that they don't believe they can be profitable participating in the Affordable Care Act. Our group is now very small, mostly over 55 years old with some health issues. Now we're forced to sign up for ObamaCare. If Congress had defunded ACA before, perhaps our insurance company would have kept our policy.

From Dan in Park City: "My first concern is that even though I am retired from the military, my health care will go up

about \$1,500-\$1,800.00 a year. My present healthcare provider does not know what he will do when ObamaCare kicks in."

From T. in Wichita: "I work for [a major health provider in Wichita]. I am already seeing the damage ObamaCare is going cause. We just had layoffs, a reduction in hours, and strict minimal overtime. Our treatment load has increased to an amount that almost can't be completed. Patient care is suffering. Long wait for call lights to be answered. No raise this year for the first time in 25 years. Costs are rising. My pay is stretched further and further.

All of this comes even before the Affordable Care Act begins offering insurance programs on January 1 of next year. Beyond these very bad outcomes is the even greater risk that we will see the total cost of health care increase in America. The ability of Americans of all income levels to actually see a doctor, get a prescription filled, or seek preventive services, may greatly diminish. This is what the fight is about. And it is a worthy fight.

On Tuesday, October 1, I will attempt to enroll in the federal health exchange as I am required to do by law. Hundreds of thousands of Kansans will likely make the same effort. I'd appreciate continuing to hear about your real world experiences with the Affordable Care Act—and I'll share my experience enrolling my family too. Just go to <http://pompeo.house.gov/ObamaCare> and tell me how the Affordable Care Act affects you, your family, or your company. Let me know the following:

Is your new premium lower? Higher?

Are you new out of pocket expenses lower? Higher? (co-pays, deductibles, etc.)

Can you see as many doctors as you did before?

Did you have many options for your insurance as you did before?

Was the customer service as provided by the federal government good?

Did you go the federal exchange because your employer told you it was discontinuing its plan? Or because you were laid off as a result of the Affordable Care Act?

Have your work hours been reduced?

What is your doctor telling you about how the Affordable Care Act impacts her? (If you are a doctor, tell us how it impacts you and your patients).

This is a takeover of nearly 1/6th of the economy. The President has said there would be some "hiccups" at the beginning, but I am convinced that hiccups are the least of our healthcare worries. The battle continues.

Kansas GOP Passes Common Core Resolution (UPDATED)

UPDATED with articles and the resolution document – September 18: [State GOP adopts resolution demanding withdrawal from Common Core, science standards](#) *The Kansas Republican Party has adopted a resolution that demands state leaders reject Common Core school standards and prohibit adoption of new science standards. State GOP Chair Kelly Arnold said today there is "a groundswell of people" who are opposing Common Core standards for reading and math, which are going into effect in Kansas and 44 other states. "We feel we lose control over what we are allowed to teach our children here in Kansas," Arnold said.*

[Kansas GOP gives failing grade to Common Core](#) *Under the Kansas GOP resolution, Republicans declared the standards were adopted by the state Board of Education "without meaningful input from or even effective notice to Kansas parents, teachers and other taxpayers. "The resolution declared Common Core obliterates Kansas' control over English language arts and mathematics standards in our schools" and implicated the state in an "unconstitutional and illegal transfer of power to the federal government." It concluded the new guidelines for Kansas public schools committed the state to "a set of mediocre standards based on questionable philosophies."*

The following is the text of the resolution:

[Kansas Republican Party Common Core Resolution](#)

WHEREAS, adoption of the Common Core Standards

Obliterates Kansas's control over English language arts and mathematics standards in our schools;

Implicates the state in an unconstitutional and illegal transfer of power to the federal government and unaccountable private interests;

Commits our state to a set of mediocre standards based on questionable philosophies; and
Imposes an enormous unfunded mandate on our state and on our local school districts; and
WHEREAS, adoption of the Common Core Standards was accomplished without meaningful input from, or even effective notice to, Kansas parents, teachers, and other taxpayers; and
WHEREAS, administration of the SMARTER Balanced assessments aligned with Common Core will subject Kansas students to burdensome new testing requirements and will unfairly tie teachers' evaluations to the scores on the assessments; and
WHEREAS, the scheme that includes the Common Core Standards and the SMARTER Balanced assessments will require the collection and sharing of massive amounts of personal student data, thus threatening student and family privacy and serving no legitimate academic purpose;
RESOLVED, that the Kansas Republican Party that our state leaders should withdraw the state from the Common Core Standards and aligned assessments; prohibit adoption of any standards that require the state to cede any measure of control over their drafting and revision, including but not limited to the Next Generation Science Standards; and prohibit the collection and sharing of private student data for any non-academic purpose.

The Perspective Of A Russian Immigrant By [Svetlana Kunin](#) -- Posted 09/10/2009 09:00 PM ET

In the Union of Soviet Socialist Republics, I was taught to believe individual pursuits are selfish and sacrificing for the collective good is noble.

In kindergarten we sang songs about Lenin, the leader of the Socialist Revolution. In school we learned about the beautiful socialist system, where everybody is equal and everything is fair; about ugly capitalism, where people are exploited and treat each other like wolves in the wilderness.

Life in the USSR modeled the socialist ideal. God-based religion was suppressed and replaced with cult-like adoration for political figures.

The government-assigned salary of the proletariat (blue-collar worker) was 30%-50% higher than any professional. Without incentive to improve their life, professionals drank themselves to oblivion. They — engineers, lawyers, doctors, teachers — earned a government-determined salary that barely covered the necessities, mainly food.

Raising children was a hardship. It took four to six adults (parents and grandparents) to support a child. The usual size of the postwar family was one or two children. Every woman had the right to have an abortion and most of them did, often without anesthesia.

There is a comparative historical reality that plays out the consequences of two competing ideologies: life in the USSR and in America.

When the march to the worker's paradise — the Socialist Revolution — began in 1917, many people emigrated from Russia to the U.S.

In the USSR, economic equality was achieved by redistributing wealth, ensuring that everyone remained poor, with the exception of those doing the redistributing. Only the ruling class of communist leaders had access to special stores, medicine and accommodations that could compare to those in the West.

The rest of the citizenry had to deal with permanent shortages of food and other necessities, and had access to free but inferior, unsanitary and low-tech medical care. The egalitarian utopia of equality, achieved by the sacrifice of individual self-interest for the collective good, led to corruption, black markets, anger and envy.

Government-controlled health care destroyed human dignity.

Chairman Nikita Khrushchev released facts about Stalin and his purges. People learned of the horrific purge of more than 20 million citizens, murdered as enemies of the state.

Those who left Russia found a different set of values in America: freedom of religion, speech, individual pursuits, the right to private property and free enterprise. The majority of those immigrants achieved a better life for themselves and their children in this capitalist land.

VOTER IDENTIFICATION REQUIREMENTS

Valid Forms of Photographic Identification

Starting January 1, 2012, Kansas voters must show acceptable photographic identification when casting a vote in person:

- A driver's license or non-driver's identification card issued by Kansas or by another state or district of the United States
- A concealed carry of handgun license issued by Kansas or a concealed carry of handgun or weapon license issued by another state or district of the United States
- A United States passport.
- An identification card issued by a municipal, county, state, or federal government office.
- A military identification document issued by the United States
- A student identification card issued by an accredited postsecondary institution of education in the state of Kansas.
- A public assistance identification card issued by a municipal, county, state or federal government office.

Exemptions from the Photo ID Requirement

- Persons age 65 or older may use expired photo ID documents.
- The photo ID requirements do not apply to military and overseas citizens who vote under the federal Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA).
- The photo ID requirements do not apply in mail ballot elections. Mail ballot elections are limited to local jurisdictions holding special question-submitted elections.
- The photo ID requirements do not apply to voters who qualify, apply and are accepted to the permanent advance-voting list, as long as they remain on the permanent advance voting list.
- Any person whose religious beliefs prohibit photographic identification may be exempted from the photo ID requirement. Any such person must complete and sign a Form DRO (Declaration of Religious Objection).

Advance Voters Identification Requirements

- A person voting in person in the county election office or at a satellite site is treated the same as a regular voter at the polling place on Election Day.
- A person voting by mail may write his or her driver's license number on the application form or submit a copy of valid identification with the ballot application.
- If an advance voter fails to provide identification information, or if the information provided is not valid, the county election officer may issue a provisional ballot, but the ballot is not considered valid unless the voter submits identification sometime before the county canvass.

Free Photographic Identification

- A registered voter who does not possess any of the approved government-issued photographic identification documents and who wishes to vote may apply for a free non-driver identification card at the Division of Motor Vehicles. The person must sign a form containing an affidavit stating that he or she (1) is registered to vote and (2) does not possess a photographic identification document. Form DE-VIDI (Certification Requesting Fee Waiver for Non-driver Identification Card) is provided by the Division of Vehicles at all driver's license offices, at all county election offices and on the Secretary of State's website.

Free Birth Certificate in Order to Obtain Free ID

In order to obtain a non-driver identification card, a person must present acceptable proof of identity and proof of residence to the Division of Vehicles, Kansas Department of Revenue. Qualifying individuals who lack proof of identity and desire to obtain a free non-driver identification card may obtain a Kansas birth certificate from the Kansas Office of Vital Statistics at no cost. To qualify, such person must;

1. Not possess any valid photographic identification documents under Kansas law,
2. Lack any of the documents necessary to prove identity,
3. Sign an affidavit attesting to items 1 and 2,
4. Be registered to vote in Kansas, and
5. Have been born in Kansas.

To obtain a free birth certificate in order to obtain a free non-driver identification card, all three of the following forms must be submitted to the Kansas Office of Vital Statistics by a qualifying individual:

1. Form VS-235 10/09 (Application for Certified Copy of Kansas Birth Certificate).
2. Form BCA (Affidavit of Person Requesting Free Certified Copy of Birth Certificate), and

3. Form DE-VIDI (Certification Requesting Fee Waiver for Non-driver Identification Card).

Please note that if a person is trying to obtain a birth certificate under this program for the purpose of obtaining a free non-driver identification card:

- A free driver's license will not be issued under this program; only a non-driver identification card will be issued.
- A Kansas driver's license and a Kansas non-driver identification card cannot be held simultaneously by the same individual.
- Only one birth certificate per person may be issued under this program. The recipient should keep it safe for future needs.
- The forms submitted under this program can be shared with other agencies.
- Individuals not born in Kansas may find how to obtain a birth certificate in their state or territory at the National Center for Health Statistics website.

Not Born in Kansas: Free State Voter Identification Document

Individuals who were born outside of Kansas, who do not have proof of identity and do not wish to pay for such a document from their home state, may apply for a State Voter Identification Document. (NOTE: This identification document is valid only for the purpose of voting in Kansas and may not be used for any other purpose.) To qualify, such person must: (1) not possess any valid photographic identification documents under Kansas law; (2) lack any of the documents necessary to prove identity; (3) sign an affidavit attesting to items 1 and 2; (4) be registered to vote in Kansas; and (5) have been born outside of the state of Kansas. Qualified individuals should contact the election division of the Secretary of State's office at election@sos.ks.gov or (800) 262-VOTE.

In view of the coming elections in 2014, if you do NOT have ID that would serve as Voter ID you should be working to take care of this --- NOW so you'll have it for the coming elections. Under Kris Kobach's guidance Kansas is setting the example for all other states to follow. A person is required to show ID in so many places. Most everyone has it - just remember to bring it to the voting location!!! If YOU feel this is unfair, PLEASE, PLEASE TELL ME HOW AND WHY!!

Israeli Prime Minister Benjamin Netanyahu [remains suspicious](#) of Iran’s new leadership.

Friday, 9/20/13 - The House of Representatives passed a Continuing Resolution that would fully fund the government (including things that Republicans don't like) while at the same time defunding ObamaCare.

Result: House Republicans compromised on spending that we'd like to see cut in exchange for defunding ObamaCare.

Friday, 9/27/13 - The Senate stripped the defunding language out of the House passed Continuing Resolution and sent it back to the House.

Result: Harry Reid and Senate Democrats refused to compromise.

Saturday, 9/28/13 - The House of Representatives added two amendments to the Senate revised Continuing Resolution to delay ObamaCare for one year (far from what we were originally willing to agree to) and repeal the medical device tax.

Result: House Republicans compromised away from defunding to delaying ObamaCare for one year.

Monday, 9/30/13 - The Senate stripped the two amendments from the House passed Continuing Resolution and sent it back to the House.

Result: Harry Reid and Senate Democrats refuse to compromise one inch on ObamaCare.

Monday, 9/30/13 - The House of Representatives responded by adding language to the Continuing Resolution to delay the individual mandate for a year and to take away the health care subsidies Members of Congress and their staffs received from the Office of Personnel Management ruling earlier this year.

Result: House Republicans compromised away from delaying ObamaCare for one year to delaying the individual mandate for a year and requiring that Congress live under ObamaCare just like the rest of the American people.

Monday, 9/30/13 - The Senate voted to table the House passed continuing resolution.

Result: Harry Reid and Senate Democrats refused to compromise.

Monday, 9/30/13 - The House appointed conferees and sent a message to the Senate requesting a conference meeting to resolve their differences.

Result: House Republicans were still willing to compromise and reach a solution.

Tuesday, 10/1/13 - Midnight - No Deal is reached and a temporary shut down begins.

Tuesday, 10/1/13 - The Senate votes to table the House's request for a conference to resolve differences.
