Air Force Homosexuals Go After Christians

The acceptance of open homosexuals in the military is increasingly having the effect that many conservatives anticipated, as Christians and anyone who opposes homosexual "marriage" are finding that they are being punished for their views.

A group of airmen from Lackland Air Force Base recently attended a packed meeting at Village Parkway Baptist Church in San Antonio, where they expressed concerns about a rise in intimidation and persecution from homosexual commanders and their supporters, according to Fox News.

Pastor Steve Branson heard from at least 80 airmen about religious persecution going on at Lackland.

"There is an atmosphere of intimidation at Lackland Air Force Base," Branson said. "Gay commanders and officers are pushing their agenda on the airmen. There is a culture of fear in the military and it's gone to a new level with the issue of homosexuality."

One of the meeting's attendees was Senior Master Sgt. Phillip Monk, who claims he was relieved of duty after refusing his commander's order to say he supported homosexual marriage.

After filing a religious discrimination complaint against the Air Force, Monk was accused of making false statements and is now facing a possible court martial.

According to Branson, other airmen have told him they are afraid to speak out publicly because of what is happening to Monk.

Branson relates the story of one airman who was told that even thinking homosexuality is a sin is discrimination: "A commander told him, 'Don't you understand discrimination – that your thought process is discrimination?' The commander actually pulled up the definition of discrimination on Wikipedia and read it to him in front of everyone so he would understand what it was."

The parent of an airman at the meeting said that the 19-year-old was asked during basic training what religion he was. When the young airman said "Christian," he was required to retake basic training.

One airman claimed he was written up for having his Bible out, while a nearby Muslim airman had out a prayer rug.

Branson said a colonel told him that officers are being ordered to publicly affirm support for homosexuality and being Mirandized if they don't.

The Obama Administration has been an enemy of Bible-believing Christians since it came into office, issuing warnings through the Department of Homeland Security about the potential terrorist threat of conservatives. Obama himself, before he was elected, revealed his contempt when he complained about people "bitterly clinging to their guns and Bibles."

The persecution of Christians in the Air Force and other branches of the military should serve as a warning. If the Administration goes after religious rights in the military, it will go after yours as well, as has been borne out repeatedly.

The state of affairs in the Air Force should be regarded as foreshadowing.

There is a purge going on. Historically, governments have purged bureaucracies and militaries of

undesirables in order to create weapons to use against their own people.

The current effort is aimed at controlling, breaking the spirit of and, if necessary, expelling those with a moral conscience. The only goal can be to create a military that won't care if it is ordered to engage in unethical behavior.

We don't have to look very far for actual examples of how such "ethically refined" armies have been used. Take your pick: Nazi Germany, Soviet Russia, Communist China, Vietnam, Iran, etc.

There is no good purpose that can come of this military purge, and frankly none is intended.

Pattern for Revival

As I was reading in the book of Jonah, I noticed something that I had never noticed before. There is a God established pattern for revival in a nation. You can see it in Jonah 3:1-10. There are six things that happen here.

The first thing that happens is that God calls His prophets to proclaim His message of repentance. (v. 1-2) Second, the prophets obey God's command even when it is very costly to them. (v. 3) Next, the common people hear the word of the Lord and begin to repent. (v. 4-5) Then, word of these things reaches the nation's leadership who hear

that word and repent themselves. (v. 6) Fifth, the leadership proclaims and participates in a national repentance. Last, when God sees that the nation's repentance is real, He has compassion on that nation and stops His judgment. (v. 10)

The question that came to my mind is: Is this the pattern God is following in America today? I think the evidence gives us the answer.

This nation's turning from God has been going on for some time. I can see clear indications right after WWII when we failed to publicly give God the glory and praise for that victory. From that time forward, we have the rebellion of the '60's and 70's, then the downhill slide into the moral degradation on all levels that we are experiencing today. We are deep into our sinfulness just as Nineveh was in Jonah's day.

God started calling His prophets a long time ago. In the early '70's, one was David Wilkerson. He published *America's Last Call* in 1974. He was immediately ridiculed, even by many Christians. However, nearly all the things he predicted have come true.

Then in the '80's there came Larry Burkett with his book *The Coming Economic Earthquake*. Again, he was ridiculed by most. Yet, today we are living in the condition he predicted.

In the last several years, there have been many speaking out what God has been saying. Rabbi Jonathan Cahn, Dr. Richard Land and Erwin Lutzer, just to name three from three totally different religious affiliations. I have become aware of nearly 20 such people, all dedicated believers of Jesus Christ. So, is the biblical pattern being followed?

The sin of America has long been rampant. 1. God has called his prophets. 2. They are proclaiming a message of repentance. 3. Common people are listening and repentance is spreading throughout America. 4. Some of the lower and middle levels of leadership are now beginning to hear and act. Are these folks perfect? Absolutely not! Are they moving towards God's standard of righteousness? The evidence, when compared with Scripture, suggests that they are. But, they too are being ridiculed.

The next question is will the upper leadership hear and repent? If the pattern in Jonah holds true and those who are repenting continue to persist, 2 Chronicles 7:14 seems to indicate that they will.

I want to include a word of caution here. There are cases in the Bible and in history when all of the steps towards revival occurred, but the national leadership did not hear and repent. In every case, God did judge the nation, but he also took care of those who did repent. The key seems to be whether those who are now repenting will continue to persist in their drawing close to God.

Witness what happened right after 9/11? The entire nation turned to God. But after a few months, it all died out. What will happen this time? Will we persist in our pursuit of God's righteousness or not?

Even when it comes to something as basic, and apparently as simple and straightforward, as the question of who shut down the federal government, there are diametrically opposite answers, depending on whether you talk to Democrats or to Republicans.

There is really nothing complicated about the facts. The Republican-controlled House of Representatives voted all the money required to keep all government activities going -- except for ObamaCare. This is not a matter of opinion. You can check the Congressional Record.

As for the House of Representatives' right to grant or withhold money, that is not a matter of opinion either. You can check the Constitution of the United States. All spending bills must originate in the House of Representatives, which means that Congressmen there have a right to decide whether or not they want to spend money on a particular government activity.

Whether ObamaCare is good, bad or indifferent is a matter of opinion. But, it is a matter of fact that members of the House of Representatives have a right to make spending decisions based on their opinion.

ObamaCare is indeed "the law of the land," as its supporters keep saying, and the Supreme Court has upheld its Constitutionality.

But the whole point of having a division of powers within the federal government is that each branch can decide independently what it wants to do or not do, regardless of what the other branches do, when exercising the powers specifically granted to that branch by the Constitution.

The hundreds of thousands of government workers who have been laid off are NOT idle because the House of Representatives did not vote enough money to pay their salaries or the other expenses of their agencies -- unless they are in an agency that would administer ObamaCare.

Since we cannot read minds, we cannot say who -- if anybody -- "wants to shut down the government." But we do know who had the option to keep the government running and chose not to. The money voted by the House of Representatives covered everything that the government does, except for ObamaCare.

None of this is rocket science. But unless the Republicans get their side of the story out -- and articulation has never been their strong suit -- the lies will win. More important, the whole country will lose.
