Sorry — back to what I started to write about. Everyone was given to believe that waiting until the last minute meant that one could wait until March 31, 2014 to enroll. That is the end of the open enrollment, isn’t it??

Yes, the initial open enrollment lasts for 6 months, from October 1, 2013 until the end of March, 2014. That is true, BUT...

To avoid the individual tax penalty, the law also requires you to be insured for at least 9 months with no break in coverage during that time. So your coverage must be effective no later than April 1, 2014.

Under the rules established for the insurance companies selling on the exchanges, due to expected processing time, HHS has told them that when a person enrolls prior to the 15th of a month, coverage will start on the 1st of the month following the next month after processing of the enrollment. SO to be effective 4/1/2014 an individual’s paperwork must be completed AND submitted no later than February 14, 2014.

That is a full month and a half before the March 31, 2014 enrollment deadline our wonderful Secretary of HHS has been touting!! Oh, and by the way, the news story just hit that the President KNEW that the exchanges WERE NOT READY to operate. He knew they would not work. But he ordered them to open anyway! This week, I am pleased to announce my bipartisan House resolution recognizing the importance of accessible, quality health care for rural communities, [H. Res. 356](#), now has 25 cosponsors.

With more than 60 million Americans relying on rural health care providers, Congress must recognize access to quality rural health care is crucial to the success and prosperity of our nation. As someone who grew up in rural Jackson County, I know first-hand how important it is to have a hospital nearby, and the impact it can have when you are deciding where to start a family or open a new business.

This resolution is particularly relevant given the recent report from the Health and Human Services’ Office of Inspector General (OIG) that recommends Congress pass legislation that would ultimately eliminate the Critical Access Hospital (CAH) designation for 72 of Kansas’ 83 CAHs. This proposal would be devastating to rural Kansas and fails to recognize the unique circumstances of delivering health care in rural America.

Another ObamaCare Delay

Adding to the long list of ObamaCare’s broken promises, this week the administration did another pre-holiday news dump by announcing another setback in the healthcare law’s implementation, a year-long delay for online enrollment in the federally-run small-business exchanges, called SHOP. The Department of Health and Human Services (HHS) had already delayed online SHOP enrollment a couple months ago, saying it would be ready sometime in November, but the failures continue.

Two months into ObamaCare’s disastrous roll-out, and this past Saturday marked the deadline for the administration to have [Healthcare.gov](#) working for only 80 percent of users. What about the other 20 percent of users? What are they supposed to do if they had their plans canceled because they do not meet the new Washington-approved requirements under ObamaCare, and they cannot even get on the website to find a new plan?

Next week, the [House Ways and Means Committee's Health Subcommittee](#) will hold a hearing on the status of the law’s implementation, and discuss the current and long-term challenges Americans are faced with in finding affordable, quality health coverage as a result of ObamaCare.

It is clear the problems with ObamaCare extend far beyond the website. If President Obama will not admit his healthcare law is broken, he should at least delay this train wreck for all hardworking Americans, instead of picking winners and losers under the law.

We are often told about meetings/hearings to be held in the House, but we rarely hear about the results of these meetings. Not ObamaCare, but PatientCare — Good health care is about people, not faceless government

The fatal conceits of Obamacare are the absurd notions that the government can spend your money more wisely than you can and that bureaucrats are more capable than you are to make your own most intimate, personal decisions. The antithesis of government-centered Obamacare is what I simply call “PatientCare.” Patients should be at the center of our health care universe, not President Obama and not the government.

Nearly two decades ago when I started medical school, I realized that no matter what the politicians do, or what administrators or anyone else say, all that ultimately matters is the care I provide to my patients. Everything else is secondary. At every level of a health care system, a simple question should be asked: What is best for patients? Not what’s best for government or lawyers or even doctors, but patients.

Patient-centered health care — PatientCare — looks like this:

Tax fairness: Eliminate ill-conceived taxes that have the perverse effect of preventing Americans from acting responsibly and purchasing individual insurance. If your boss pays for your insurance — with money he would have otherwise paid directly to you — then he understandably wants a say about your medical treatment, your private behavior and even your weight. Tax fairness would allow patients to purchase their own insurance and keep their employers out of their private examination rooms.

Insurance portability: When health insurance is decoupled from employment — as is auto insurance — you no longer risk being stuck in a job you hate for medical reasons. Moreover, when patients have their own policies, the insurance companies are finally forced to listen to them. If they don’t treat you right, you can fire them and hire another — just like you can your auto-insurance company.

Medicare Advantage: Nothing is more cruel than making promises to patients that cannot be kept and, quite simply, Medicare is insolvent and cannot keep its promises. The U.S. government is already the world’s biggest denier of medical claims. Part of the solution: Give patients the freedom to voluntarily enroll in premium-assistance programs like Medicare Advantage, where they own their own policies, rather than being subject to the rationing whims of unaccountable bureaucrats.

Health savings accounts: HSA’s put patients in the driver’s seat. They are incentivized to keep an eye on costs yet funds are still available if — and this is the key — the patient himself decides it’s necessary. Patients who avoid wasteful spending are rewarded by keeping the savings. Unlike government rationing, HSA’s reduce spending without compromising health care results. As Dr. Ben Carson says, when a child is born, he should be given a birth certificate and a health savings account.

End government monopolies: This is simple. Competition provides patients with more options, lower costs and better services. Equally true: Monopolies kill competition. Each state has created its own insurance monopoly, or at least cartel, by larding up health insurance with mandates to cover whichever services are offered by those providers who can hire the best lobbyists. These mandates protect the insurance companies and doctors at the expense of millions of patients who can no longer afford the high-priced insurance. The same holds true with medical licensing that protects doctors from competition. Your state should open its borders and allow reciprocity for physicians and carriers licensed in other states to practice medicine and offer more products to compete for your business.

Eliminate frivolous lawsuits: Patients pay a hidden “lawsuit tax” embedded in every medical procedure, pill and product, and hundreds of billions of dollars are wasted on defensive medicine. Patients should be protected not just from harmful doctors, but also from harmful lawyers, who are enriched by our current lottery lawsuit system.

Help the needy: Obamacare unleashes the worst approach to those in need. It artificially hikes health care costs beyond their means and then provides welfare to families — even those earning up to \$94,000 a year — that still won’t cover the new, higher rates. That’s a double disaster, since taxpayers who now have to pay for their own higher premiums also must cover the welfare, not only for the needy, but even for their affluent neighbors. This is a train with too many cabooses and not enough engines, which will come crashing down the hill. For far less, we could, for example, simply give cash to needy families so they can purchase their own market-based insurance.

These are common-sense reform measures and, unlike Obamacare, they remain true to one guiding principle: Put patients first.

The president’s health care leviathan is already showing signs of collapse under its own weight. The Obamacare lies of universal coverage, cost savings and deficit reduction have been exposed, and even one of its own architects now admits that the law is “beyond comprehension” and predicts a “huge train wreck” that, after its bad start, “will just simply get worse.” Indeed.

It’s time to prepare for the post-Obamacare era. It’s time to build a system that finally puts patients first. It’s time for PatientCare.

Common Core ‘architect’ David Coleman’s history with Bill Ayers and Barack Obama

CHICAGO — Referred to as ‘Common Core lead standards authors’ by the Council of Chief State School Officers (CCSSO), David Coleman and Jason Zimba are just two in a long list of Common Core creators whose academic roots are with the education-for-a-revolution machine borne by Annenberg Institute, Carnegie Corporation, Bill Gates, et al.

Today, Coleman and Zimba are head of Student Achievement Partners, an organization that played a leading role in developing the standards, and actively supports districts and states in implementing them.

Prior to Student Achievement Partners, Coleman and Zimba were co-founders of the Grow Network (now owned by McGraw-Hill Company). Grow Network began as a pilot program in New York in 2000. Less than a year later, the Chicago Public Education Fund began negotiating a contract with Grow Network on behalf of Chicago Public Schools.

The Chicago Public Education Fund (‘The Fund’) was created in 1998 by the Chicago Annenberg Challenge (CAC) board of directors, which included Barack Obama as board chairman and communist Bill Ayers, as co-chair.

President Obama’s recently appointed Commerce Secretary, Penny Pritzker, was one of twelve founding board members appointed to The Fund.

Obama himself worked with The Fund for the next several years as a leadership council member, alongside Bill Ayers’ father, Thomas Ayers, and brother, John Ayers.

From *Catalyst Chicago*, March 2000:

“The Chicago Annenberg Challenge will close up shop in June 2001, but its efforts to improve public education will live on through a new community foundation... the Chicago Public Education Fund...”

The Fund existed and still exists to carry on the work of the Chicago Annenberg Challenge — that work being the expansion of Theodore Sizer’s Coalition of Essential Schools, the reform movement that now (even absent Common Core) indoctrinates students in several states and districts nationwide with a Marxist-Communist political, moral and social ideology.

In 2001, shortly after Arne Duncan began his stint as CEO of Chicago Public Schools (CPS), David Coleman’s newly formed Grow Network solidified its \$2.2 million contract with CPS to provide the district with data driven student performance reports for the 2002-2003 school year.

In CPS’s 2002 Education Plan, which introduced Grow Network as a new initiative, President Obama is listed as a member of the district’s planning and development advisory committee. The report also names John Ayers and Communist-Maoist Mike Klonsky of Bill Ayers’ Small Schools Workshop as participants in CPS’s education plan discussion groups.

In 2004, Coleman and Zimba sold Grow Network to McGraw Hill, which continues its lucrative partnership with CPS today. In fact, two former Grow Network members now work for the Chicago Public Education Fund — one of them as its managing director.

The fact that Grow Network has history with the Ayers/Obama/Annenberg led Chicago school system, and was recruited by the Ayers/Obama/Annenberg created Chicago Public Education Fund, doesn’t necessarily implicate David Coleman and Jason Zimba as supporters of Chicago’s radically progressive style of education. However, given Coleman’s progressive upbringing and the fact that CPS paid more than \$2 million to bring his untested and unproven program to the district, it does seem likely that Coleman and Zimba had prior connections to the Chicago ed machine.

Fast forward to today and we see each of these players still working to expand the Annenberg/Coalition of Essential Schools (CES) reform model, a model whose teaching strategies, lesson plans, and curriculum resources are identical to those now being used with Common Core.

Communist, domestic terrorist, and creator of the Chicago Annenberg Challenge, Bill Ayers, continues to speak on behalf of the Annenberg/CES reform effort and provides professional development to teachers and principals from CES schools and districts.

From the White House, Obama and Duncan promote, by name, Bill Ayers’ Small Schools Workshop and the Coalition of Essential Schools while funneling billions to states that have adopted Common Core.

Carnegie Corporation, which has continued to support Annenberg/CES reform over the years, now also provides heavy funding to the Council of Chief State School Officers for the creation and implementation of Common Core.

Officials Hide Evidence: After 4 Years of Common Core — Test Scores Plummet

GULFPORT, MS - A Common Core school district — Gulfport, Mississippi — is covering up failing test scores. At a recent meeting by Superintendent Glen East, parents were told that the test scores of the district had improved dramatically under the implementation of the Common Core curriculum. The Superintendent made his claims regarding dramatic academic improvement of all students by using ONLY the scores of the top 150 students.

In his comments to parents, Mr. East stated,

“This district already had national average ACT scores. We’ve now gone with our top students, our top 150 students, we’ve gone from a 23 average to almost a 25 in over four years. That is not a new ACT, that is the ACT we are currently working with. We’ve improved reading achievement for all students. When I look at that data about how we’ve grown over the past four years and the success we’ve had, if you are in my shoes, you have to celebrate what you are doing. Very Powerful!”

However, a couple of weeks later at a subsequent event, it seems that parents had a chance to research the data that the Superintendent had reported. Upon closer inspection of the data, parents found that the Superintendent completely misrepresented the data, and that the results were worse, not better. They were not simply a little worse, but a lot worse.

U.S. Secretary of Education Arne Duncan should take note. This father does not look much like a white suburban mother. Chris Ashley is the pastor at a local Baptist Church who has a son attending the Gulfport schools. He opens his talk with congratulating the district on the gains they had made. After a brief applause from the audience, he goes into the data.

“According to the Mississippi Department of Education website and their stats, and I can leave them here with Mr. East or all you all can go and get them yourself, everywhere else we are dropping. From 2009 to 2012, almost every grade has dropped in their scores. Not all of them, but overall our test scores have dropped.

“... GreatSchools.org you can go there, they’ve pretty much done all the math for you, they tell you the percentages of students that have scored proficient or better. Third grade language arts, we’ve dropped 4%, this is all 2009-2012. Math 3rd grade we’ve dropped 6%. Fourth grade language arts, we’ve gone up 8% but we dropped 5% in math. Fifth grade we dropped 5% in language arts and 6% in math. Sixth grade we went up 1% in language arts, we dropped 2% in math. Seventh grade and eighth grade, went up 8 and 4, and eighth grade went up 4 and 12.

“The 5th grade MST test we did well at — we went up, we went up 9 and 17 points.”

Well, that is good, right? But what about on the very SAT and ACT that the school district touts?

“The SATP from 2009-2012 in Algebra we dropped 34%. In 2009-2012 in English we dropped 18%, in Biology we dropped 46% in those same years, and in history we dropped 38%. You see I heard a lot about our ACT scores and how great they are from the 10th grade and that is awesome. I didn’t check the 10th grade scores, but I did check the graduating seniors... From 2007-2011 we’ve dropped 1% in English, 0.7% in math, we are level in reading, we’ve dropped a half a percent in science and a half a percent in composite scores.

“Now, we all know we can take data and we can twist to show what you want it to show. I took the numbers straight from there and said I didn’t give you just the 10th grade or just the 7th and 8th grade where it looks good. I gave it all to you.”

Then this parent details what the No Child Left Behind testing shows, that Gulfport schools appear to be falling behind.

“I have our district report card here from the No Child Left Behind, and we have dropped. We have dropped without a doubt. Every grade 3-8th in mean score scale, everyone one has dropped. The 3rd-8th grade in language arts, and math, and science, the mean scale score, we have dropped from the previous year, every grade. We have dropped in algebra in the high school, we’ve dropped, uh, we’ve dropped in the mean score in every subject except biology we stayed even 648.

“Like I said, I have all kind of common core curriculum questions, **but what I don’t like is somebody to screw the numbers and tell us we are doing good when we are really not doing good.**”

What was the answer to this parent from Dr. Carla Evers, Director of Instructional Programs?

“I looked at the GreatSchools website, it will show the Gulfport schools going up, and then all of a sudden **we just dive like we went off a cliff and stopped teaching. Well, we did.** We stopped teaching the state standards and we shifted to the common core standards state standards. So that should have happened because the things that are on that test were not what we were now teaching in our classrooms. So we understood that, the state department put that in our newspaper, but for some reason they still put those test scores on their state website.”

Now, what material would it have been that is no longer taught in the Gulfport schools? Reading? Addition? Subtraction? Multiplication? These are huge score drops. Further, the ACT was the same test that Superintendent East had just bragged about, so how is it that it can be used to brag about improvement for one grade, but not erosions in learning in another grade?

Even worse, the school district is upset that the State Department of Education failed to hide the scores from the state website? This is outrageous!

If the ACT and SATP are not valid measures of student learning in Gulfport, MS, then what measure is? Do the colleges in Mississippi no longer accept the ACT and the SAT?

Activists at Stop Common Core Mississippi Facebook page noted,

“Common Core clearly fails to teach the foundational material needed to pass tests. Whose fault is it that the failures was leaked to the public?”

What is Common Core? The Common Core State Standards are a set of national core-content standards for k-12, in English language arts and math. The purpose is to impose “rigorous standards” so our students will be better prepared for competing in a global economy, and allow comparison of performance across states.

Why are we against the Common Core State Standards? This is nationalized education without representation, because curriculum will be tied to the standards, and assessments under CCSS violates the 10th Amendment, and the three statutes that keep the federal government from creating a nationalized curriculum. Because of the way these standards were adopted parents, teachers, principals, school districts, and even state boards have no control over what is being taught in our schools.

This was said to be a state-led initiative, which simply isn’t true. The CCSS were created under the auspices of two D.C.-based trade organizations that have nothing to do with legislation. These organizations were the National Governors Association (NGA), and the Chief Council for State School Officers (CCSSO). These organizations were funded by the Bill and Melinda Gates foundation to jump start this initiative.

How did states get involved? In 2009 secretary of education Arne Duncan announced the “Race to the Top” grant application process, which was funded by the stimulus bill. In order to be considered for this grant money, states were required to adopt the CCSS and national tests aligned with these standards.

In July of 2009, KS Gov. Mark Parkinson, and Kansas Education Commissioner Alexa Posny signed a memorandum of agreement to participate in “Race to the Top.” The state Board of Education never saw this MOA, and the Legislators knew nothing about this education initiative. Please keep in mind the legislators are not even in session June through November to hear testimony on such an idea, which was the plan all along. Also keep in mind in 2009 states were cash strapped looking for ways to fund education.

[We Bet You Haven't Heard This About Obamacare](#)

Another push is underway to raise the minimum wage. But what you probably haven't heard is that Obamacare has already done that.

The plan on the table in Congress would raise the federal minimum wage above \$10 an hour (which is higher than all existing state rates). ObamaCare's mandate on employers, however, is already scheduled to raise the hourly cost of hiring a full-time worker past \$10 an hour. >>> [See how much Obamacare adds to labor costs in your state](#)

The idea behind a minimum wage is to help low-income workers. But ObamaCare's mandates will hurt the job prospects of these very workers — and raising the federal minimum wage would further limit the number of jobs available.

Combining federal (or state) minimum wage rates, payroll taxes, unemployment insurance taxes, and soon ObamaCare's employer mandate, employing a worker full-time will cost a minimum of \$10.30 an hour. The government has made hiring more costly without raising workers' pay.

Unfortunately, this will make entry-level jobs harder to get. And these jobs are important. For the majority, they are stepping-stones to higher pay and higher-skilled positions. As Heritage's James Sherk and Patrick Tyrrell [explain](#):

Two-thirds of minimum wage workers [earn raises within a year](#). Entry-level jobs pay off in the long run for many workers. But if Congress adds a minimum-wage hike to the ObamaCare mandate, many employees will never get that chance.

Of course, companies with 50 or more employees can avoid ObamaCare's mandate by cutting workers' hours below 30 hours per week. An increasing number of employers announced plans [to do exactly that](#) before the Administration delayed the mandate a year. Fewer hours is not a good outcome for workers.

People looking for work — or trying to hold down a full-time, minimum wage job — are victims of ObamaCare. Adding this minimum wage hike would bring the minimum cost of hiring a full-time worker to \$12.71 an hour. This, as Sherk and Tyrrell put it, "would cut the bottom rung off many disadvantaged workers' career ladders."

"The Holley Provision" and One American Family's Sacrifice in the War on Terror

As Thanksgiving passes we continue to be thankful and celebrate the service & sacrifice of our Military Heroes and their families. Today we bring you the story of Matthew J. Holley, a combat medic in the 101st Airborne whose parents John and Stacey Holley fought for all military families to make sure all of our fallen warriors return home with the honor and respect they deserve.

John Holley was one of the Gold Star Parents we were able to take with us to Iraq in 2006. A trip he credits with helping him honor his son and move forward in his life. We have had the pleasure of working with John and Stacey Holley ever since and are so grateful for all they have done for other military families. Please take the time to read the story below and learn about their son.

Thanks to the efforts made by the Holley Family the "Holley Provision" exists to ensure all of our fallen heroes return honor and respect they deserve.

The story of Army SPC. Matthew J. Holley,

On a cool autumn afternoon in November 2005 the world seemingly ended for John and Stacey Holley. With the ringing of the doorbell and the appearance of uniformed military strangers on the porch of their North Idaho home, their quiet lives were shattered by the news that **their son and only child SPC. Matthew J. Holley had been killed along with three other soldiers by a roadside bomb while on patrol in Taji, Iraq. He was a Combat Medic with the 101st Airborne Division out of Ft. Campbell, Kentucky.**

Growing up, Matthew was the child that most parents hope for; he was charismatic and talented both athletically and artistically. By the age of 18 he was a three-time U.S. National Karate champion and a talented amateur artist. For most who knew him, Matthew was a person of few words, choosing instead to let his actions speak much louder. He thrived on the challenge of being the best he could be.

When Matthew made the decision to become a soldier he was following in the footsteps of four generations of family members before him, including both John and Stacey. He was driven by a few valued lessons in life that he was raised on. The first to know and respect "that to whom much is given much is expected" and second that whenever the opportunity availed itself "to take his eyes off of himself and to put them on to others."

Etched on SPC Matthew Holley's gravestone are the following words, "To Serve a Cause Greater Than Myself". Profound words spoken by a profound young man to his mother and father for

his reason to join the United States Army and become a Medic. Matthew's zest for life was to apply those valued lessons handed down to him and in doing so share a little of that freedom so many in our nation take for granted, or a little of that free spirit we all have.

Like so many who feel called to serve our nation, Matthew loved the Red, White and Blue. He loved the freedom it exudes and offers anyone who lives in the United States of America. As many in our generation, most will always remember that fateful Tuesday in 2001 when the towers fell. Matthew was just one week short of his 17th birthday, but as his mother reflects back, she believes that day was as much a catalyst for his decision to serve our nation as any. It was on that day that he saw the cause for freedom and all he had been raised to believe in challenged, and he expressed that **"if there was one thing worse than dying, it was being alive and not being free."**

Even in the midst of their grief, John and Stacey knew that they were not the only parents who would face such a crisis. They were not the only American family destined to hear the ringing of a doorbell, or to learn the news of a loved one's ultimate sacrifice from the lips of complete strangers.

Unbeknownst to them John and Stacey's sorrow would quickly turn to horror when they discovered that Matthew's casket would return to San Diego's Lindbergh Field **as common freight.**

There would be no honor guard to welcome their fallen hero back to his hometown.

Instead, Matthew Holley's remains would be carted around by forklifts and baggage handlers, like a crate of auto parts. Determined to welcome their son home with honors befitting his sacrifice to our nation, the Holley's embarked on a quest to challenge the law, and to begin a journey of healing that would touch the lives of Gold Star families across our nation.

In 2011 the Holley's released their co-authored book, *Medals, Flags and Memories*. In the book they share the story of their struggle in the weeks and months following Matthew's death, as they fought to enact the law known today as **"The Holley Provision"** or as some have come to refer to them as "Angel Flights." John and Stacey chose not to write simply a memoir of grief and loss.

Rather their desire was to share a journal of personal transformation, a guidebook for anyone who finds themselves struggling in the storm of their lives. It's a journey of faith, love, and ultimate perseverance. But beyond all of these things, it's an unmistakable demonstration of the American ideal in action.

Today each fallen heroes casket is met by honor guards in white gloves and crisp uniforms, instead of baggage handlers with forklifts. The legislation, was signed into law by President George W. Bush in October 2006, and enacted by the Pentagon in January 2007.

Faced with the entrenched bureaucracy of our government, the Holley's proved that an ordinary family can tip the scales of American justice. And, in an age where many people feel alienated and powerless, the Holley's have shown how *ordinary citizens can impact the change in federal law, and transform the world we live in.*

In a sense, one world ended for John and Stacey Holley in November 2005, when **Matthew died to preserve the American dream.** But another world opened up, as the Holley's discovered the power of prayer, determination and belief in the values that our great country was founded on. John and Stacey have honored Matthew's death by reminding us that his sacrifice and the sacrifice of all those who serve our great nation is not in vain or without the honor due. **That the American dream is still very much alive and well, and it is within the grasp of each citizen who dares to reach out and claim it.**
