A MARINE'S CANDID THOUGHTS ON AMERICA

Yesterday morning, in the Phoenix Sky Harbor Airport, I sat down at Matt's Big Breakfast to get a quick bite before my trip.

But after Providence led me to sit next to a Marine Staff Sergeant, a simple meal became something else entirely.

The young man was 28 years old, the same age as my oldest son, and he had just left his wife and three kids in Orlando. He was about to begin another tour in Afghanistan.

Over breakfast, we had a candid discussion about his unit, about Iraq and Afghanistan, and about his Commander-in-Chief, Barack Obama and you'll be shocked by some of the things that he told me.

First and foremost, though, I have to say that this man's parents should be proud. In a world of "failure to launch," he's tackling the tough duty of being not just a father but also a provider.

"I have three kids and a wife, so I need this job," he said softly. "I have responsibilities." His words spoke a universal truth to me about the duty of fatherhood, something we don't teach well in America.

Yet being a father and a provider was hardly the only wisdom that this young soldier possessed.

A Man of Duty and Honor

I asked him what type of unit he was in, and he said, "They just transferred me from a training unit to an infantry unit. We're sure to be mixing it up. Things have heated up, now that we announced we're leaving."

There it was, another universal truth: Never announce your plans to the enemy. This young Marine intuitively understood a crucial element of diplomacy and foreign policy that even the president doesn't get.

You see, Obama blundered by making his timetable for exit public knowledge. Regardless of what we're doing, why would we announce it to the enemy? There's no reason to preemptively reveal your plans to surrender... yet Obama is doing so anyway, which means we should expect the same results in Kabul that we've seen in Baghdad.

Speaking of Baghdad, the young Marine dropped a bomb to me: "We'll soon be back in Iraq, some guys are already back, we're expecting to go again," he predicted. So much for a successful drawdown.

Forty Illegal Immigrants Returned to Honduras Amid Massive Influx

Some 40 illegal immigrants, including both adults and children, were returned to Honduras from a U.S. detention facility in New Mexico on Monday, Homeland Security officials confirmed to FoxNews.com.

The group had been housed at the Federal Law Enforcement Training Center in Artesia, N.M., and was among thousands of illegal immigrants from Central American countries, including Honduras, Guatemala and El Salvador, apprehended at the border.

After the plane landed, U.S. officials touted the move as a step in the right direction.

“As President Obama, the vice president, and (Department of Homeland Security) Secretary (Jeh) Johnson have said, our border is not open to illegal migration and we will send recent illegal migrants back,” Homeland Security officials said in a written statement.

The proverbial pat on the back for sending 40 Hondurans home came as close to 82,000 illegal immigrants remain in the country. Of that number, minors make up about 57,000.

Homeland Security officials said Monday’s flight was just the “initial wave” of deportations. Immigration officials have seen a spike in immigration in recent months as false rumors spread of a June deadline under which they could legally stay in the U.S.

Many of those who crossed the border said they came to America looking to escape atrocities back home.

As required by law, recent border crossers subjected to expedited removal are screened for “credible fear,” DHS said, adding that despite quick removal proceedings, adults and children “maintain important due process rights, including the ability to seek asylum, appeal to an immigration judge the denial of a credible fear finding, and the ability to seek legal representation.”

Last week, the president of Honduras declared a humanitarian emergency and announced that the country would create a revolving fund to coordinate the deportation and reintegration of children.

In Honduras, immigration officers review the documents of deportees before they leave the plane. They are then moved to a processing center where they get their “documentation, coffee, hygiene kits, and their property (i.e. luggage),” ICE officials said.

Representatives from the Labor Office are there to help them with employment, and, in a separate office, the National Registry of Persons signs them up for national identification if they don’t have any.

For minors, the child welfare agency in Honduras tries to connect them with family members living in the country.

I know – This is a drop in the bucket to how many have come across our borders illegally!!! We have to start somewhere! The U. S. officials even acknowledged that it is “a step in the right direction”. We have to take a few steps before we can run. Run these people right back as soon as they cross the border!! "Who Would Jesus Deport?" Is The Wrong Question For Christian Patriots

When Nancy Pelosi said that illegals should be treated like the "baby Jesus," the former Speaker became the latest liberal politician to opportunistically use Christianity to guilt trip Americans into giving away their country. Unfortunately, the former Speaker the *American Thinker* called an "occasionally devout Catholic" is not alone, as evidenced by the widespread use of the deeply dishonest slogan "Who Would Jesus Deport?" [*Nancy Pelosi's 'Baby Jesus' Argument*, by Jeannie DeAngelis, July 23, 2014]

"Who Would Jesus Deport?" is widely deployed by open borders advocates in [articles](#), [cartoons](#), [t-shirts](#) and even its own [Facebook page](#). And as you might guess, those asking the question already have an answer—[certainly not illegal aliens](#). The loaded question is designed to force American Christians into supporting destructive policies out of [misplaced morality](#).

Elvira Arellano, an illegal who made a great show of [holing up inside a church](#) to avoid deportation and used her [anchor baby](#) son Saulas a prop, tried to cast herself as a Christian martyr using the slogan. Here's a [photo](#) of Elvira back in 2006 wearing a "Who Would Jesus Deport?" t-shirt.

Though some are simply misguided idealists, many of the "Christians" who use this slogan are less concerned with living a Christian life than with using the faith [as a way to get Americans to sabotage their own interests](#). A typical example is the [Evangelical Immigration Table](#)—financed in part by [atheist globalist George Soros](#).

Of course, "Who Would Jesus Deport?" is a parody of the famous question, "[What Would Jesus Do?](#)" Coincidentally, "Who Would Jesus Deport" forms the same acronym (WWJD)—and it's basically the same argument.

As a Christian, I disagree somewhat with "WWJD"—especially the careless way it is used. Naturally, Christians should follow Jesus Christ—as [I John 2:6](#) states, "whoever says he abides in him [Christ] ought to walk in the same way in which he walked."

However, the questions “What Would Jesus Do?” or “Who Would Jesus Deport?” aren’t calls to lead to a Christian life—just slogans. A Christian should think about the [real world consequences](#) of catchphrases that owe [more to marketing than theology](#). He should also think about what Jesus really came to Earth to do.

The Bible teaches that Jesus Christ, God the Son, was incarnated as a man to accomplish a mission—to [die for us](#) and be [resurrected](#).

Therefore, there are many things in this life that Jesus did not do, not because they were wrong, but simply because they weren’t part of His mission to preach the Good News.

Jesus Christ was not a government official. If a contemporary Christian is a government official, he can’t say “I’m going to do my job as a government official just as Jesus did.” There may not be specific examples from Matthew, Mark, Luke and John about how to perform a specific task.

Nevertheless, although Christ was not in government, he did recognize governmental authorities, both [Jewish](#) and [Roman](#). His famous [distinction](#) between rendering to God and [rendering to Caesar](#) teaches his followers to recognize the difference between the Kingdom of God and the Kingdoms of Men. Though the Kingdoms of Men are certainly not identical to the Kingdom of God, under God’s authority they serve providential purposes.

Some things that governments do (or should do) include protecting the country’s borders and, yes, deporting illegal aliens. These are not specifically Christian duties, but they’re not anti-Christian either. They are simply functions of human governments.

The folks who ask loaded questions can’t imagine Jesus deporting illegal aliens, so they conclude nobody should deport illegal aliens. (Or at least, the United States shouldn’t, because I don’t hear them complaining when other countries do it.)

But deporting illegal aliens simply wasn’t part of [Christ’s mission on Earth](#) (though today’s plutocrats should take a hard look at [what he did](#) to the moneychangers in the Temple). That doesn’t mean He forbids deportation. .

The real question is not “Did Jesus Deport Illegal Aliens?” The real question is “Do human governments have the authority to control their borders and deport illegal aliens?”

There is nothing in the Bible or Christian doctrine [that denies such authority](#).

In fact, in Acts chapter 17, the apostle Paul, in his discourse [to the Aereopagus, states](#) that God “...hath made of one blood all nations of men for to dwell on all the face of the earth, and hath determined the times before appointed, and the bounds of their habitation..” ([Acts 17:26, KJV](#))

The [Greek](#) word for Nation used in the text is ethnos (ἔθνος), from which derive our English word “ethnic”. We find in this verse a justification for [ethnic-based nation states](#) with [definable borders](#).

Besides, open border fanatics are very selective in their moral indignation. They claim the United States mistreats illegal aliens but have nothing to say about how the governments of [Mexico](#) and [Central America](#) cynically export their own problems to the gringos.

Wouldn’t it be of more relevance for Christians to focus their concern on Latin Americans who abandon their families? Or on Latin American parents who [send their children alone to travel thousands of miles](#)? Or on criminals who kidnap, abuse, and kill illegal aliens?

Or, most important of all, on the responsibility of [Christians in other nations](#) to improve life in their own homelands?

Sadly, actually solving problems instead of bashing the gringos doesn’t bring the same favorable media attention—or [donations from George Soros](#). It’s much easier and more popular to criticize ordinary Americans who simply want their laws to be enforced.

One exception is [Samuel Rodriguez](#) of the National Hispanic Christian Leadership Conference. I criticized Rodriguez in [previous articles](#) as an amnesty supporter. Nevertheless, during the present crisis, Rodriguez has publicly appealed to Mexicans and Central Americans not to send their kids to the United States. Bravo to Rodriguez for that, and credit where credit is due. We ought to see more of that, but sadly, we don’t.

Demanding that our government fulfill its duty by controlling our borders is not evil or anti-Christian. KS Supreme Court removes 'hanging Chad' from ballot

As we predicted after Tuesday's hearing, the Kansas Supreme Court ordered that the name of Shawnee County District Attorney, Chad Taylor, **be removed** from the ballot as the Democrat contender for U.S. Senate.

It remains unsettled whether the final ballot for the Kansas U.S. Senate seat will include a Democrat because Secretary of State, Kris Kobach, asserts that the state Democrat Party is legally obligated to submit a replacement candidate for Taylor.

At a press conference Thursday, Kobach announced the new Democrat name must be received by noon, Sept. 26.

Taylor had filed at the last possible hour to remove his name (*see more here*) and has not yet commented on the reason he withdrew. The Kansas law on this matter was supposedly strengthened to prevent such **late withdrawals of candidates for purely partisan calculations** that disenfranchise those who voted in the primary.

The state Supreme Court's unanimous ruling late Thursday remained very narrow and focused, declaring that Taylor's official request to remove his name "pursuant to" the statute was acceptable, without a declaration of his "incapability to serve."

Kobach told Bloomberg News he was disappointed:

"The court's decision essentially nullifies what the legislature did in 1997 when they inserted 14 words into the law to require a candidate declare that he is incapable of fulfilling the duties of office."

Incumbent Republican U.S. Senator, **Pat Roberts, is the only pro-life candidate** for that office. He commented about the ruling, "This is not only a travesty to Kansas voters, but it's a travesty to the judicial system and our electoral process."

Pundits point out that elimination of a Democrat nominee will benefit lately-entered "independent"

candidate, Greg Orman. Multi-millionaire Orman has already spent over \$900,000.00 on TV commercials.

The state Supreme Court did not rule Thursday on the legal duty to supply a Democrat substitute for Taylor, but a motion for the Court to address **this issue has now been filed** by a disgruntled Democrat.
