It was all fear-mongering today at an event in celebration of the Congressional Black Caucus' 44th Annual Legislative Conference.

Black Woman Calls on Black People to Start “Speaking Properly”

As difficult as blacks had it during the days of segregation, a distinctly black culture developed, even in the prevalence of racist attitudes and restrictive laws. We forget, or have never been told, that Washington, D.C., from 1920 to 1960, “was a financial, spiritual, and cultural stronghold. Because Washington was a segregated city, blacks simply created their own metropolis... The first black bank, the Industrial Savings Bank, was started here.” While “the black population of New York’s Harlem inherited many of its buildings from previous white owners... many of the buildings in Shaw were paid for by black businessmen and built by black hands.”

Families were intact, the divorce and unwed mother rates were no different from that of white communities.

Take a look at photographs of the 1963 March on Washington led by Martin Luther King, Jr. Notice how everyone is dressed. Most of the men are wearing suits and ties. Many of the women are wearing hats, as are the men. There is a dignity about the crowd.

Blacks are not helped by the continued claim that all problems for them are racial. Some are, but most aren’t. Black-on-black crime is not the fault of white people. Sky-high out-of-wedlock births are not the fault of whites. High dropout rates among blacks are not the fault of whites. The solution is not cry “racism” and blame everything on whites or hundreds of years of oppression. Blacks won’t find their problems solved by appealing to the State.

Welfare programs have done a lot to keep black families down by subsidizing family fragmentation and fostering multi-generational dependency. Black problems aren’t solved by naming streets after Martin Luther King, Jr. The same can be said for the King Holiday and Black History Month. These are literal crumbs to appease the black community, but have any of these actions helped blacks?

Consider this recollection by basketball great Kareem Abdul-Jabbar when as a 9-year-old he was enrolled in a predominately black Catholic school outside of Philadelphia in the 1950s:

“I got there and immediately found I could read better than anyone in the school. My father’s example and my mother’s training had made that come easy. I could pick up a book, read it out loud, pronounce the words with proper inflection and actually know what they meant. When the nuns found this out they paid me a lot of attention, once even asking me, a fourth grader, to read to the seventh grade. When the kids found this out I became a target...”

*“It was my first time away from home, my first experience in an all-black situation, and I found myself being punished for doing every thing I’d ever been taught was right. **I got all A’s and was hated for it; I spoke correctly and was called a punk. I had to learn a new language simply to be able to deal with the threats. I had good manners and was a good little boy and paid for it with my hide.**”*

Sadly, many black people in America today blame the problems they face on institutionalized **racism** from white people.

In reality, much of the issues they face stem from **years of liberal policies** implemented by Democrats.

These policies have led to absurd levels of **black on black crime**, namely because of the destruction of the black family, the embracing of poverty and the **welfare state**, and an abysmal public education system.

This lack of a good education has resulted in many black people not having a solid grasp of the English language. Not being able to speak properly and clearly only perpetuates the unemployment and poverty issues that plague many black Americans.

One young black lady wants to change all of that, and she put out a video explaining why it is important for black people to learn to “speak properly”.

She begins by attacking the notion that there is such a thing as “talking white”, which she says is actually called “speaking fluently”.

Finally, she calls on her fellow blacks to stop criticizing people for “speaking white” and claiming that white culture is holding them down, as that actually perpetuates the notion that whites are an elevated and educated

culture, superior to blacks.

This woman speaks the truth, and hopefully her properly enunciated words will not fall on deaf ears.

Unfortunately, she was promptly attacked in the comments section on the web site to which her video was initially posted. She was called all manner of derogatory and racially charged names, when she was only trying to help her fellow blacks make something better of themselves.

Obama Has Skipped Nearly 60% of His Daily Intel Briefings; Wait, What?

According to this morning's [Real Clear Politics average](#), Barack Obama's job approval rating is 41.4%. That's a tick higher than the percentage of daily intelligence briefings he has attended so far in his second term.

Not that he was that much more vigilant about national security in his first term, during which he was present for 42.1% of those briefings.

A [report by the Government Accountability Institute \(GAI\)](#) reveals that Obama has skipped 57.0% of these briefings, known officially as Presidential Daily Briefs (PDB), in the 2,079 days of his presidency to date. The shocking report comes less than 48 hours after [Obama's appearance on "60 Minutes"](#) in which he blamed the lack of preparedness for ISIS's rapid rise on his intelligence team, calling out Director of National Intelligence James Clapper by name. **WHO IS THE ONE IN CHARGE?**

During the interview, Steve Kroft asked, "How did they (ISIS) end up where they are – in control of so much territory? Was that a big surprise to you?" Obama replied:

"[National Intelligence Director] Jim Clapper has acknowledged that I think they underestimated what had been taking place in Syria."

Spokesmen for the administration spent much of the day Monday trying to spin Obama's comments, which [drew the ire of reporters on both sides of the aisle](#), but to no avail. Many commenters were struck in particular by his choice of pronouns, referring to "they" rather than "we," or even more fittingly "I," in explaining away this security lapse.

It is not only the press that is rankled by Obama's feeble attempts to deflect blame. Members of his security team, who warned him early and often about the rise of ISIS, are also fuming. [The Daily Mail quotes](#) an unnamed source within the White House as saying:

"It's starting to affect morale around here. Any time you're hired by a boss to advise him about what to do in a high-stakes area, and he ignores you for a long time, it's going to gnaw at you. He had enough to go on... He knew what was at stake. He knew where all the moving pieces were. By February [of 2014] we had generals basically reading out their memos to Congress."

The reference in the last statement is to testimony by [Lieutenant General Michael Flynn, the director of the Defense Intelligence Agency](#), who told the House Foreign Affairs subcommittee in February that ISIS "had already seized Fallujah and Ramadi," and had the "ability to concurrently maintain multiple safe havens in Syria." Flynn was ultimately fired, but not before [delivering a warning to the Obama administration](#) about its naïve "narrative that al Qaeda's brand of nihilistic extremism had died with Osama bin Laden in 2011."

It is understandable, if not defensible, that Obama was AWOL during the majority of his PDBs inasmuch as national security simple doesn't interest the president, who fancies himself more a domestic policy geek. That it is a fundamental responsibility of any world leader, let alone leader of the free world, is an inflection point on the gravity of his dereliction. The other day, someone posted a question on my Facebook page which started out by asking "What if 75 million eligible Christians, who currently refuse to vote, showed up at the polls to vote for who they think are honest politicians..." I have run into several people myself who told me they don't vote.

According to the Barna Group, 71% of adults want to stay informed, but tend to skim the information, because there is so much of it. They want it in a shortened form. To me this means the desire to dig into a subject through research is likely not being done. After all, research is lengthy, because it involves digging for the true facts in all of information. Information is not necessarily truth.

After the 2012 election, Barna conducted a survey that found that an overwhelming majority of protestant (74%) and evangelical Christians (81%) voted for the pro-life, more conservative candidate. Only 56% of what Barna calls "self-proclaimed non-evangelical born-again Christians" voted for the person who most closely stood for Biblical principles. 39% of all born-again Christians voted for Obama! And to my surprise, they found that 57% of Catholics voted for Obama in spite of that denomination's pro-life stand! Still with all of that, the majority of folks who profess to be Christians voted for the more Biblically oriented and more conservative candidate.

One more fact before I get to my point. In the 2012 election, Obama won by only 4,982,296 votes out of 126,849, 296 votes cast. That is 3.9% margin!

I ask my readers to consider two things before the next two approaching national elections. The first thing is the effect of fervent prayer for revival in America. We should be pleading with God for Revival so strongly and so long that the Holy Spirit would convict those of us who are already born-again. Then our thoughts and actions would totally line up with God's Word. Every revival in America's history started with fervent prayer. SALINA — Congressional candidates squared off in what will most likely be the only joint appearance before the November election between First District opponents.

Incumbent Rep. Tim Huelskamp, R-Kan., and Democratic challenger Jim Sherow explained their positions at a candidate forum Tuesday evening at Kansas Wesleyan University in Salina.

They disagreed on nearly every issue addressed — same-sex marriage, immigration reform, the Affordable Care Act, minimum wage, and use of military force in the Middle East.

When answering a question about the Affordable Care Act, members of the audience booed Huelskamp when he discussed the amount of money taken away from Medicare. Sherow asked the crowd to refrain from making noise so Huelskamp could answer the question.

Sherow said if he were elected he would hope to be able to serve on the House Agriculture Committee, a committee that Huelskamp was removed from by the GOP house leadership following the 2012 elections.

On the issue of same-sex marriage, Sherow said he supported equal rights for all Americans, While Huelskamp said he would listen to the voters of Kansas who approved a gay marriage ban amendment to the Kansas Constitution in 2005.

The forum was sponsored by the Salina Area Chamber of Commerce and League of Women Voters.

It was explained to me that Salina has a very well organized Democratic Party. They were in full force. I'll never understand the reasoning of a Democrat. Mr. Sherow had to read each and every answer or comment he made. At first I thought he somehow had acquired the list of the questions, until some of his answers were not entirely related to the questions. One time Representative Huelskamp was prompted to give his response. When prompted he replied, "I'm sorry, I didn't realize Mr. Sherow had answered the question." Recently, the Arizona Republic reported on my work in Washington on the Veterans Committee **to increase the transparency and accountability** from the bureaucracy and ineptitude at the VA.

One of the problems Congress had when we investigated the VA health care scandal was getting accurate information out of the bureaucrats. When I made a shocking discovery that the VA was training employees using the book "**How to Lie with Statistics**," I used a Congressional hearing to ask the VA officials why.

Here is an excerpt from the story:

The VA course is held three to four times a year, with about 150 employees in each session. Sixteen employees from the VA Southwest Health Care Network, which includes Phoenix, attended the course this fiscal year. The VA pays \$1,000 per employee for the program.

The book was removed from the course syllabus per McDonald's order.

Rep. Tim Huelskamp, R-Kan., a former statistical analyst, drew a connection between the book's titular dogma and the committee's continued frustration with conflicting VA data and investigators' findings that the agency repeatedly manipulated statistics.

"We've received misleading, misleading numbers again and again," Huelskamp said.

McDonald's order was the correct move, Huelskamp said: "If we're going to get the VA fixed, we need a good, open relationship and good, accurate, real numbers from the VA. And the secretary, I think, is going to provide those and move forward and work together."
