### **9-Yr-Old Old Black Boy Gunned Down, Media & Black Leaders Remain Silent**

9-year-old Antonio Smith was gunned down in a hail of bullets in Chicago. Smith was a black kid who was needlessly riddled with bullets, but you haven't heard any of the main stream media or black leaders like Al Sharpton screaming for justice. Why?

Members of the Siron City offshoot of the Gangster Disciples were cruising through the Greater Grand Crossing neighborhood looking for members of their rival gang, the Pocket Town, faction GD. They spotted two men that they believed to be part of the rival gang. One of the gang members in the cars handed a gun to one of his partners and told him to go shoot the two men.

As he approached his targets, they saw young Smith in a back yard and thought he shouted out a warning to their two rivals, so he opened fire on the 9-year-old. Smith's body was later found along a set of railroad tracks that served as a dividing line between the two gangs. He had been shot multiple times.

So again I ask why was the media and black activists so silent and not outraged at the murder of Antonio Smith? After all, Smith was a black kid, but then so were the four men that have since been arrested and charged with his murder.

While black leaders remained silent, the community spoke to our local law enforcement, leading them to Jabari Williams, 22, Derrick Allmon, 19, Michael Baker, 19 and Paris R. Denard, 19 who have been charged with first-degree murder. Allmon, identified as the actual shooter, had just been released on parole after serving only 1 ½ years of a 3 ½ year sentence for a weapons conviction.

Blacks killing blacks happens far more often than a white killing a black. In fact, more blacks are murdered by other blacks than by all other ethnic groups combined. Why isn't Sharpton screaming about these murders? The answer is simple; the black on black crime does nothing to fuel his prejudicial hatred for whites. Keeping racial hatred alive and burning is the only thing that keeps Sharpton employed. As for the media, it won't help their liberal agenda by reporting the senseless black on black murders but the trumped up racial murders sell news and keeps them secure in their jobs. If there was no racial war in America, Sharpton and a number of news people would be out of a job, so no, they won't report on the cruel murder of 9 year old Antonio Smith.

On an interview Thursday with Philadelphia radio host Anthony Garano, ex-NBA all star Charles Barkley responded to the rumors over Seattle Seahawks quarterback Russell Wilson's receiving criticism over not being "black enough" from some of his teammates. #### **Horses and ebola: interesting point...**

The present Ebola crisis in the world is frightening.

I have submitted the following letter to the editor of the Lewiston Morning Tribune:

Editor, Lewiston Morning Tribune:

If I wish to import a horse into the United States from Liberia or any African country other than Morocco, the horse needs to undergo a 60 day quarantine period at a USDA approved quarantine facility prior to mingling with the general population of horses in this country. Africa has a disease called African Horse Sickness that does not exist in the US; this is the way we have kept it out of this country. African Horse Sickness does not cause disease in people, only horses; our government has determined that it would be devastating to the US horse industry if it were to come here.

The United States (and virtually all other countries) require a myriad of tests and often quarantine prior to bringing in a foreign animal.

I can't legally cross state lines in the United States with a horse or cow without a health certificate signed by a USDA accredited veterinarian stating that the animal has been inspected and found free of infectious disease. In

most cases blood tests are also required. In fact I can't legally cross the Snake River and ride my horse in Idaho without a health certificate and a negative blood test for Equine Infectious Anemia.

I'm not complaining; the United States of America, the States of Idaho and Washington as well as the other 48 states take the health of our livestock very seriously, and we have a very good record at keeping foreign animal diseases out of our country. I am happy to do my part to maintain bio-security in our animal population.

If I am a resident of Liberia incubating Ebola, to enter the United States all I need to do is present a valid visa, and lie when asked if I have been exposed to Ebola. Within hours (no quarantine required) I can be walking the streets of any city in the United States .

I feel very fortunate to live in a country that values our animals so highly.

final note...

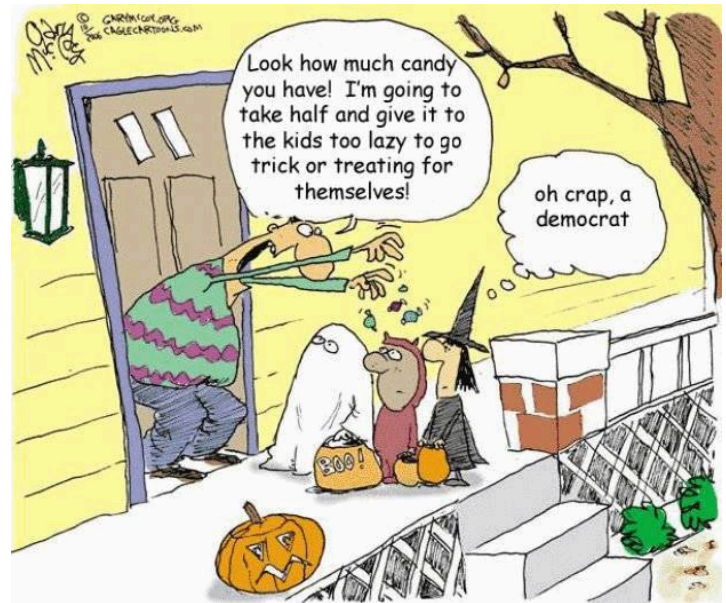

But now the Michigan chapter of CAIR has jumped into the fray. CAIR, the Council on American-Islamic Relations, apparently doesn't believe that the good professor had the right to express his opinion.

For its part, the university is standing its ground. They say the e-mail was private, and they don't intend to publicly condemn his remarks. That will probably change. Wichman says he never intended the e-mail to be made public, and wouldn't have used the same strong language if he'd known it was going to get out.

How's the left going to handle this one? If you're in favor of the freedom of speech, as in the case of Ward Churchill, will the same protections be demanded for Indrek Wichman? I doubt it.

**Origins:** On 28 February 2006, Professor Indrek Wichman, a tenured professor of mechanical engineering at Michigan State University (MSU), sent the e-mail embedded in the example above to the Muslim Students' Association of Michigan State University. The message was a response to the Muslim group's having handed out free cocoa during a public awareness event about controversial cartoons that depicted the Prophet Muhammad as a terrorist. Wichman's letter prompted the Muslim Students' Association and twelve other student and advocacy groups to call upon the university to officially reprimand the professor.

MSU officials have declined to issue a reprimand, saying Wichman's comments constitute free speech. Terry Denbow, spokesman for MSU, said while Wichman's views in no way represent the university's views, they do not violate the university's antidiscrimination policy. However, Denbow noted, Wichman "was cautioned that any additional commentary ... could constitute the creation of a hostile environment, and that could ... form the basis of a complaint" under the school's antidiscrimination

policy.

Wichman told the *Detroit News* the letter had been intended for a one particular person, not the entirety of the Muslim Students' Association; he had believed the e-mail address he used was that one student's inbox. However, students who lead the association said the e-mail address was part of the group's official Web site.

The professor expressed in interviews that he had regrets about the e-mail: "I used strong language in a private communication that I would certainly not have used if this communication would have gone public. ... For the record, I thought it was a private communication and it was written in haste. I think a very minor thing has been blown completely out of proportion. I wrote it in 60 seconds. It was not like I sat and pondered over this thing for days. It was like you talking one night to your wife or your kids."

## **Planned Parenthood Suing for Right to Endanger Women's Lives**

In March of 2012, a woman nearly died at an abortion clinic in Sharonville, Ohio, a part of the greater Cincinnati area. She was getting an abortion at the [Women's Medical Center](#) from Dr. Martin Haskell. The patient went into status epilepticus as she came out of her anesthesia. This is a life threatening condition where the person is in a constant seizure for over 5 minutes with no signs of letting up. The only way to stop this condition is with medical



intervention, which the abortion clinic did not have. If not stopped within 5 minutes, the seizures can cause damage to the neurons in the brain and become life threatening.

Since neither Haskell nor the abortion clinic had hospital admitting privileges, they ended up calling 9-1-1. Witnesses observed paramedics using life saving procedures on the patient before transporting her to the hospital.

This is not a one-time event in the abortion industry. A number of women have died from the butchery they receive at the hands of questionable doctors. In a move to protect the health and lives in women, last year Ohio passed a law that requires all abortion clinics or the doctors working there to have hospital admitting privileges.

Currently there is only one remaining abortion clinic in the general Cincinnati area which is the [Elizabeth Campbell Surgical Center](#) in the Mount Auburn section of town. The center is owned and operated by the largest baby murdering organization in the United States, Planned Parenthood.

Under the Ohio law, the abortion clinic or its doctors must have hospital admitting privileges. Having failed to obtain those privileges, the Ohio Department of Health issued a citation to the clinic and told them that they face closure if they do not comply with the law.

So far the Planned Parenthood clinic has not been able to get any of the private hospitals to enter into a patient-transfer agreement. Other hospitals in the area are Catholic (Cincinnati has a large Catholic population) and they want nothing to do with the abortion clinics as it's against their faith. That leaves public hospitals, which rely heavily on public or government funding and the new law bans public hospitals from being involved with abortions. The Planned Parenthood clinic had an agreement with the University of Cincinnati Hospital (US Health), but when the new law was passed, that agreement was forced to end.

Planned Parenthood professes to put the health and welfare of women above all else and you would expect them to support a measure that is designed to protect women, but you would be wrong. On Monday, Planned Parenthood of Cincinnati filed a lawsuit challenging the legality of the new Ohio law.

The [lawsuit](#), now before a federal judge, states:

*“The last provider of surgical abortion services in the Greater Cincinnati area will close, making abortions virtually unavailable in Cincinnati and violating the constitutional rights of and imposing irreparable harm upon (Planned Parenthood) and its patients. Given that the majority of (Planned Parenthood’s) patients are low-income, the increased costs, travel, and delays will make it impossible for a significant number of women to obtain an abortion.”*

I have a simple answer to that argument. If they don't want a baby then don't have sex! Plain and simple. You play, you pay. But they want their fun without the consequences and they have to learn that everything you do in life has consequences. If you don't like the consequences then don't do the action.

The scary part of this is that Jennifer Branch, the attorney representing Planned Parenthood, has a long history of being pro-abortion. This year Branch ran for the Hamilton County Court of Common Pleas, Juvenile Division judge's seat. Fortunately, she lost **52.9% to 47.1%** to her challenger, [Paula Westwood](#), Executive Director of Right to Life of Greater Cincinnati commented about Branch's run for the bench saying:

*“She recently ran for judge for Hampton Court of Common Pleas, which is a real concern because she was running for juvenile division. Judges for this division have influence over whether the judicial bypass is granted to minor girls who want abortions without parental consent.”*

Since Ohio passed the new law, the number of abortion clinics in the state have dropped from 14 down to 8. Hopefully Planned Parenthood will lose this lawsuit and the number will drop down to 7. Eventually, we'd all like to see it drop down to 0, but we'll take every single closing as a victory to protect and save the lives of the innocent unborn children that are a gift from God.

## **Defiant Obama Plans to Use His Power on Immigration and Keystone XL**

Could it be that the United States of America is on the verge of a constitutional crisis? As reported by [Politico](#), “President Barack Obama on Friday defended his plans to use executive power to bypass Congress, signaling that he's determined to move on issues like immigration and climate change, especially when lawmakers have failed to act. “They have the ability to fix the system. What they don't have is the ability to do is expect me to stand by with a broken system in perpetuity,” Obama said on immigration reform at a joint news conference here with Myanmar dissident leader Aung San Suu Kyi. “It's way overdue. We've been talking about it for 10 years now and it's been consistently stalled.”

So why didn't President Barack Hussein Obama take up the issue of immigration reform in his first term — especially the first two years when he held a supermajority in House and Senate? After all, he did push through ObamaCare and Dodd-Frank.

Obama stated, "I gave the House over a year to at least give a vote on the Senate bill. They failed to do so," the president said. "I indicated to Speaker Boehner several months ago that if Congress failed to act, I would use all lawful authority that I possess... That's going to happen. And that's going to happen before the end of the year."

It seems to me Obama is under the misconception that the legislative branch works for him. He fails to realize the U.S. House of Representatives is the "People's House" and is elected by its constituents — not appointed by the president. As well, we have a Constitutional system of governance for this Republic based on the premise of coequal branches of government. It appears that Obama doesn't grasp the concept of governing, but instead thinks only of ruling — dictating by edict and proclamation.

In the case of the Keystone XL Pipeline, which passed the House of Representatives overwhelmingly and will be taken up in the Senate next week, Obama has already stated he will veto unless Keystone XL meets his climate change criteria.

Obama clearly displayed his dismissal of Keystone XL stating, "I have to constantly push back against the idea that Keystone is either a massive jobs bill for the U.S. or is somehow lowering gas prices. Understand what the project is, it will provide the ability for Canada to pump their oil and send it through their land down to the Gulf where it will be sold everywhere else," the president said.

Does President Obama believe everything has to be accommodating to his whims and approval — or else? Obama's stance on immigration reform isn't a battle between him and the GOP. It's a battle pitting him against the American people — and there will be ramifications.

Obama is placing his political agenda above that of the American people and our rule of law. This does not end well. First of all, his decision will be a millstone about the neck of the next Democrat nominee for president in 2016. And it will be an anchor about the ankle of every Democrat running for office in 2016. It will cause a rift in support of Hispanics for the Democrats. The Hispanic community is not monolithic and there are those who actually believe in the rule of law and the rights of those who have come here as legal immigrants.

Obama cannot enact policy by his pen and phone — that is simply unconstitutional. And this comes on the heels of the president's climate change agreement with China that forces restrictions on America with nothing imposed on China. And of course Obama attempted to take some moral high ground — which resembles quick sand — "I have been very clear I have a responsibility as president not just to the current generation but to future generations," the president declared. "I took seriously the notion that we want all countries to participate in solving a global problem so I engaged with China over a lengthy set of negotiations and by all independent accounts for the first time we got China to make a very serious commitment to constrain its greenhouse gas emissions. Why would anybody be against that? It sounds like the right thing to do to me."

President Obama doesn't get to unilaterally decide what is the right thing to do for America — or what is best. Just like the countless amendments to ObamaCare issued by Obama by his will — that's not how our system works, or should work.

Ronald Reagan worked with House Speaker Tip O'Neill. Bill Clinton worked with GOP House and Senate majorities and claims credit for a constitutional conservative legislative agenda that resulted in a balanced budget, budget surplus, and a reduction in the size and scope of government. It was Bill Clinton who pivoted away from "HillaryCare" and stated, "The era of big government is over." Perhaps Obama should learn that lesson, especially after the 2014 midterm election drubbing.

Obama seems to believe he's still popular and can implement his will. He has demonstrated his disregard for the American electorate saying he heard the voices of the two-thirds of the American people who did not vote — as if their non-votes count.
