### **Kansas' Judges Should Be Recalled Before They Do Any Further Harm**

Kansas Supreme Court Justices Lawton Nuss, Marla Luckert, Carol Beier, and Dan Biles have failed to serve the people of Kansas and should be removed before they do any further harm. Not only have they consistently imposed their will in place of the law, they have also inflicted unnecessary suffering on Kansas families.

The U.S. Supreme Court struck down the last seven attempts by these justices to reverse the convictions of murderers and predators. If the nine robed jurists in Washington consistently overrule Kansas's highest court, it's not only embarrassing to the state—it's evidence that these justices are making up the law.

Not only did these justices impose their views; they did so at the expense of the victims' families. For example, in the case of [Kansas v. Marsh](#), the Kansas Supreme Court tried to invalidate the law imposing the death penalty on the defendant after he broke into a house, waited for the victim and her 19-month-old child to return, slashed her throat, set the house on fire, and left the child to burn to death. In [Kansas v. Ventris](#), the Kansas Supreme Court tried to undo a murder conviction for two defendants who robbed and murdered a man in his home to make off with \$300 in cash.

Yet, the most egregious example by far is the Carr case. When the Carr brothers robbed, kidnapped, raped, and tortured seven innocent people, killing five of them, a jury of their peers found them guilty beyond a reasonable doubt and sentenced them to death under Kansas law. Eleven years later, these four justices voted to overturn the Carrs' sentences and force the state to put them on trial all over again. That vote would also force the families of the victims who were tortured to death to relive this horror, hear the evidence again, and feel the media spotlight. This alone should be enough to justify voting Nuss, Luckert, Beier, and Biles out.

Fortunately for the victims in these cases, the U.S. Supreme Court found the Kansas Supreme Court had misapplied the Constitution. But each of these cases is emblematic of a broader pattern of lawlessness that merits voting against retaining these justices.

As the late [Justice Antonin Scalia wrote](#) just weeks before his untimely death, "Kansans ... do not think the death penalty is unconstitutional and indeed very much favor it, which might suggest that a retention election that goes before such people would not come out favorably for those justices who create Kansas law."

This week, according to the [complaint filed against Justice Carol Beier](#) by the Foundation for Accountability and Civic Trust, Beier undermined the integrity of the Court even further: her husband hosted a Democrat political fundraiser for then-gubernatorial-candidate Paul Davis at her home in 2014. Although her husband was the purported host for the event and Beier was out of the house at the time, the Kansas Commission of Judicial Qualifications has already held that these factors don't make a difference.

In 1990, the Commission held a judge's spouse may not hold a meet-and-greet at their jointly owned home. Letting a gubernatorial candidate solicit political donations in a Supreme Court justice's house isn't just foolish; it doesn't just look bad. It should make Kansans who might appear in court wonder if the whole system is rigged in favor of the political party allowed into Beier's home. Regardless of whether the Commission imposes sanctions, the voters should preserve the integrity of the office by voting her out.

The most frequent objection to voting out judges relies on the idea that courts should not be subject to politics. And that is indeed true — America’s legal system rests on the separation of powers, where an independent judiciary upholds the law as a cooling check on political passions. But that principle rests on another, more foundational one: that because all human beings are created equal, just governments must rest on the consent of the governed.

When four justices like Nuss, Luckert, Beier, and Biles thwart the application of criminal law by rewriting the laws the people's representatives passed, they undermine the sovereignty of “we, the people” and replace it with “we, the enlightened judges.” Removing them from office does not politicize the courts — the justices’ choice to impose their politics already did that. Voting them out is the only way to restore impartiality and the rule of law.

On November 8, Kansans should remember the victims the Kansas Supreme Court did not, remember the laws the Kansas Supreme Court did not follow, and remember the names of Nuss, Luckert, Beier, and Biles when they vote corruption out and the law back in.



## **You're On the Fence About Your Vote, This Pastor Clarifies --How the Very Future of America Is At Stake**

I have been asked "the question" so many times regarding Trump or Hillary. By way of background, I have followed every national convention—Republican and Democrat—from the time I was age 9, and have attended most of the GOP Conventions from 1984 to the present. I have watched the news virtually every day from the age of 8. I have never seen anything like what we are observing.

In spite of the unprecedented nature of this election cycle, I will attempt to respond to "the question." I am not demanding that anyone else share my view. But I was asked. Here is my best attempt to answer as I am able to see things at this time:

The Democratic and Republican party platforms are as different as night and day, in my opinion, as far apart as evil vs. good. The 51-page Democratic platform is the most leftist ever. (I don't care for the "right vs. left" nomenclature. I am far more concerned with "right vs. wrong.") The Democratic platform contains many points which are anti-biblical. (Time does not permit me here to identify what is meant by "anti-biblical," which is covered in my new book *Well Versed: Biblical Answers to Today's Tough Issues*.) It is thoroughly socialistic (a socialist is a communist without a gun). The 54-page GOP platform is one of the strongest GOP platforms ever. A biblically alert person could be comfortable with almost all of it. Party platforms are a big issue to me. Although some "blow off" party platforms, I do not. Nor do many people up and down the ballot who are running for office. This is a serious and very important item. I have a hard copy of both platforms in front of me now. Most people have never checked out what the party platforms say. They should. If a person is not drawn to the "top-of-the-ballot" candidate, they ought to at least consider voting for the candidate attached to the best party platform.

Analogy #1: Both candidates are flawed. We all know that. But permit me an analogy: As a pastor, I would rather deal with a church attendee who is blatant and brash in his sinning than one who is devious, lying, cunning and deceptive. Both are problematic, but one is easier to deal with than the other. If I were a pastor bringing correction to a parishioner, I would prefer dealing with a "Trump-type" any day over a "Hillary-type." The chances of making progress with the "Trump-type" are many times greater than the "Hillary-type."

Analogy #2: When my (late) wife's remarkable and much loved oncologist said, "Don't take Carol to that alternative (non FDA approved) treatment." I asked, "Why not?" He said, "The unknown." I said, "Doctor, your 'known' is much worse than the alternative treatment's 'unknown.'" I took her to that alternative treatment. One year later that same oncologist went to the alternative treatment doctor to see how it was that Carol had improved so much. While this alternative treatment did not ultimately save her life, it likely stretched two to three years of life to six years of life—by the admission of another one of her brilliant young oncologists who later said, "Without any medical training or scientific fact, you have put together a protocol of treatment that has moved her into the top fraction of 1 percent of survival rates

of all patients with Carol's particular cancer. Application of the analogy: Hillary's "known" is considerably worse—many times over—than Trump's "unknown."

Trump has lots of sins in his past (actually, we all do), and—in the present—says things he should not say. I make no attempt to defend any of the things he has said. There is no need to rehearse the wrong things he has said. We know what they are. He should not have thought or said them. But there is no need to rehash them here. So we won't. But let's turn to the other candidate. Although America has had some scandal-ridden candidates in its history, we have never seen any one major party candidate more constantly scandalous as Hillary (along with her husband). She seems to exceed all previous boundaries for wrongdoing. The scandals just don't stop. In the same way we did not take time to list all of Trump's misstatements, neither will we here rehash the seemingly continuous string of horrific scandals of the Clintons.

Trump is slowly being surrounded by increasingly good people. From time to time, I receive encouraging calls regarding this. Can these good people impact Trump? We will see. In contrast, I see no reason for any encouragement regarding the people who surround Hillary.

Trump is right on approximately 75 percent of the issues. I wish it was 100 percent. It is not. I am in hopes that those beginning to surround him can help him connect the dots on more issues. Hillary is wrong on 100 percent of the issues..

This next issue might be one of the most important, but I suspect few will understand its significance. Trump opposes globalism. Hillary thrives on it. Globalism is far more than "geographical" or "eliminating national borders and boundaries." It is spiritual and demonic at its core. Few—very few—understand this. This is quite likely one of the main reasons why Trump is hated. Do your homework on this one. Think "principalities and powers." Serious. Extremely serious.

Not voting is not a viable option, contrary to what the "purists" claim. It is not my intention to begin a war of the issue. I know that some radically disagree with this. My view? They have the right to be wrong.

Voting for a third party candidate is—regardless of what is said—a complete "throw-away." No third party candidate will be elected, or even come remotely close to being elected. And yes, that matters to me. And for the record, the Libertarian ticket—Johnson and Weld—is nearly as bad on many issues as Hillary. When I listen to them, I am stunned people of their ability have ever made it to elective office.

Trump has moved pro-life. Hillary is pro-baby killing, and prides herself on that, and honors the organization—Planned Parenthood—that actually traffics human parts from dead babies whom they have killed. This is below anything we have seen since Nazi Germany. The gall of Hillary! The Clintons have evaded justice for decades and likely will continue to. But they will someday stand before the Great White Throne. They will have to give account of their support of the ripping babies to shreds in the womb. For the record, those who vote for those who support the genocide of pre-borns will also have to give an account.

Trump wants to defend the nation (which is the purpose of government). Hillary has a horrific track record as Secretary of State, and due to hundreds of millions of dollars given to her and her husband's foundation, she is beholden to those who want us dead.

Hillary claims "everything is fine" in America. This defies every single fact, but facts have never been an interest of Hillary's. Trump understands that it is 11:59 p.m. on the "cultural clock." America is near the end—morally, economically, militarily and, sadly, spiritually. There are very clear identifiable indicators—measurable ones—that America is no longer the world's leading power. That day is over. Hillary will hasten the final destruction. Trump could either slow that down—or possibly, with God's help—reverse it. Maybe.

Trump will address the massive government spending. Hillary will expand it above the existing unsustainable debt the U.S. currently is carrying (almost \$20 trillion plus unfunded liabilities to Social Security, etc).

Trump will expose—and I pray, bring down—"the systemic evil" (crony, deceitful, misuse of capitalism) that reigns among many high-dollar lobbyists. Hillary thrives because of them.

Trump will stop the massive overreach of government. Hillary will extend it.

Freedoms come in "threes." Political freedom, economic freedom and religious liberty coexist together. Take one away and the other two will eventually disappear. One cannot exist without the other two. The genius of America is that it had all three, until recently. Trump fully grasps the loss of religious liberty. ## **K-12: Parent X Takes On Principal Zero**

As you study the decline of our public schools and see the tsunami of sophistry and deceit, you start to wonder: who promotes all this stuff? Who defends it? No normal person would want our public schools to be increasingly mediocre. What's going on?

It's not easy when you're on the outside to answer these questions. You can see the [dysfunctional theories and methods](#) operating in public schools. But the people responsible for the quackery are not likely to claim credit. Sure, they may brag to each other. But the public in general is thought to be ignorant rubes who are not entitled to know very much. (The public is probably regarded as The Enemy.)



So I was delighted when a mother wrote to me about her experiences with a local school. Long story short, she irritated the principal so much that the principal actually told the truth.

Parent X wrote:

My oldest daughter attended private school K-8. Next, she attended what was supposed to be the "best" public high school in the area. I thought grades 9-10 were marginal at best. Then a new principal was assigned with a Ph.D. in education. And things got worse!

In grades 11-12, I had at least ten parent-teacher conferences about substandard academic performance – of the *teachers*. Except for one dedicated AP English teacher, they didn't know their subjects, and they didn't care.

My complaints were elevated to the new principal. I met with him at least seven times; several times I was accompanied by a member of the school board.

Finally the principal, aggravated and arrogant, told me schools no longer believe in academic excellence because demanding subjects no longer appeal to the mainstream student or to his parents.

He proclaimed that his program, his syllabus, his teachers were all fully in compliance with local, state, and federal standards, and he wasn't going to change a single thing to accommodate me or my daughter.

He said proudly he is a "Progressive," he has a Ph.D., and he had "helped" develop and design many of those standards, and he believed in them. He said any kid who wants a higher-level education for a professional career will have to get it somewhere else.

He was emphatic that neither I nor the school board member could change anything.

I gave up on public schools. My youngest daughter was homeschooled. She is 17 and starts her sophomore year in college next month. Pre-med. She is certainly smart, but not an Einstein. We focused on core academic subjects, and we have not wasted her time with social justice indoctrination. This approach will work in every school that tries it.

For me, the key sentence is "schools no longer believe in academic excellence because demanding subjects no longer appeal to the mainstream students or to their parents." Says who? Did somebody take a survey? Did Congress discuss this? No to all such questions. These arrogant Progressives meet in back rooms and decide what the public needs and will get. And that's that.

Truth is, the dumbing down starts in kindergarten. Kids [don't learn to read promptly](#). They [don't learn basic information](#). By the time they reach ninth grade, they're dumb enough to think this principal's high school is a reasonable place, not the illegitimate fraud it actually is.

What does this principal do all day? Put another way, what is his real job? I think the best word is *enforcer*. His job is to lay down the law to irritating parents who are slow to get the message. If they or their kids still have any dreams, they should give them up. Accept average.

He has to deliver this message: *You want education? You can't handle education. You're peasants. Mediocrity is good enough for you. Eat cake.*"

The Education Establishment cannot control the vast K-12 system without tens of thousands of eager enforcers. These are the superintendents, administrators, and principals. Every school seems to be overstaffed with such enforcers but understaffed with real educators.

Years ago I heard someone propose that we need to walk through the public schools and ask each person if he does something in the classroom. If not, he's fired. It's a start. Does a community need to tighten its budgets? Fire administrators. Their main official duty seems to be the creation of unnecessary paperwork.

But let's look even deeper. What is a Progressive? That's just a fancy word for Socialist or Communist. They set low goals, especially in education. Apparently, they want people to be permanently weak and controllable. They don't want to educate people who might replace them or compete with their own children. Progressives [always seem to be training an underclass](#) who will be happy to stay at the bottom, so that Progressives can rise to the top.
