## IS KANSAS STATE UNIVERSITY HOPING TO MATCH MIZZOU IN LOST ENROLLMENT??

Kansas State University will suspend classes for a few hours next week to host a special event, KSUnite. "We cannot and will not allow the actions of a few detractors to attack our values and divide us," an email to alumni and K-State community announcing the Nov. 14 event reads. In the last few months, the university has been in the news twice for supposed racist events on campus. The headlines were swift overreactions to the wind–literally–and to an African American man who painted racially charged graffiti on his own car.

In October, wind knocked over a Jewish sukkah temporarily constructed on campus. Media rushed to conclude that it was an anti-Semitic act. Richard Myers, university president, called out the perpetrators, denounced hate on campus, while members of the community rallied to rebuild the construction and host a unity celebration. Days later, the police announced the sukkah damage was a result of strong winds—and not an anti-Semitic act. Last week, campus erupted after a black man told officials and the police his car had been vandalized with racist slurs when it was parked near campus. Once again, university officials raced to the microphones to denounce hate and racism on

campus, despite the fact that the individual involved isn't a student and his car wasn't parked on campus. The so-called victim of the racist vandalism painted the graffiti on his own car and filed a false police report, law enforcement announced a few days later. They decided against pressing charges, because it would damage the K-State and Manhattan community. The Riley County Police Department explained it was a youthful indiscretion.

Is Kansas State University attempting to out-snowflake the University of Missouri? School officials are hosting an event that only draws attention to their embarrassing overreactions to an act of nature and a hoaxer unaffiliated with K-State.

In spite of the revelations that the K-State racism complaints are no more than an act of nature and an attention seeker seeking attention, university officials are moving forward with plans to unify the campus against racism that didn't occur.

"These incidents, some of which were determined to be pranks or false reports, have caused emotional stress and angst for students, faculty, staff, parents, and members of our community, please be assured, we have taken and will continue to take responsive and proactive steps to support our K-State family and ensure a safe environment for everyone," a letter signed by school and alumni leaders reads. The email announces plans to increase police patrols on campus and reiterates plans crafted last fall to hire a chief diversity inclusion officer and an associate vice president for student life/diversity and multicultural affairs, "to develop and protect inclusive learning communities at K-State." It doesn't say how the increased patrols and dialoguing will stop wind from blowing or stop people who aren't university students or staff from making false police reports. The letter to K-State family reports that K-State is not the only college campus experiencing racial tensions. K-State might be the only one making a practice of crying racist in response to hoaxes and the wind.

A straight shot up Interstate 70 shows just what happens when university officials decide to place added emphasis on racial tensions instead of simply education. Missouri students and parents are shunning the University of Missouri, after a season of protests. In Columbia, freshman enrollment is down 35 percent. Seven dorms are closed and more than 400 faculty members lost their jobs. K-State officials should proceed with caution, especially since the headline-grabbing racial tensions at the school didn't actually occur. The university, once the fastest growing in the state, marked its lowest enrollment in years. Enrollment was down by nearly 1,000 students this year. Enrollment at the University of Kansas, Wichita State, and Fort Hays State University, meanwhile saw enrollment creep higher.

One bad actor and some wind coupled with an administration that appears far too eager to cry racism may be putting K-State on a path to disaster. For a few hours on Nov. 14, KSUnite will draw students and staff to the Anderson Hall lawn for a show of solidarity. Student leaders and Myers will speak with "a message of unity."

Shuttering classrooms and staging a quasi-protest rally only draws added attention to embarrassing overreactions on the part of K-State officials. That seems like a bad idea.

# KC STAR ED BOARD PICKS AT MORE HILL TO THROW SHADE AT KOBACH | 11/11/17

The Kansas City Star editorial board will stop at nothing to throw shade at Kansas Secretary of State Kris Kobach. Their derangement often requires picking at molehills. Such is the case in a recent editorial that suggests a voting "snafu" should give pause voter ID laws.

It's a real reach. The editorial admits that there is no evidence anyone was denied the right to vote due to the "foul-up," but the piece leads, "Hundreds, perhaps thousands of Kansans who went to the polls Tuesday ran into an unexpected problem when they provided required photo identification."

Hundreds? Thousands? Unlikely. Real IDs, which will eventually be required in order to board an airplane, were just recently rolled out in Kansas. This means it's unlikely that there are several thousands of Real ID driver's licenses even in circulation in the state. And of those, it's even less likely that a majority of Real ID holders even visited the polls. Voter turnout across the state was paltry.

Even assuming that thousands of voters presented Real IDs to election workers, the end result was that an election worker had to perform a manual search for the voter's information instead of scanning a bar code.

It's hardly a poll tax. At most, it was a mild inconvenience costing seconds of time-hardly worthy of an entire editorial. What's next? Lengthy scribes against not being able to find front-row parking at city hall?

"Someone should be embarrassed. It seems obvious that officials needed to make sure the Real ID bar codes would work with existing equipment," the editorial reads. A few paragraphs later, the board names names.

"Kansas Secretary of State Kris Kobach led the effort to force Kansans to present a valid photo ID to exercise their rights as citizens. On Tuesday, some Kansans who tried to comply by using a state-issued document discovered it wouldn't work as intended," the editorial lectures readers. "Perhaps Kobach can pause from his work on the Election Integrity Commission long enough to make sure voters' rights in Kansas are fully protected and that election systems work."

What the Star doesn't bother to note is that there are several forms of acceptable federal ID that poll workers can't scan. That includes military IDs and passports. Election workers are trained to handle those instances.

The Star is picking at a molehill in hopes of toppling Kobach. If this the best the Star editorial writers can do, Kobach will be laughing his way to the Governor's Office.

I remember how shocked I was to see someone on his knees during the playing of the national anthem. It wasn't NFL players on their knees. It was my father-in-law during my U.S. Army Officers Candidate School graduation.

He had every reason to be angry and protest how his nation had had an impact on his life. Henry was born and grew up in Brooklyn during a time of great national uncertainty and pain, when the government had failed its population and its decisions had brought great economic hardships upon its Citizens.

He was raised in a broken home. His father was a veteran who had turned to alcohol as a form of self-medication to calm the evils he had witnessed in a war his nation sent him to. Charlie had every right to protest.

At the age of 14 years Henry was present for the death of his mother in their slum apartment in Brooklyn. Just before she died Henry ran Henry ran down the street trying to get a doctor or an ambulance to come to this very bad neighborhood to try to save his mom. No one came to help. Charlie had every right to protest.

Henry was taken by the government to live with other teenagers of disadvantaged backgrounds. The government moved these children out of Brooklyn to the Deep South.

Then was came to New York. Charlie witnessed what had happened and thought the Army might be a way out. At 18, he joined the Army, trained and was sent to war. While in combat he was severely wounded.

He had been left for dead, but Charlie was tough, and somehow survived. He came back broken in body to the nation which had sent him to war. Henry had every right to protest.

Yes, Henry had every right to be bitter toward his nation for the tough life he had. He had every right to take a knee during the playing of national anthem. His life was so bad he had every right and some might say duty to take two knees during the anthem.

He was thankful and humbled for the freedom he had as a American.

He was proud of his service and of his sacrifice. Henry was a true hero and not a millionaire athlete. His salute means more than all the employees and owners of the NFL's sorry displays and opinions. They are not warriors. They are disgraces.

Henry had every right to protest, but he didn't. Henry honored, respected and celebrated his nation and his flag until the day the Flag was placed on his Casket and then given to his wife.

#### K-12: The Math You Need Is *Not* the Math You Get

Learning school subjects should be like learning anything else in life. You start at the beginning, proceed step by step, master more difficult aspects, and become skilled. Isn't that how we learn to drive a car, build a doghouse, play the piano, surf, or operate a computer? Of course. That's how we humans do it.

But our Education Establishment does not approve. Those in the Education Establishment insist on doing everything in inefficient, likely to fail ways, something like taking a child to a busy street and saying, *Now, let's see you parallel park*. Lots of adults, with years of experience, avoid parallel parking. But our schools (this is the essence of Common Core) put a 15-year-old in this stressful situation on the theory that he will be able to handle stress better in the future. No, many are scarred and never try parallel parking again.

Public schools (and Common Core) consistently embrace <u>counterproductive methods</u>. For example, "[t]he first standards gave a strong call for a de-emphasis on manual arithmetic in favor of students' discovering their own knowledge and conceptual thinking."

*Their own knowledge?* Is that a clever way of saying wrong answers? And what is *manual arithmetic*? Is that when you jot down 27 and 68 and get 95? Why would you want to de-emphasize a quick way to get the right answer?

Another summation adds: "Reformers do not oppose correct answers, but prefer to focus students' attention on the process leading to the answer, rather than the answer itself. The presence of occasional errors is deemed less important than the overall thought process."

Occasional errors? You see that the insanity is built in. Reflect on these two quotes, and you will not be surprised that PISA (Program for International Student Assessment) places the U.S. near 30th among the nations, despite vastly greater budgets.

Here is another summing up where <u>elementary arithmetic</u> is transmogrified into high school physics: "Problem-solving is a process – an ongoing activity in which we take what we know to discover what we don't know. It involves overcoming obstacles by generating hypotheses, testing those predictions, and arriving at satisfactory solutions."

Wouldn't it be more useful to teach students to generate correct answers? But no, our educational pretenders prefer lots of wasted energy.

The Standards mandate that eight principles of mathematical practice be taught:

- 1. Make sense of problems and persevere in solving them.
- 2. Reason abstractly and quantitatively.
- 3. Construct viable arguments & critique the reasoning of others.
- 5. Use appropriate tools strategically.
- 6. Attend to precision.
- 7. Look for and make use of structure.
- 8. Look for and express regularity in repeated reasoning.

4. Model with mathematics.

Seriously, shouldn't this be called Ph.D. (Piled Higher and Deeper) humor? Has anyone now reading this ever done these steps? Arguably, all of them are contrived distractions intended to keep children away from actual arithmetic.

Here's another obstacle: what these people call a problem is mislabeled. Normally, we would call it a riddle, a thing intentionally designed to be difficult and irritating, at least for a few minutes. Furthermore, the English is not at an elementary level, thereby guaranteeing that poor readers will be further alienated from simple arithmetic.

Here is a preposterous fourth-grade question that became famous for symbolizing every bad tendency in Common Core: "Juanita wants to give bags of stickers to her friends. She wants to give the same number of stickers to each friend. She's not sure if she needs 4 bags or 6 bags of stickers. How many stickers could she buy so there are no stickers left over?"

The <u>Independent Journal Review</u> concluded: "The question can NOT be answered as asked." They produced a funny video where four adults grapple unsuccessfully with this inane question. Yes, but not funny when your kid asks *you* to solve the problem.

Let's turn away from gobbledygook and look at the real problems real people routinely deal with.

A man drinks four sodas every day. How many six-packs does he need to get through the month of September?

You go on a 600-mile trip. Your car gets 20 miles to the gallon. The price of gasoline is steady at three dollars a gallon. How much money do you set aside to cover fuel?

You get a job (in June) where you can make \$100 a day (no days off), but the employment agency gets 10% commission. So what do you take away?

You plan to open a business at a certain location. You count passing cars for five minutes: 95. How many, more or less, would go by in an hour?

Everyone should be able to solve these in their head or on paper in 10 to 15 seconds. The first step is knowing the multiplication tables and other math facts. But guess what: memorization, like mastery, is disparaged. So every problem is the same sort of deep mystery over and over.

Common Core wants you to "to reason abstractly and quantitatively." What could that mean? Public schools do not teach fundamental skills, so students, after years in the classroom, can't do life's simple problems. Instead, they can "use appropriate tools strategically." Does anybody know what that would be? Oh, maybe they mean a calculator. That's pretty much the way all the kids end up: calculator-dependent.

"Parents, educators and some mathematicians opposing <u>reform mathematics</u> complained about students becoming confused and frustrated, claiming that it was an inefficient style of instruction characterized by frequent false starts." *Confused and frustrated.* That's exactly the problem. What we want students to feel is confident and comfortable.

It's a total bait-and-switch, just like sight-word reading. School officials promise to teach you superior methods that turn out to be vastly inferior. Then you realize you've wasted years; at the end of it, you can't do simple arithmetic (just as you can't read). Focus on the tsunami of waste for a few minutes, and you'll start to scorn our professors of education.

What they do in the public schools now is push kids into the dark woods before they know how to survive in the backyard. There is a real perversity throughout public school education, but you especially see it in math, where they have children crying

over what traditionally was easy homework.

The most recent <u>PISA results</u>, from 2015, placed the U.S. an unimpressive 38th out of 71 countries in math and 24th in science. Among the 35 members of the Organization for Economic Cooperation and Development, which sponsors the PISA initiative, the U.S. ranked 30th in math and 19th in science.

Math is a story of <u>endless failure</u>. "This pattern that we're seeing in mathematics seems to be consistent with what we've seen in previous assessments ... everything is just going down," said Peggy Carr, acting commissioner at the National Center for Education Statistics.

As this is the situation year after year, we can reasonably conclude that the Education Establishment wants this result. All the bad practices are so readily fixed if there were the will to do so. Seems to me the public is forced to choose between two verdicts: sabotage and unbelievable incompetence.
